Rates of Interest on Advances and Discounts

The rates on advances and discounts made by the Federal Reserve Bank of San Francisco pursuant to the provisions of the Federal Reserve Act and Regulation A are, effective October 31, 2007, as set forth below:

RATE PER ANNUM

Advances to and discounts for member banks and other depository institutions:

- (a) Primary credit advances and discounts under sections 10b, 13 and 13a of the Act and under section 201.3(a) of Regulation A
 - Primary Credit 5.00%
 - Secondary Credit..... 5.50%

- (b) Seasonal credit advances pursuant to section 201.4(c) of Regulation A..... Flexible Rate¹

Currently, no advance or discount is subject to a surcharge.

This schedule of rates supersedes our previous schedule that was effective September 18, 2007.

¹ A flexible rate that takes into account rates on market sources of funds is applied to seasonal credit.
