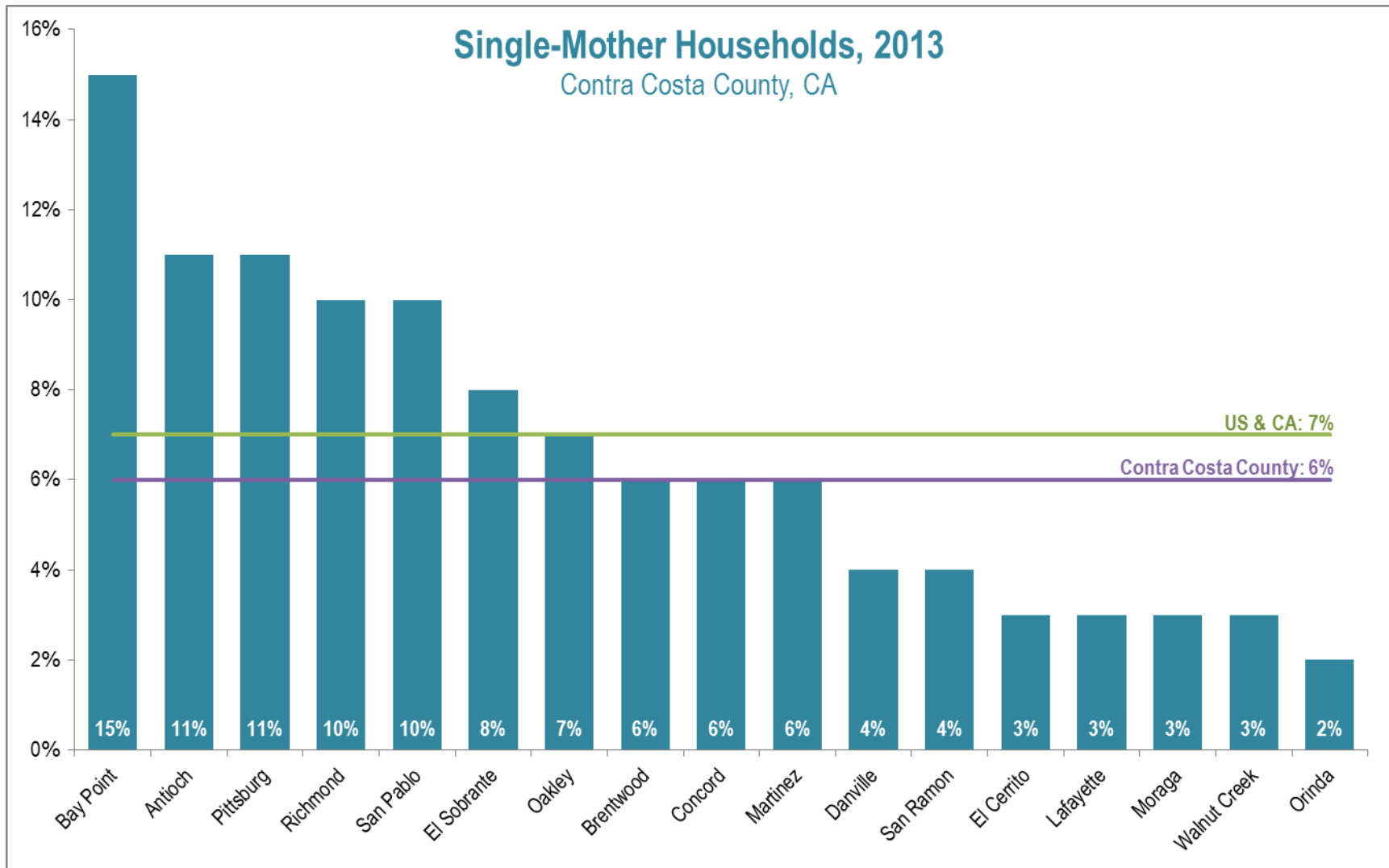

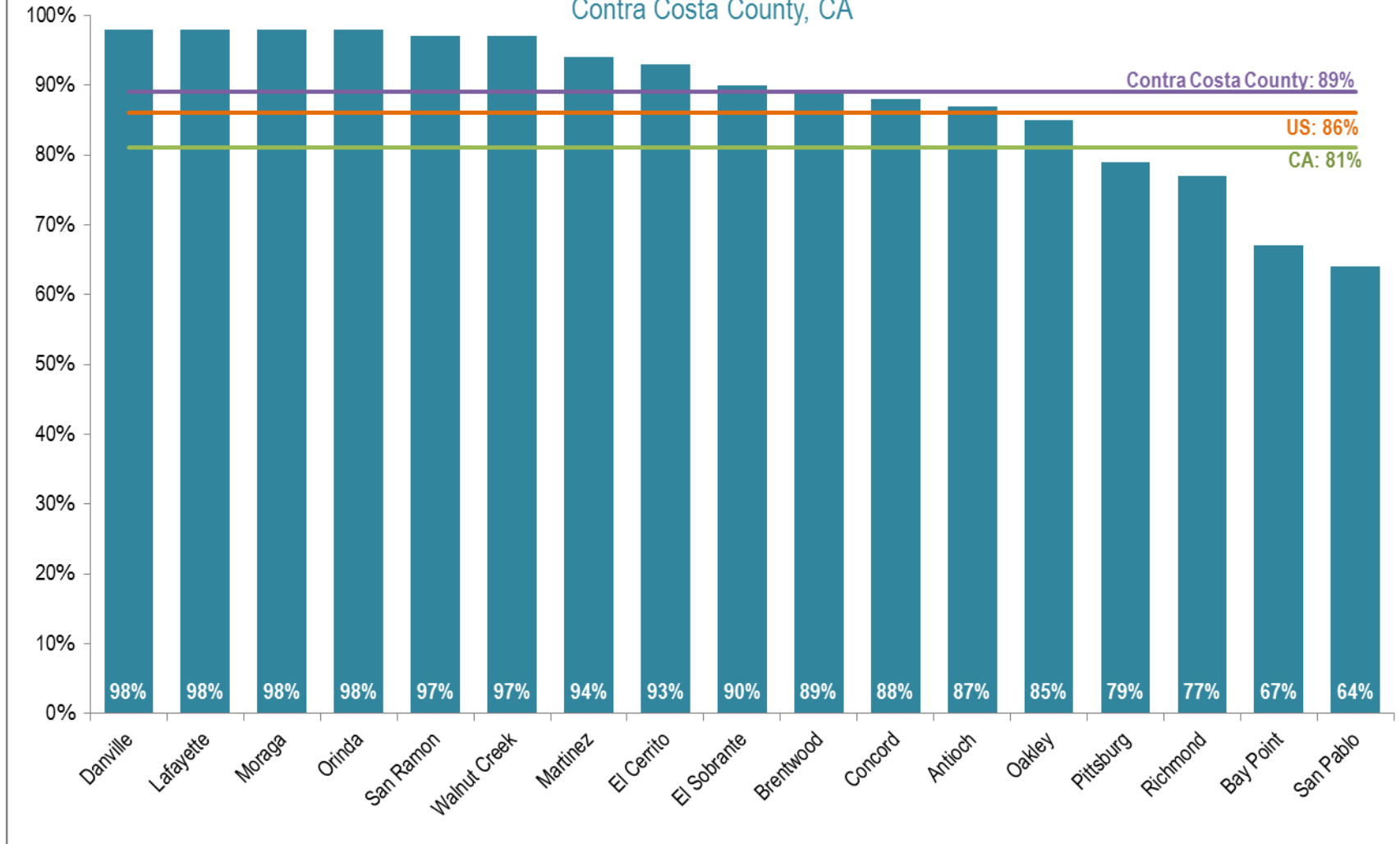

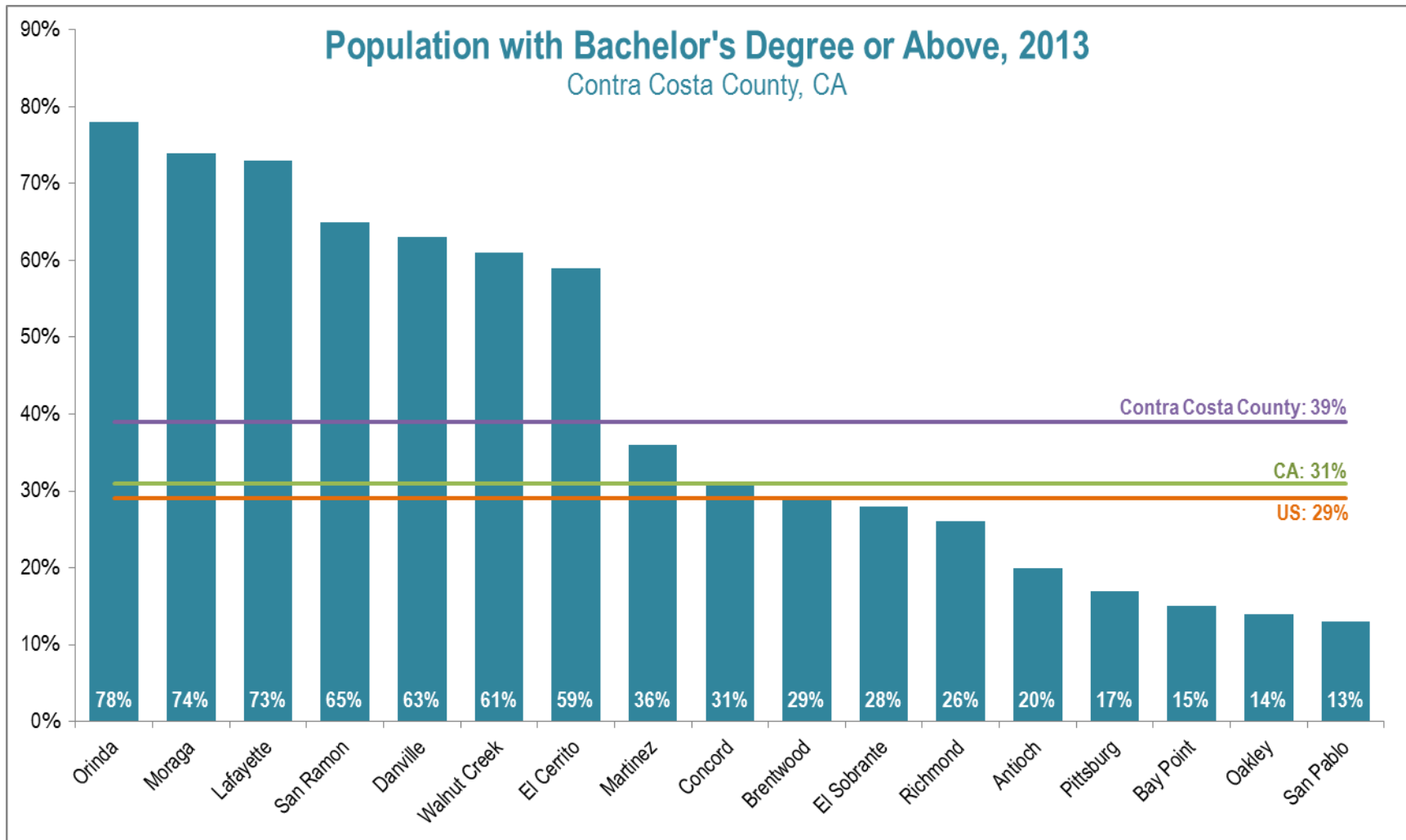

# Population with High School Diploma/GED or Above, 2013

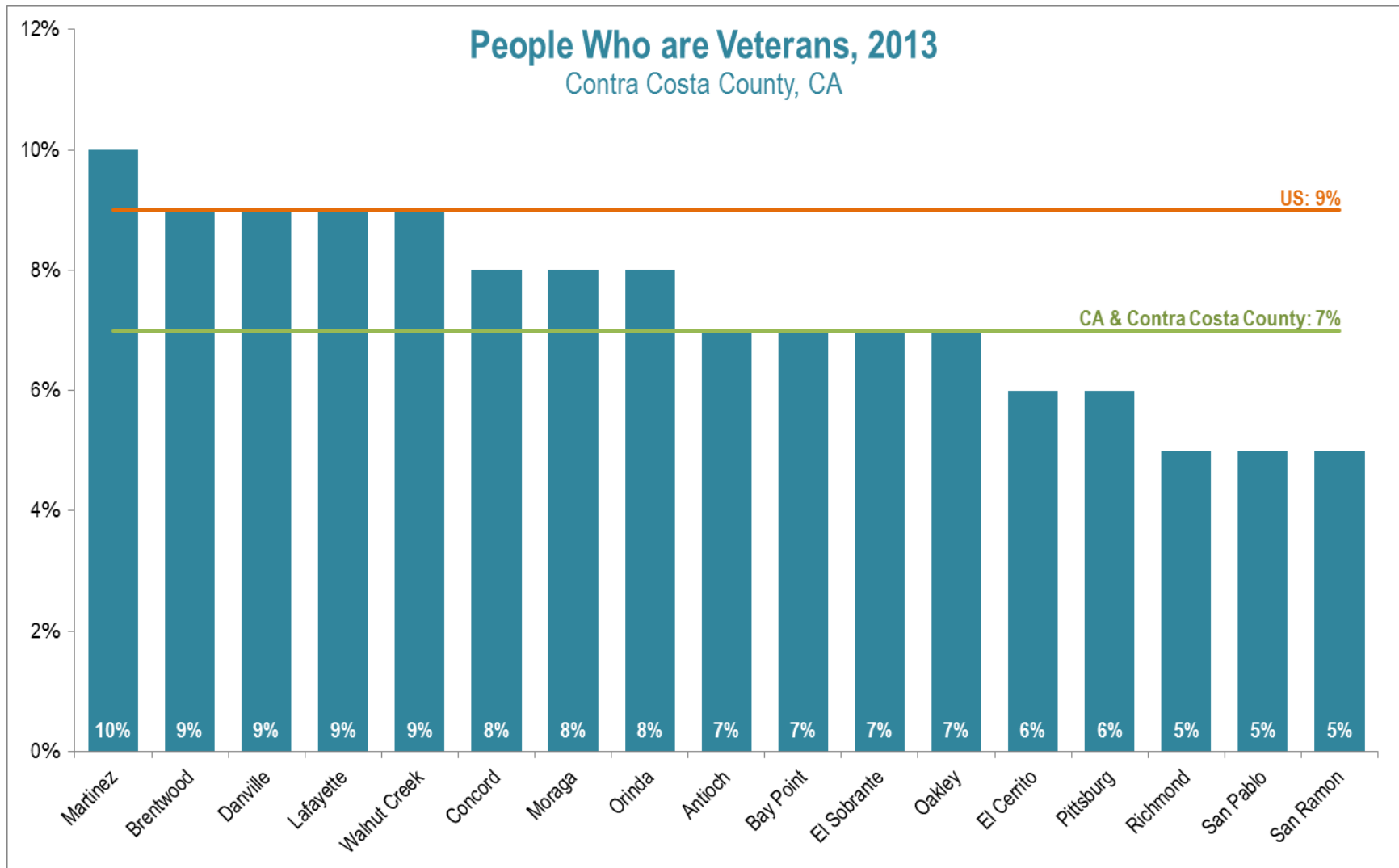

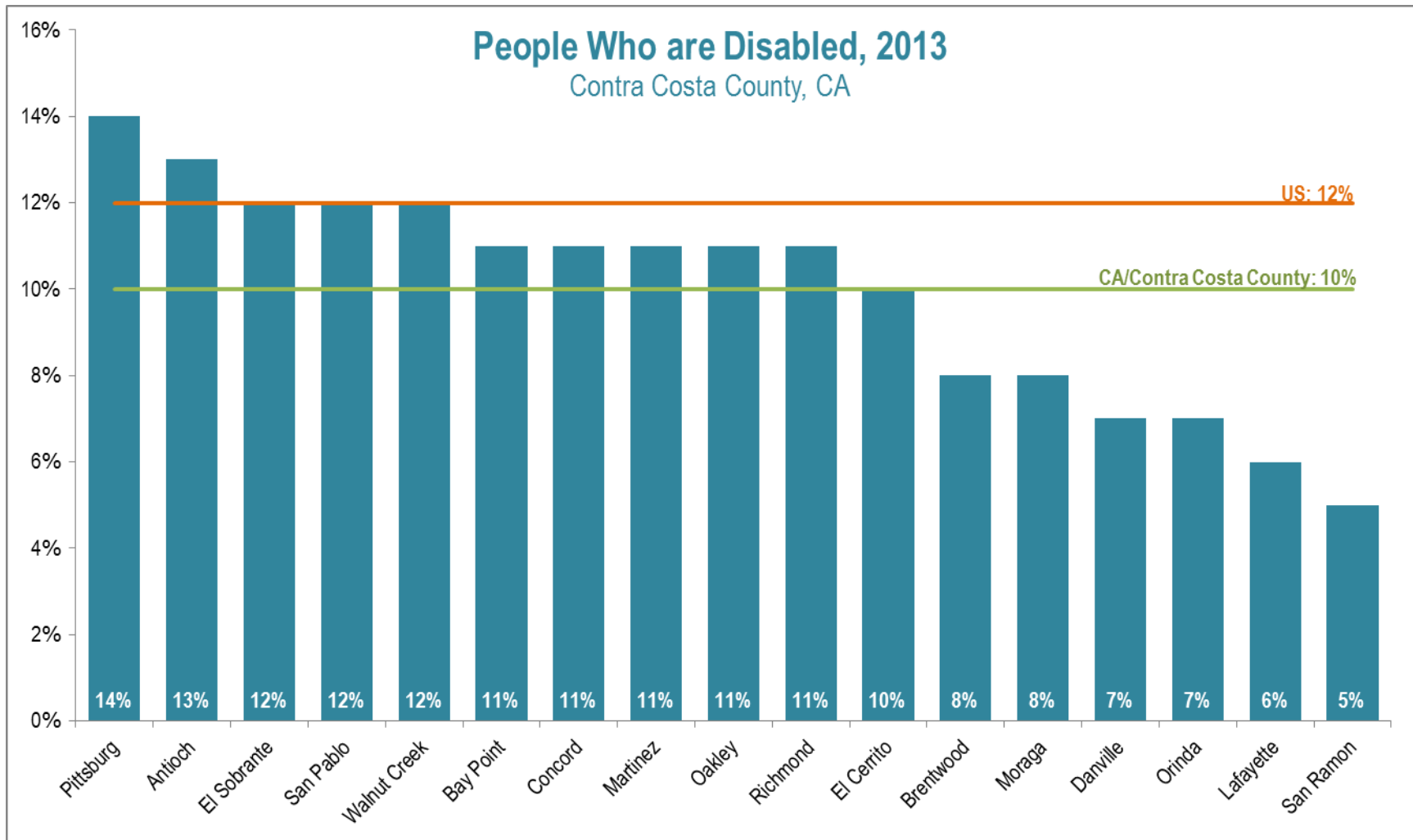

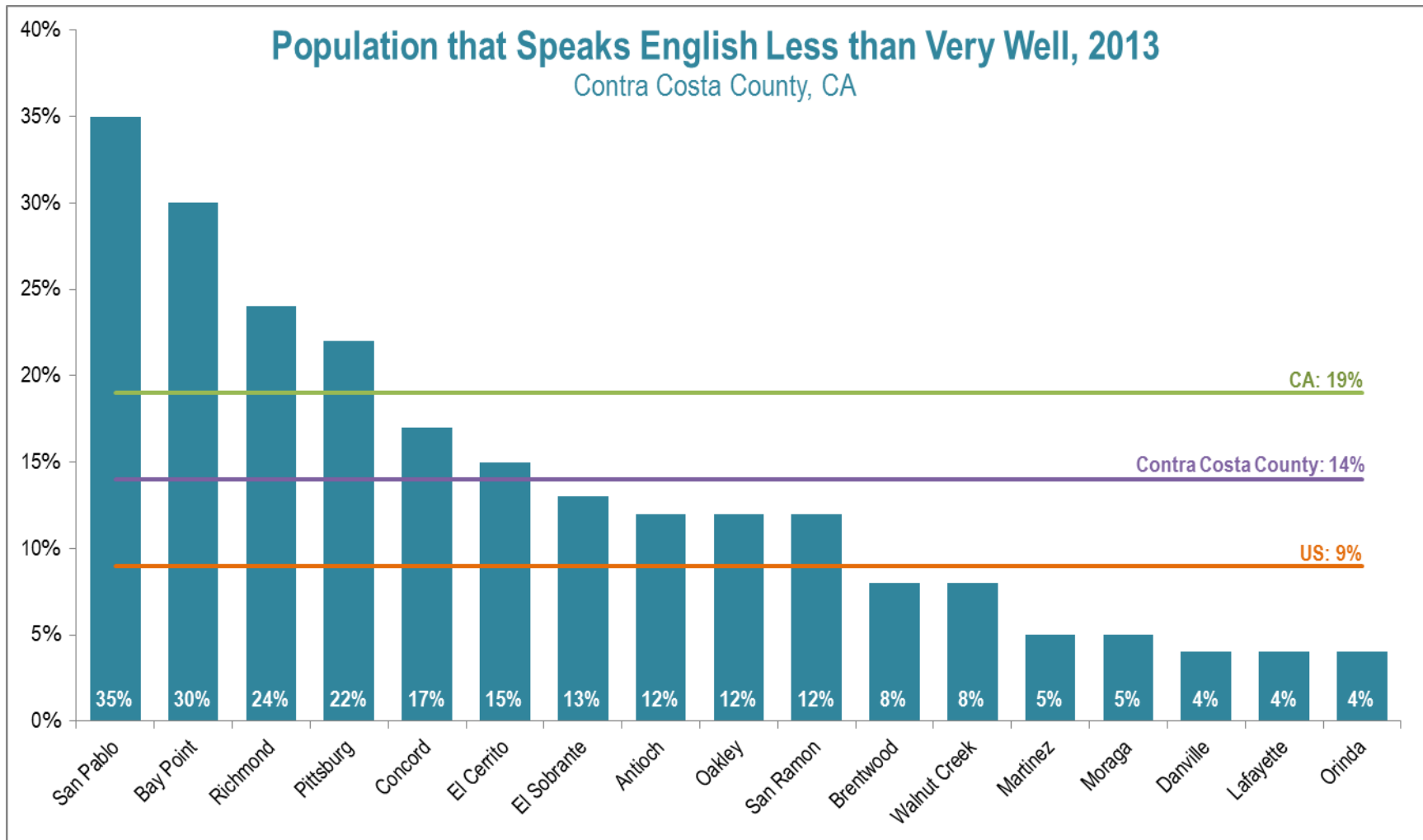

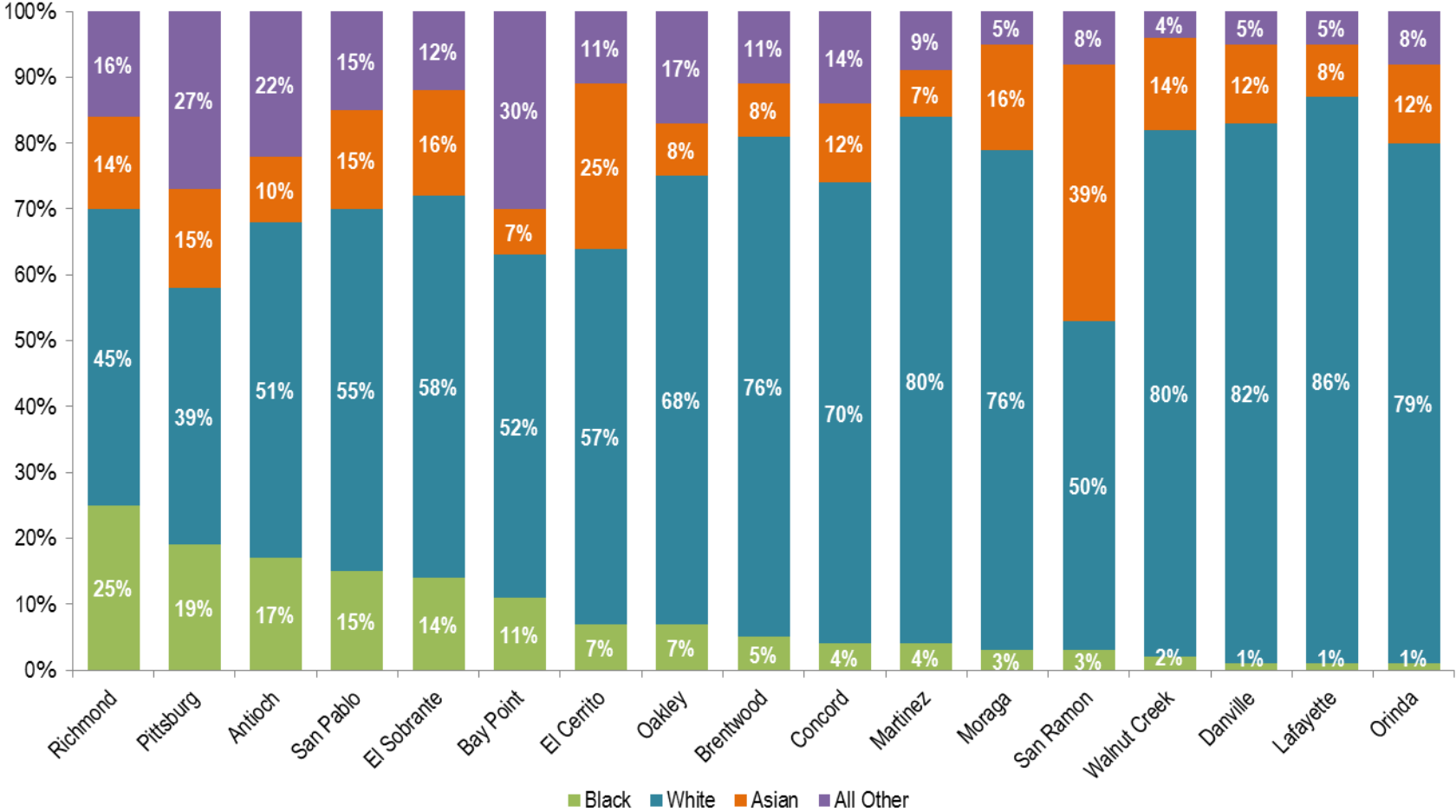

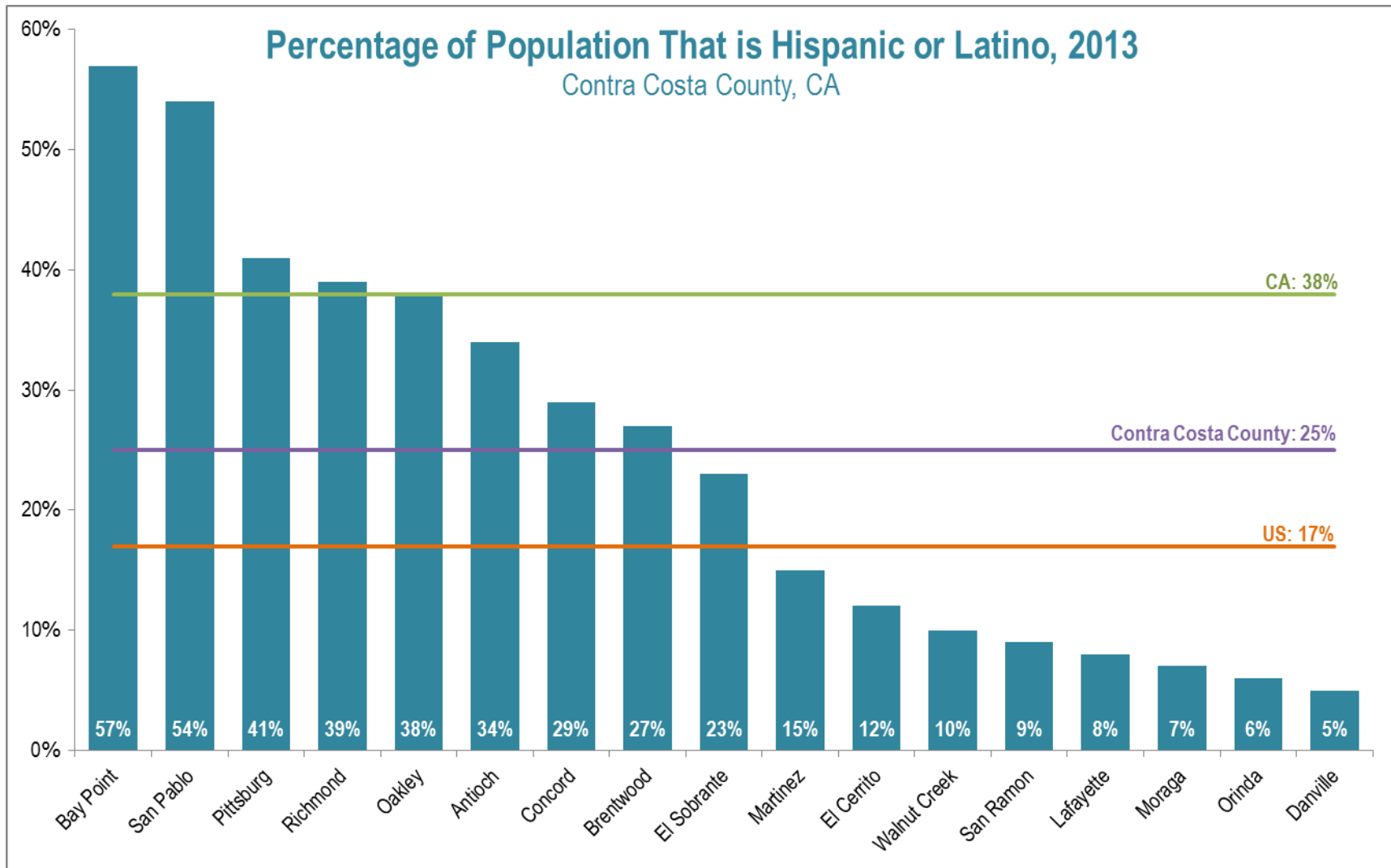

### Population by Race, 2013 Contra Costa County, CA

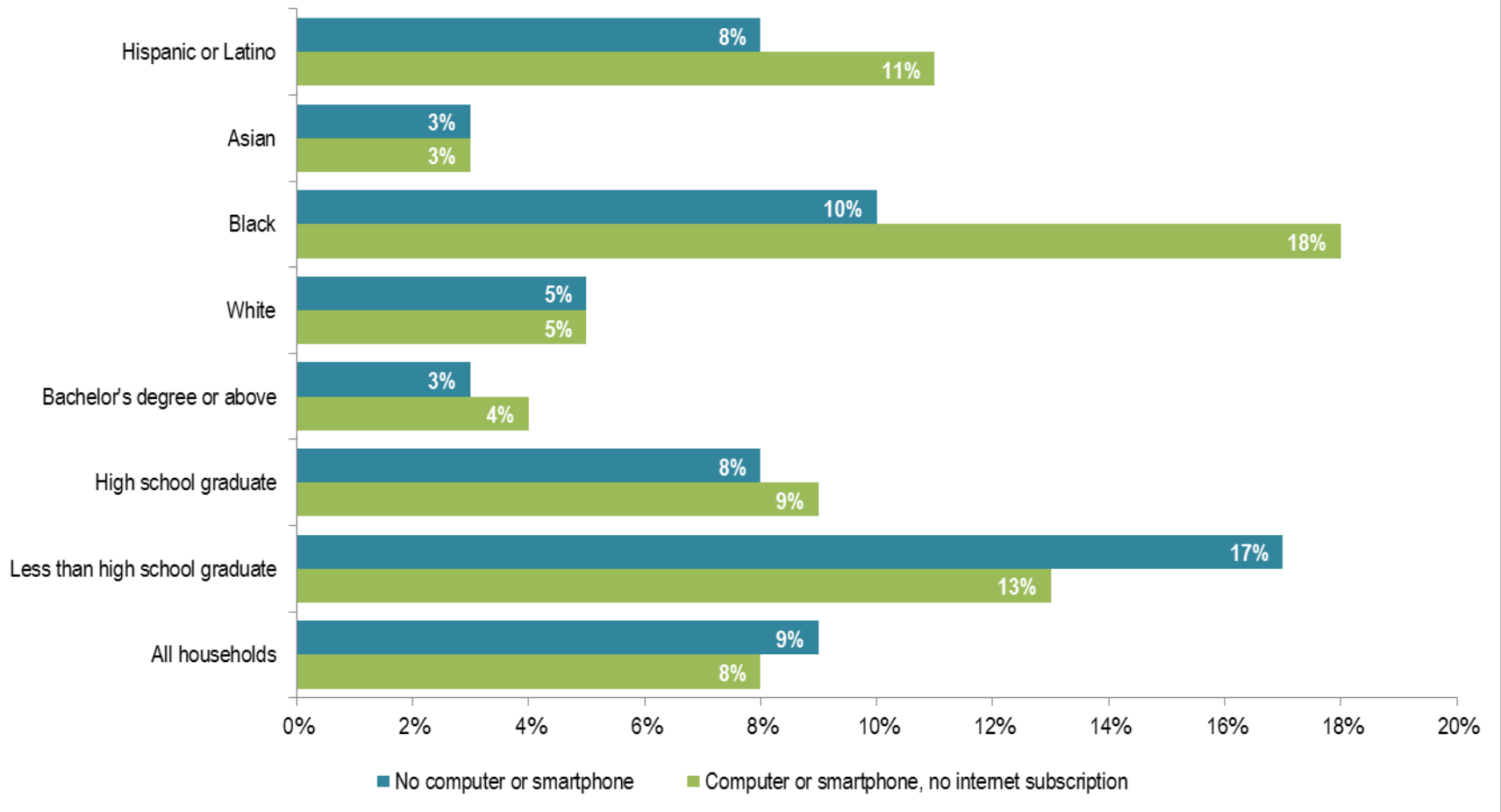

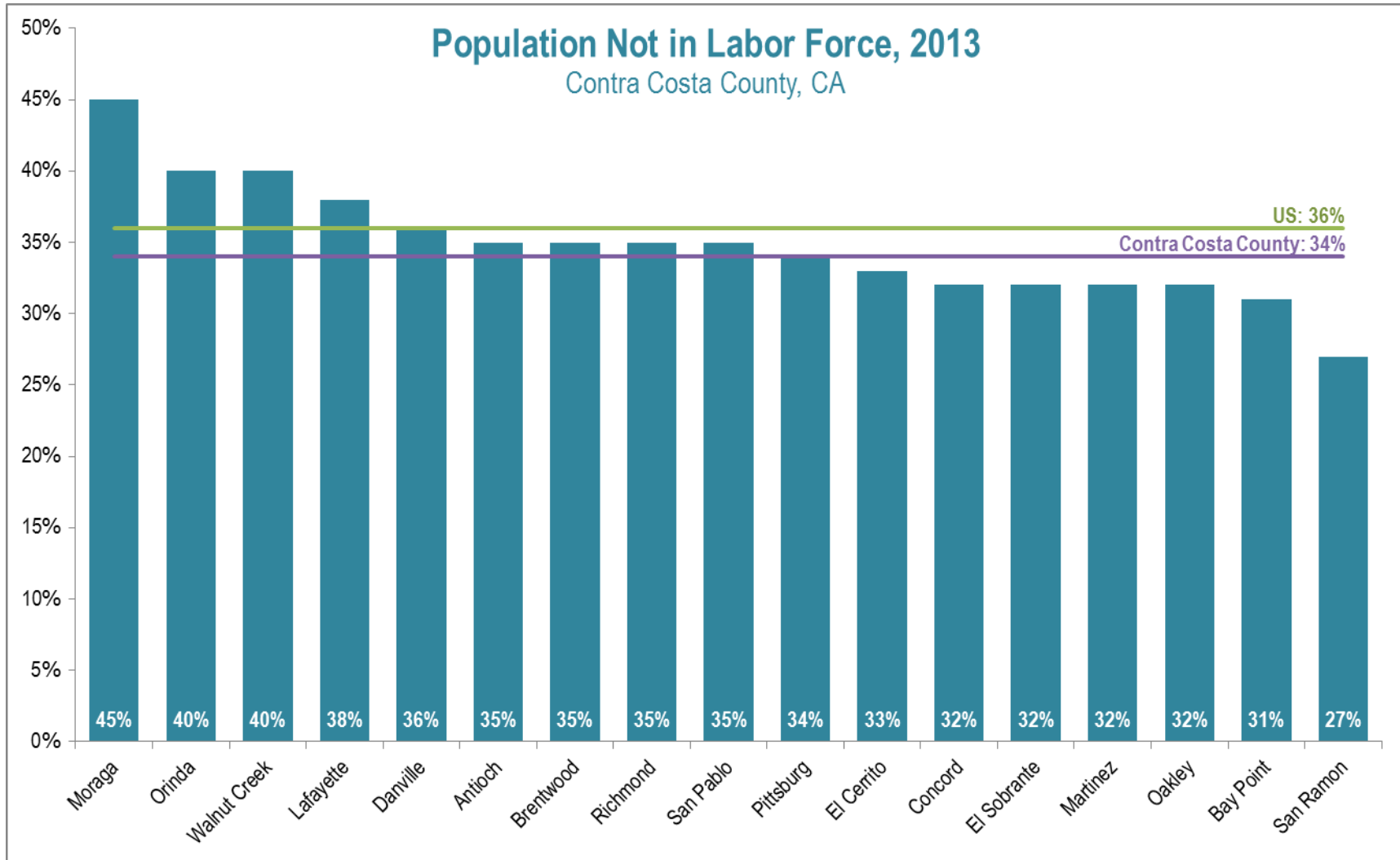

### Access to Computers, Smartphones, and Internet, 2013 Contra Costa County, CA

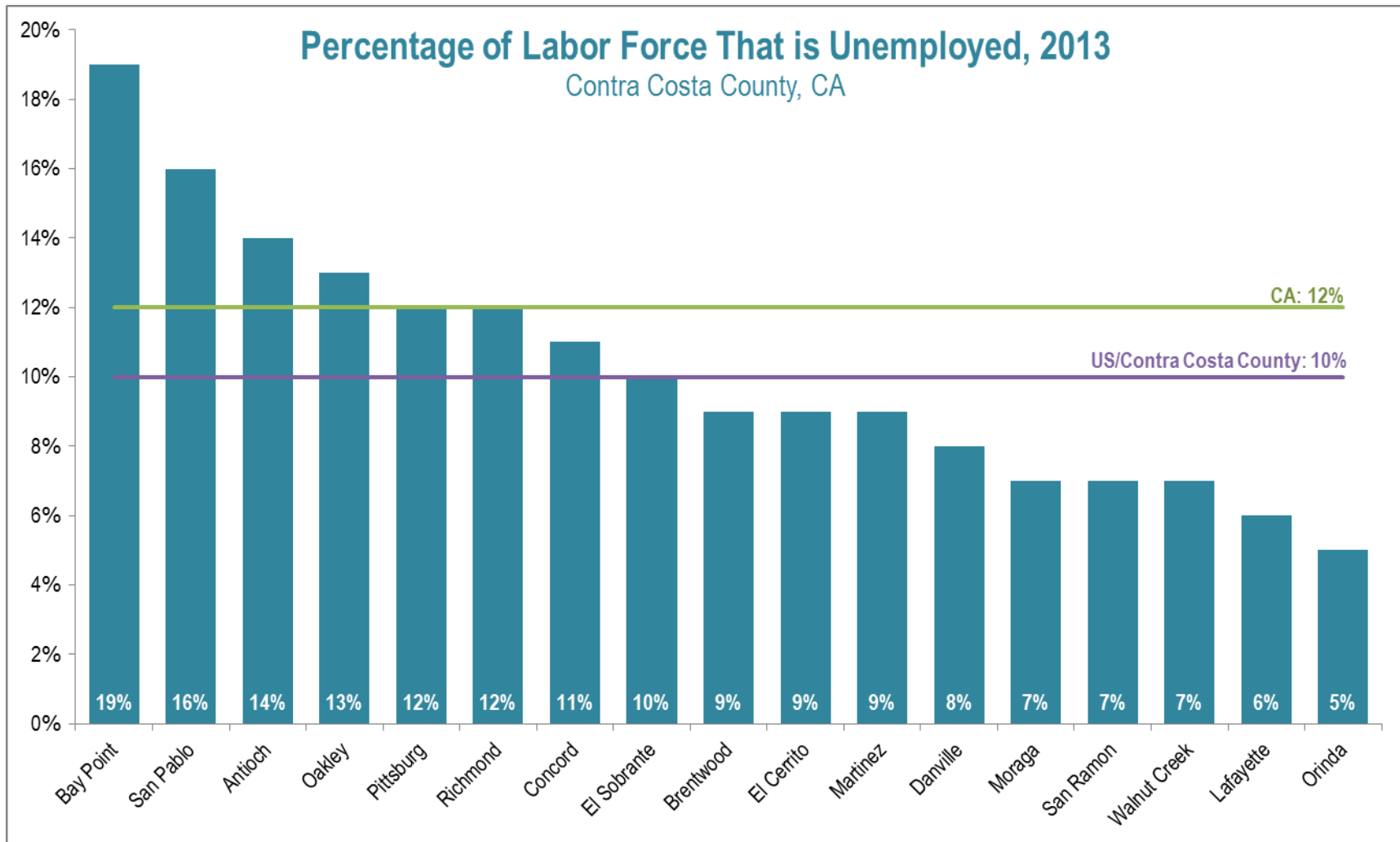

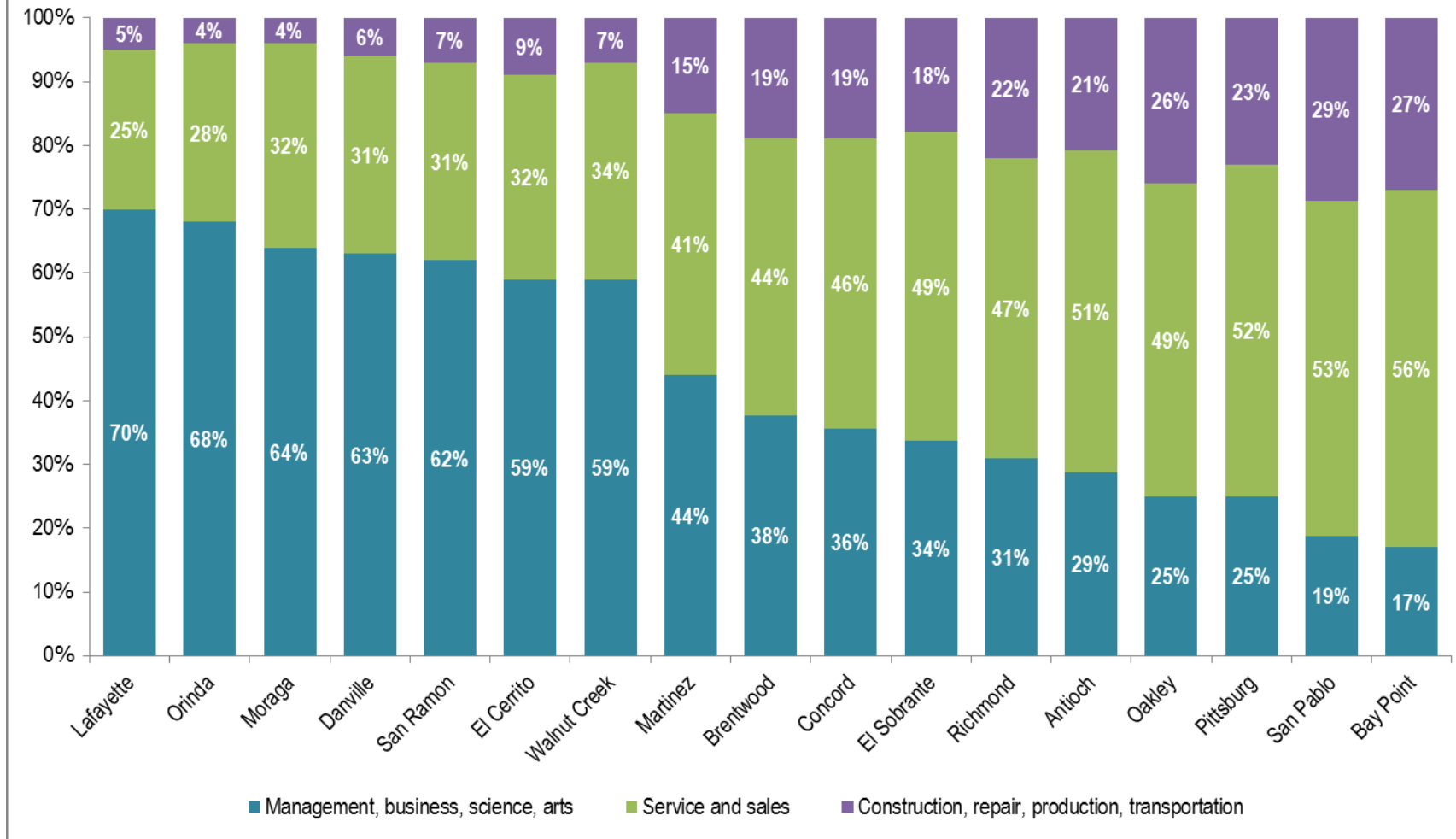

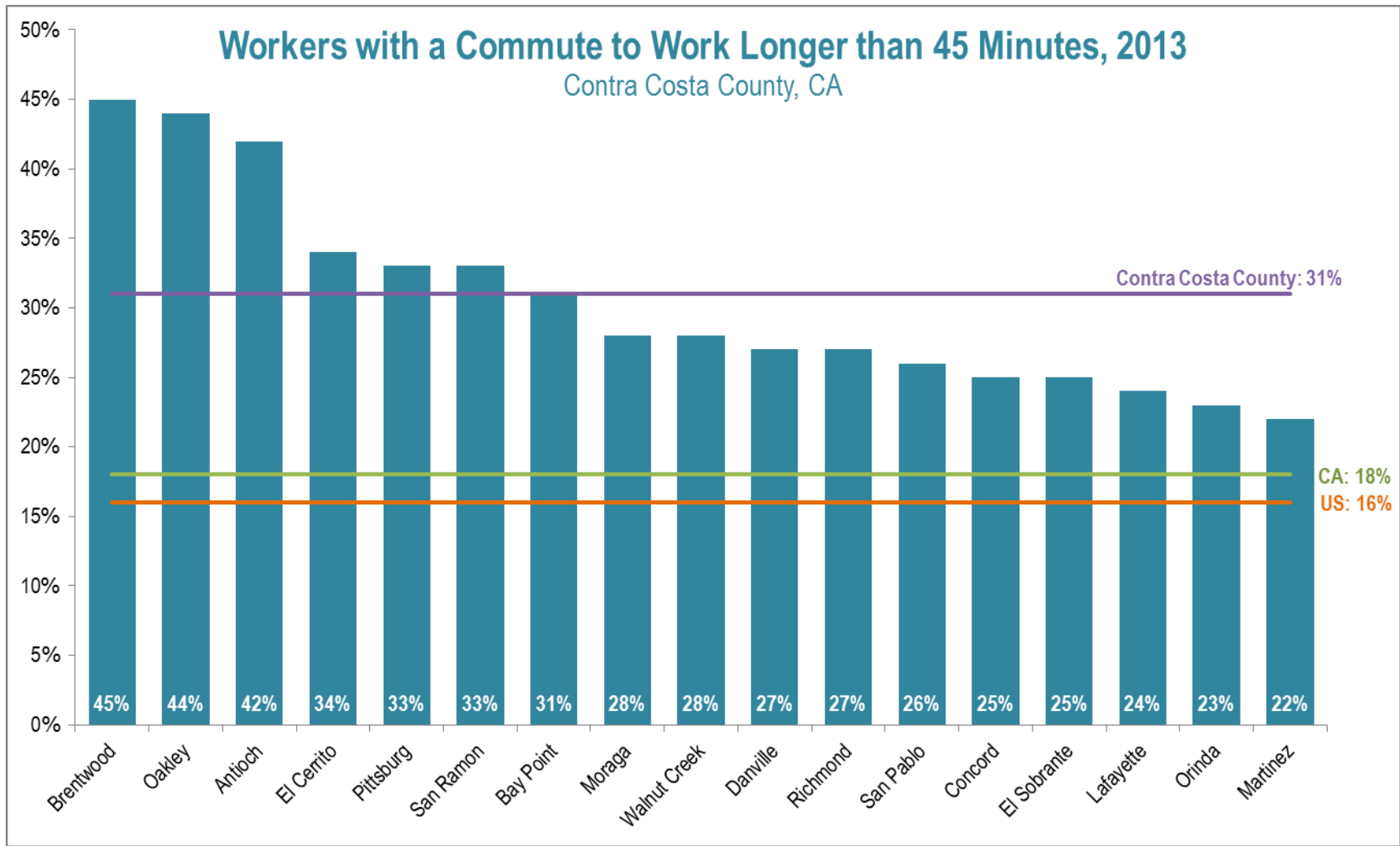

## Population Over Age 16 by Occupation, 2013 Contra Costa County, CA

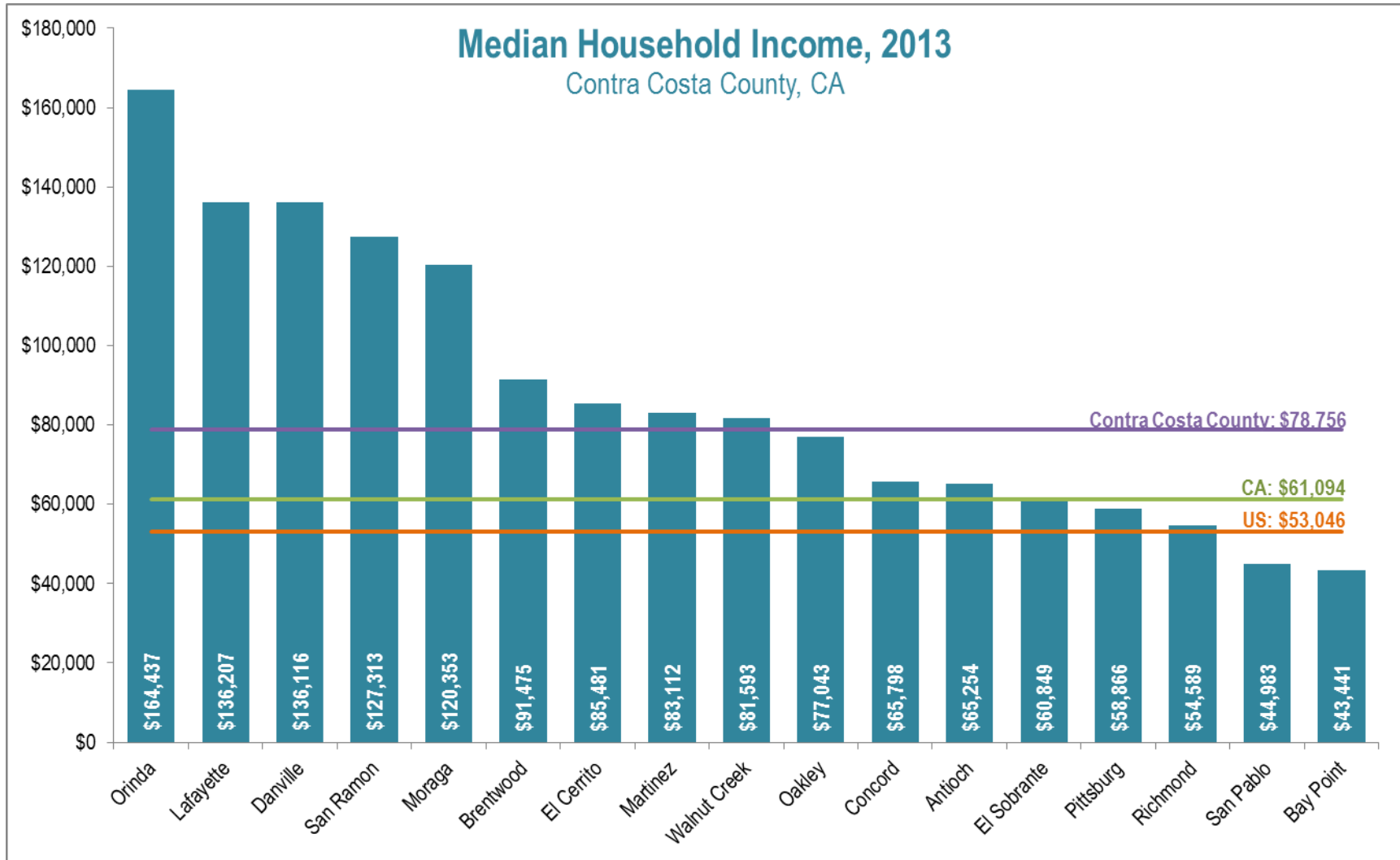

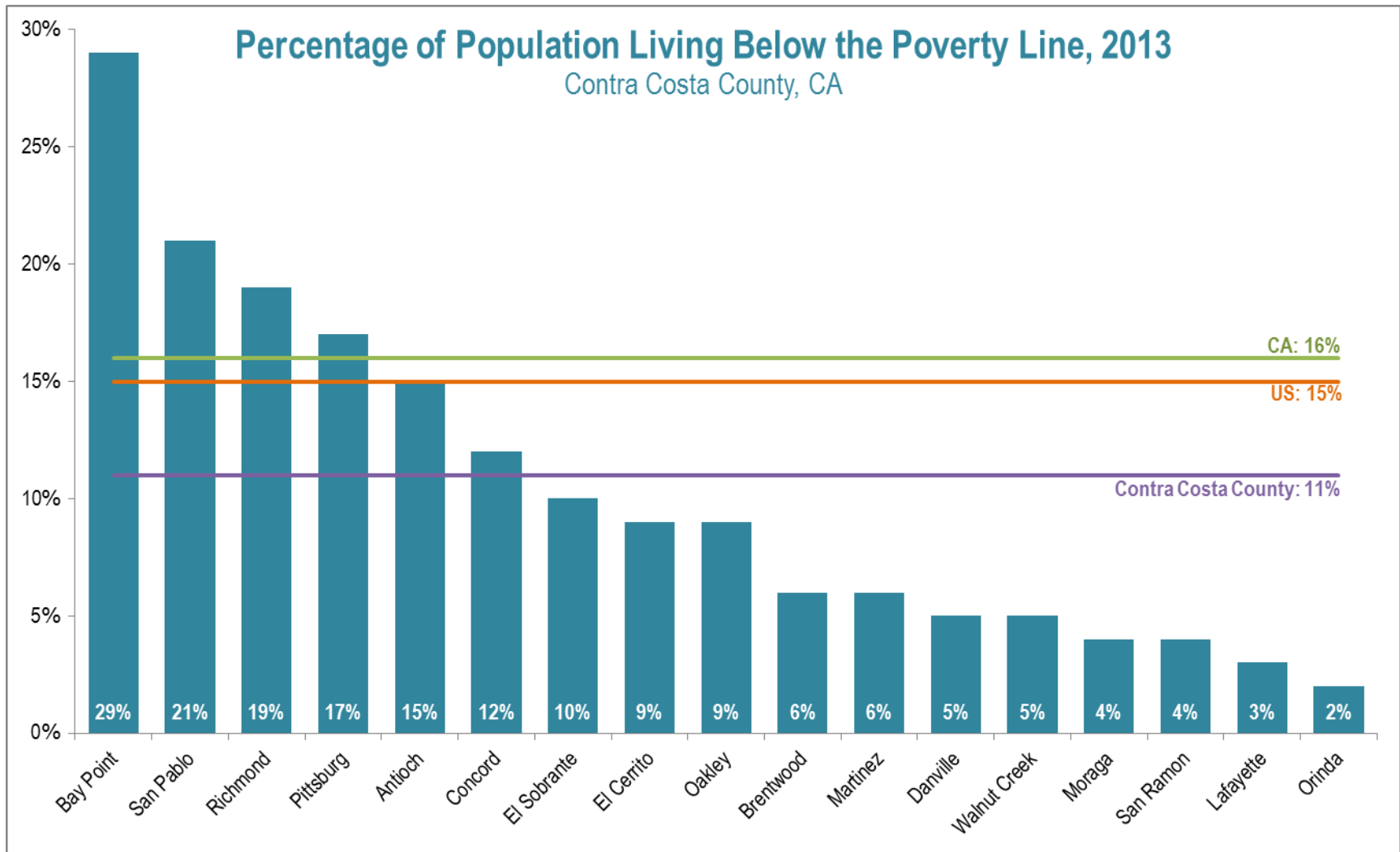

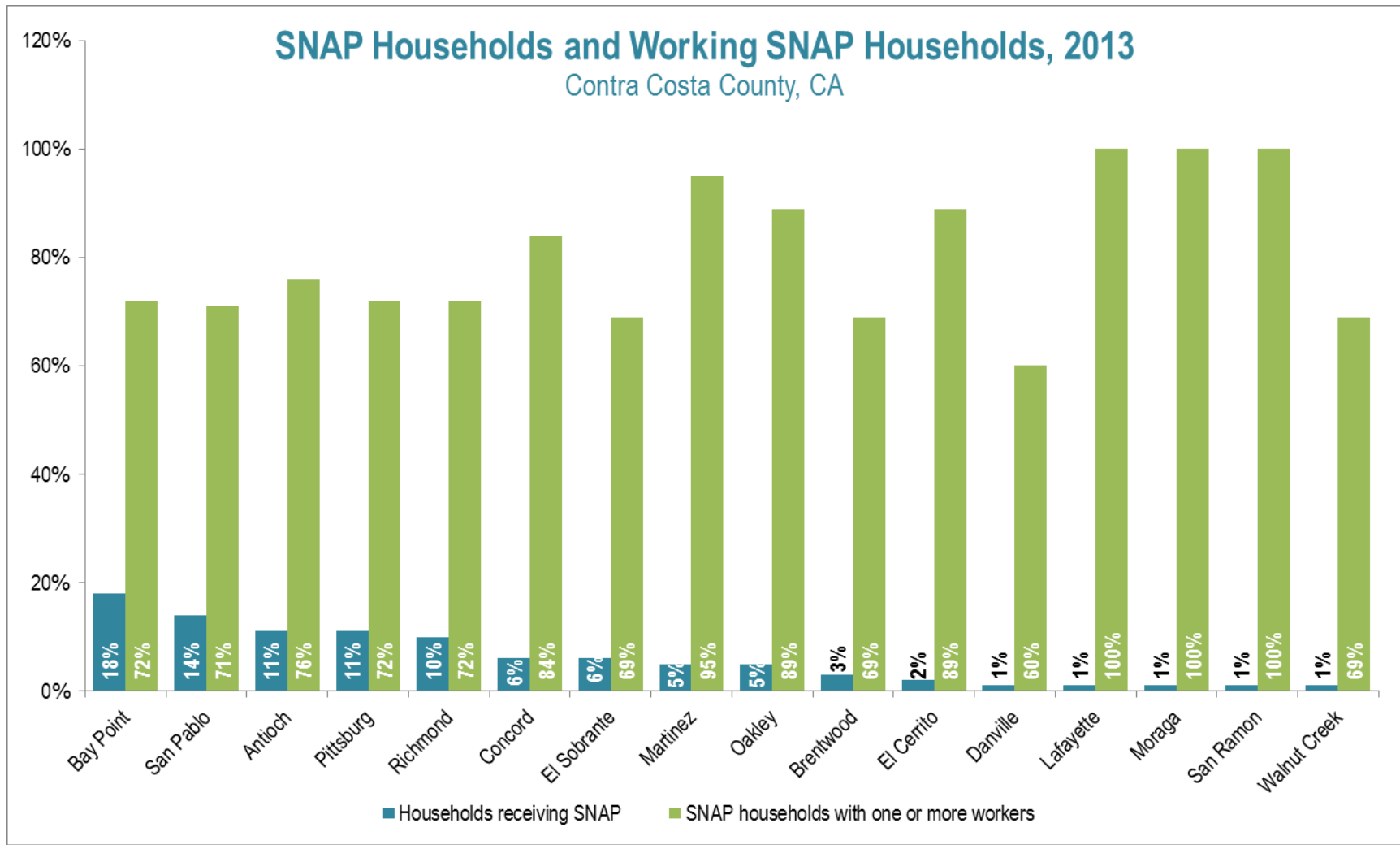

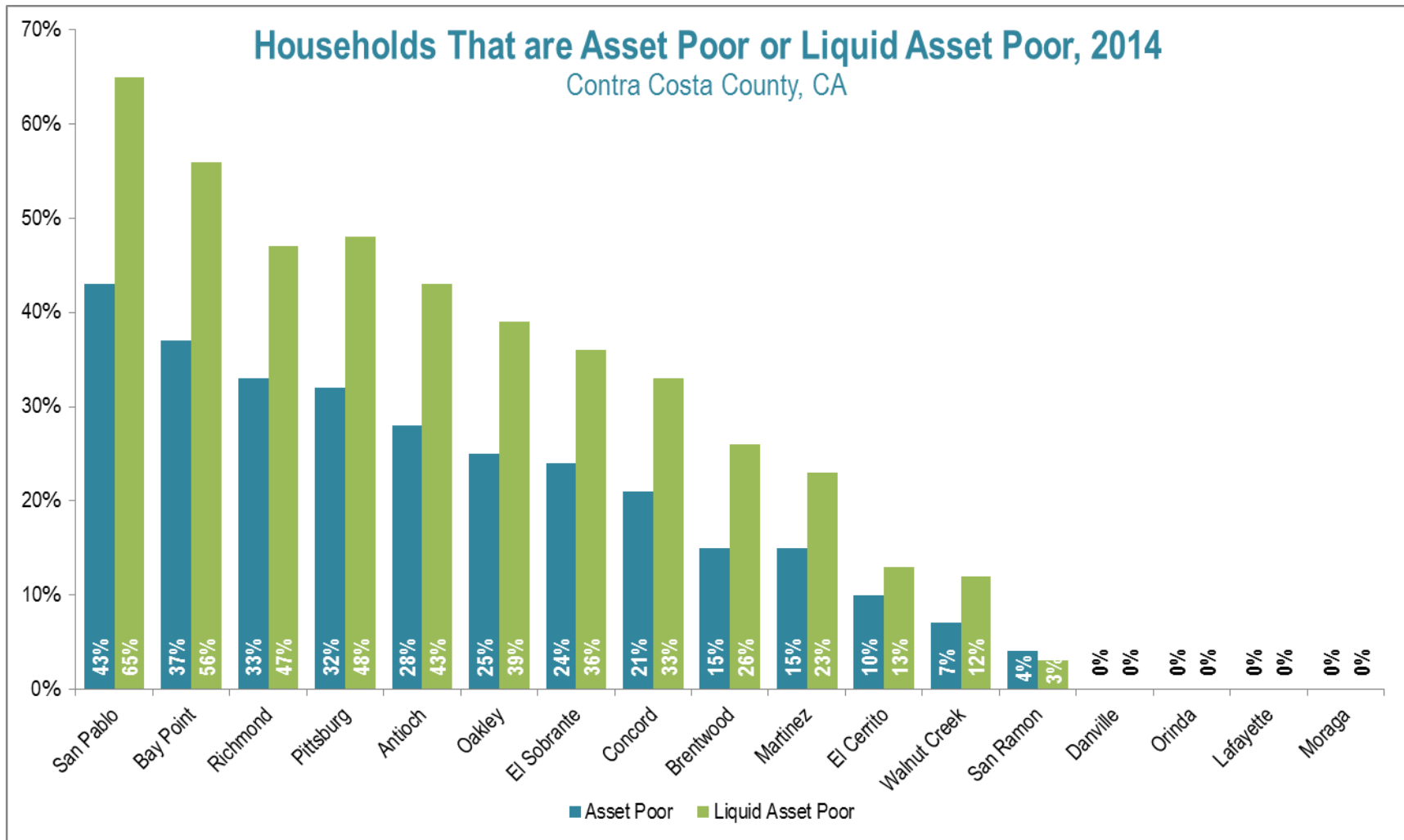




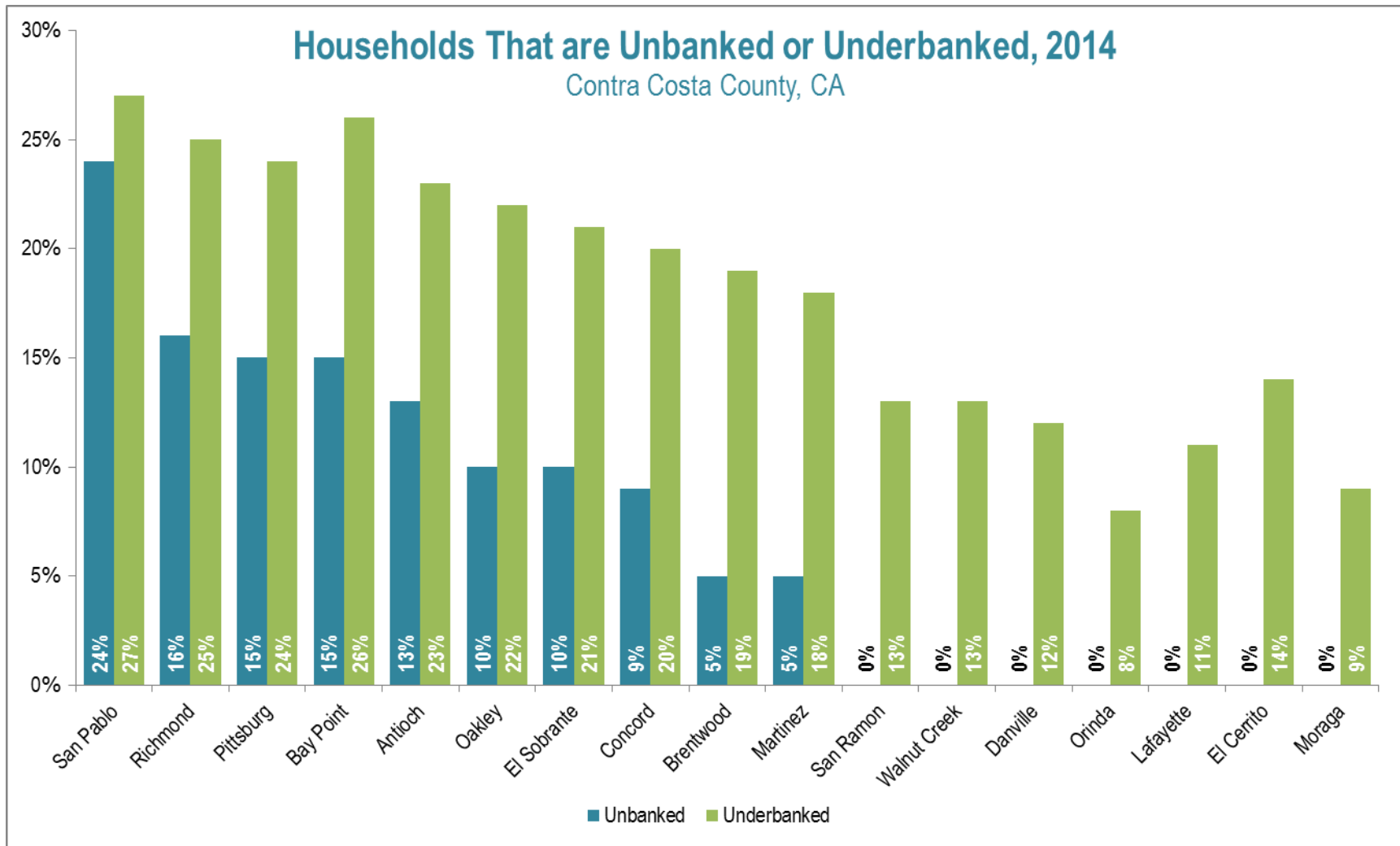

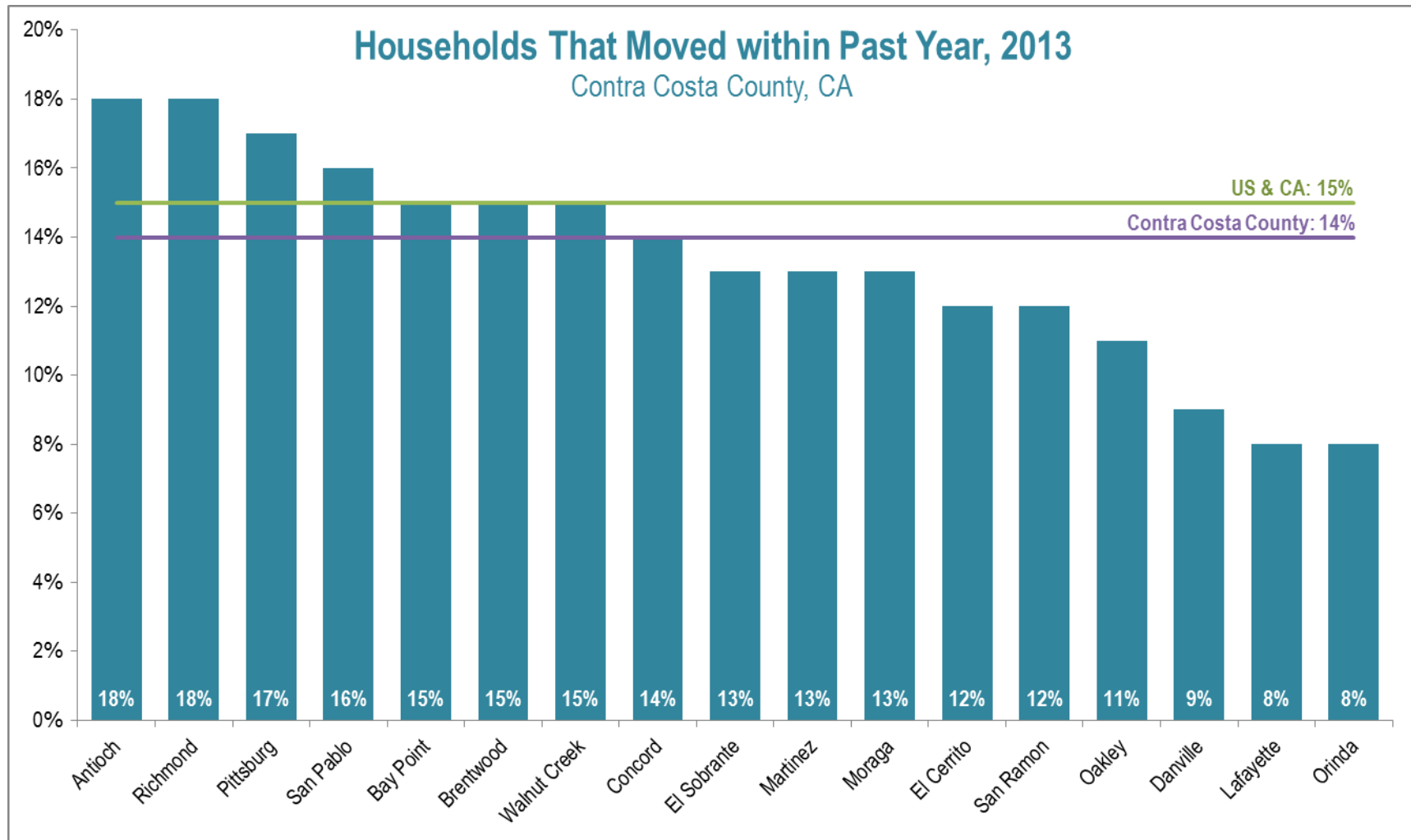

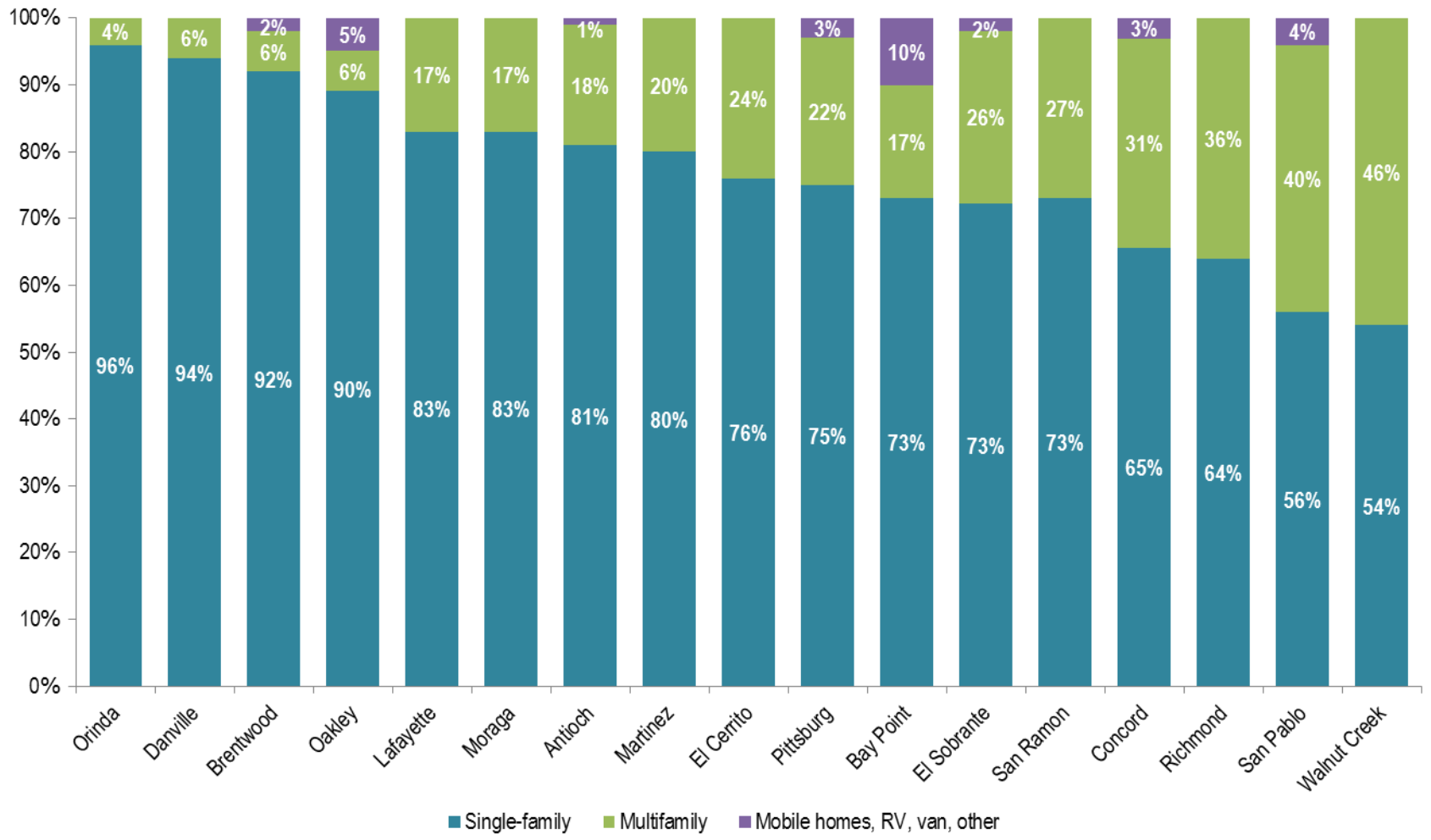

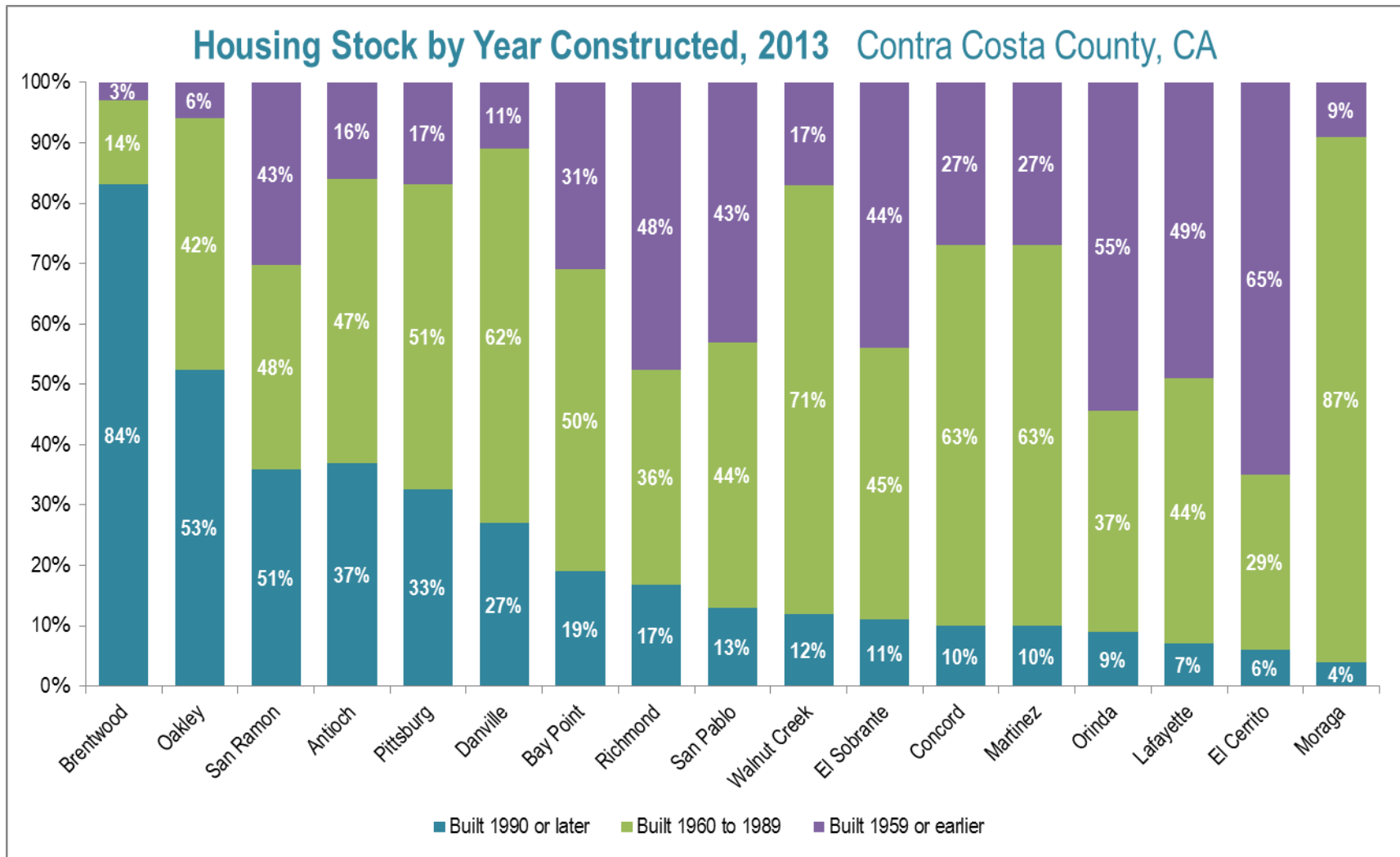

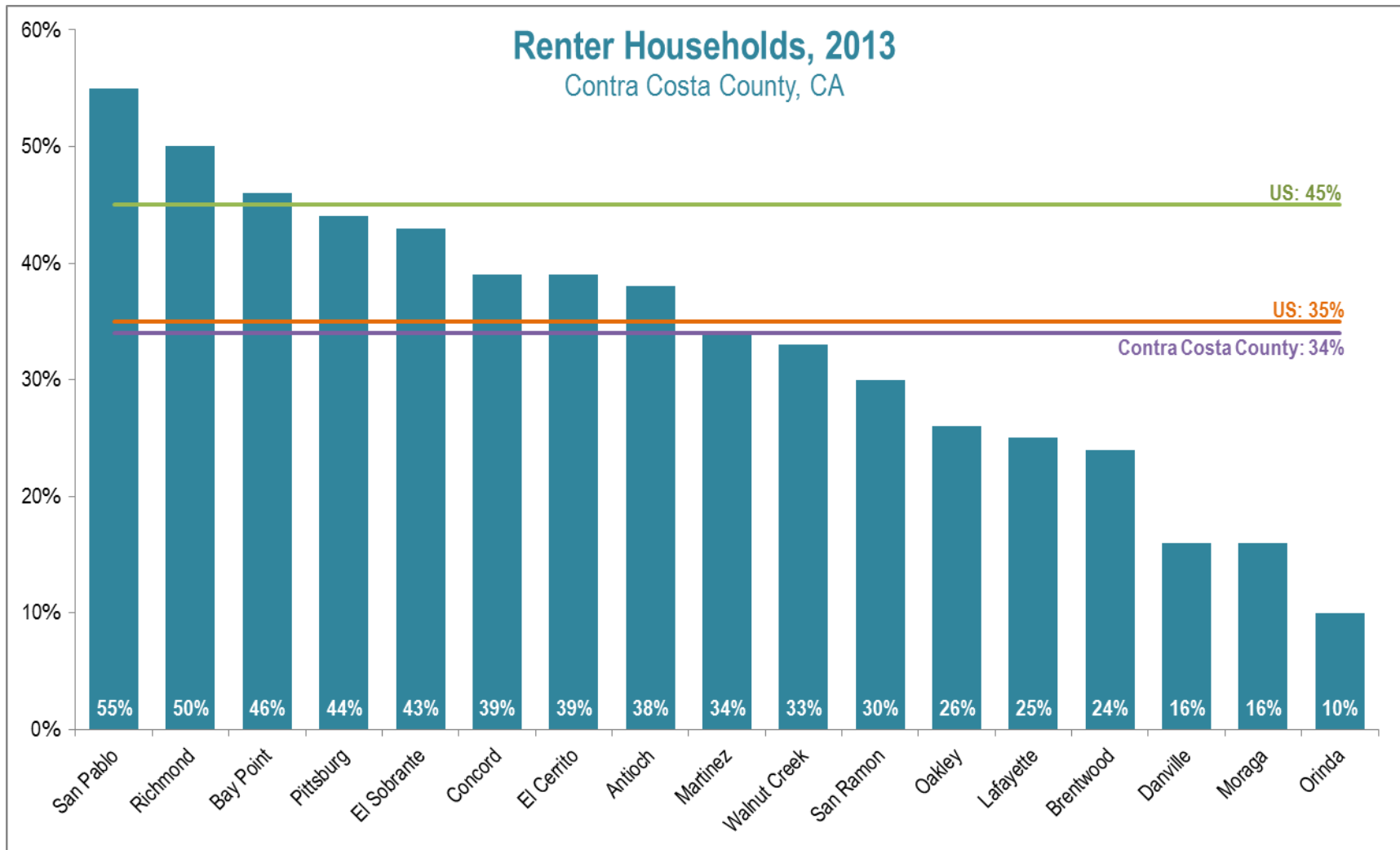
## Housing Stock by Type, 2013 Contra Costa County, CA

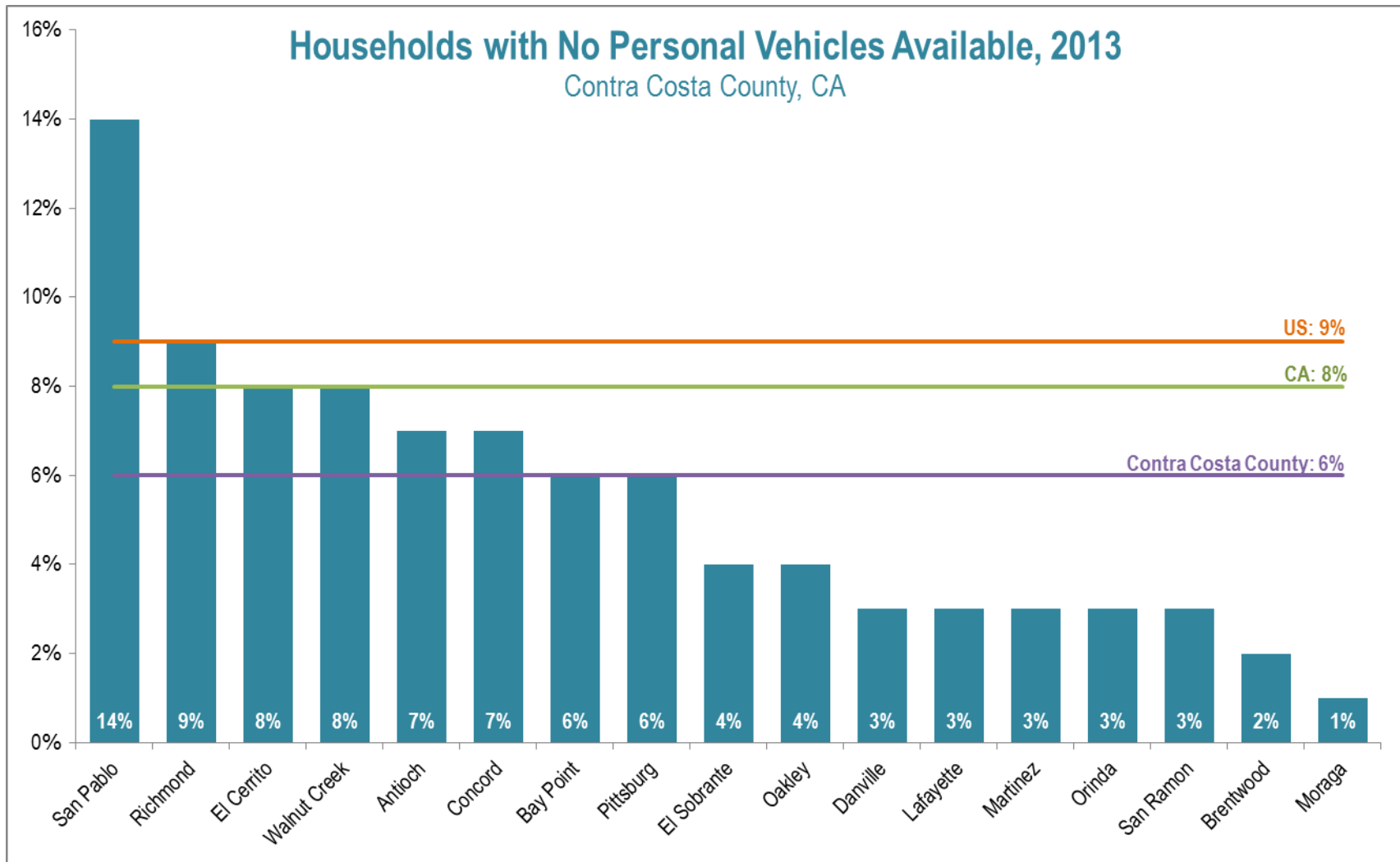

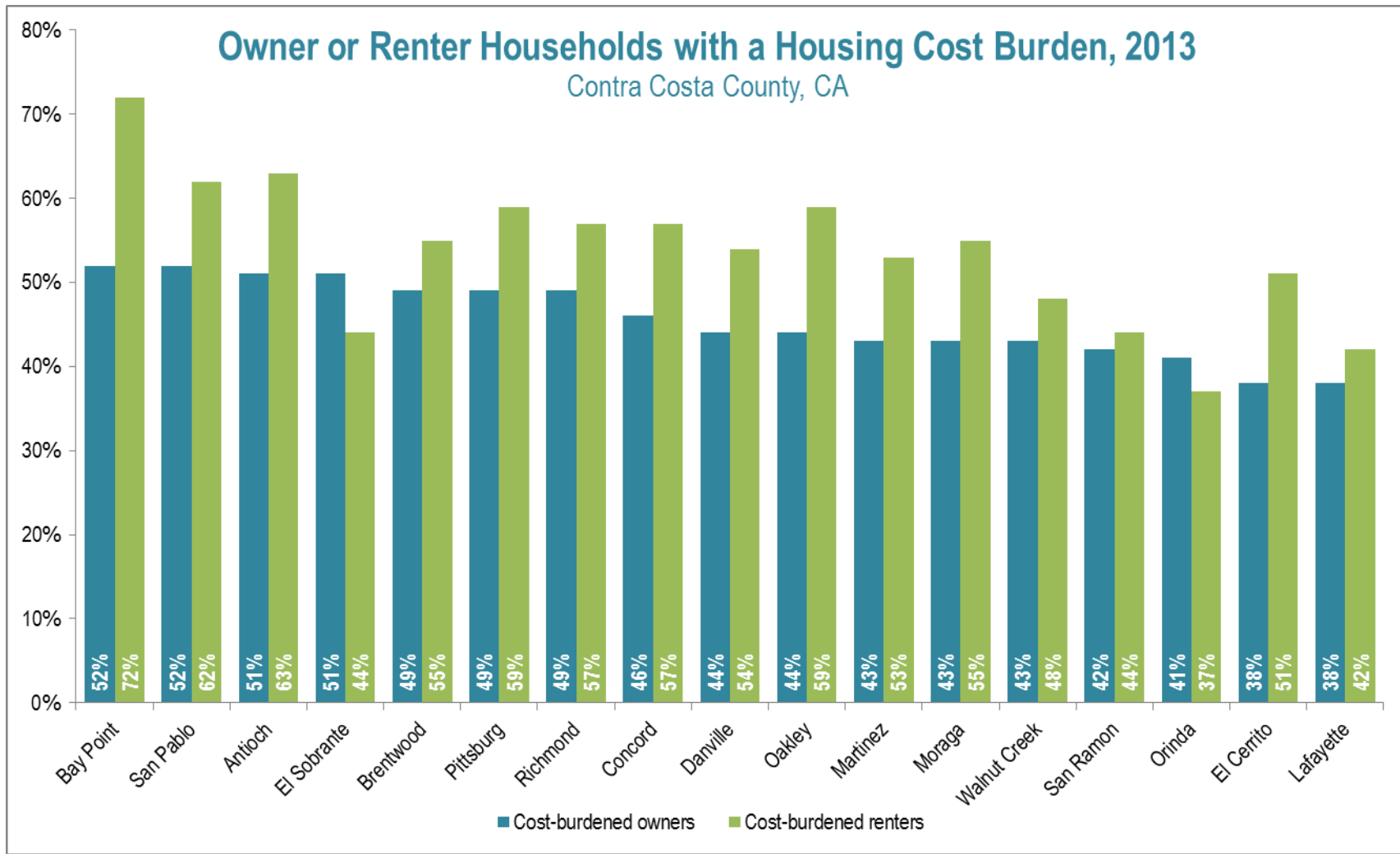
