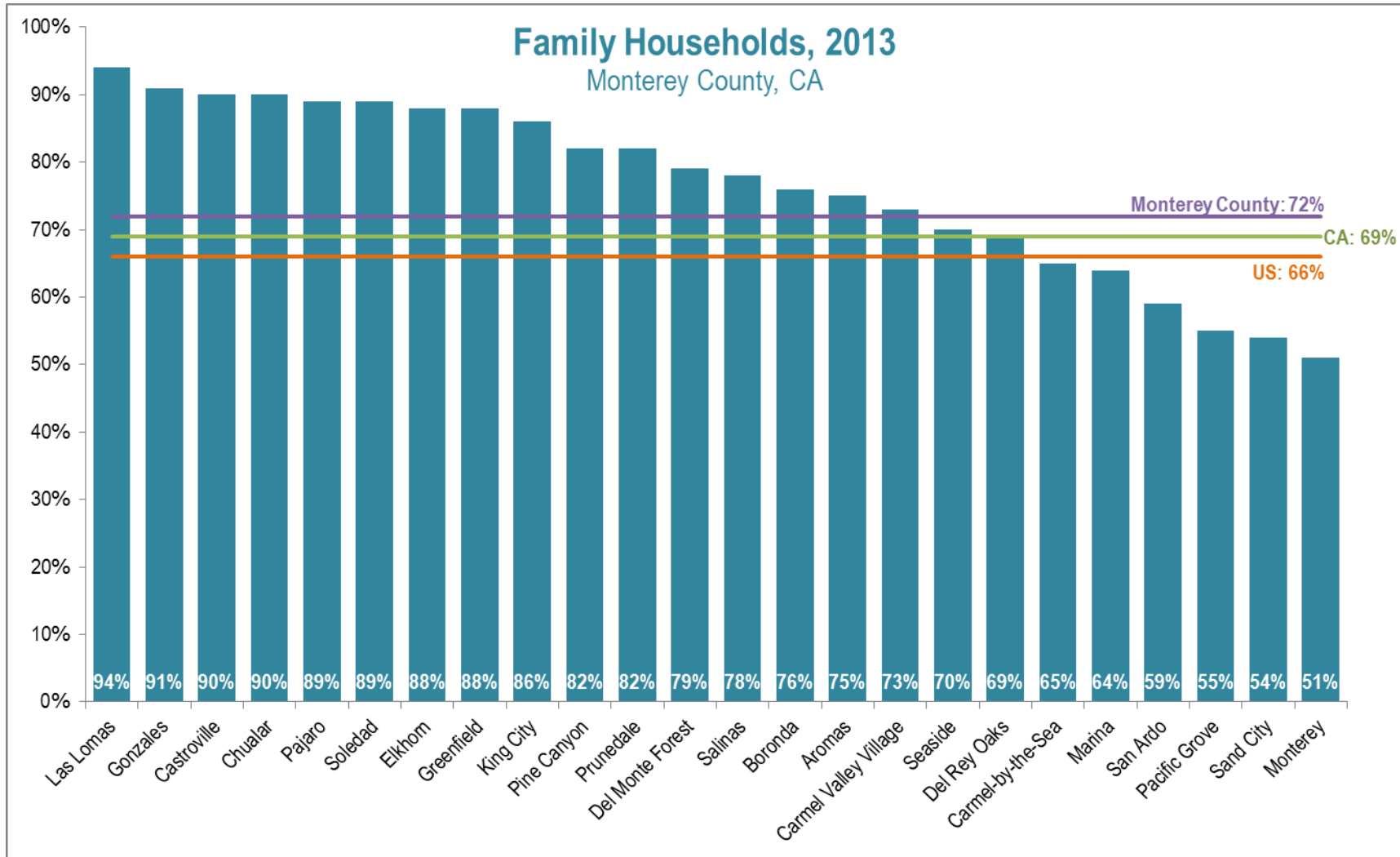

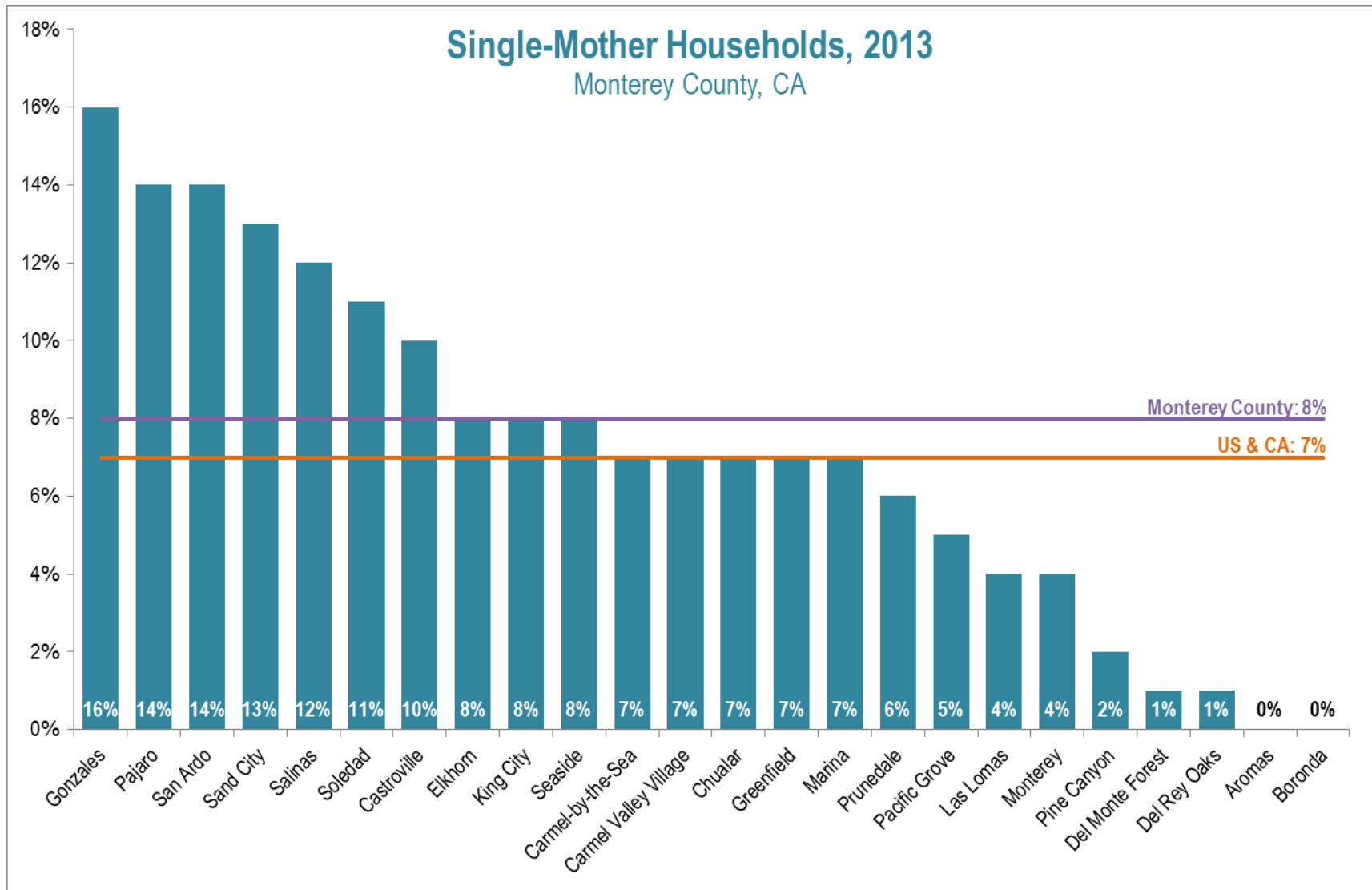

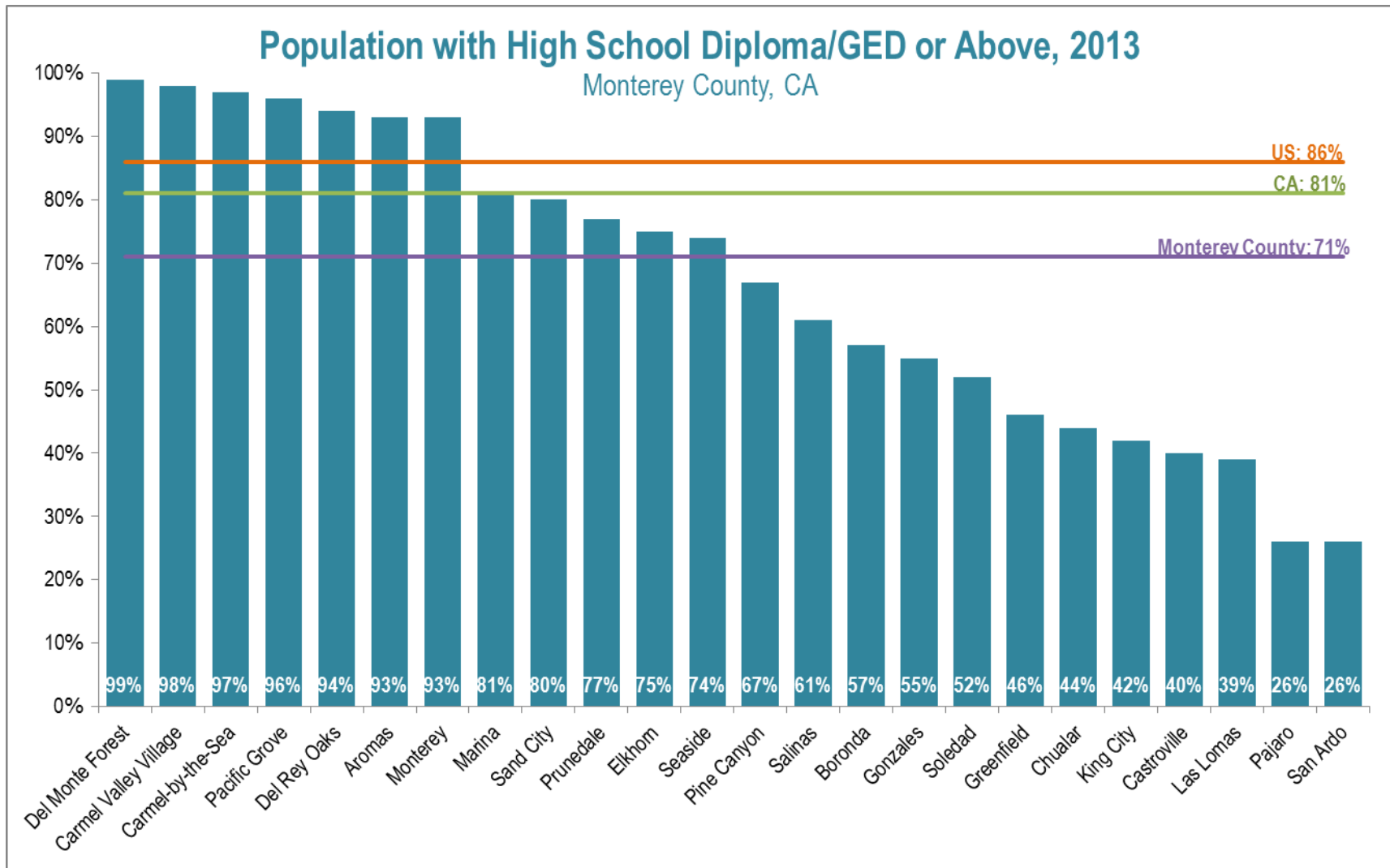

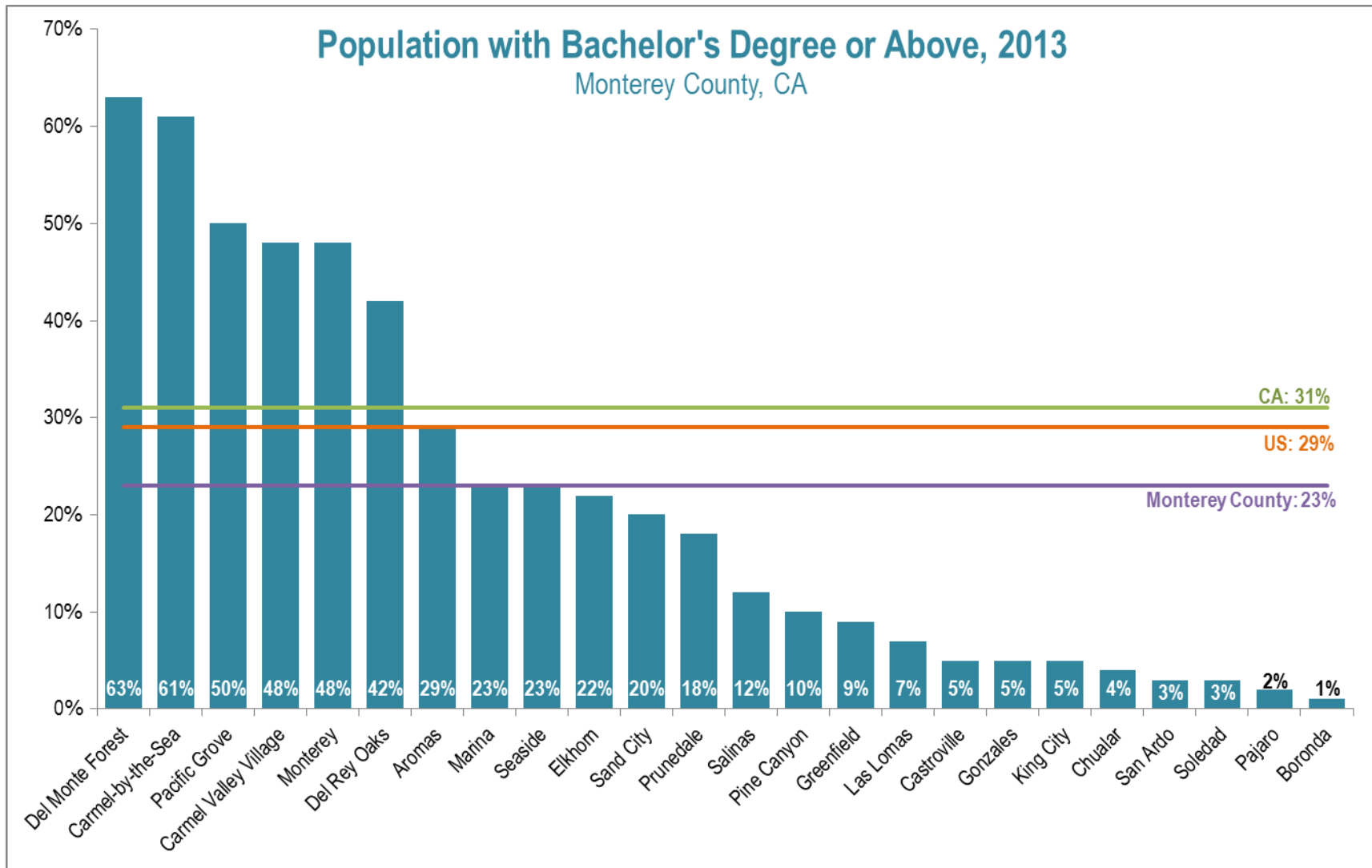

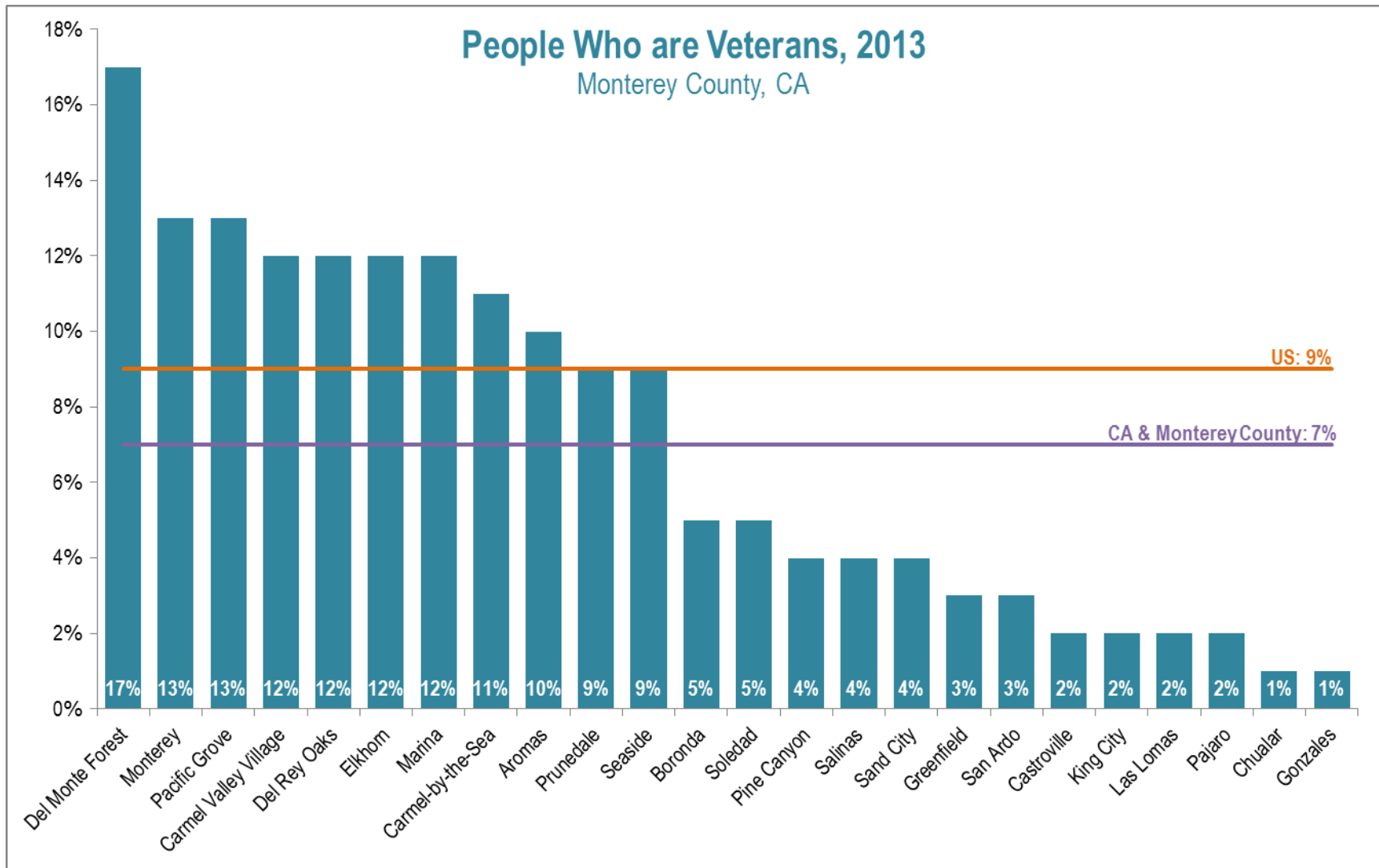

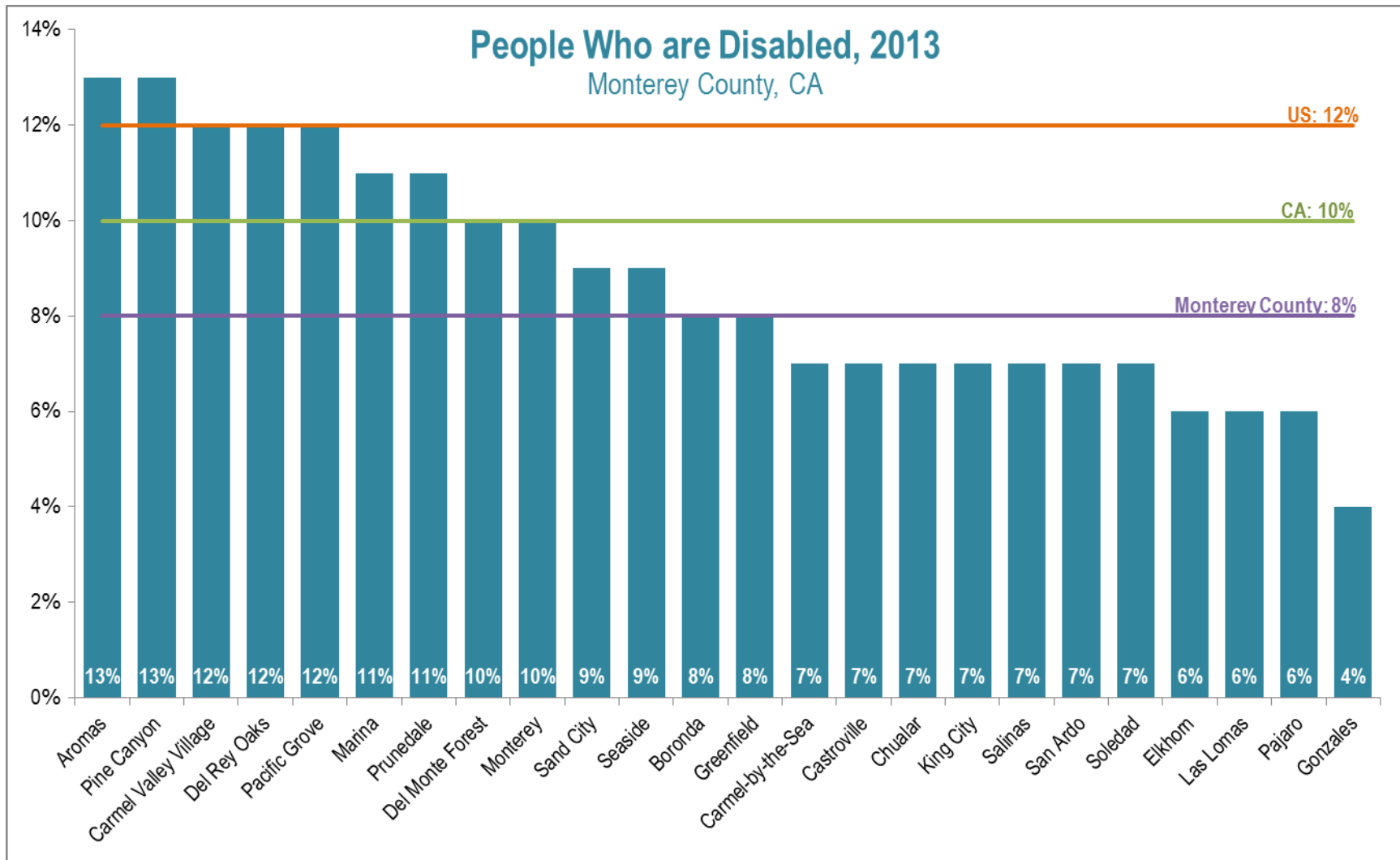

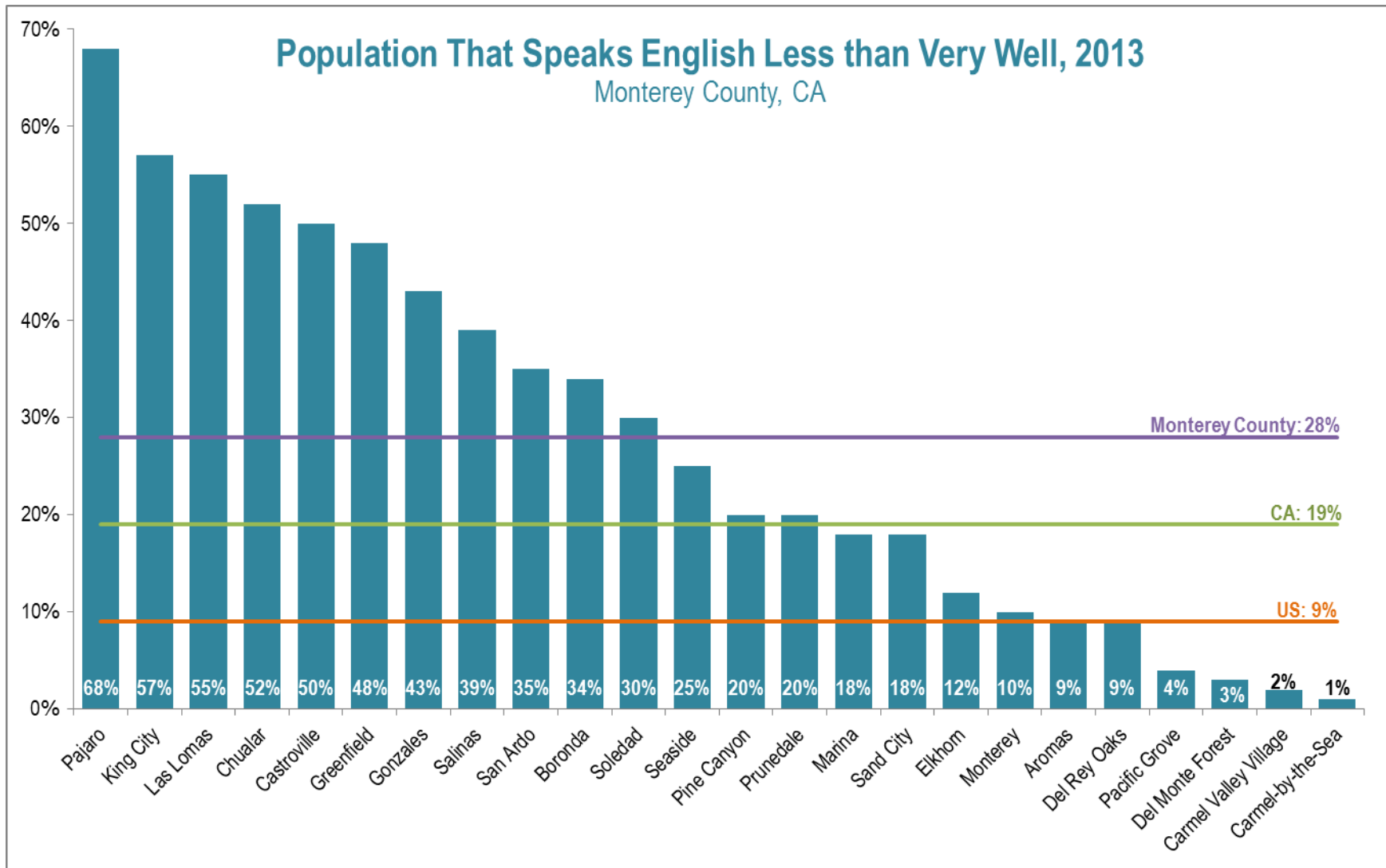

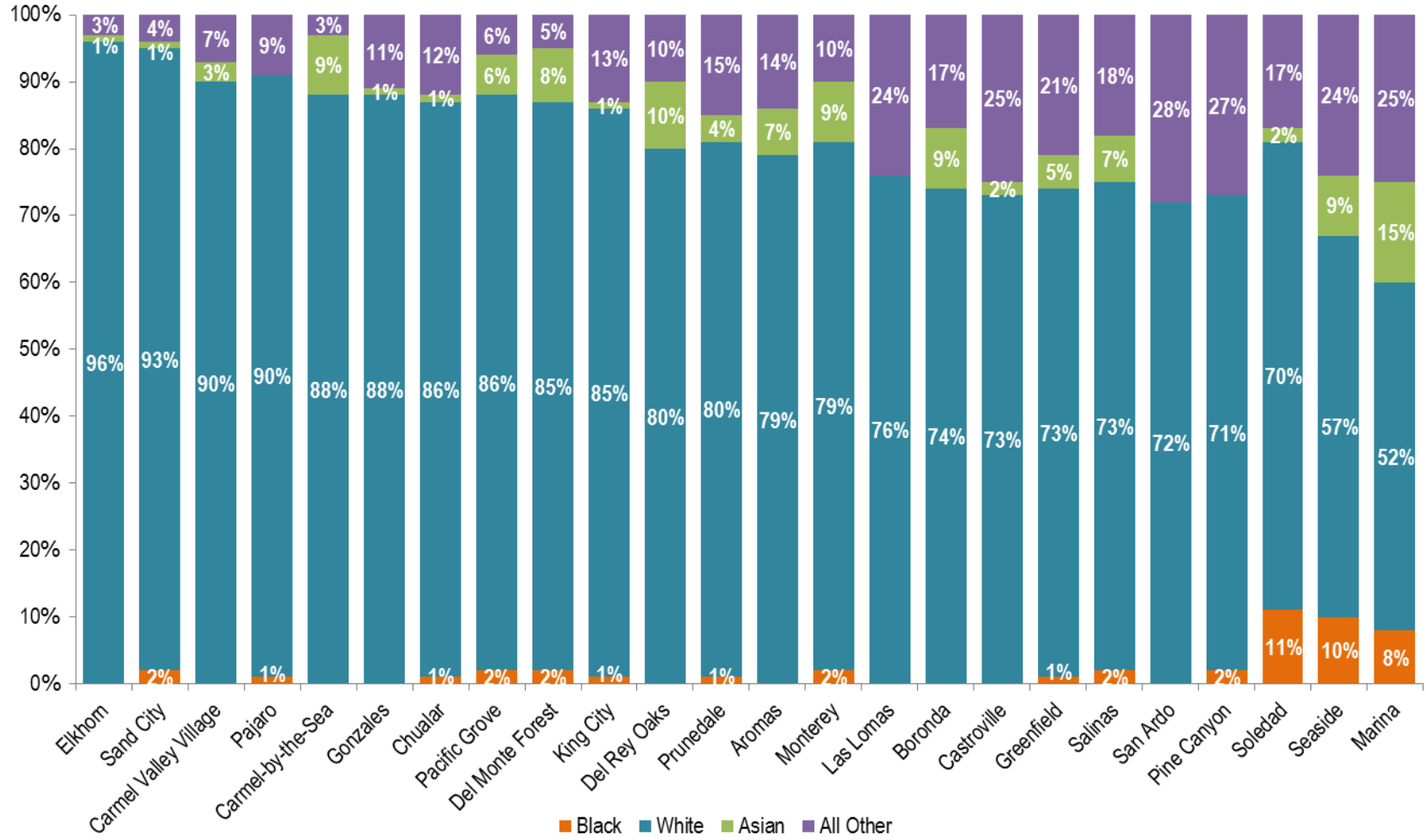

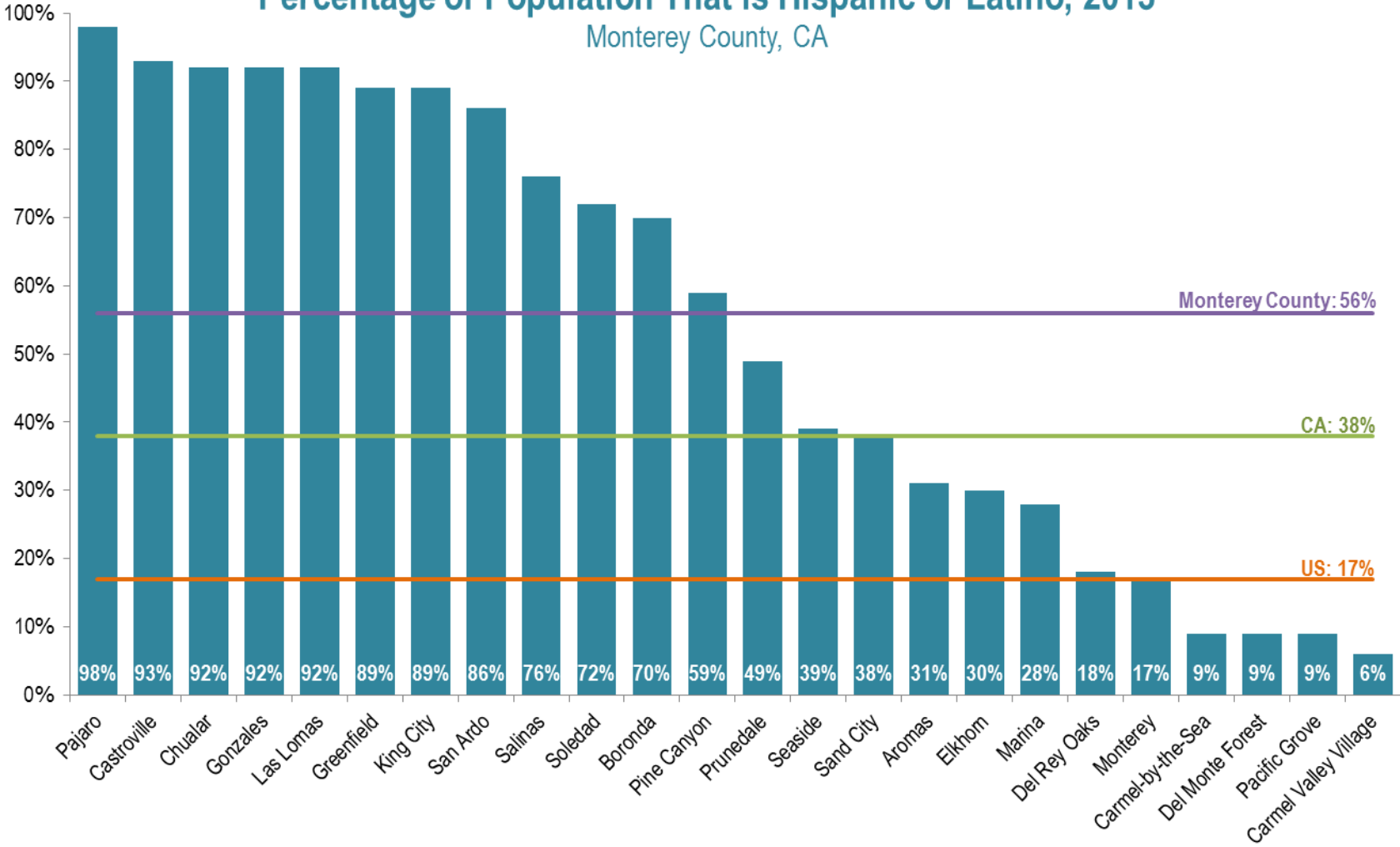
Population by Race, 2013 Monterey County, CA

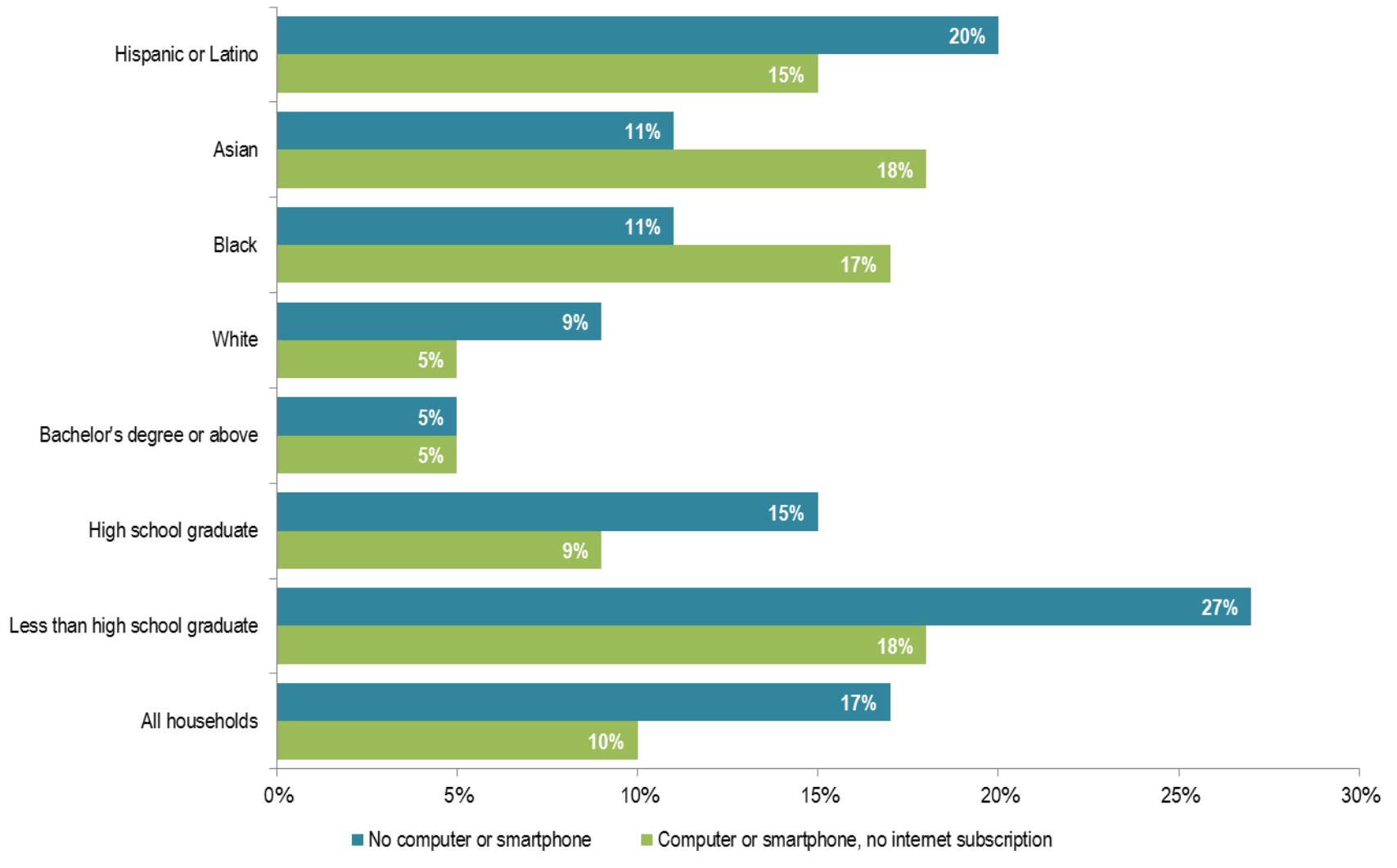
Percentage of Population That is Hispanic or Latino, 2013

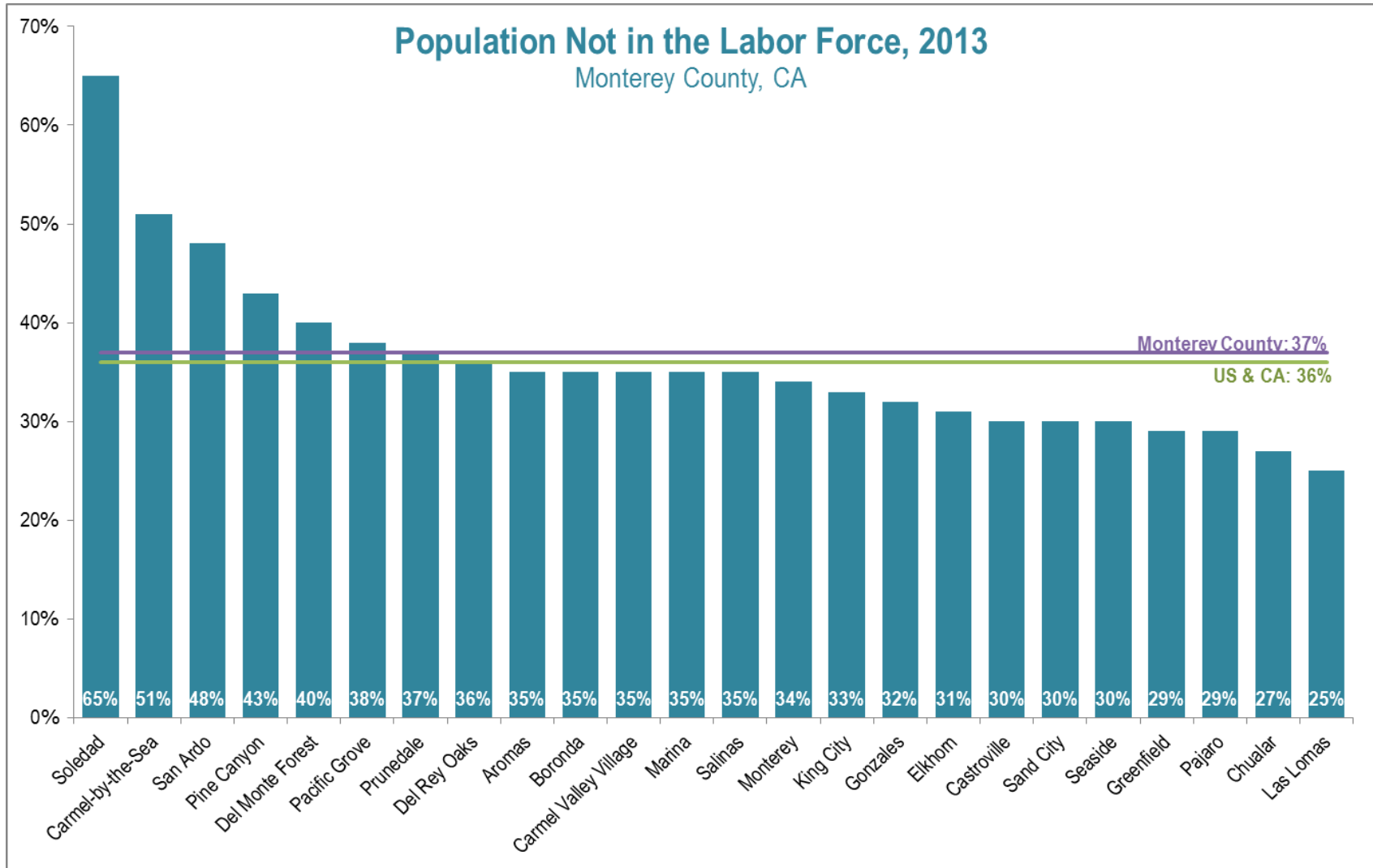

Access to Computers, Smartphones, and Internet, 2013 Monterey County, CA

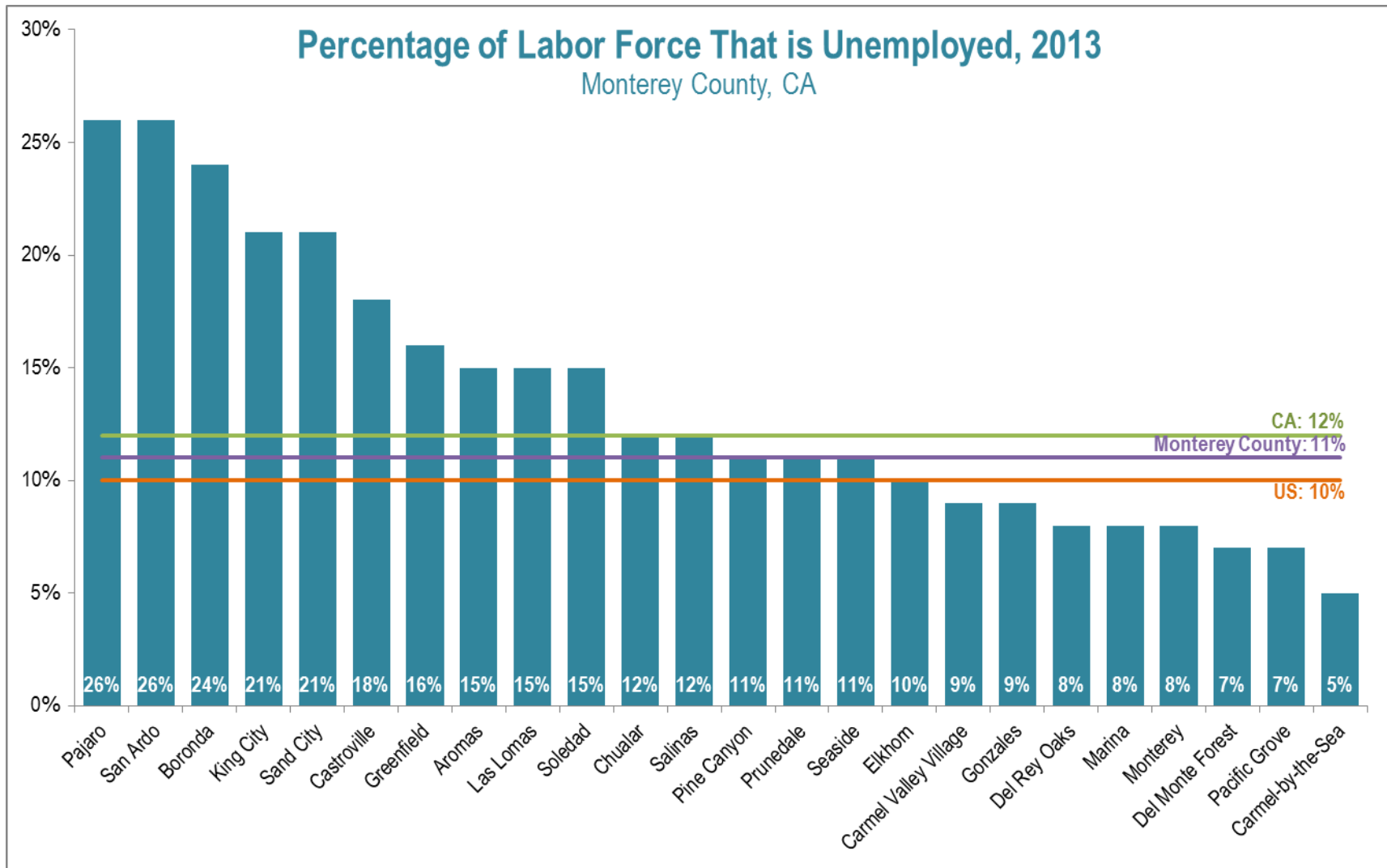

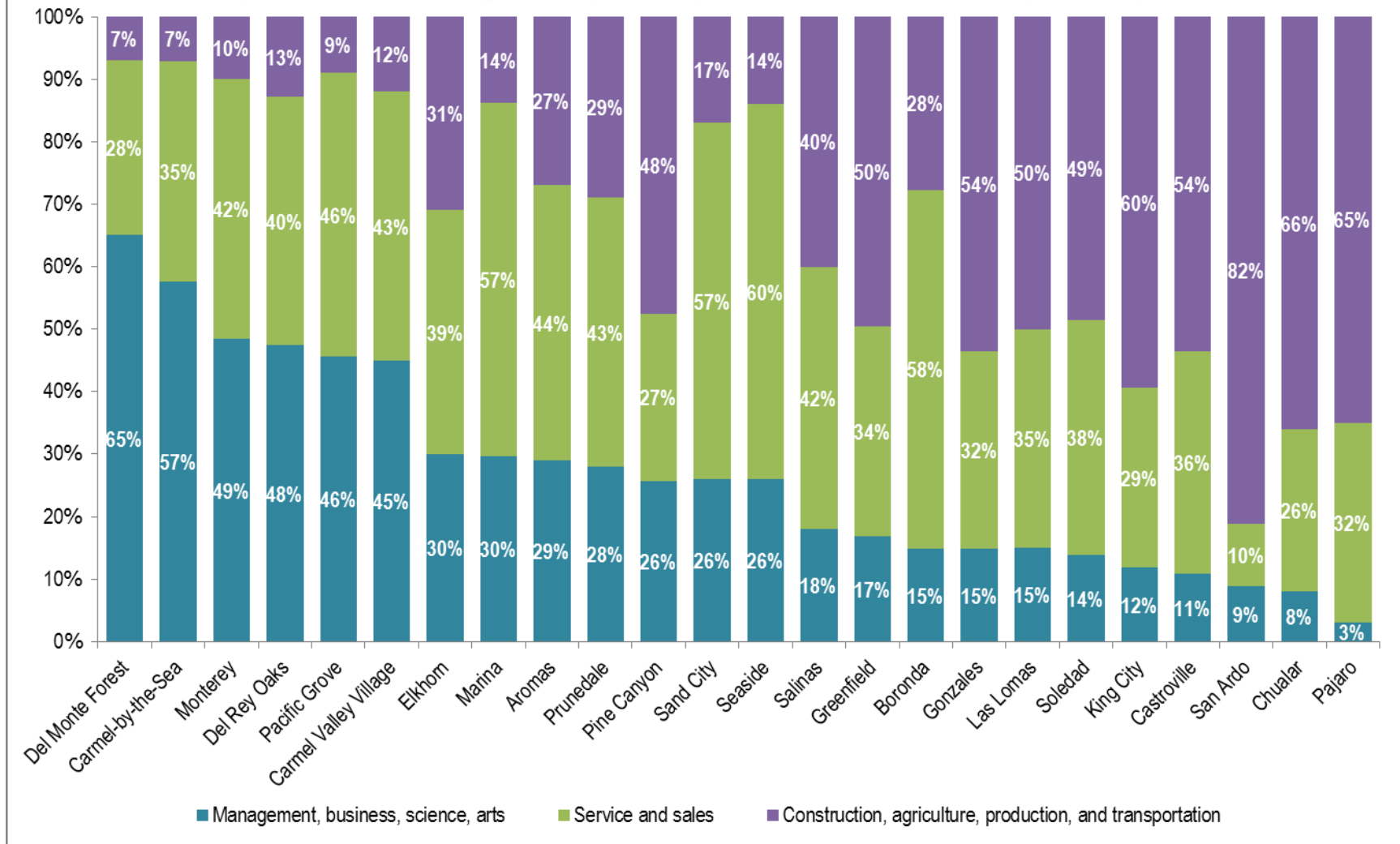

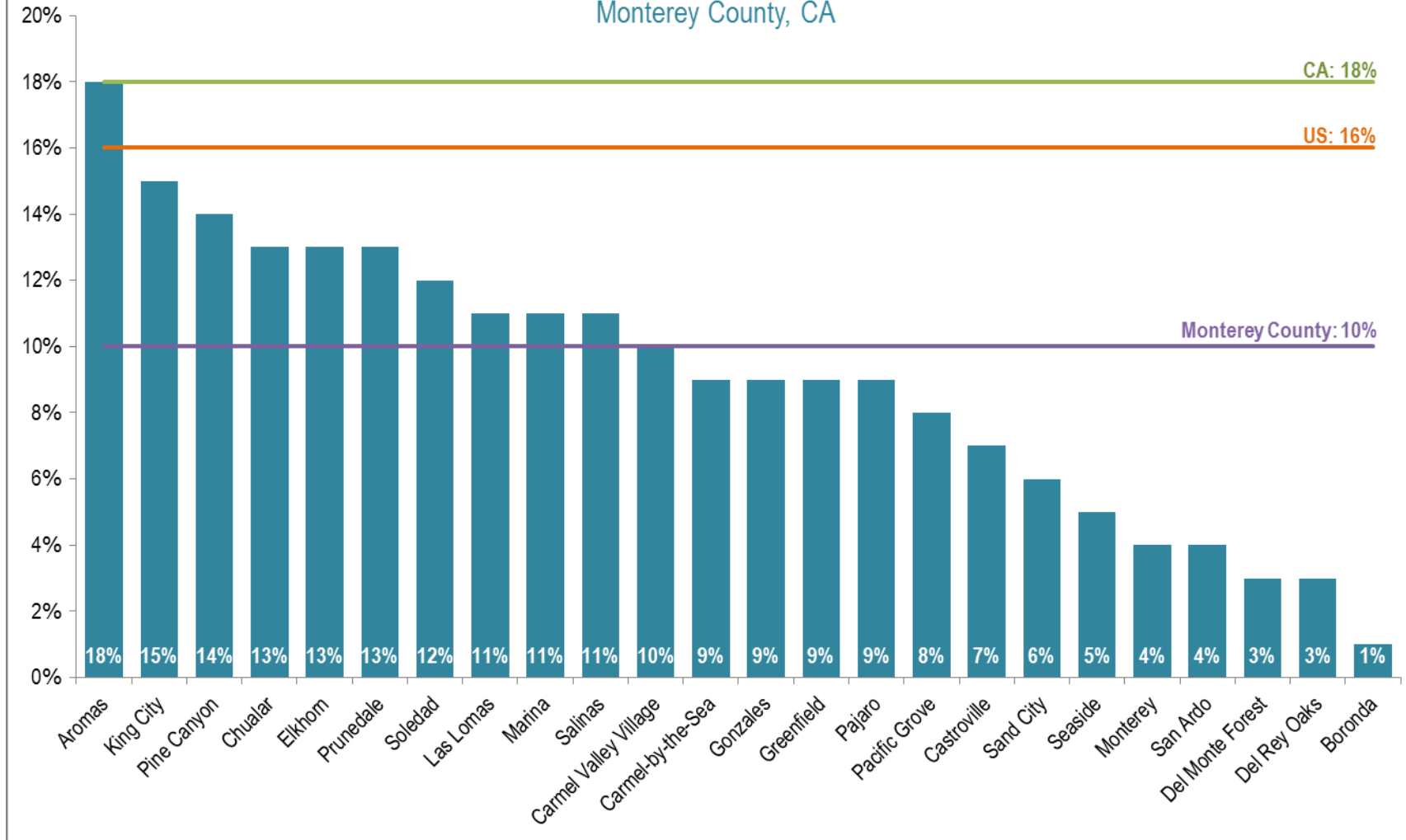
Population Over Age 16 by Occupation, 2013 Monterey County, CA

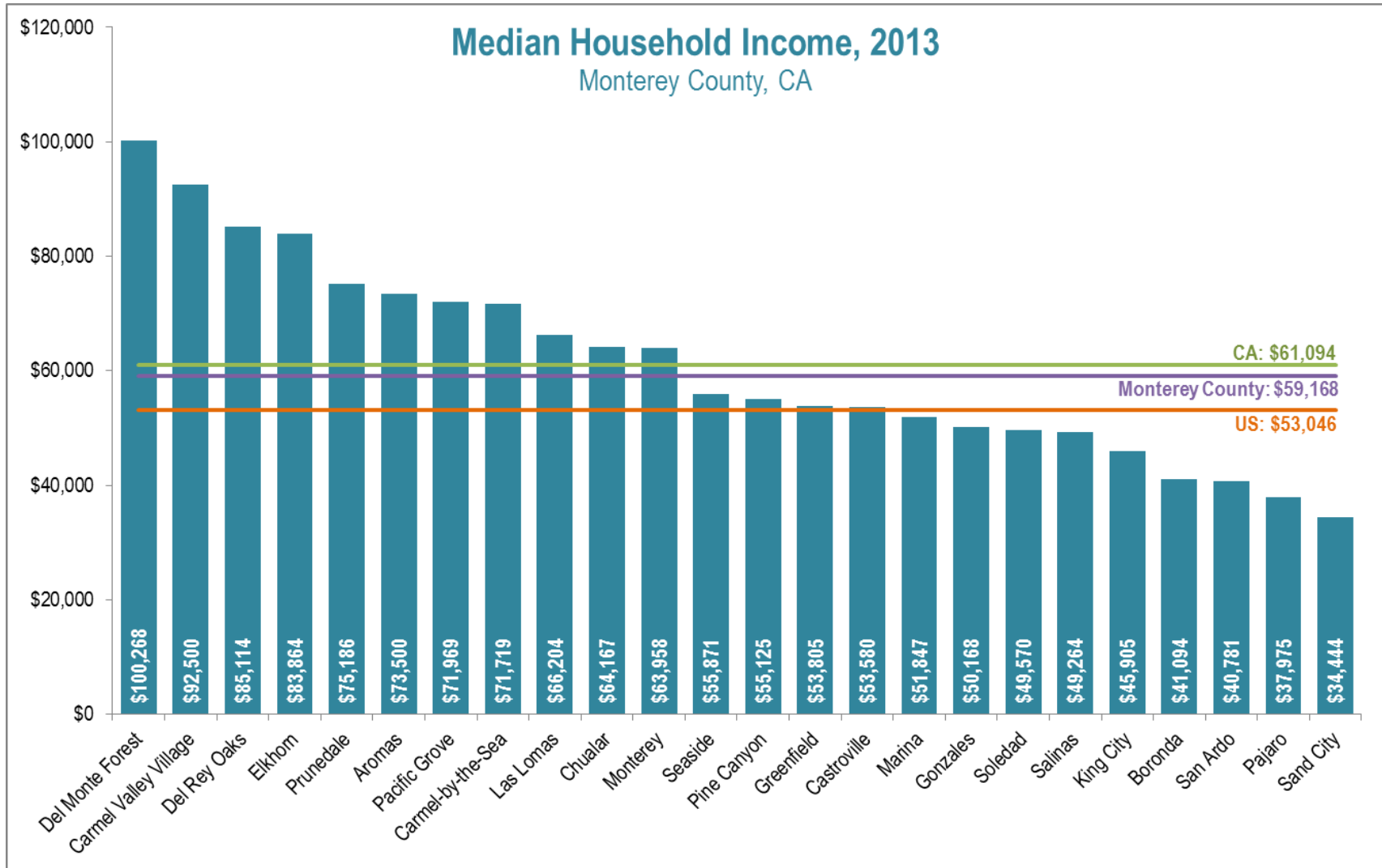
Workers with a Commute to Work Longer Than 45 Minutes, 2013

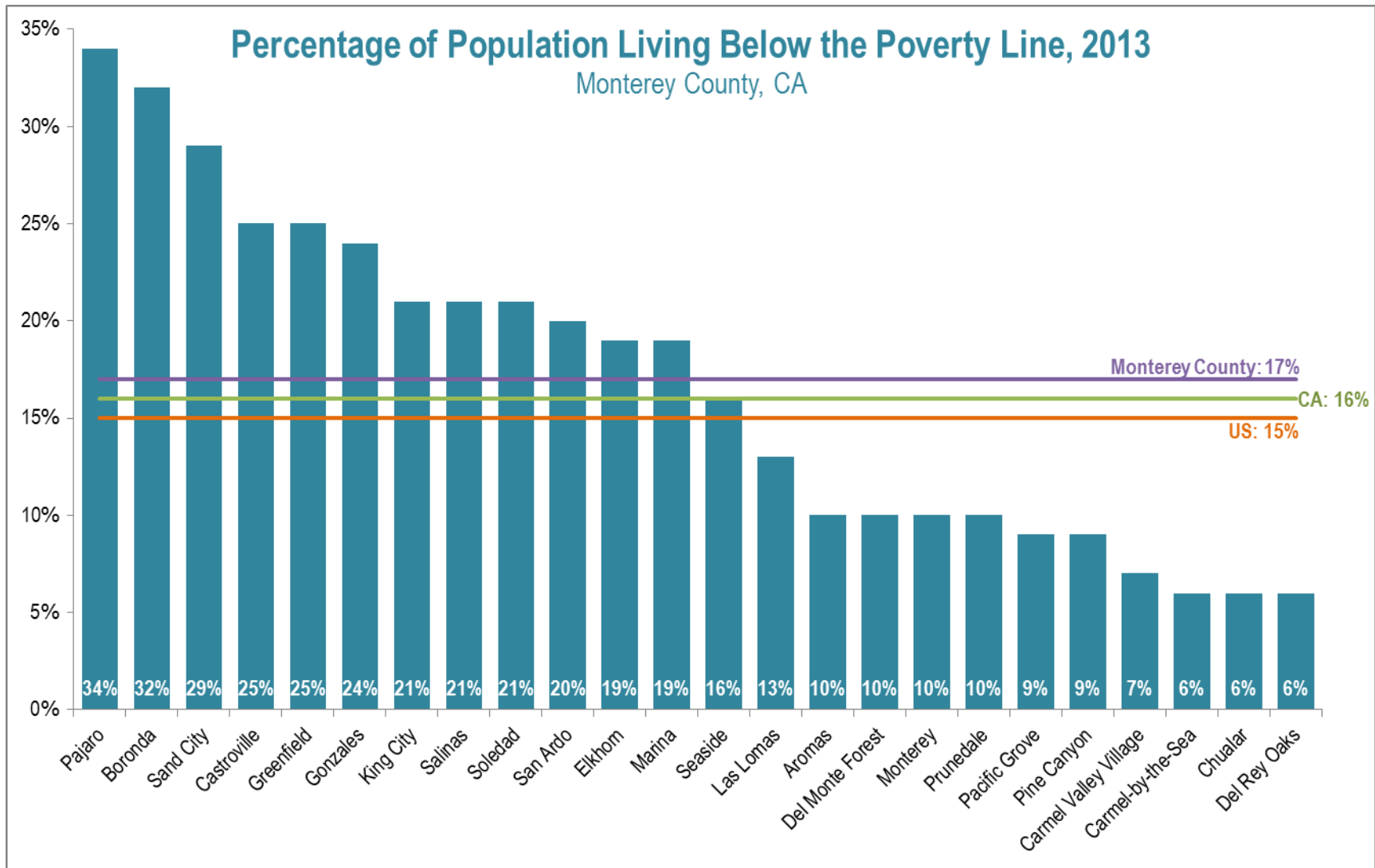

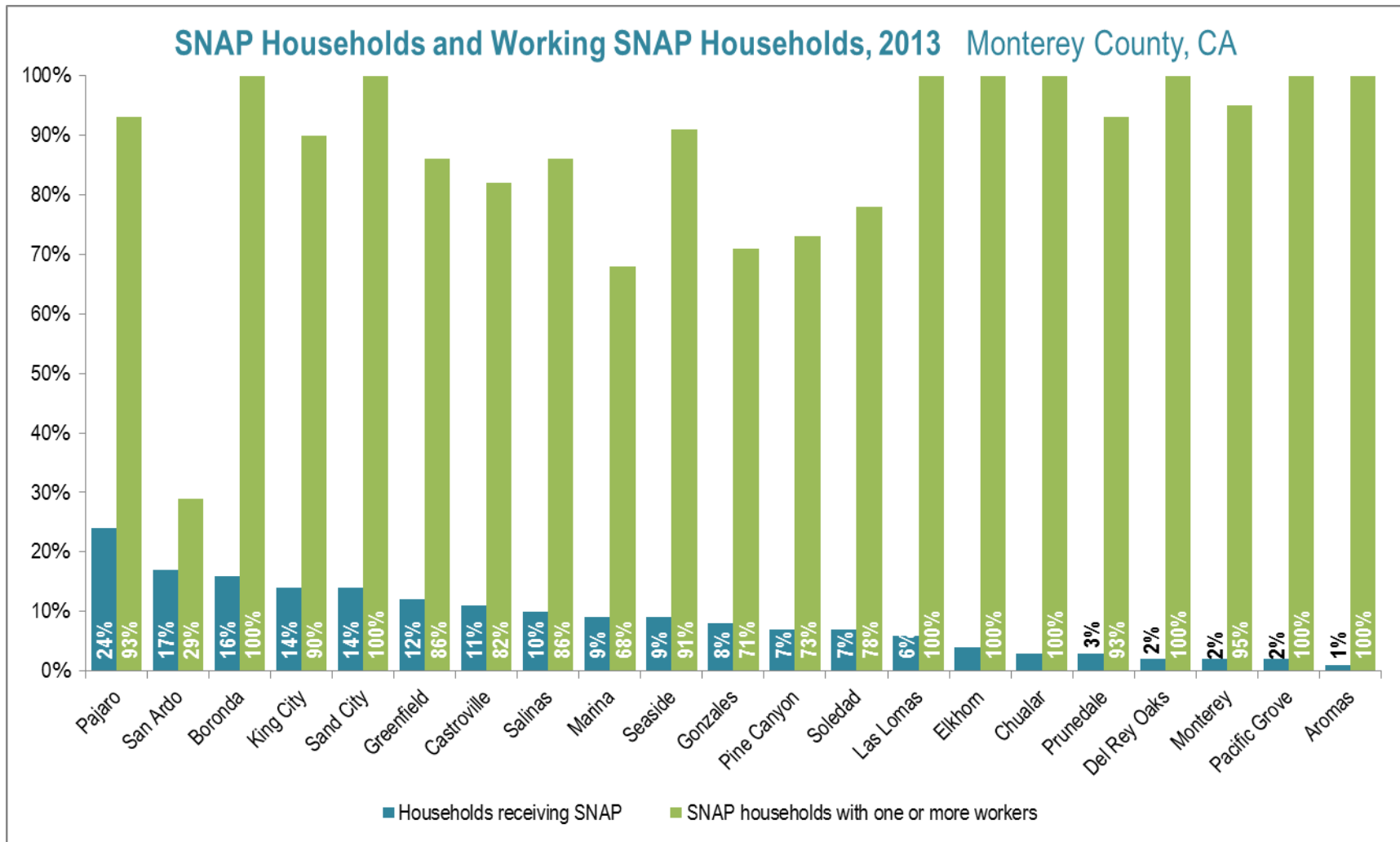

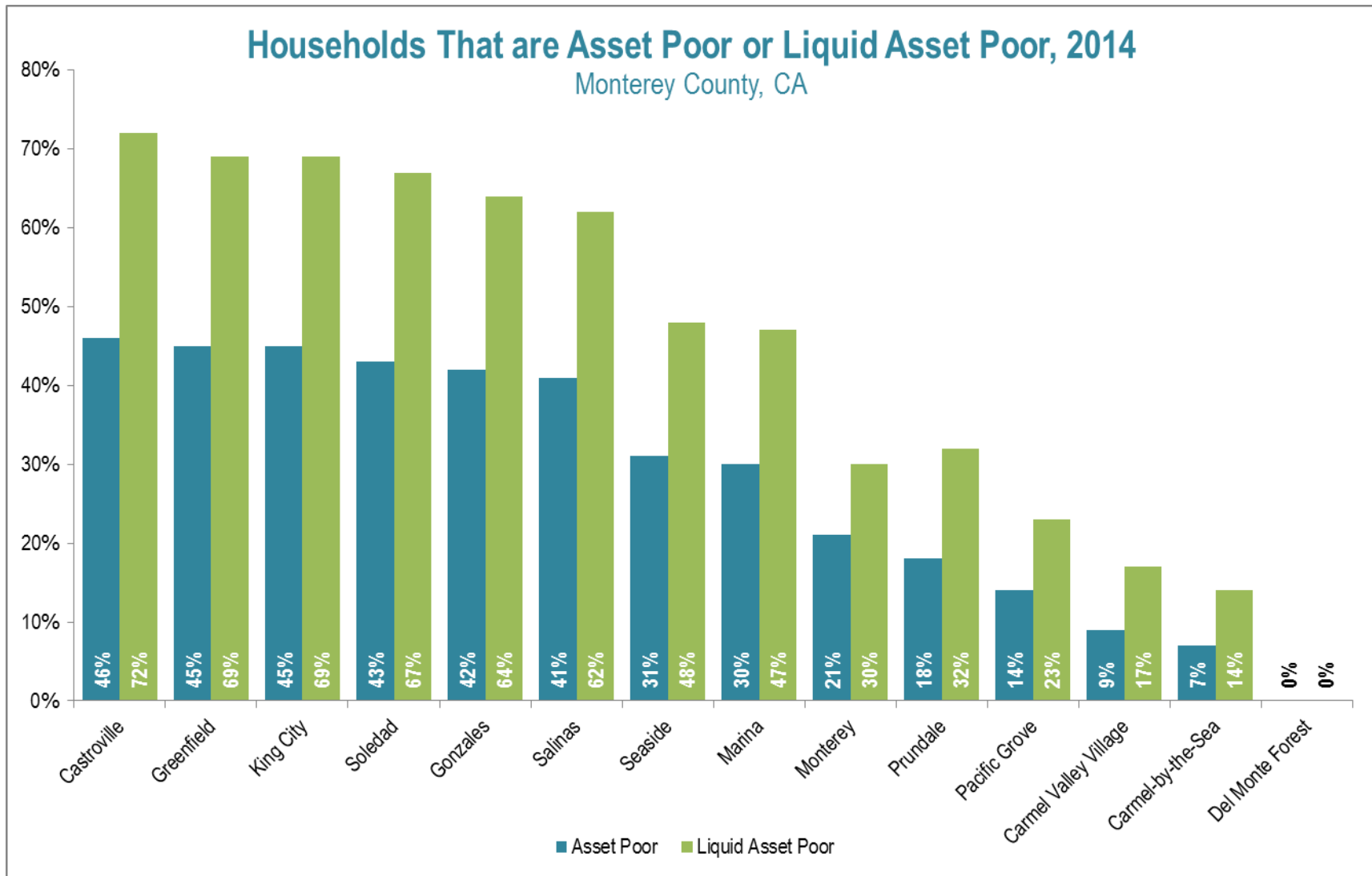

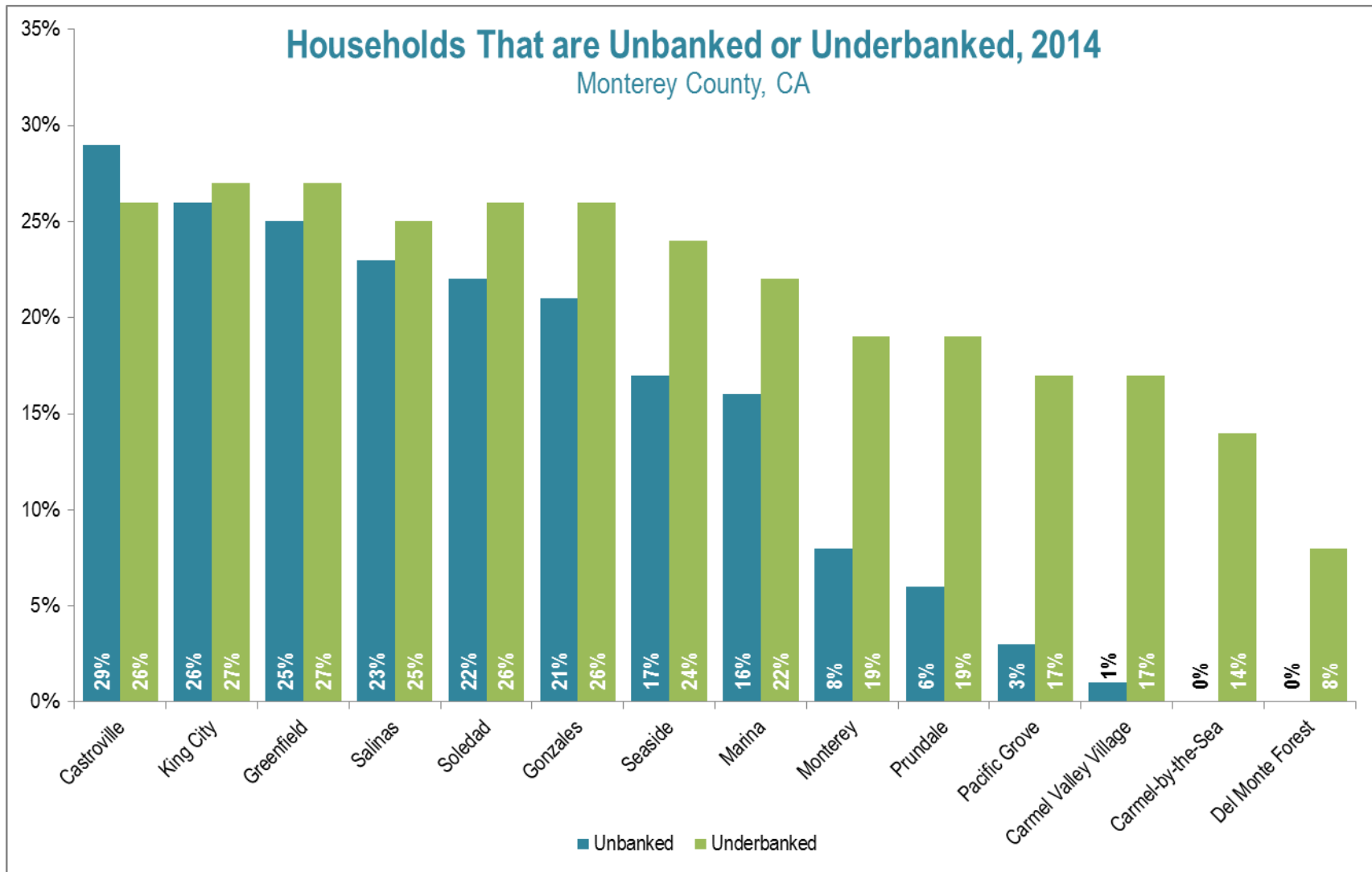

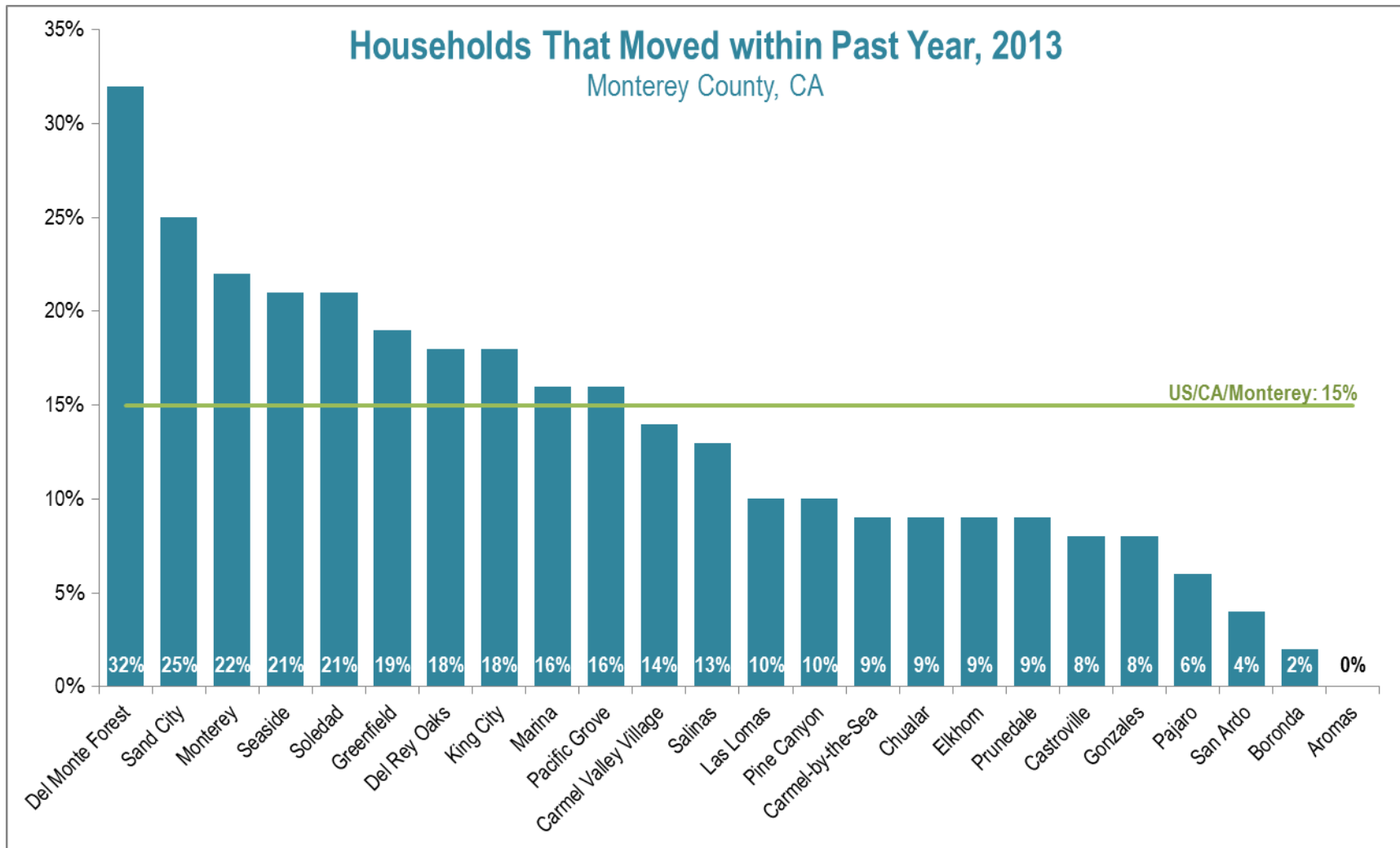

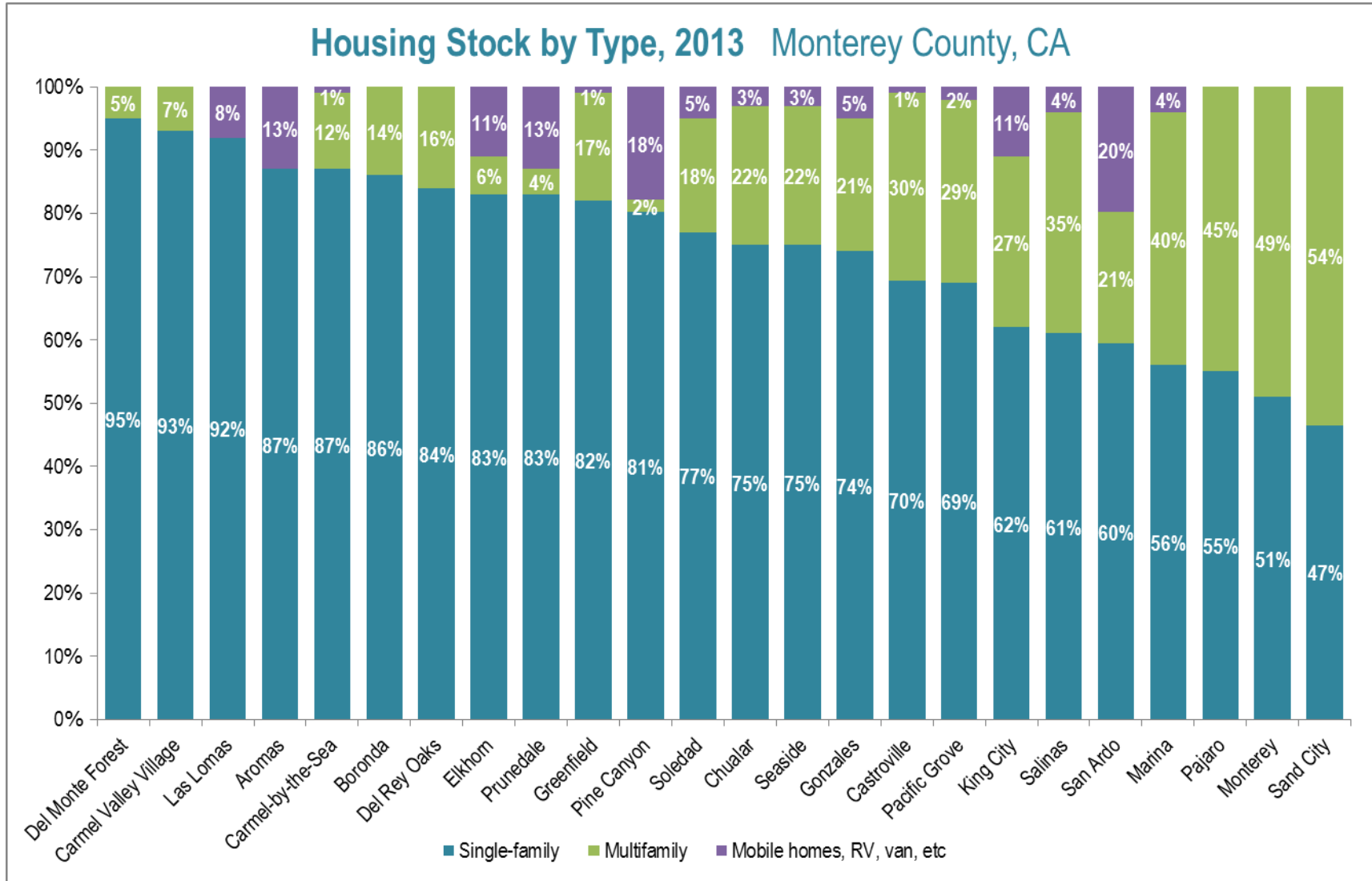

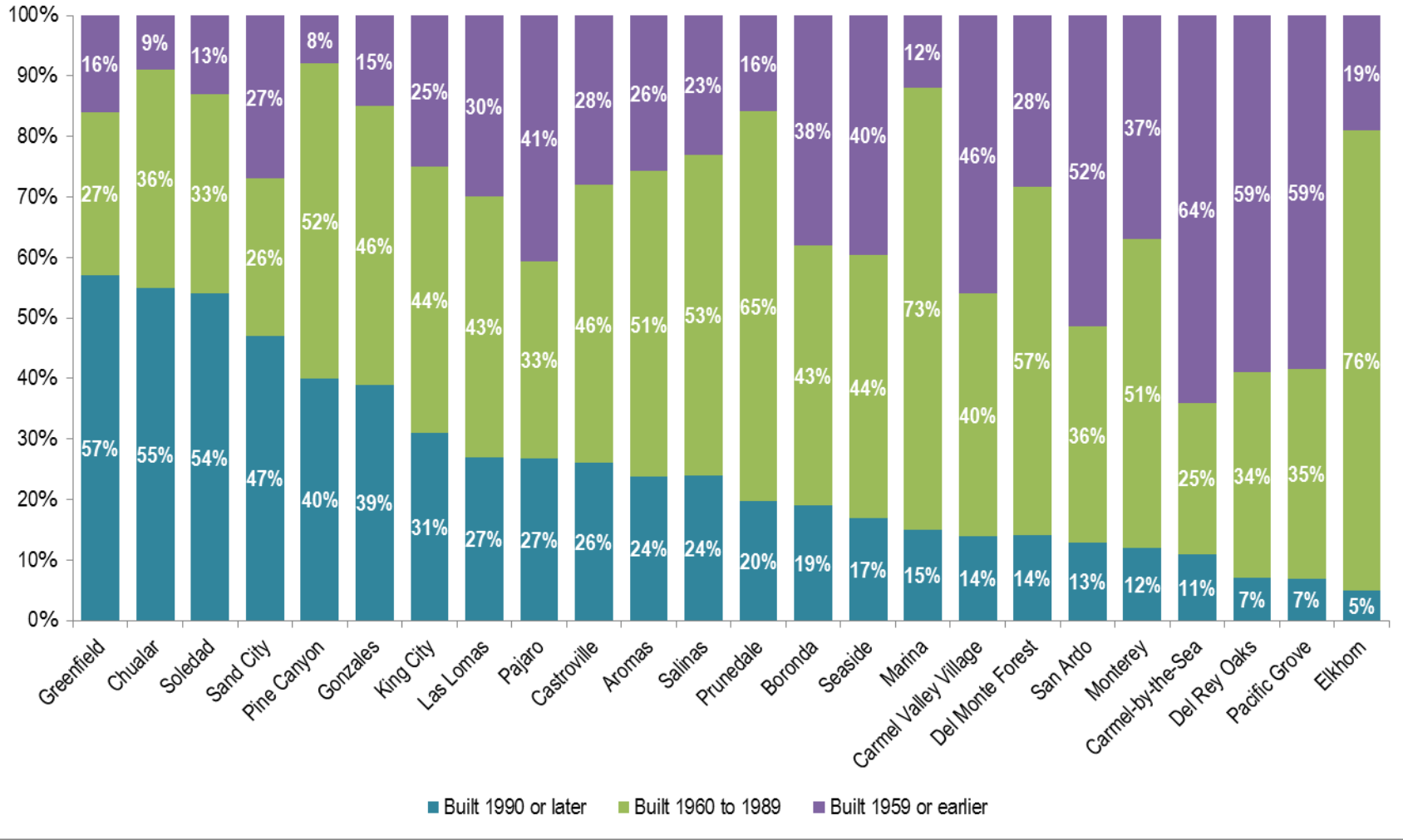

Housing Stock by Type, 2013 Monterey County, CA

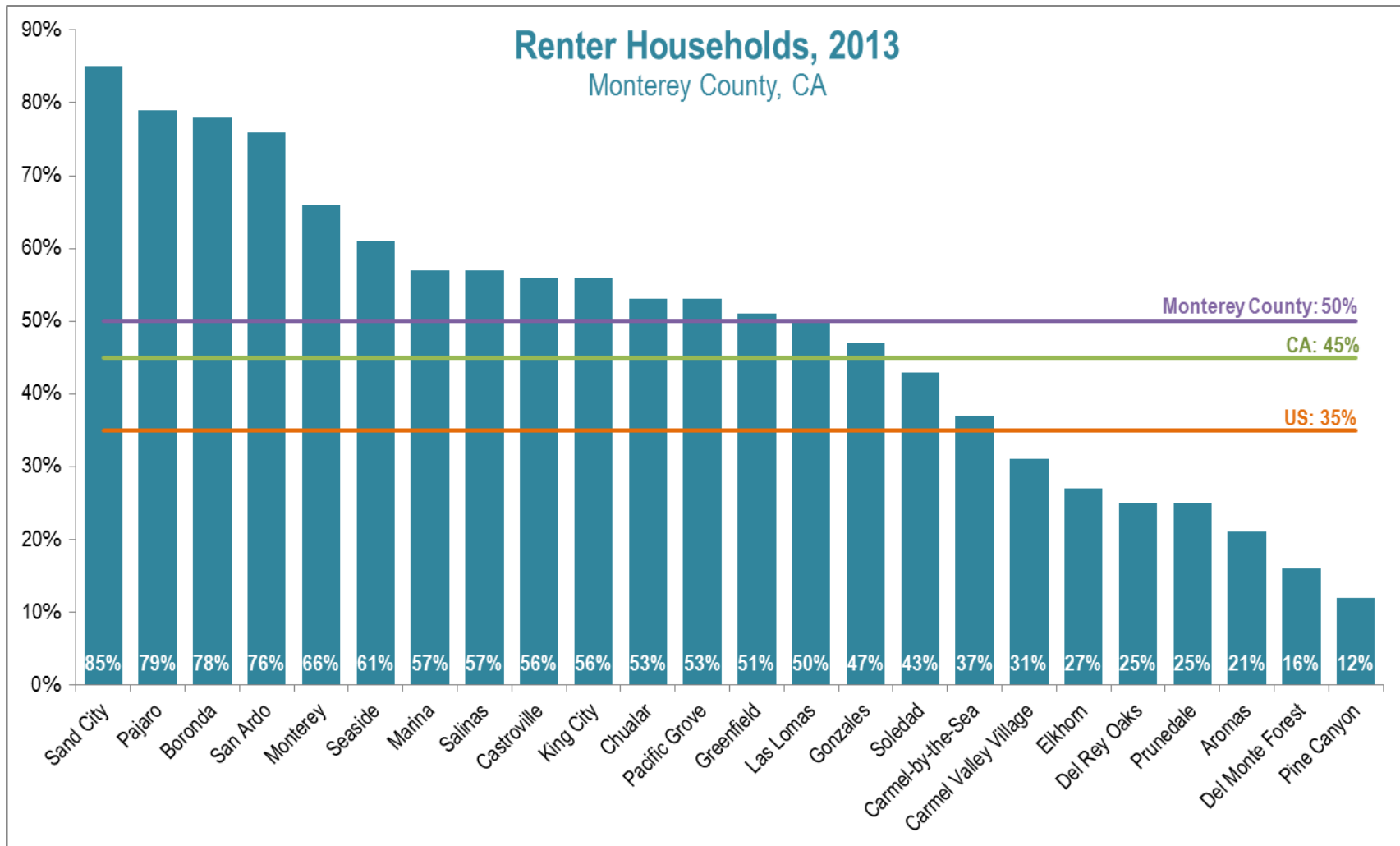

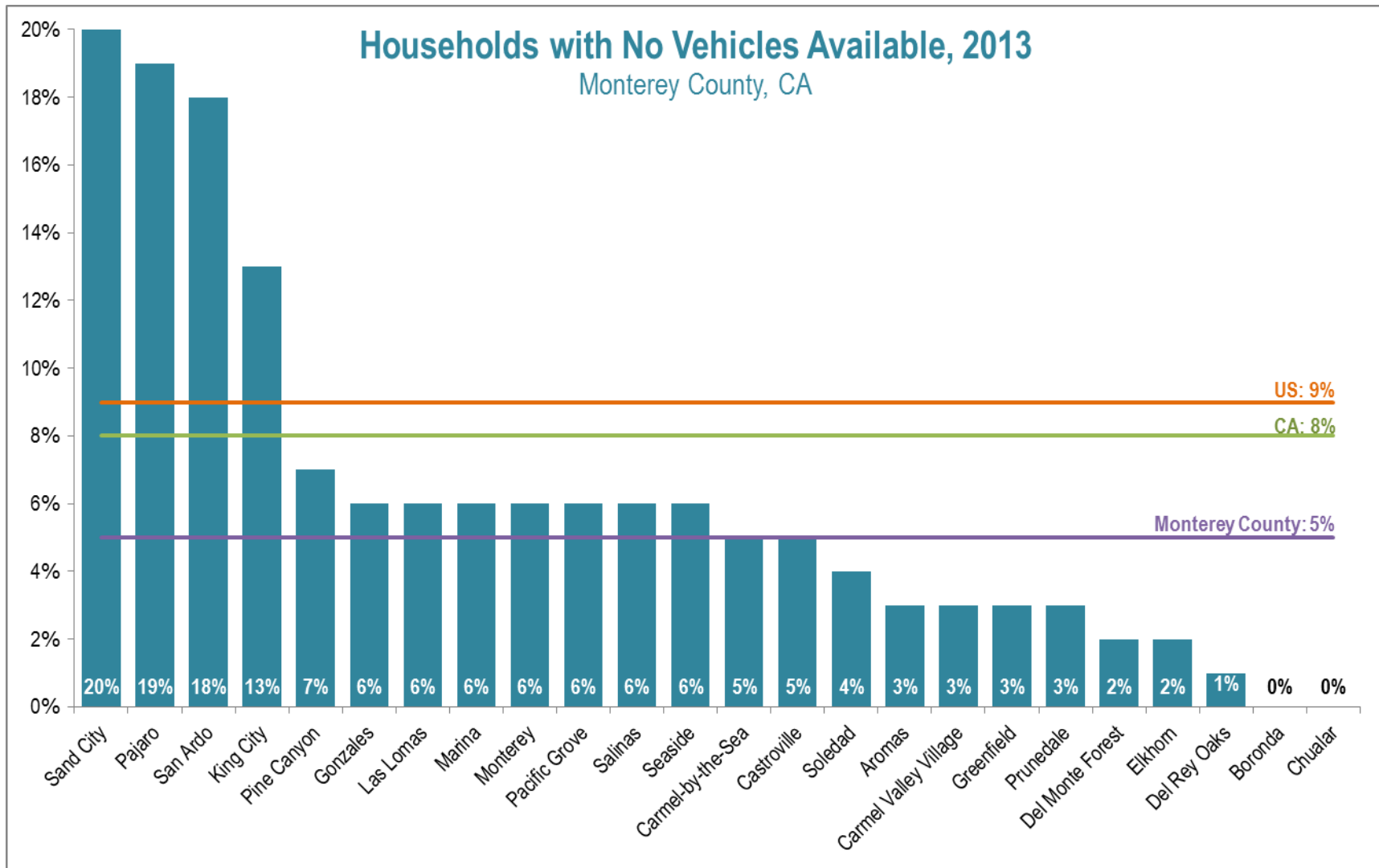
Housing Stock by Year Constructed, 2013 Monterey County, CA

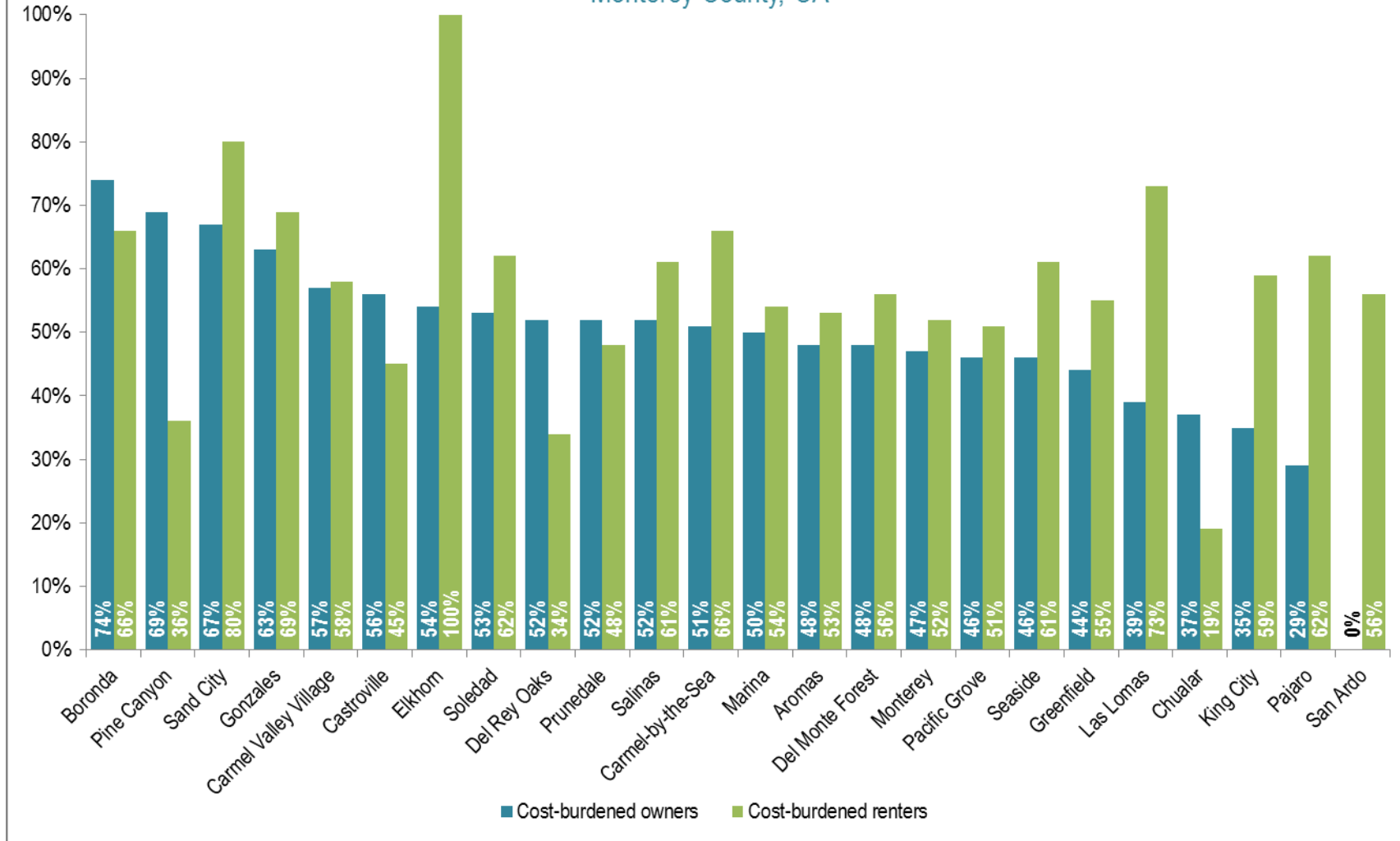
