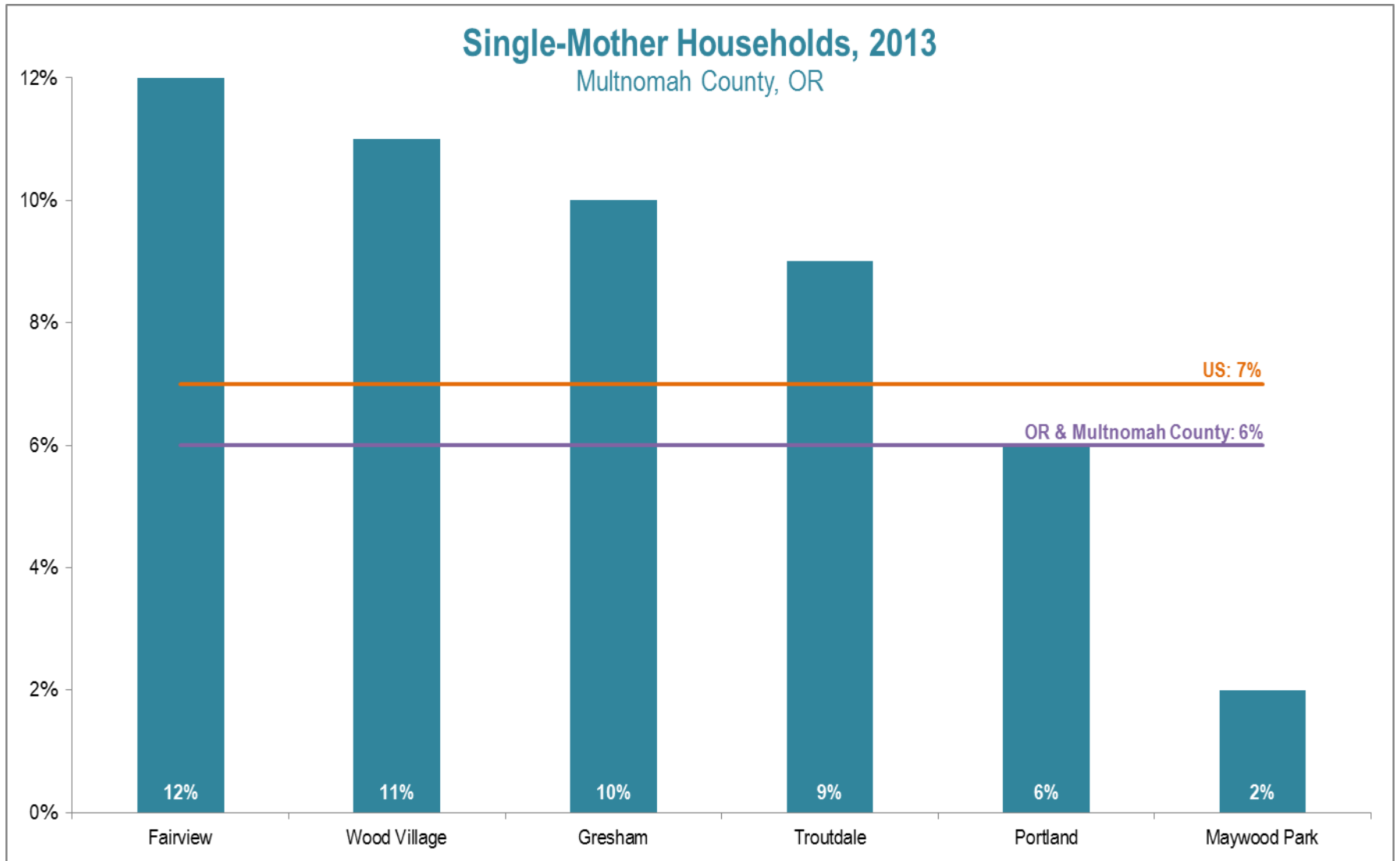

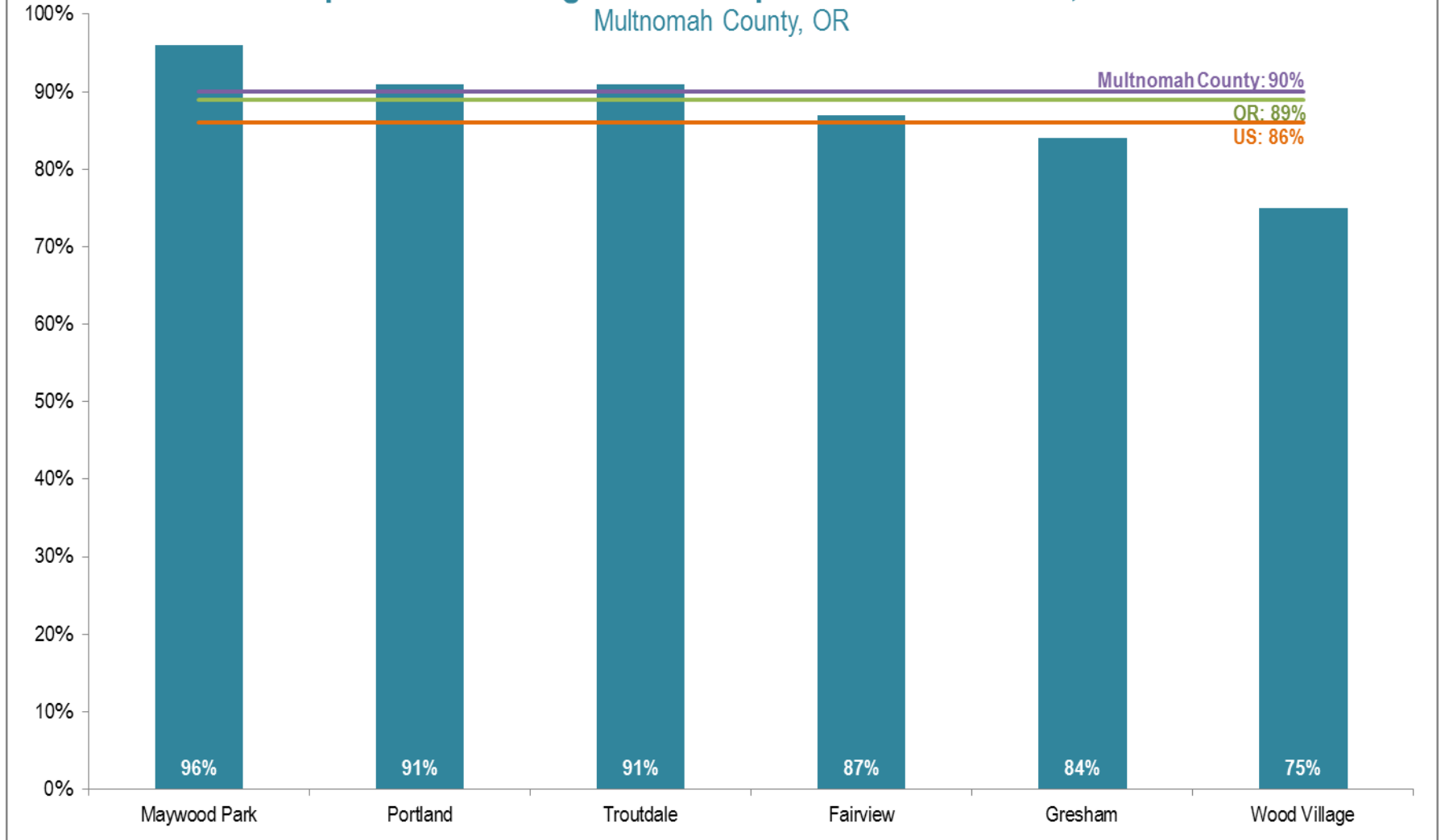

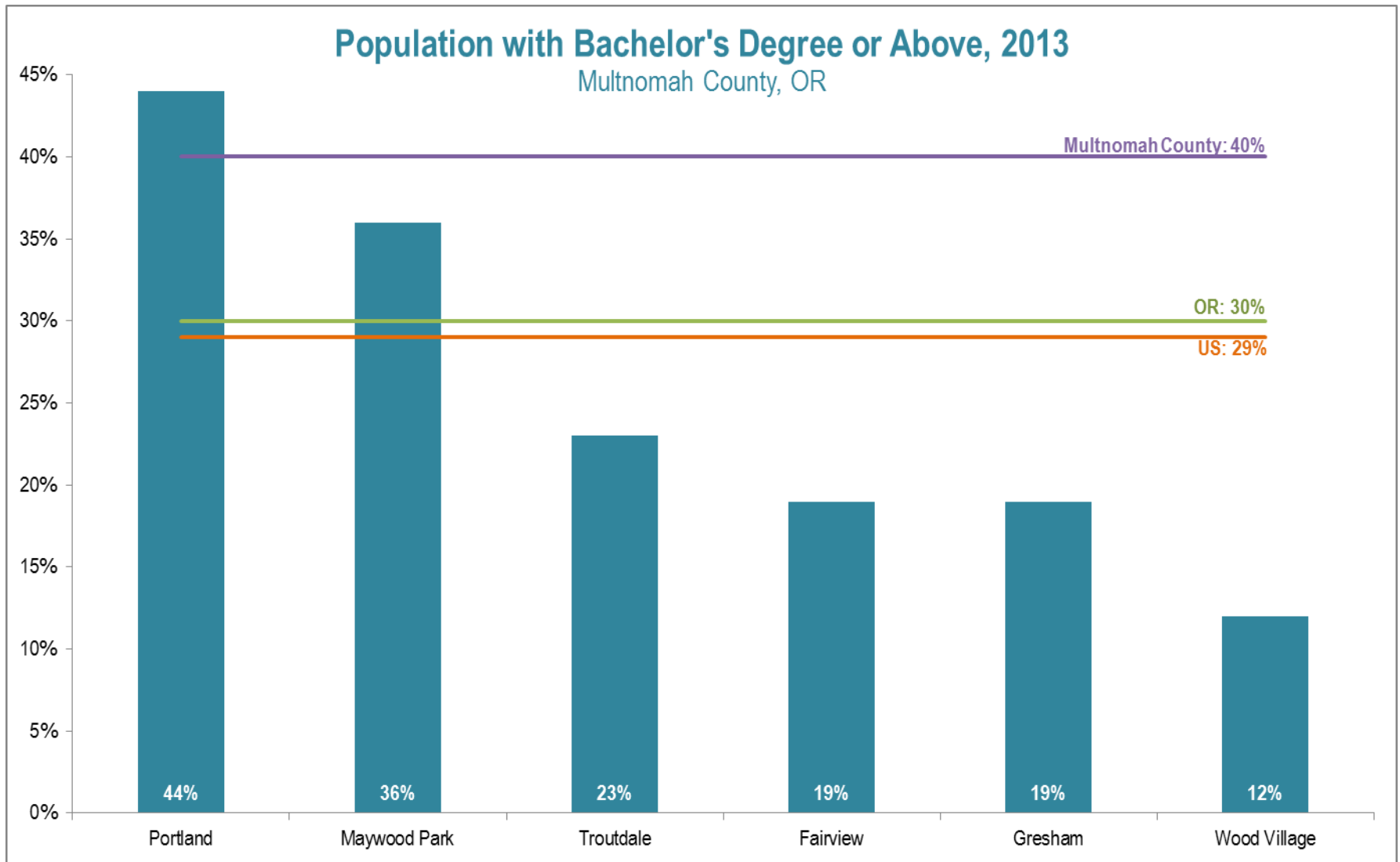

Population with High School Diploma/GED or Above, 2013

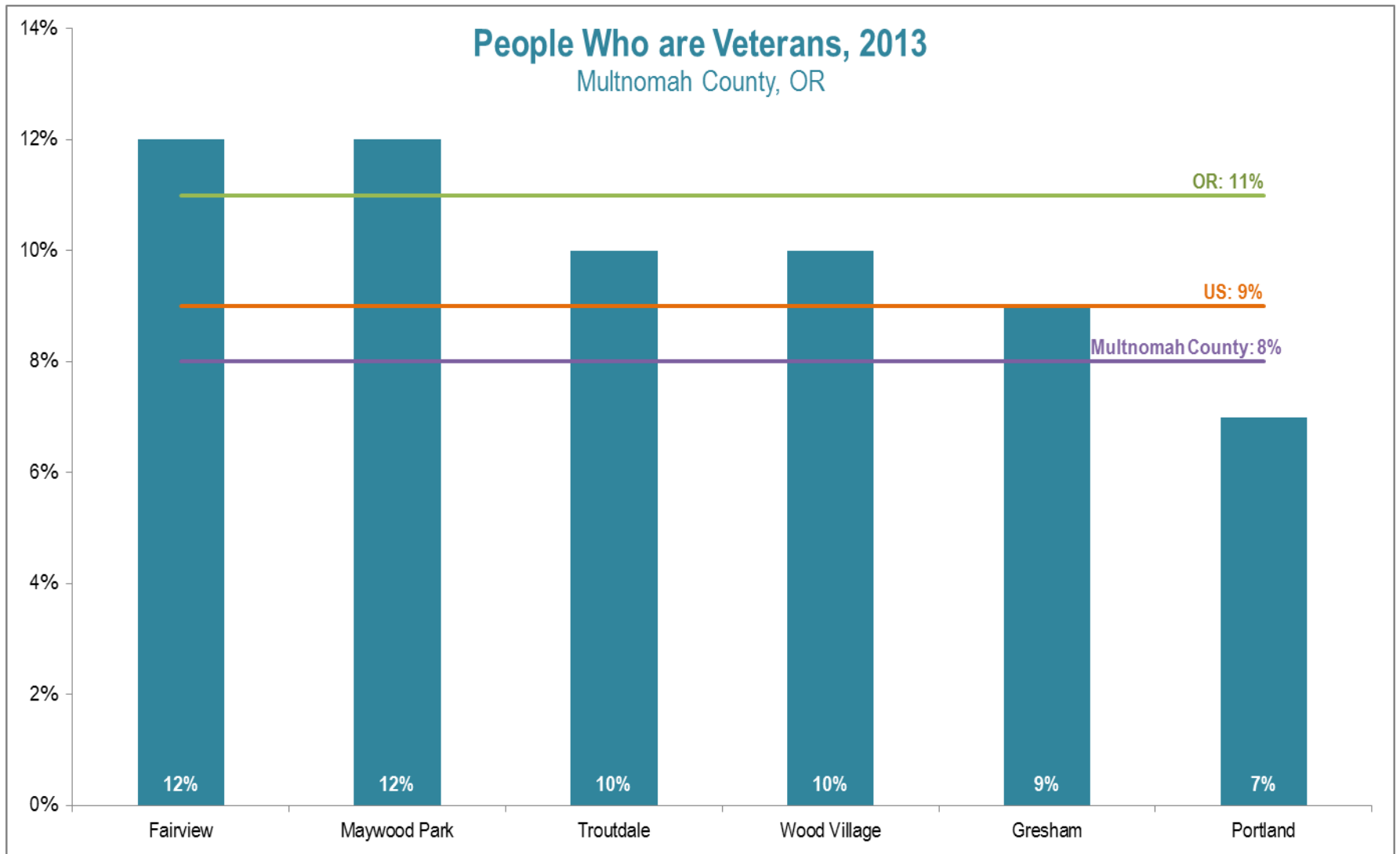

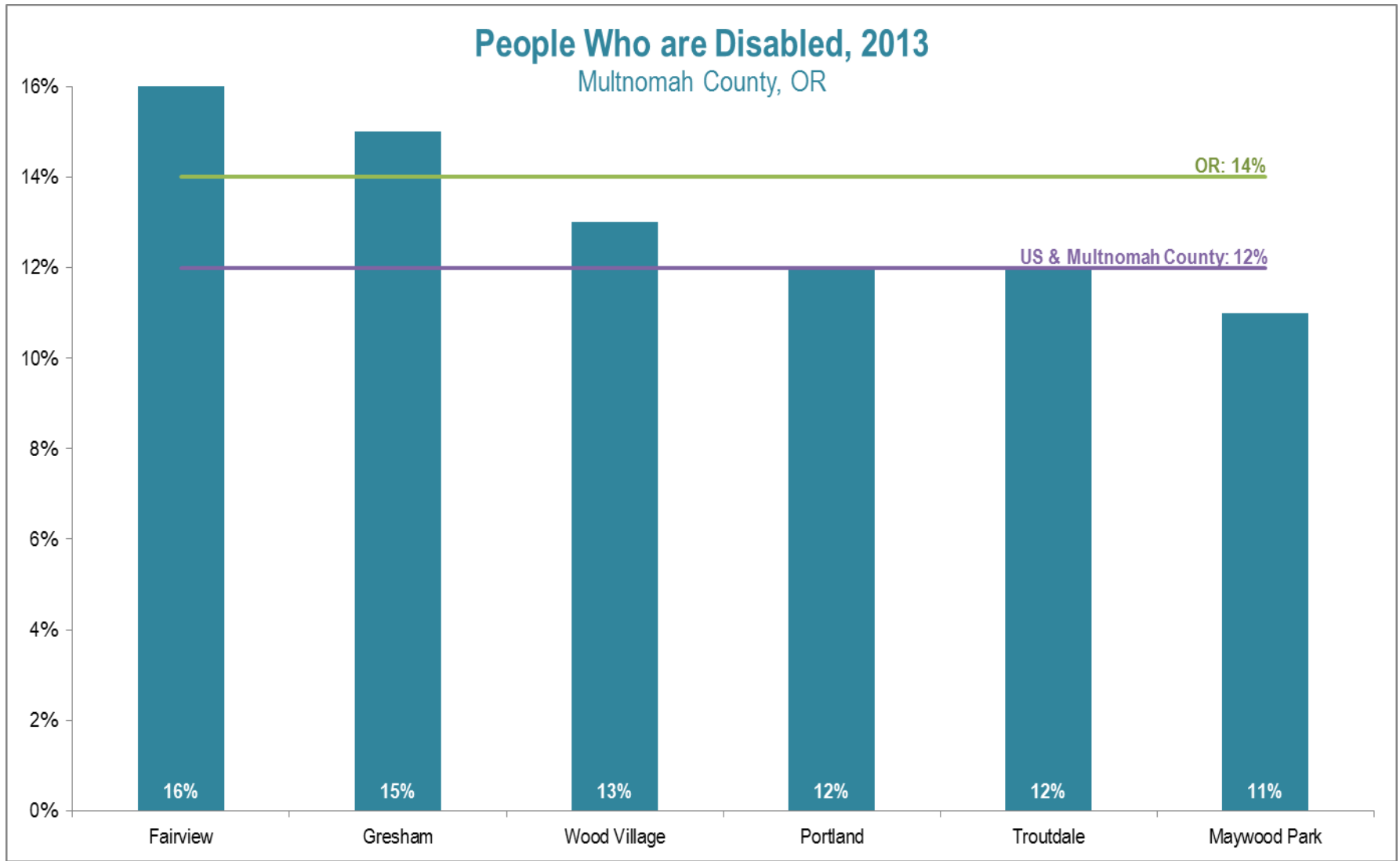

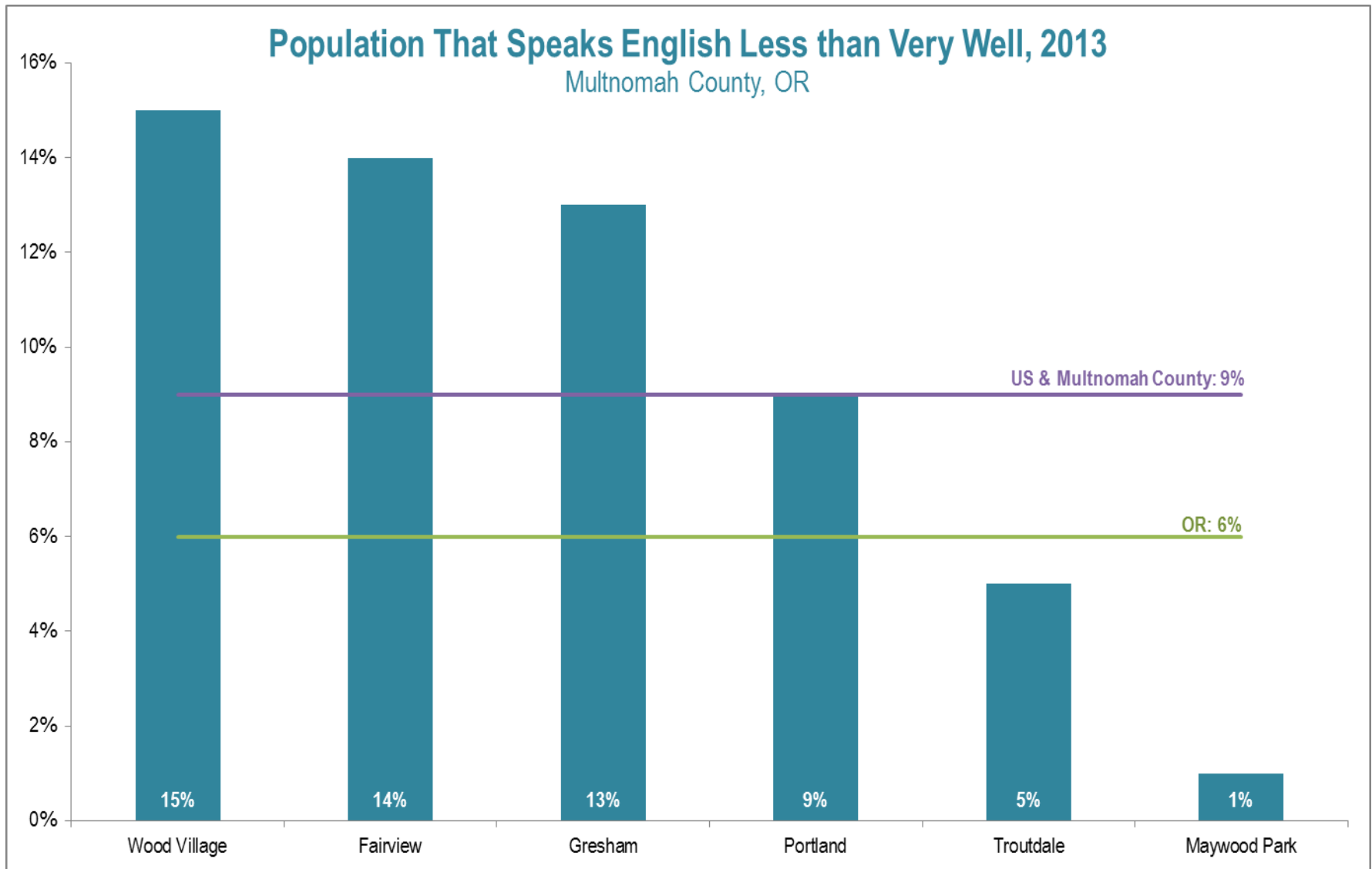

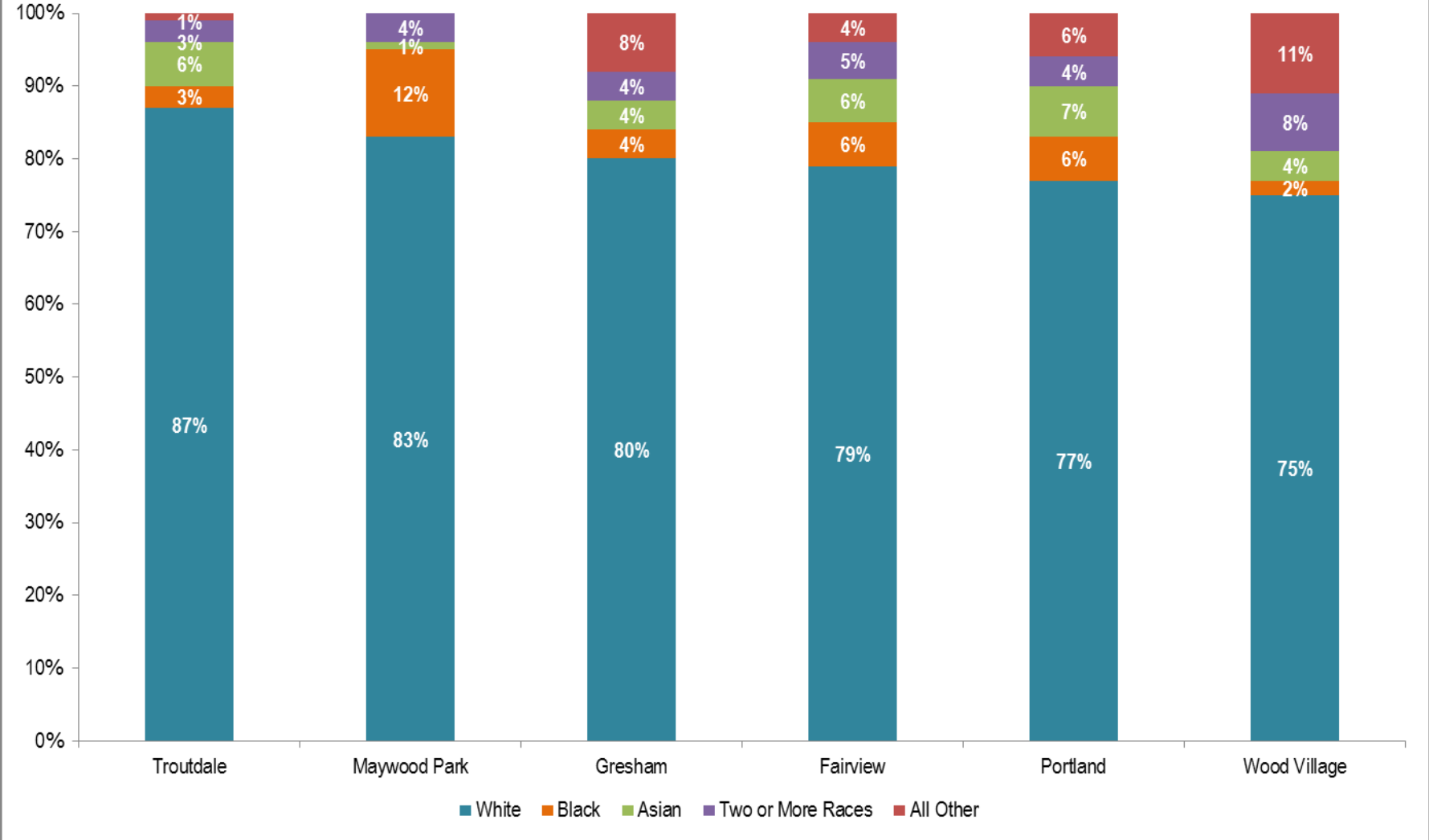

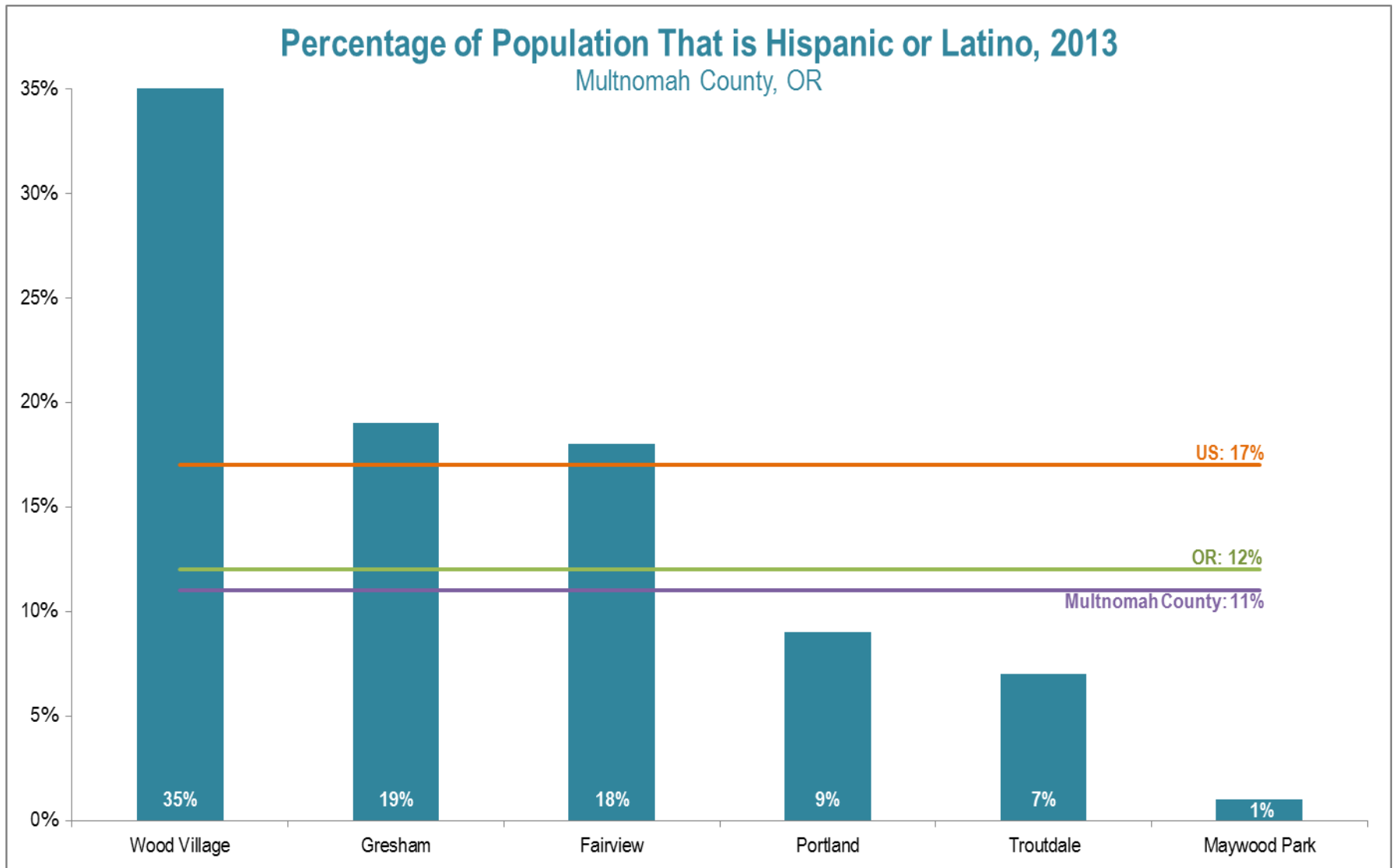
Population by Race, 2013 Multnomah County, OR

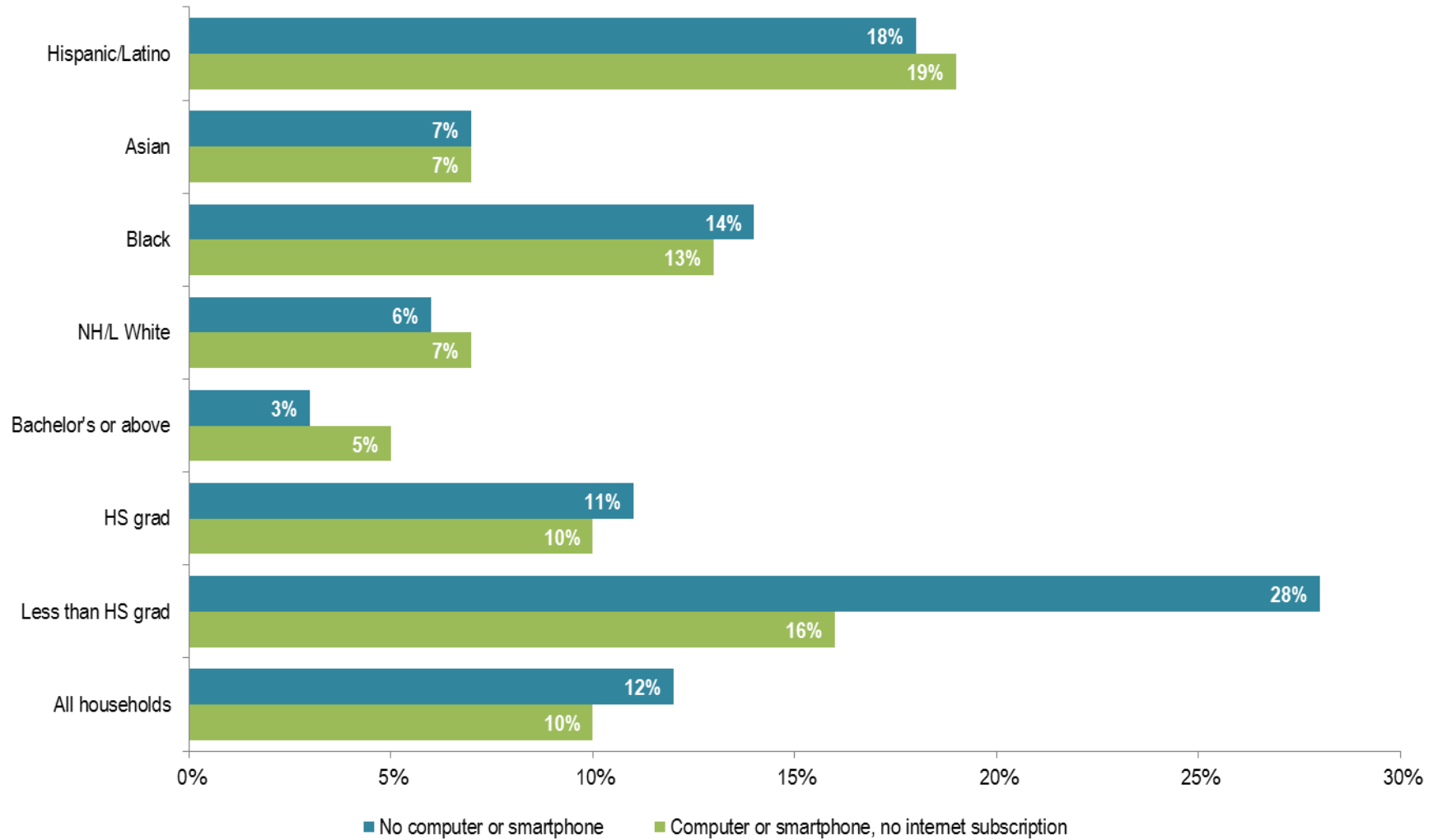
Percentage of Population That is Hispanic or Latino, 2013

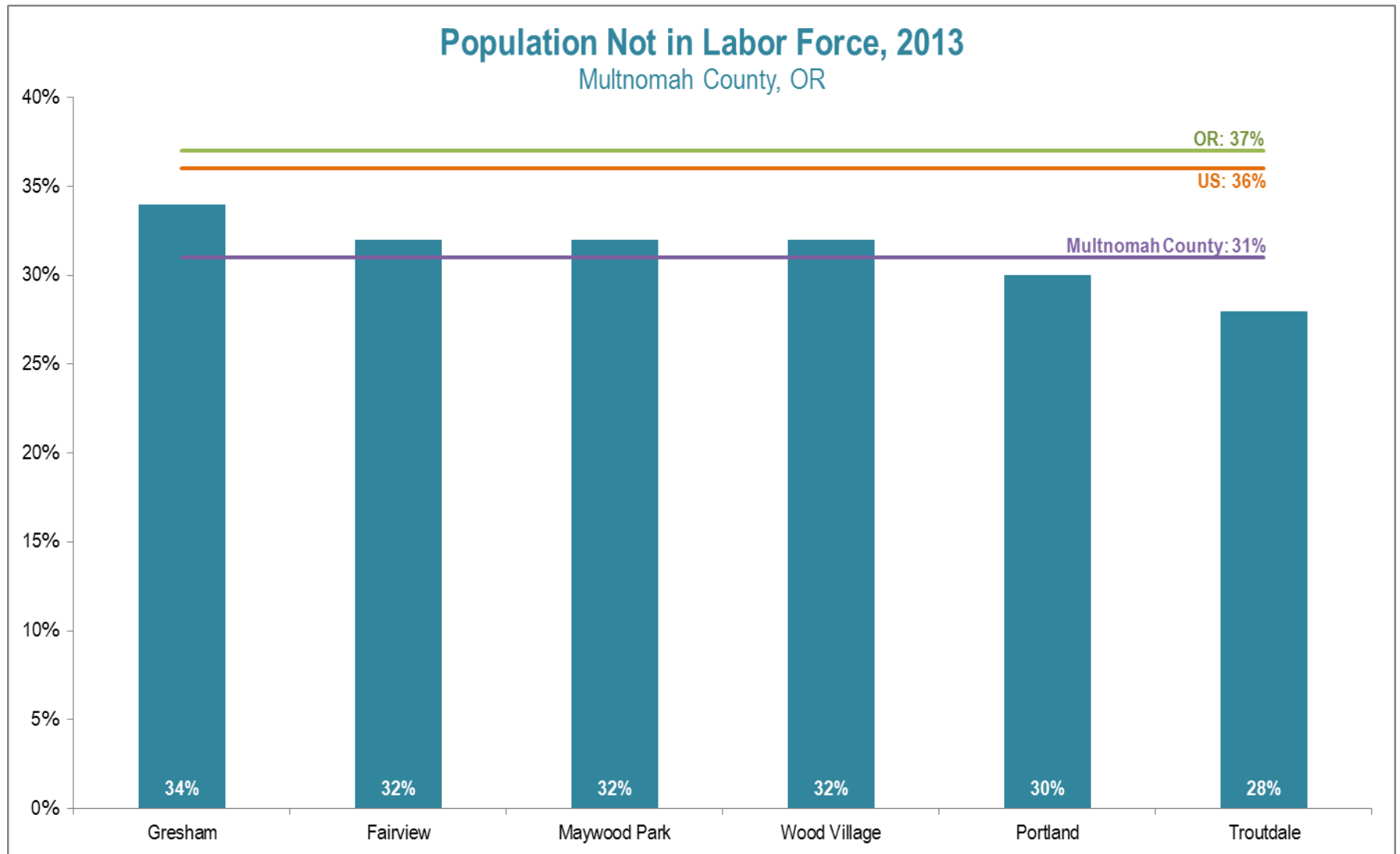

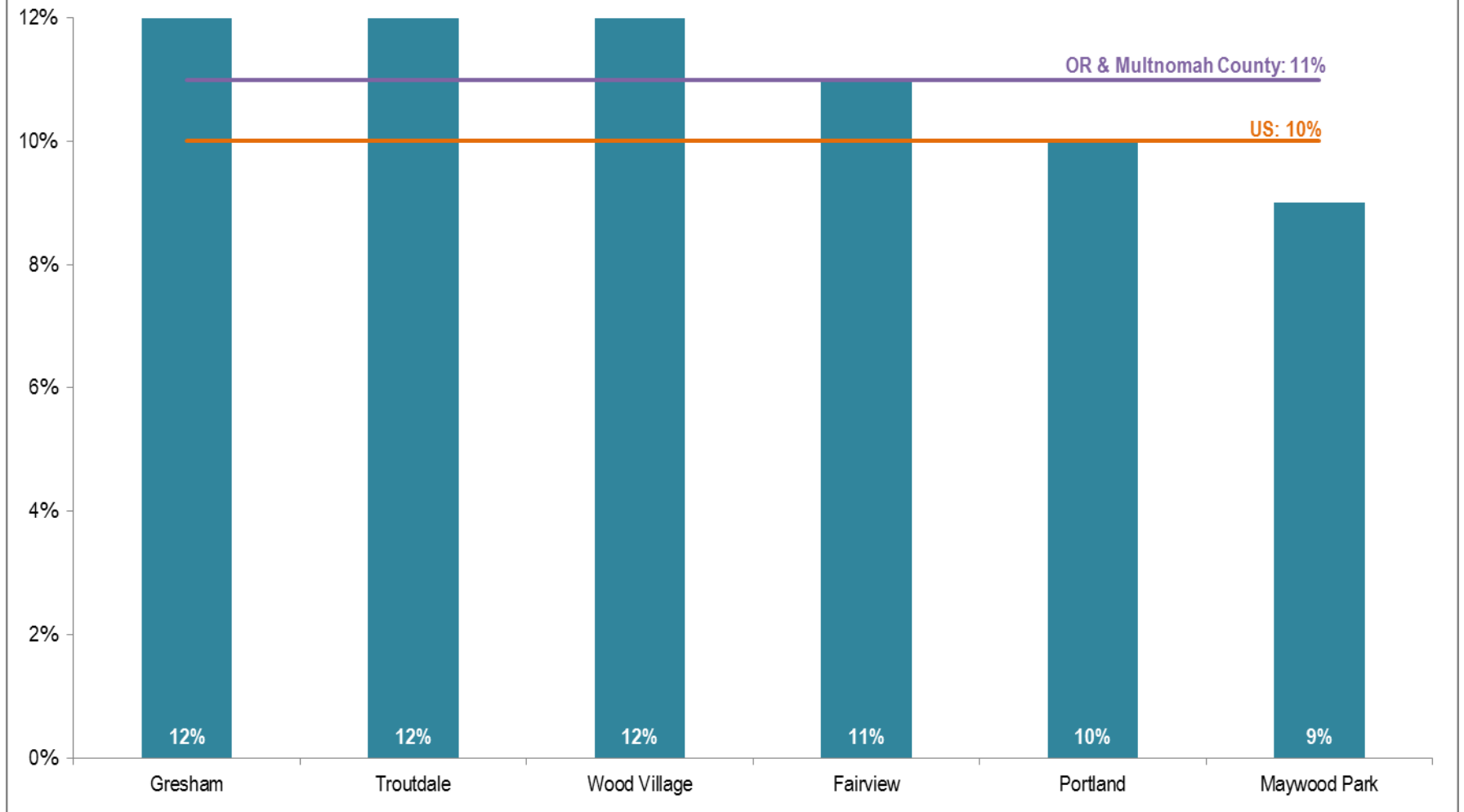

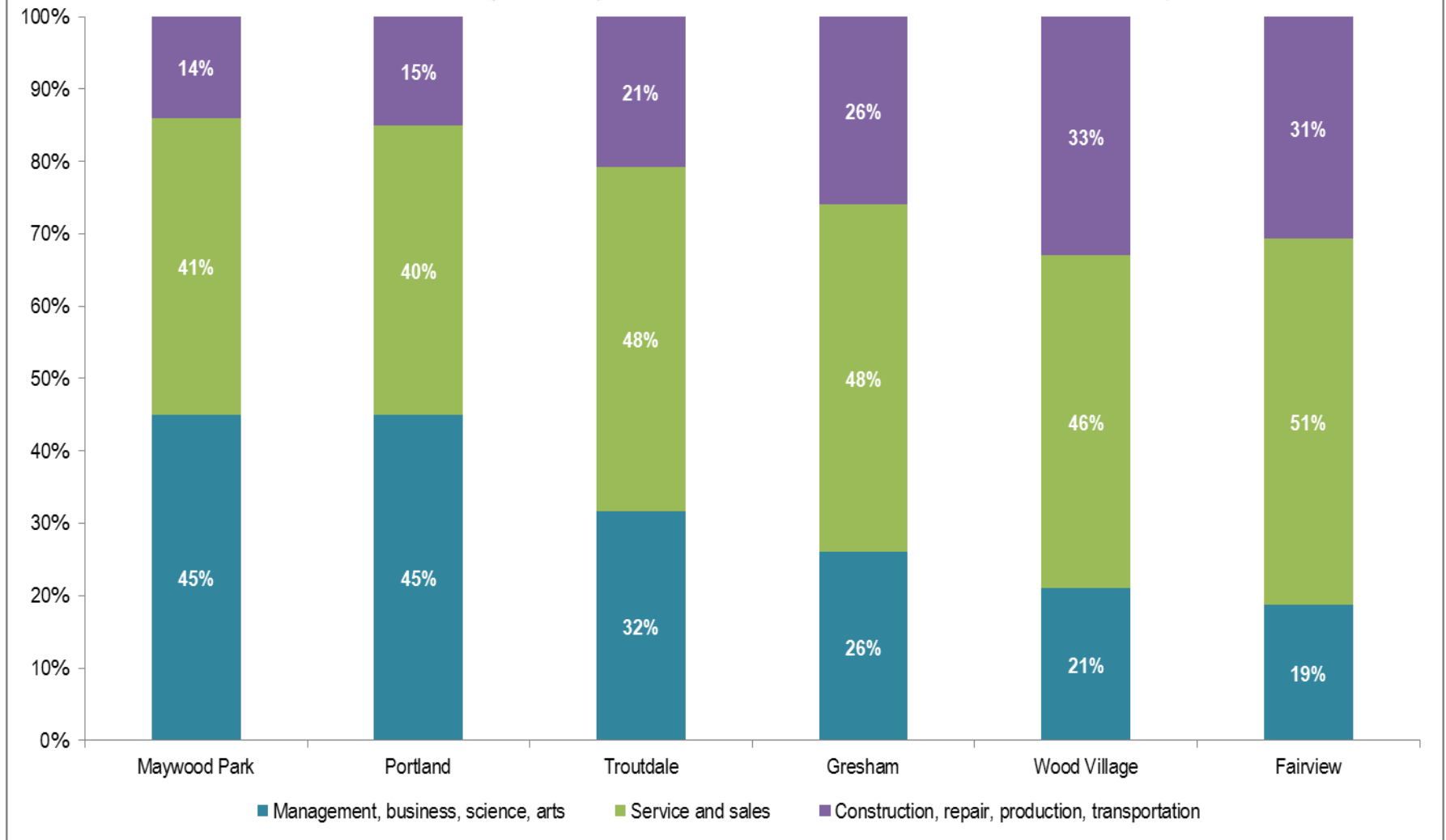
Percentage of Labor Force That is Unemployed, 2013

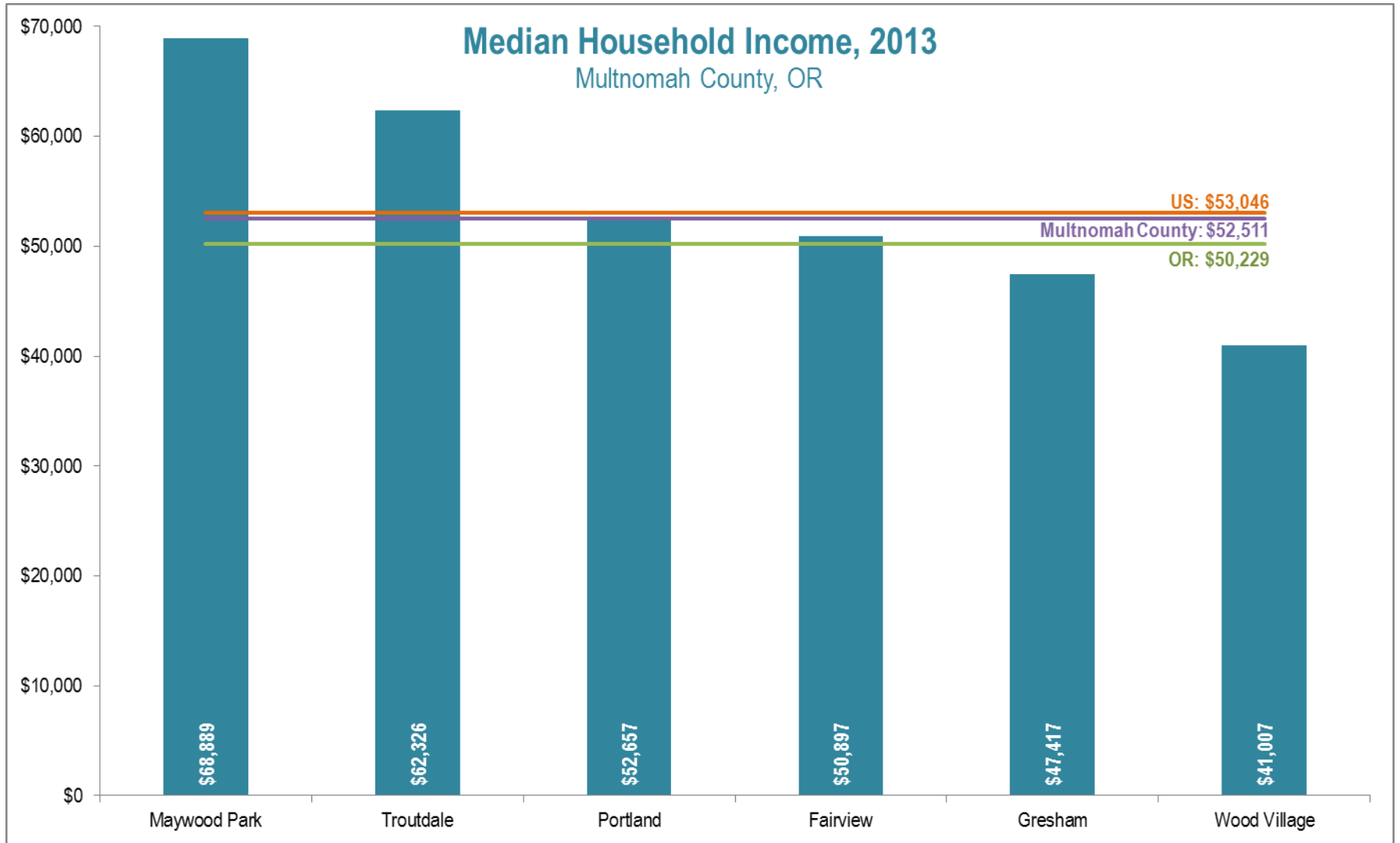

Population Over Age 16 by Occupation, 2013 Multnomah County, OR

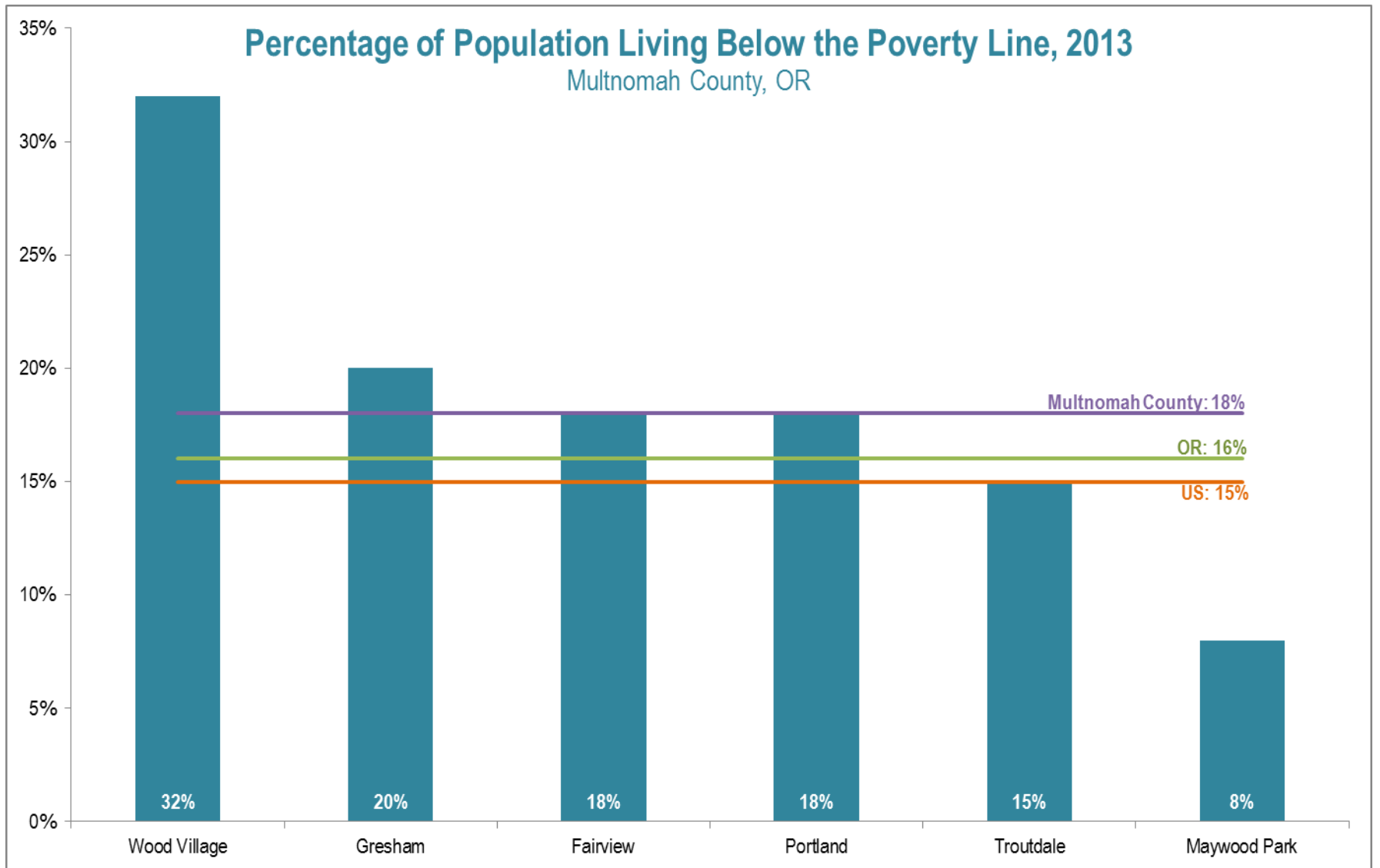

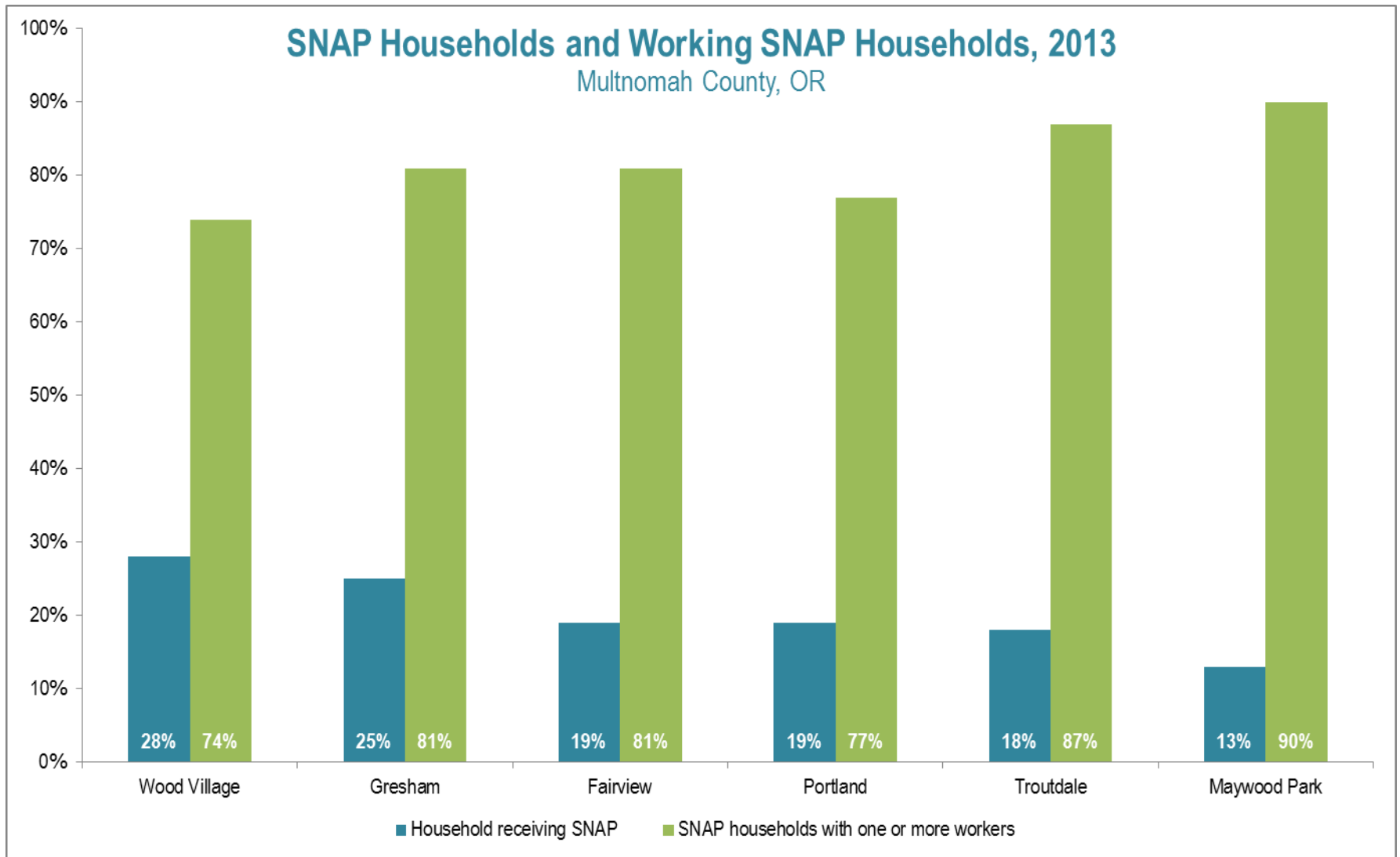

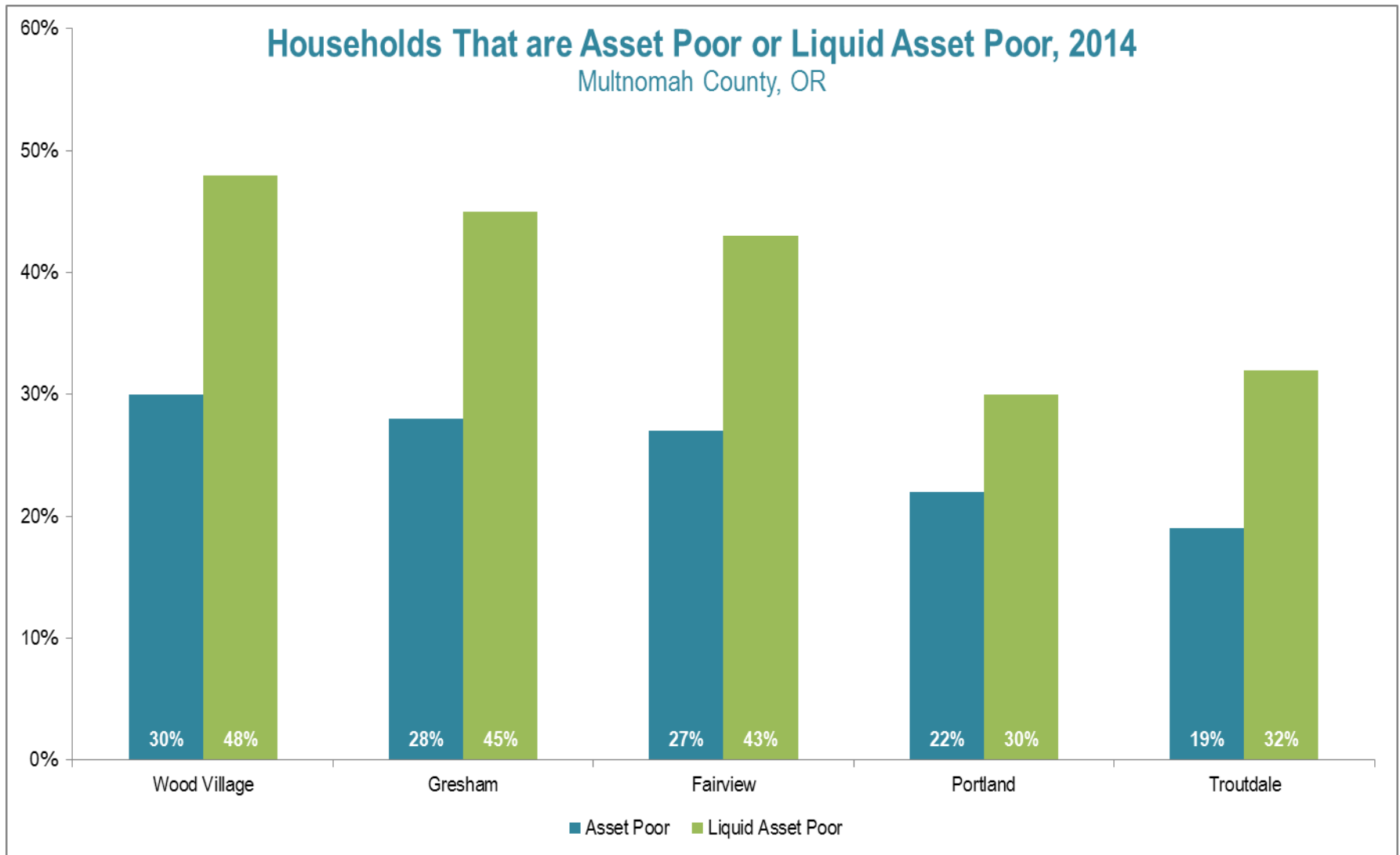

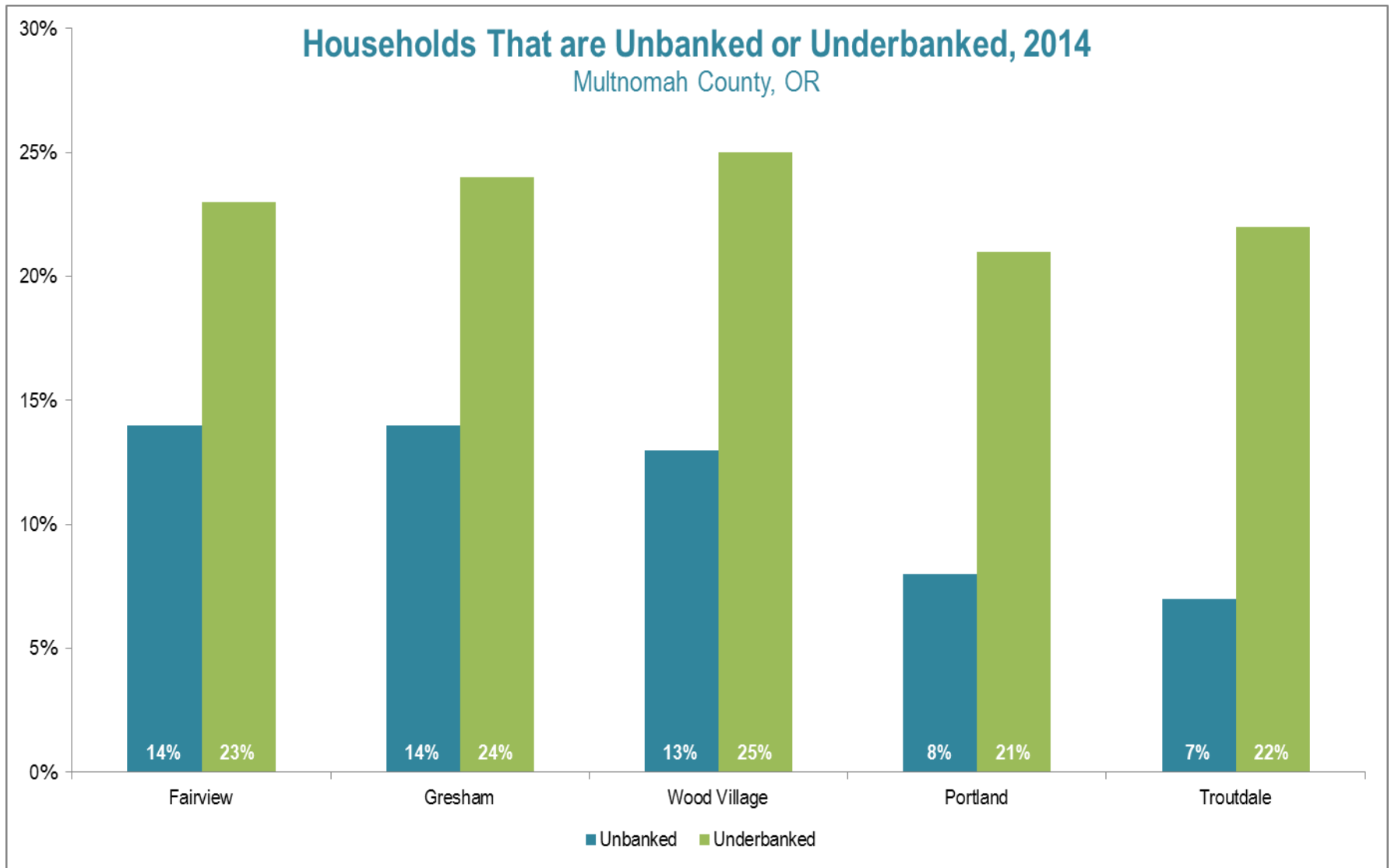

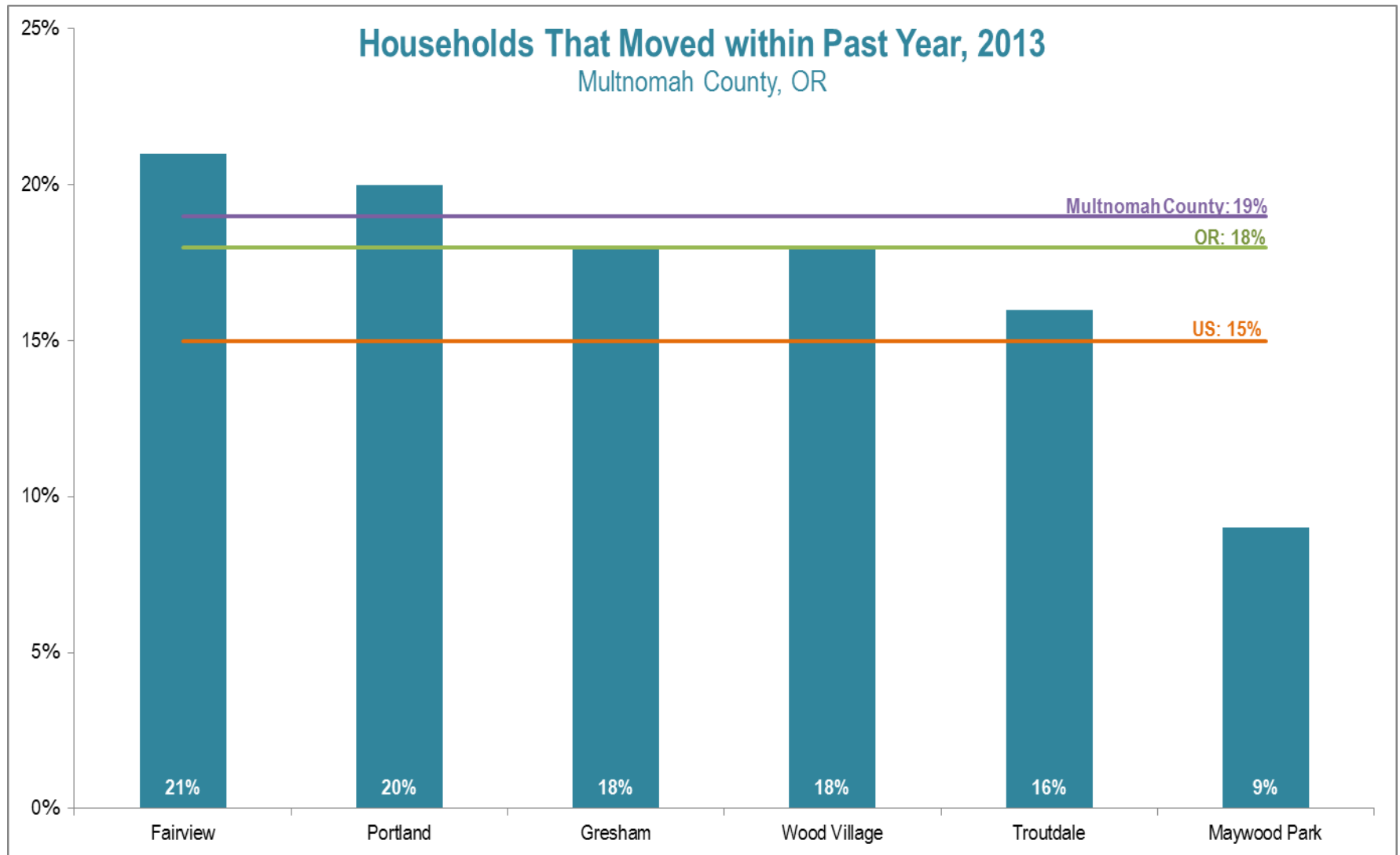

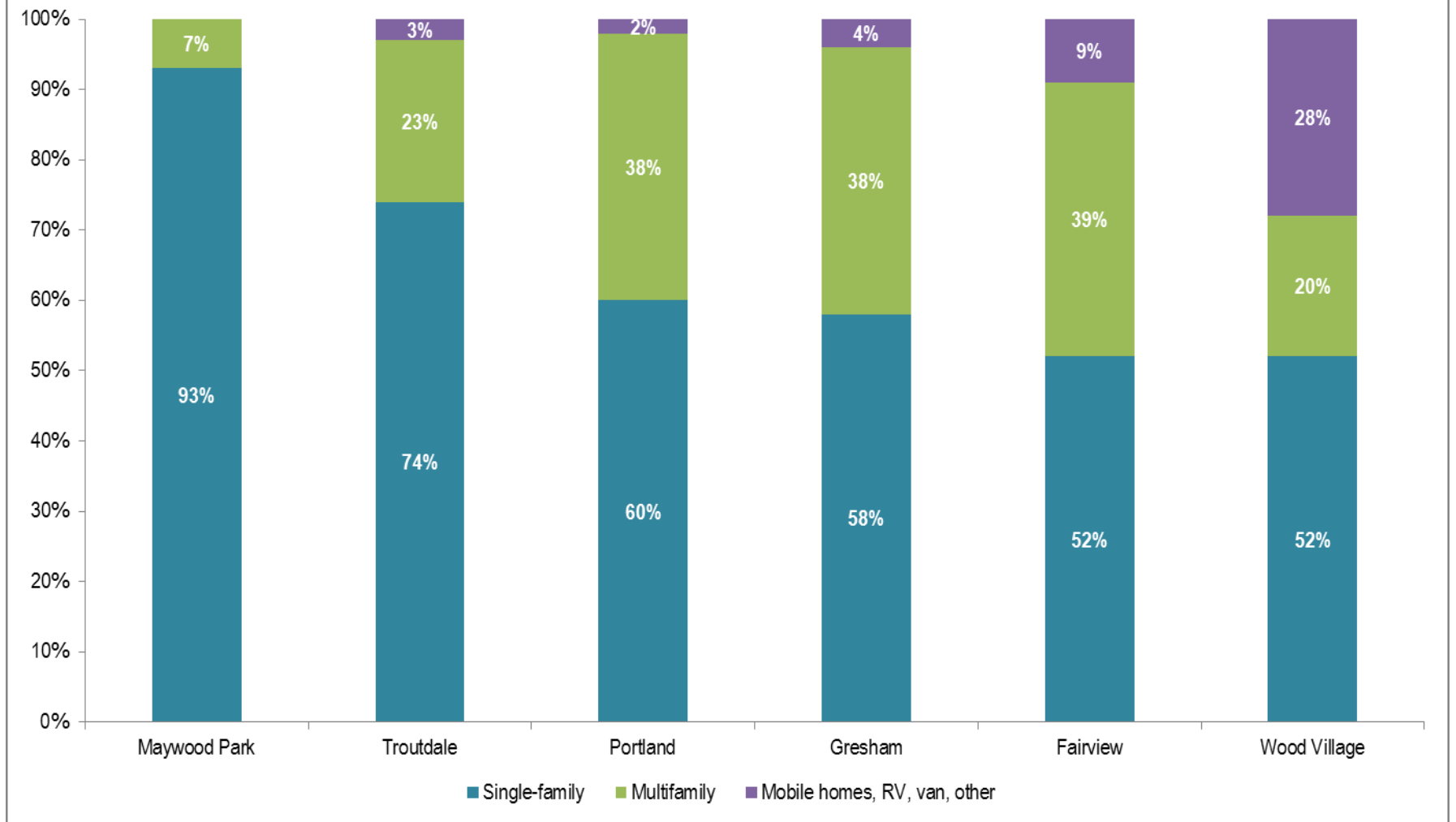

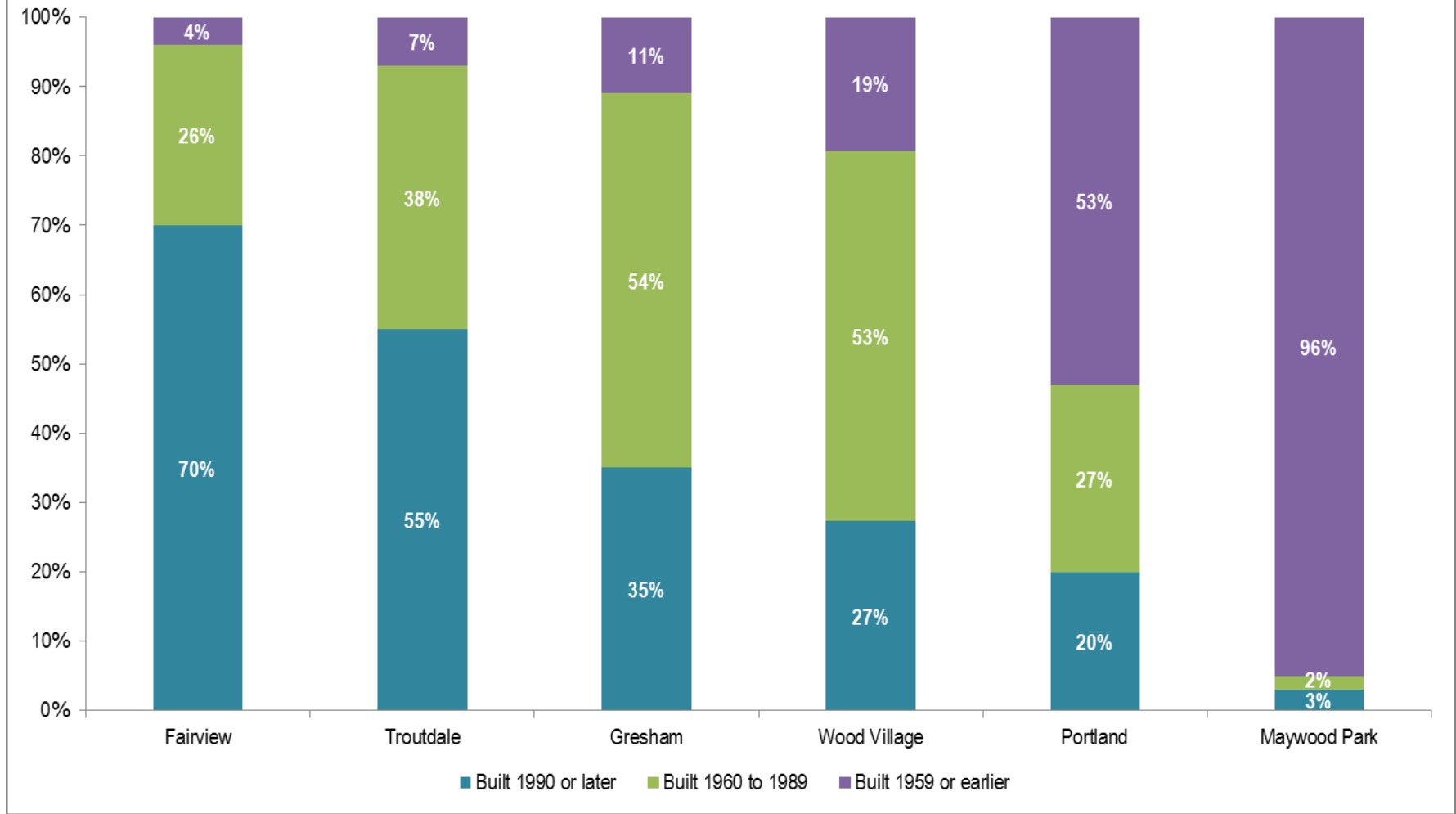

Housing Stock by Type, 2013 Multnomah County, OR

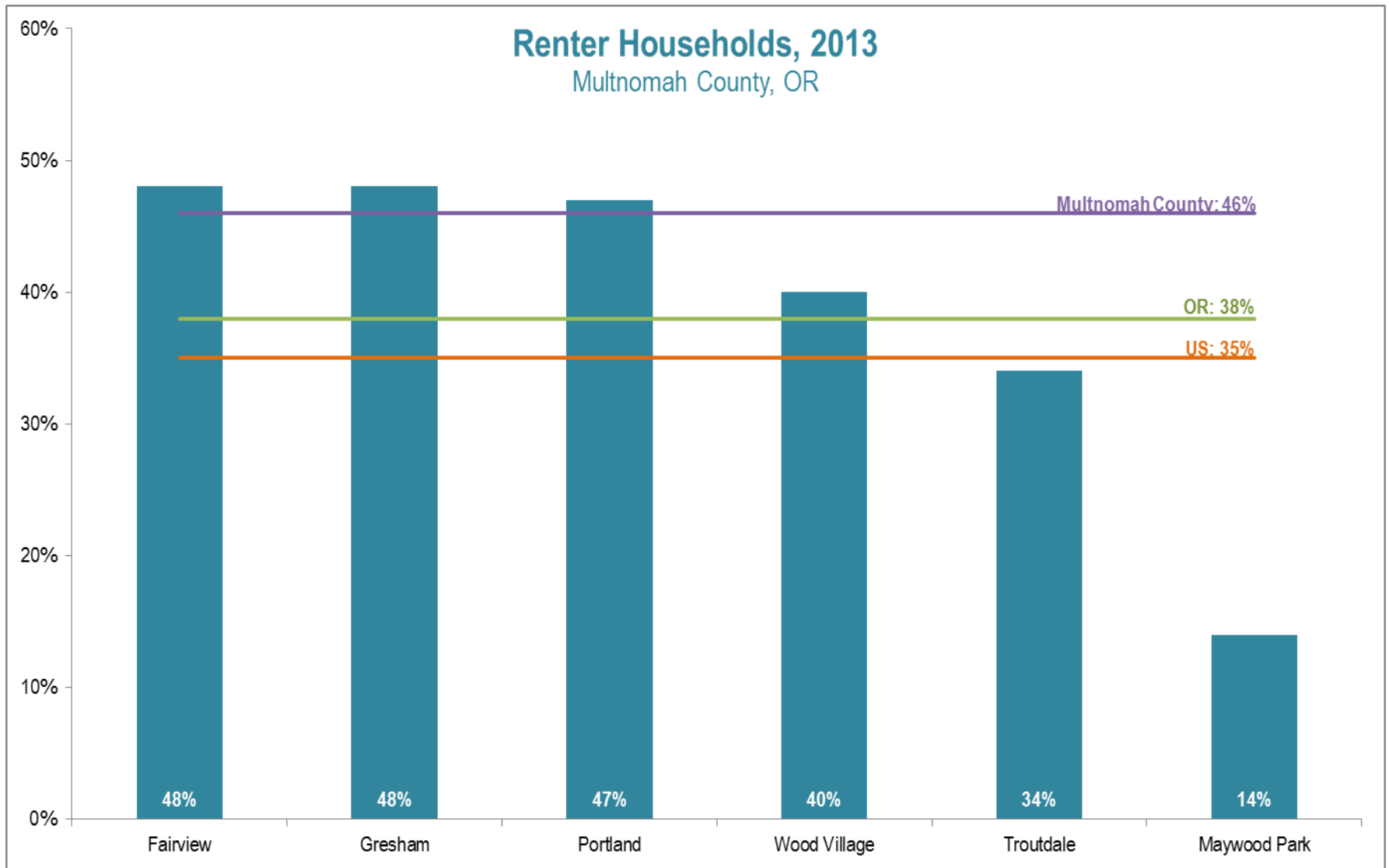

Housing Stock by Year Constructed, 2013 Multnomah County, OR



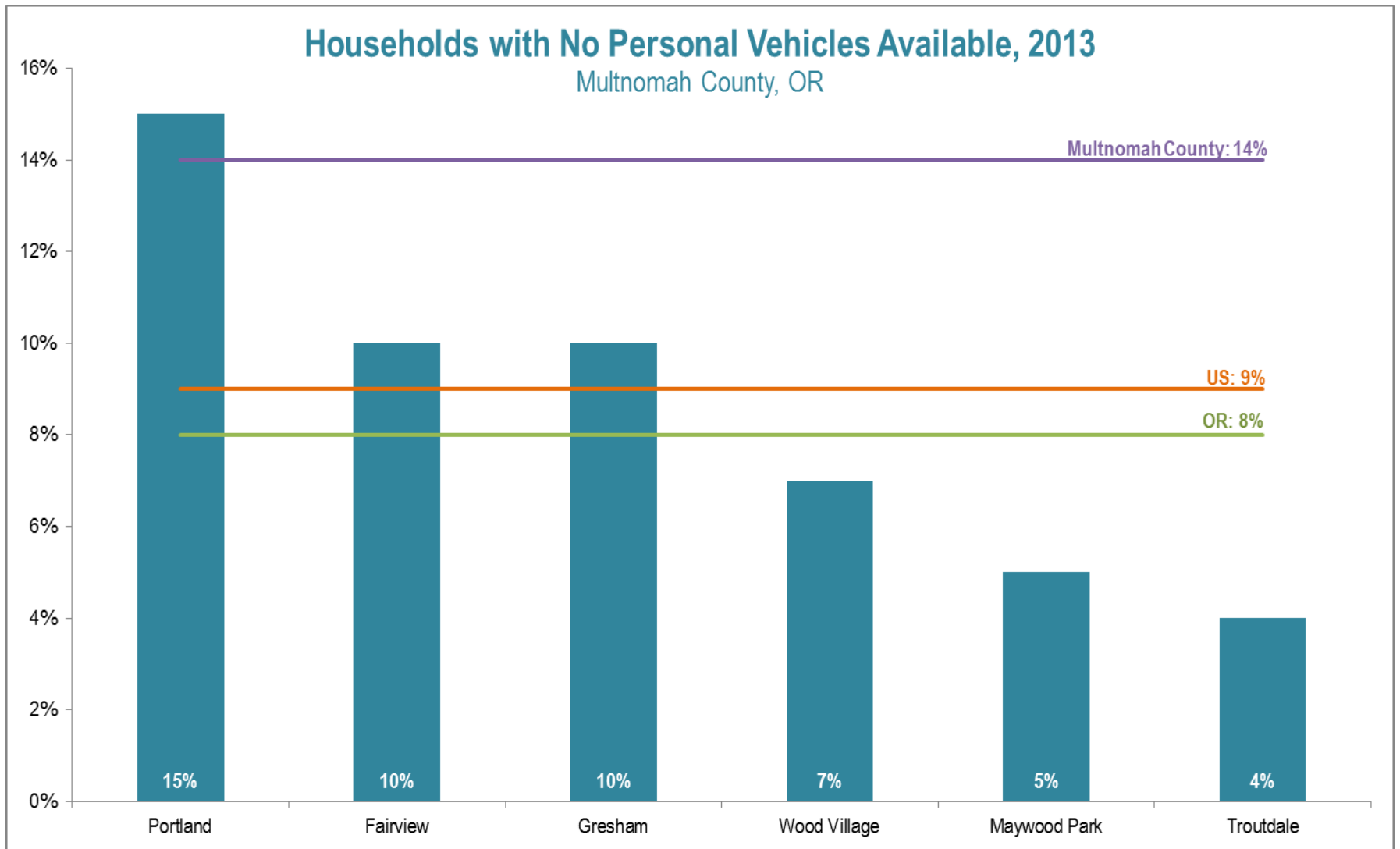

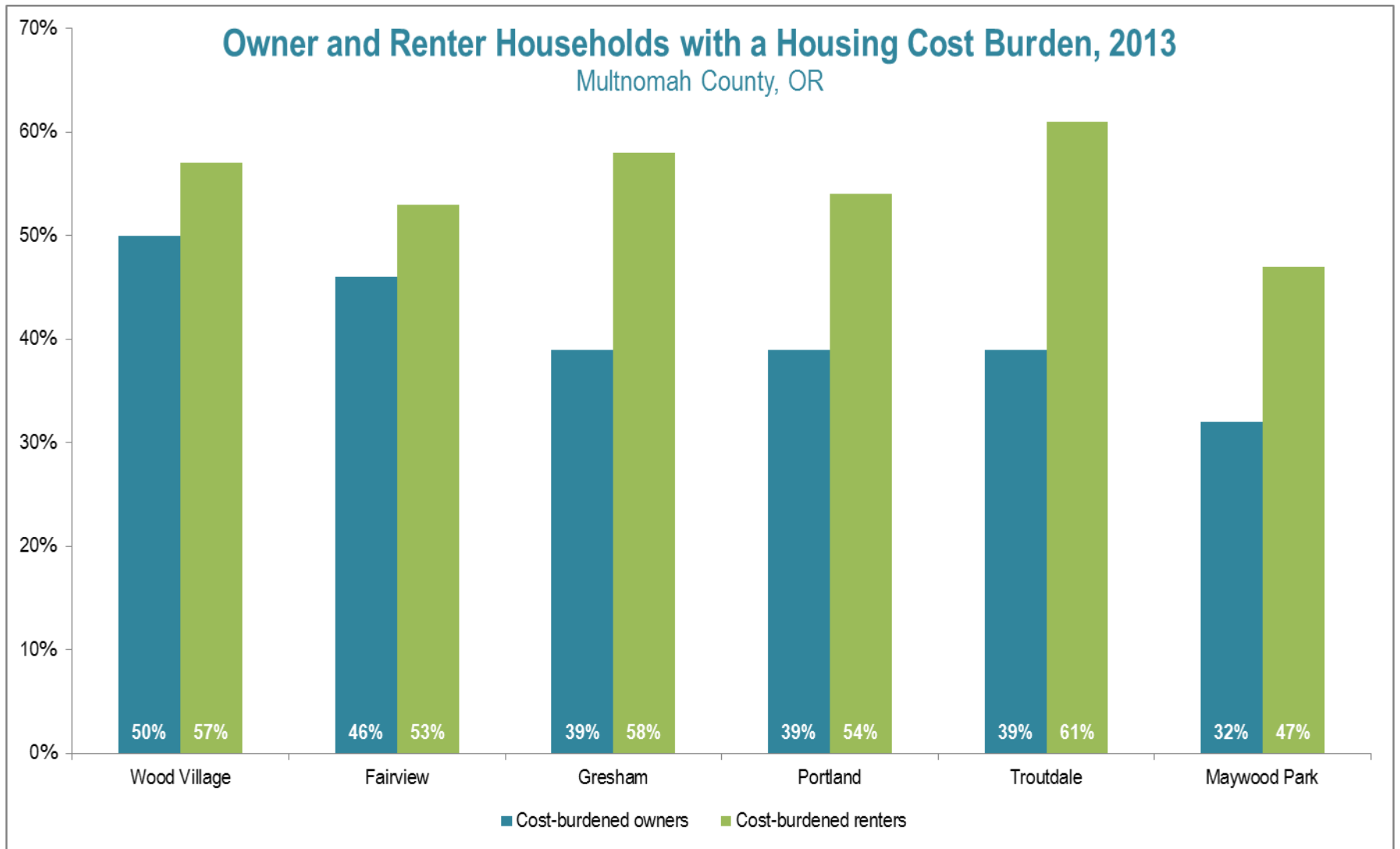
