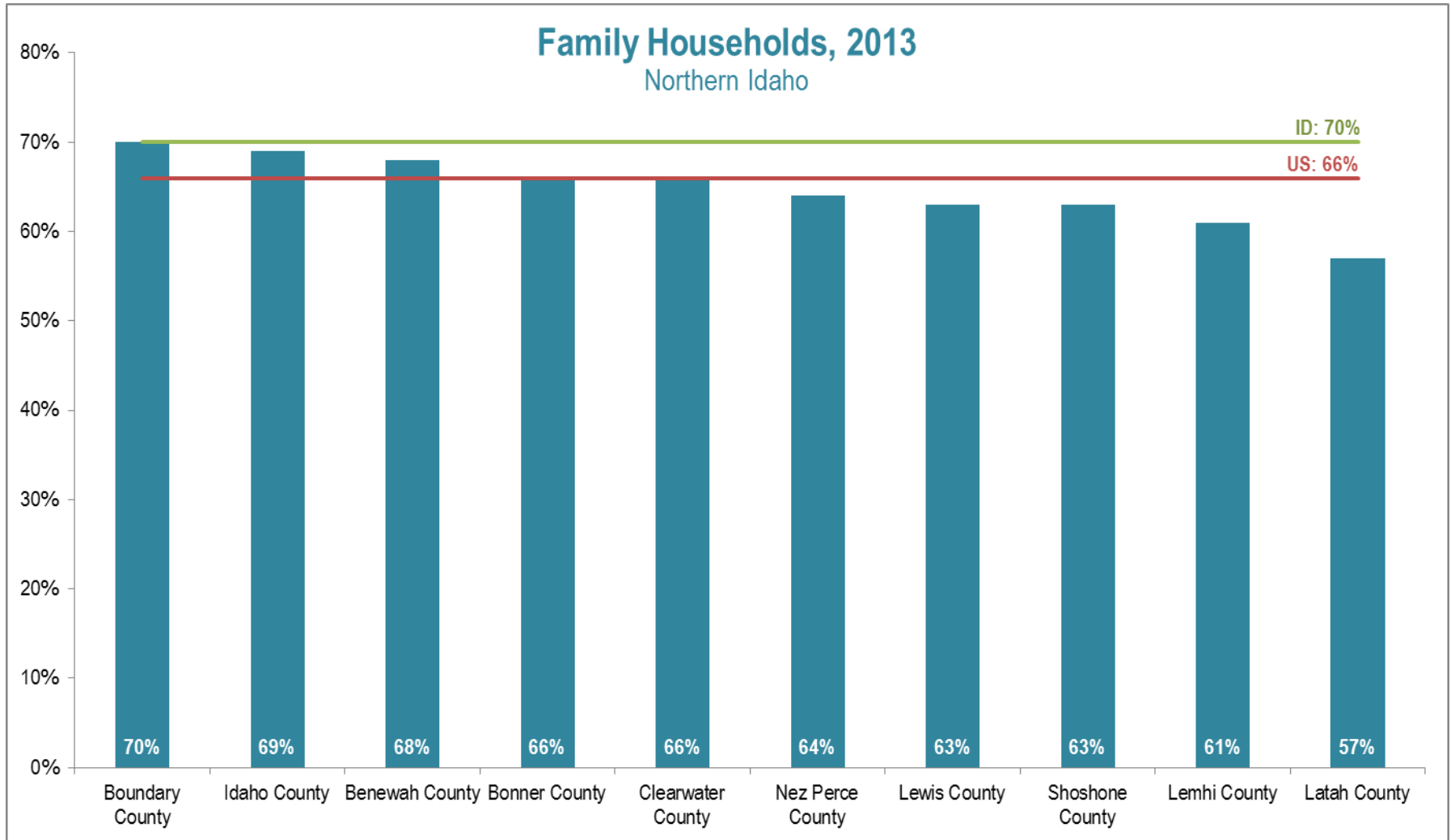

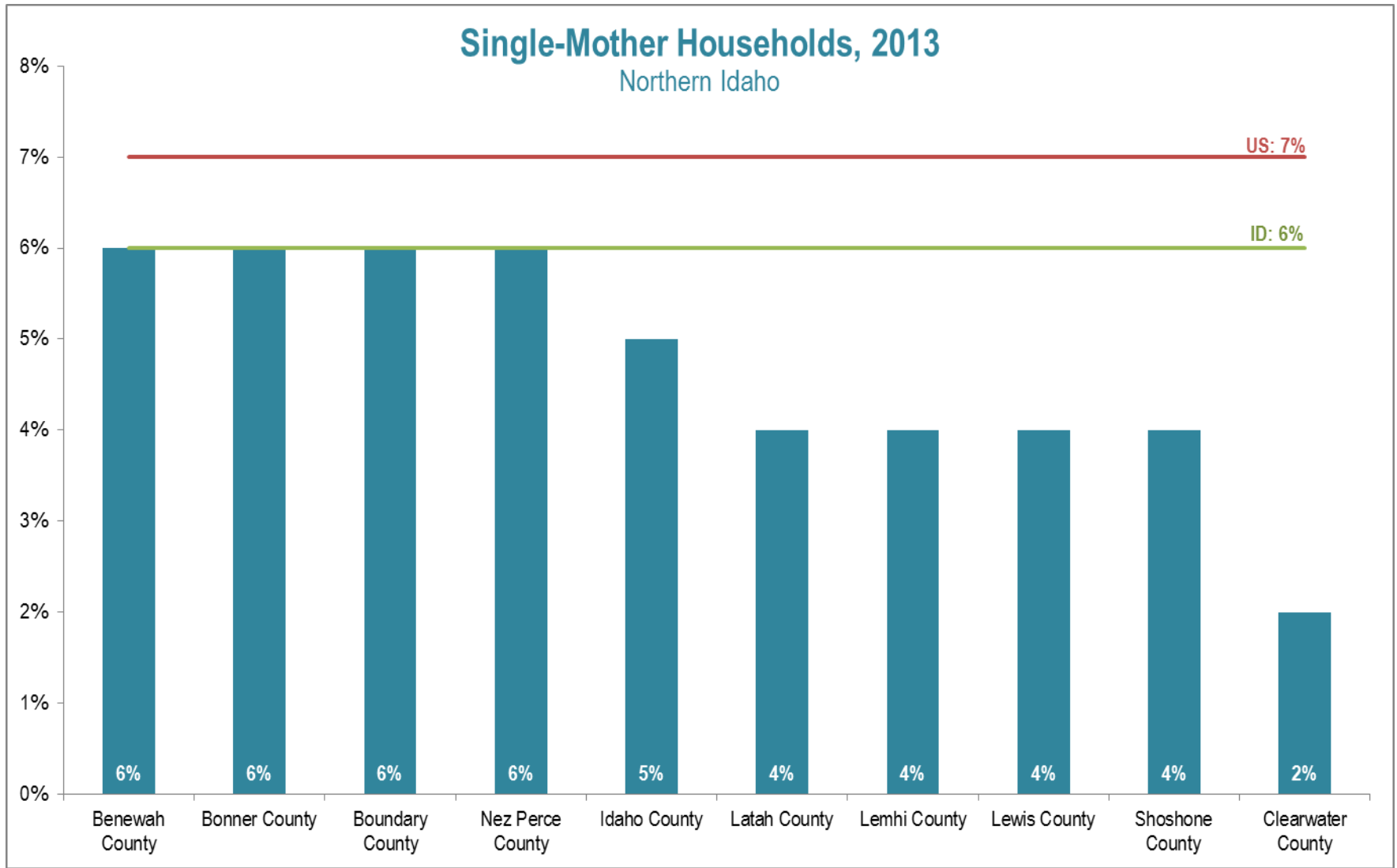

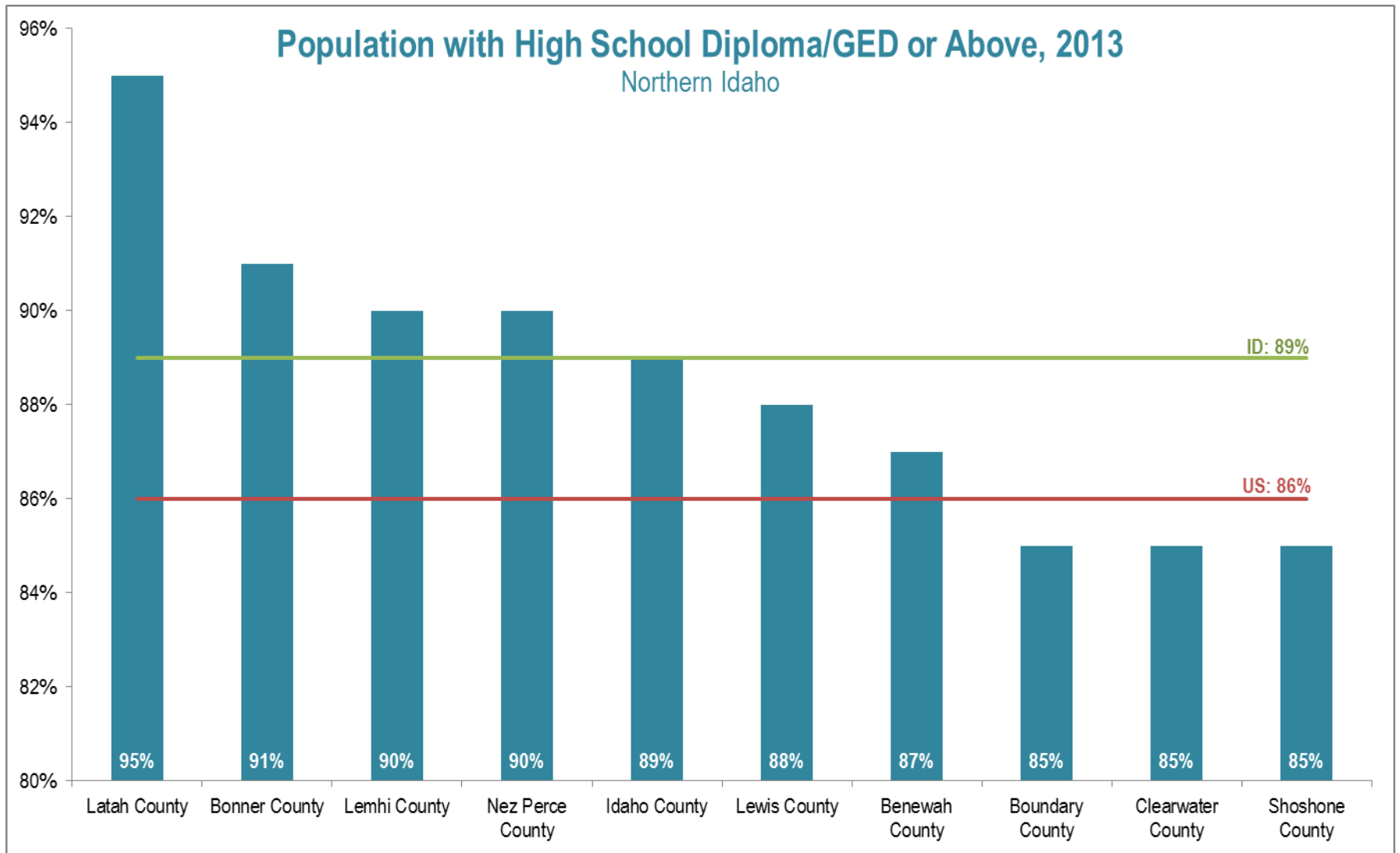

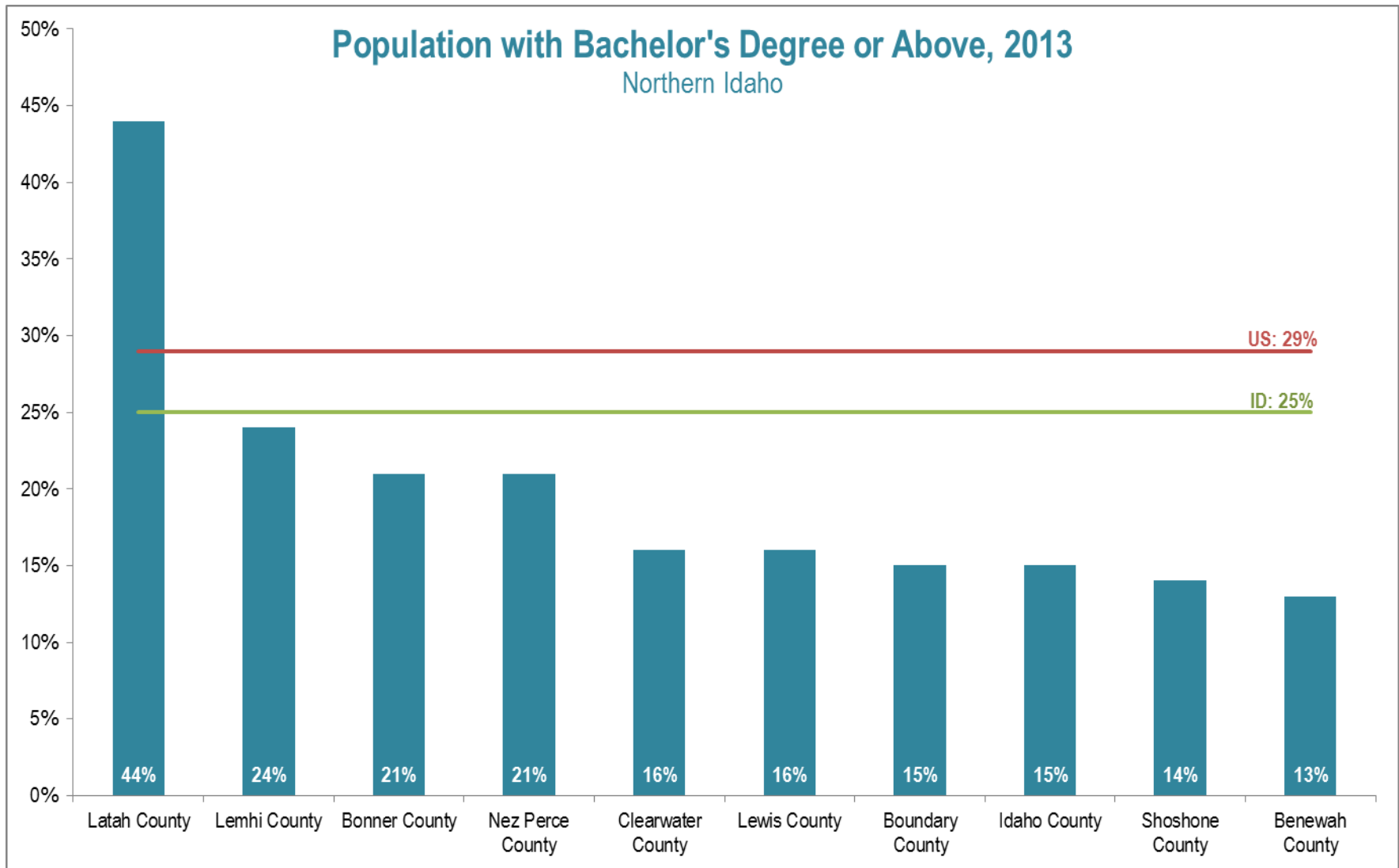

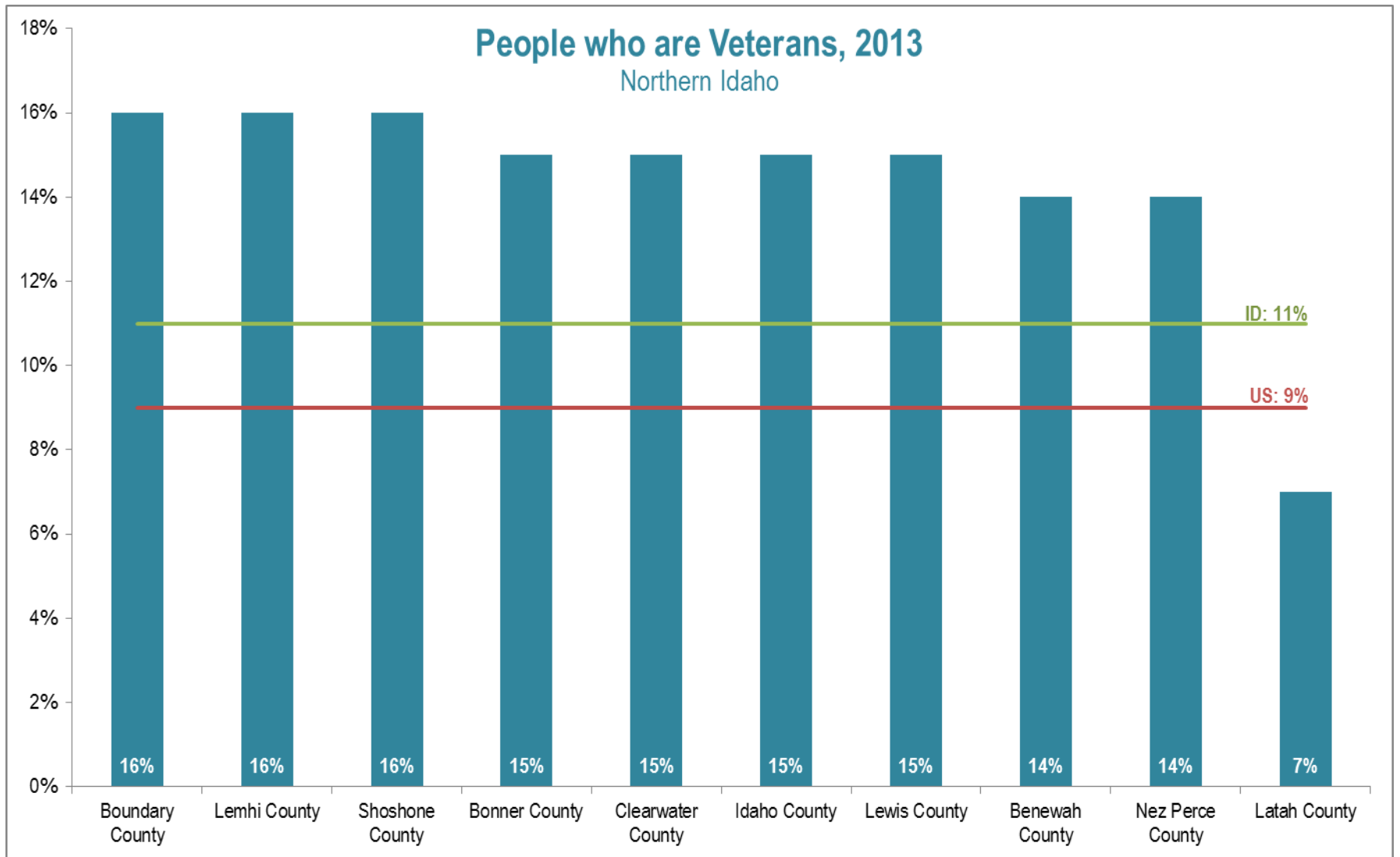

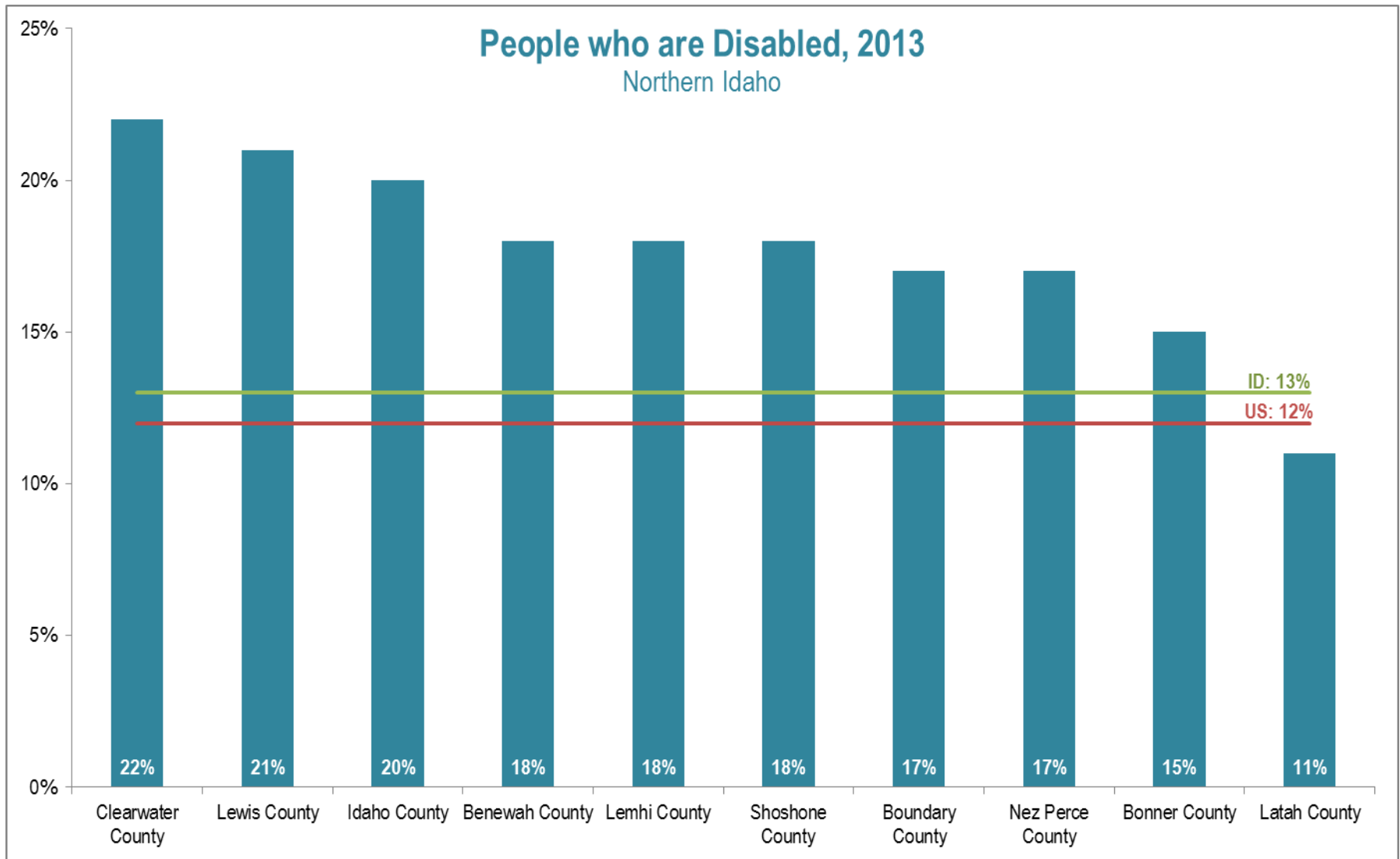

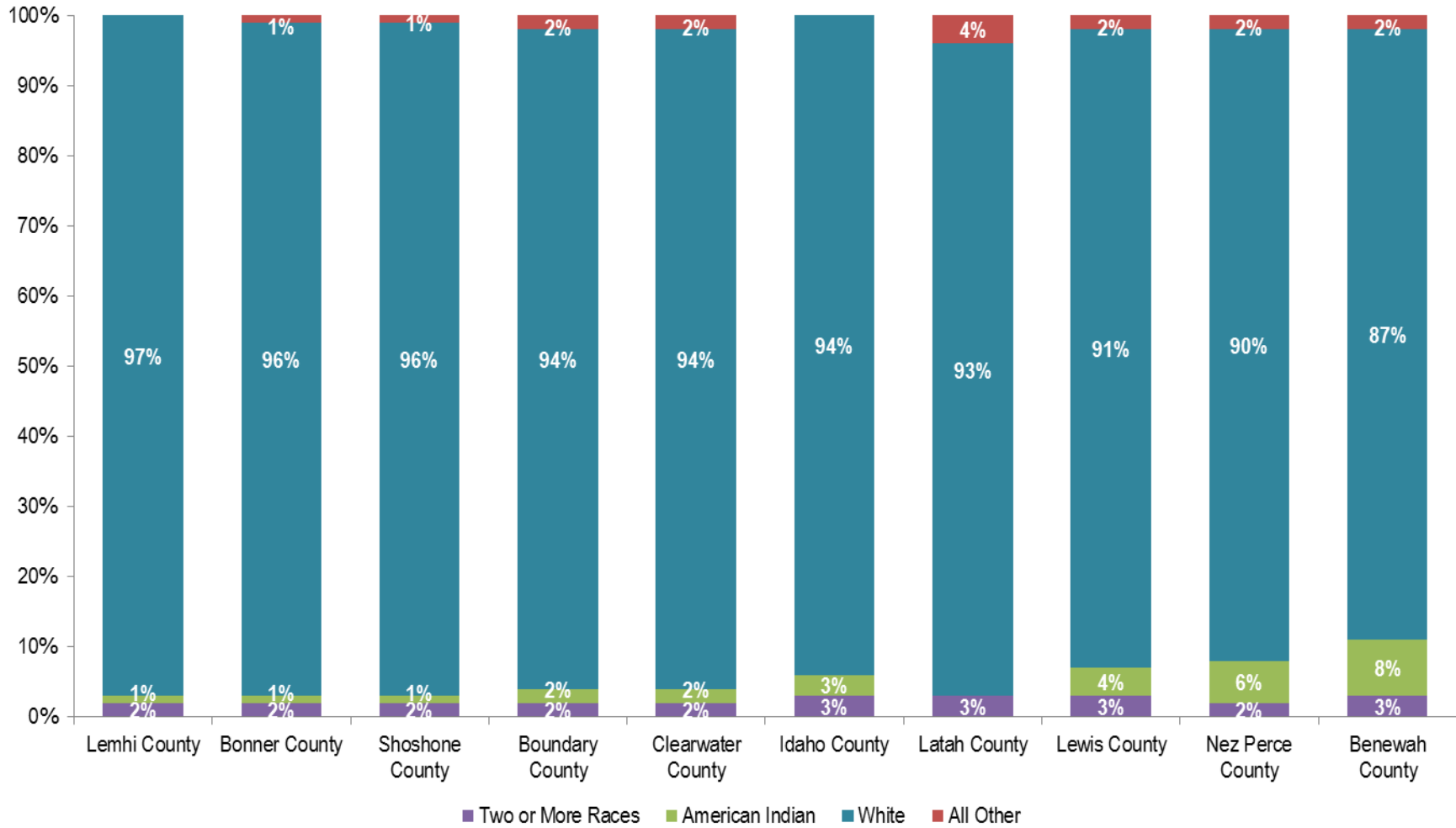

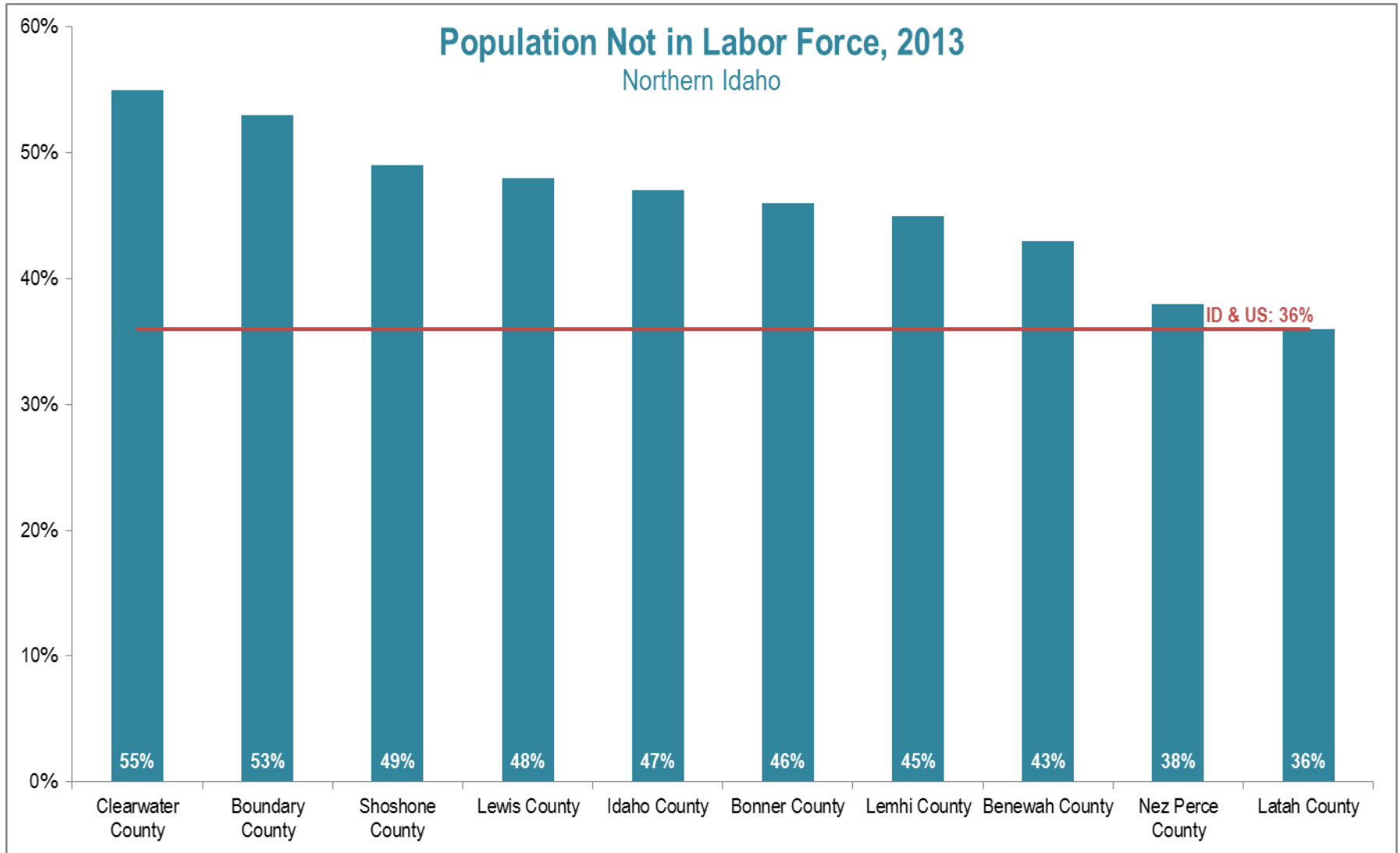

Population by Race, 2013 Northern Idaho

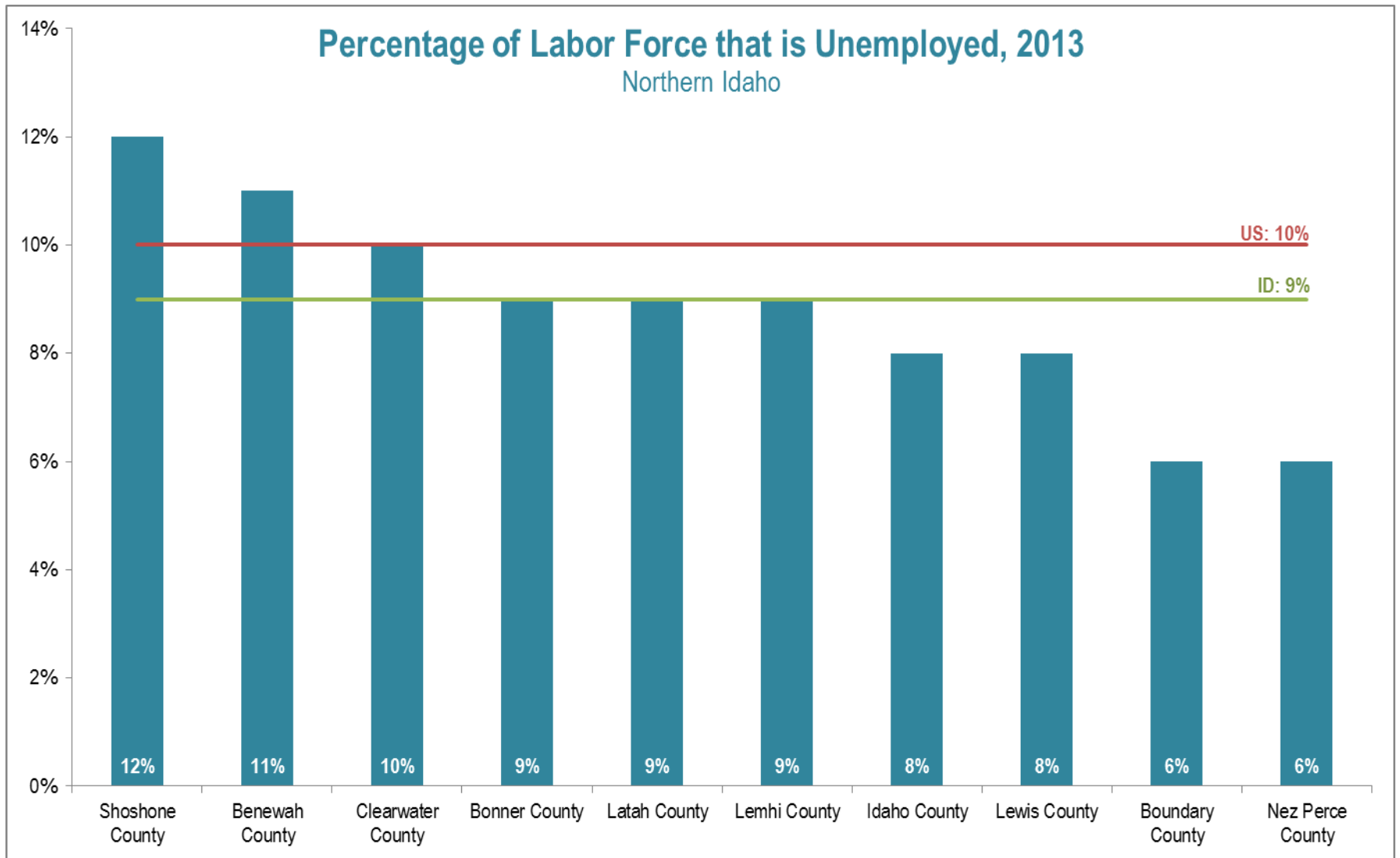

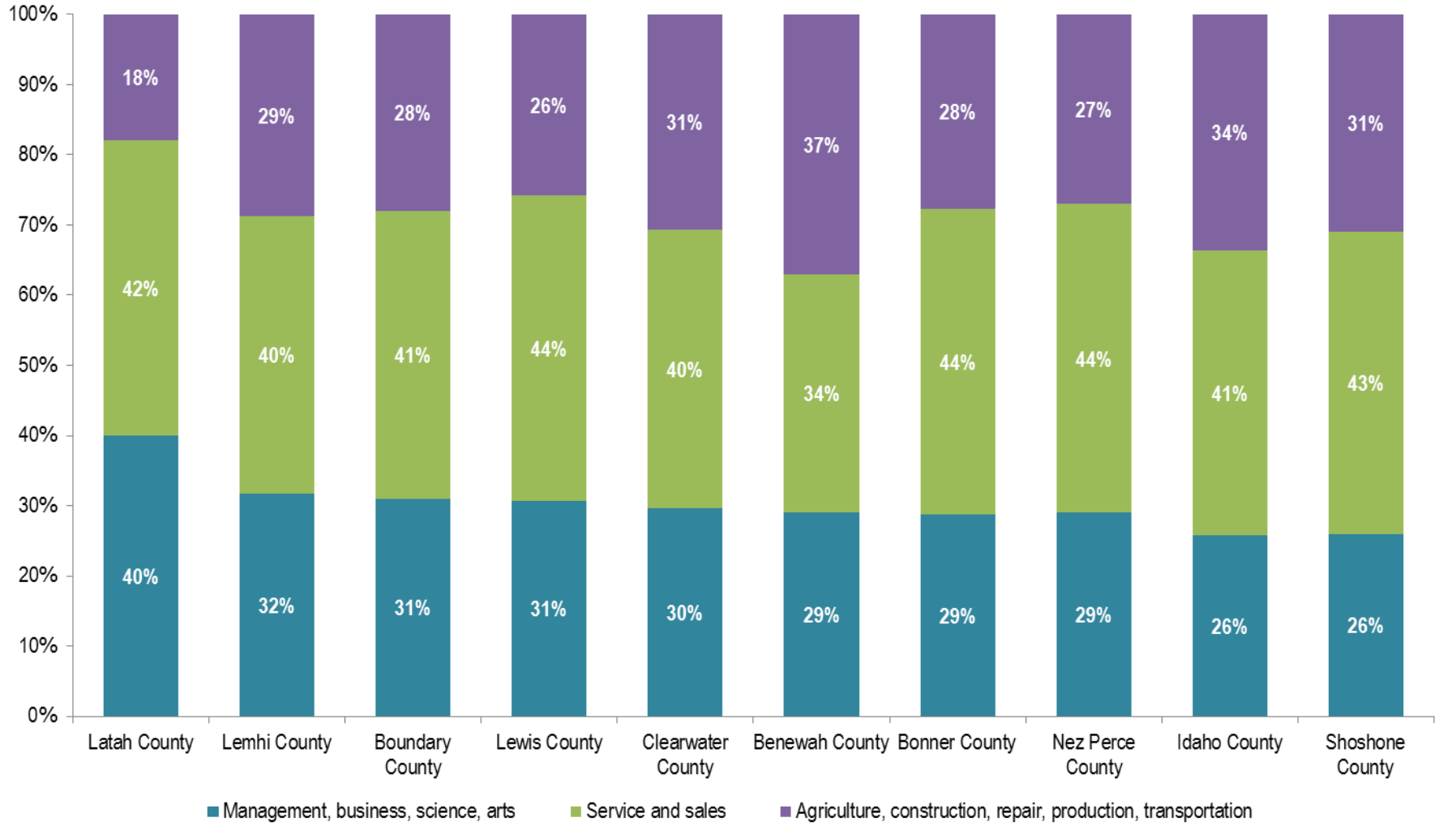

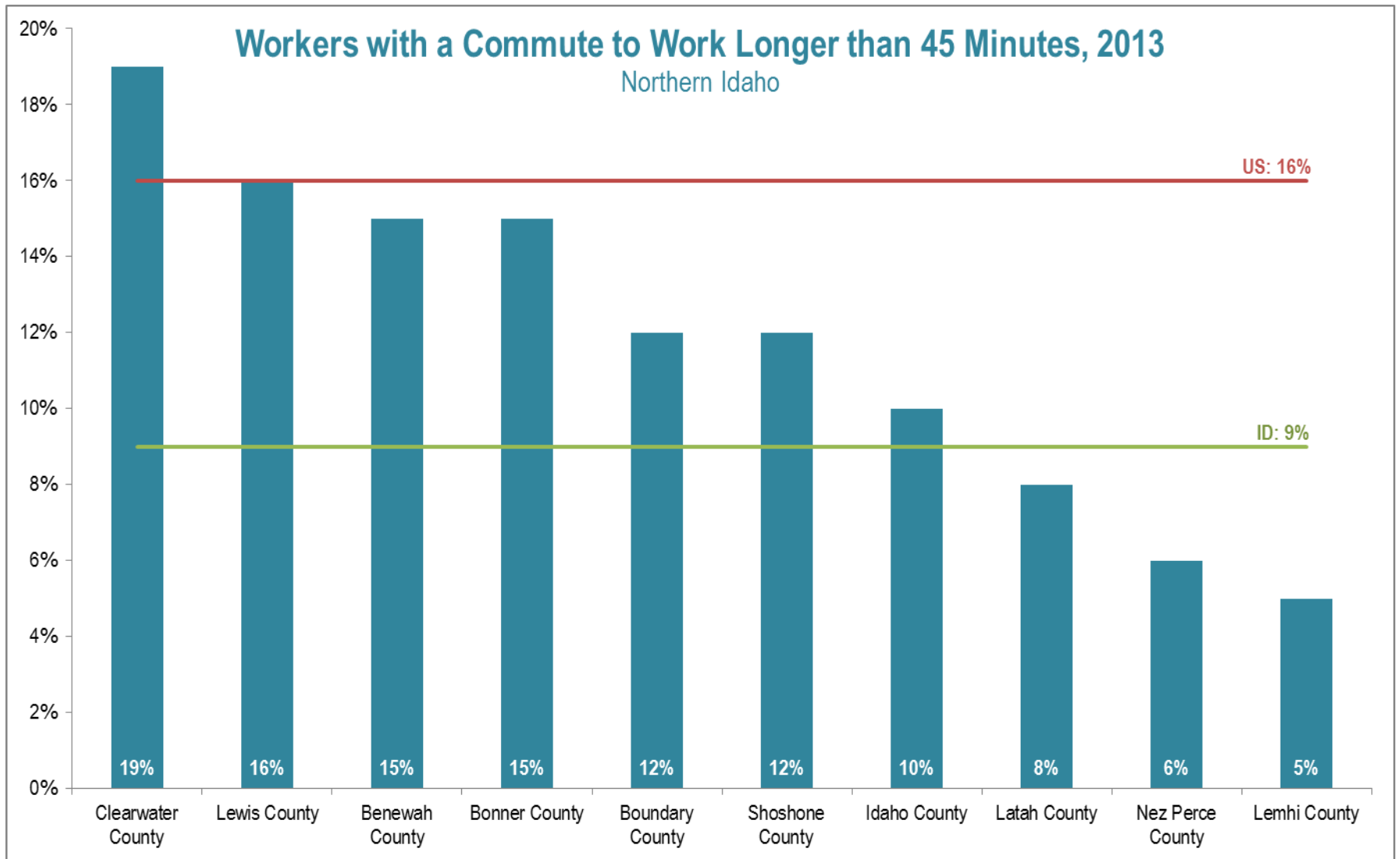

Population Over Age 16 by Occupation, 2013 Northern Idaho

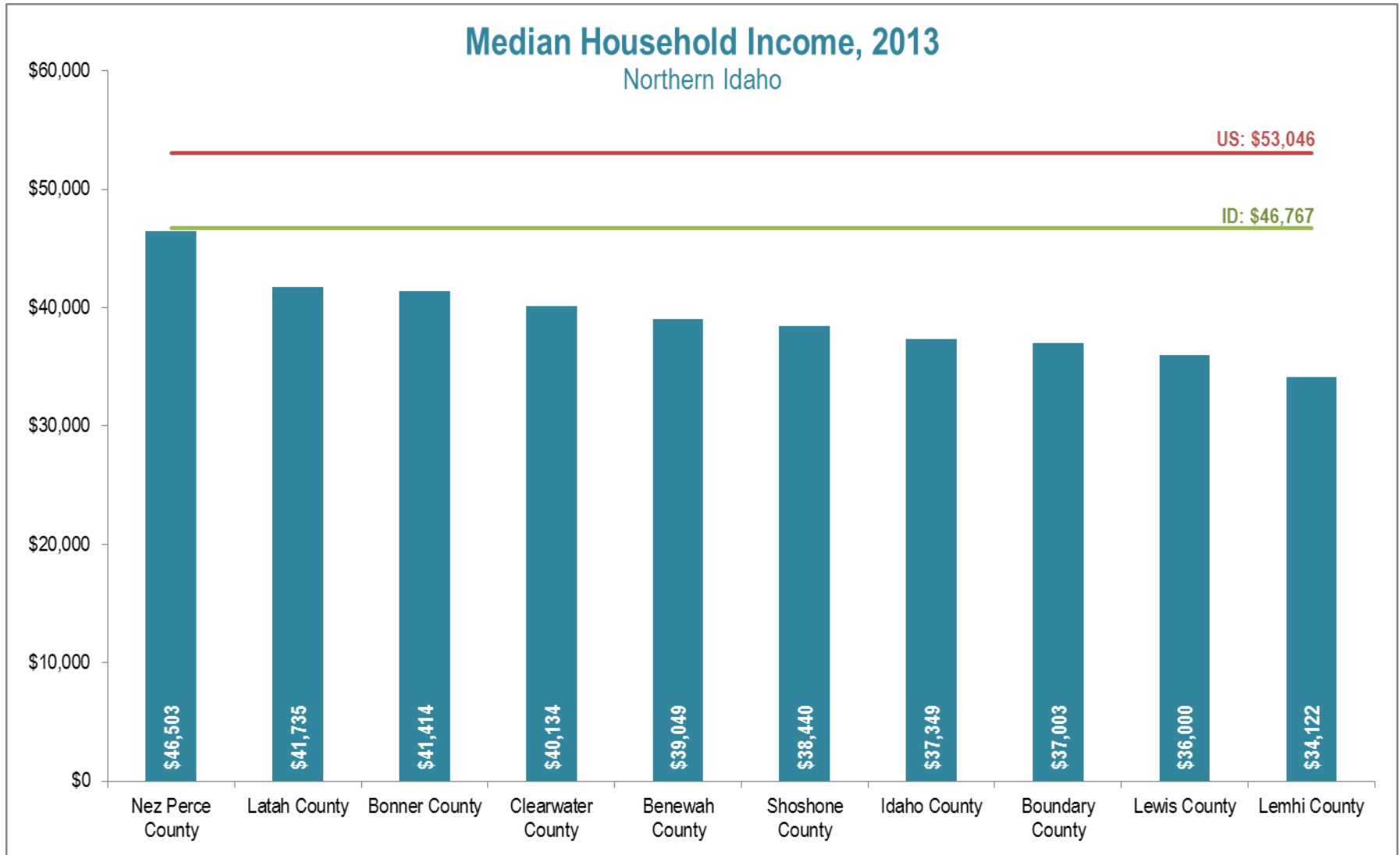

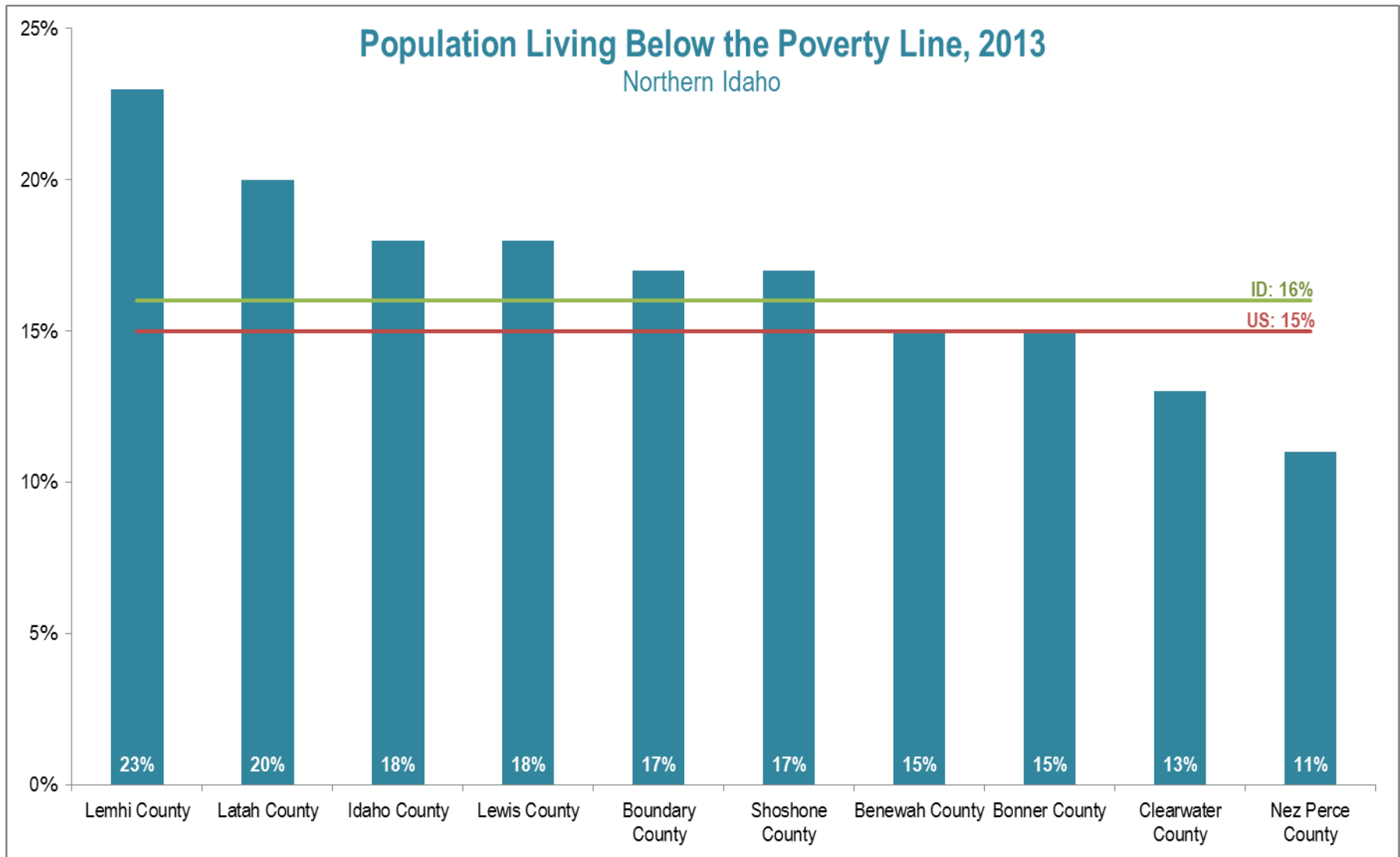

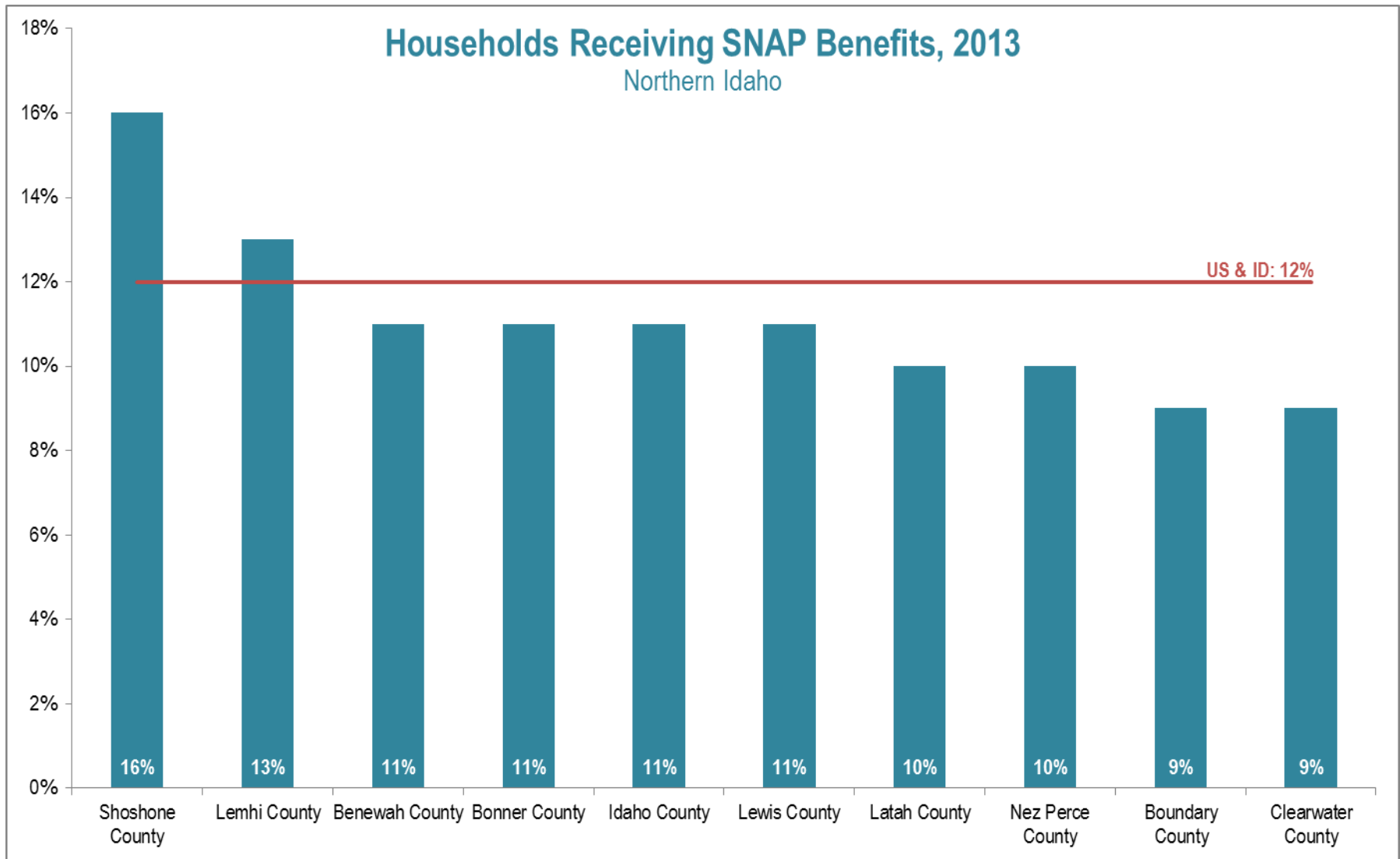

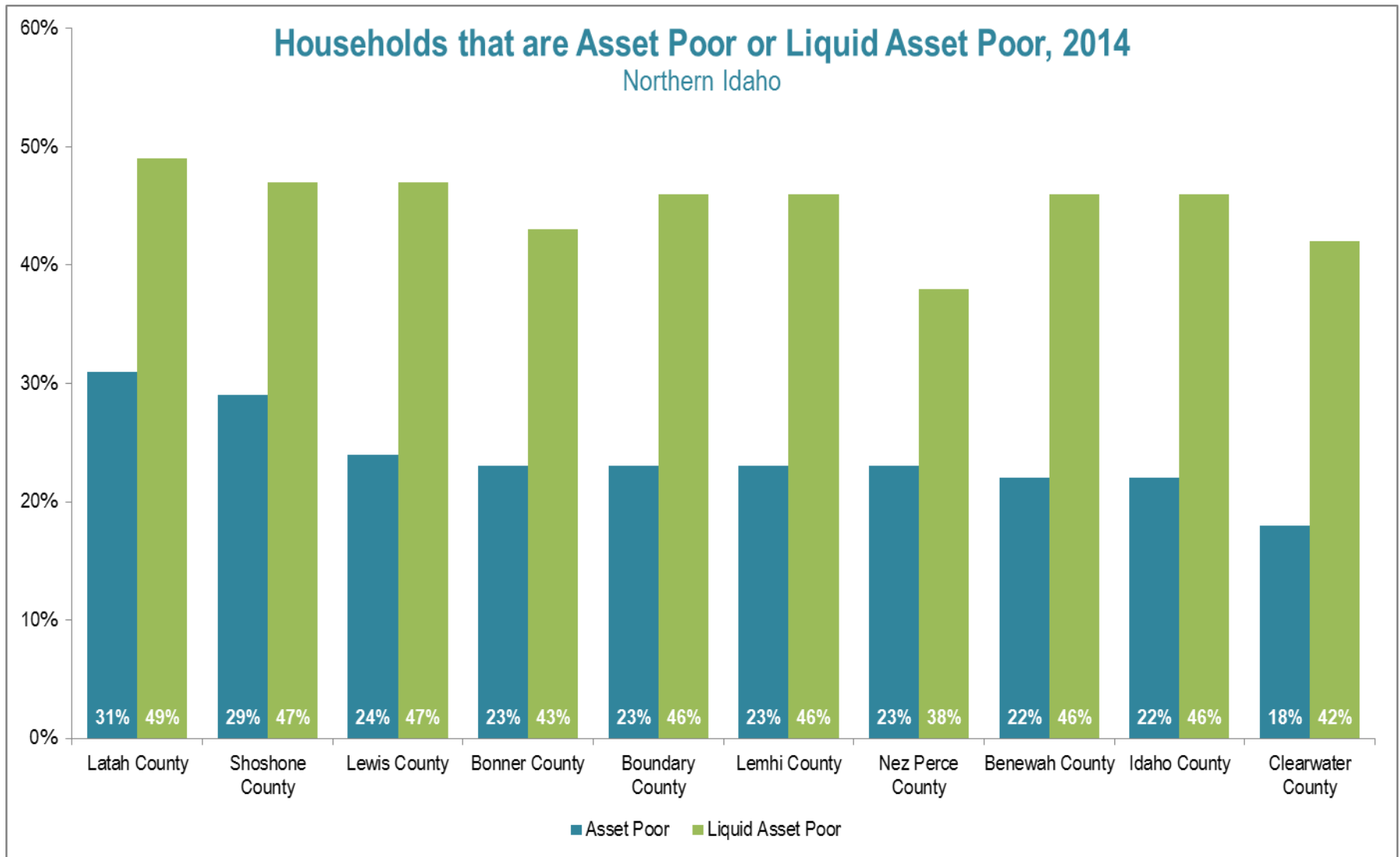

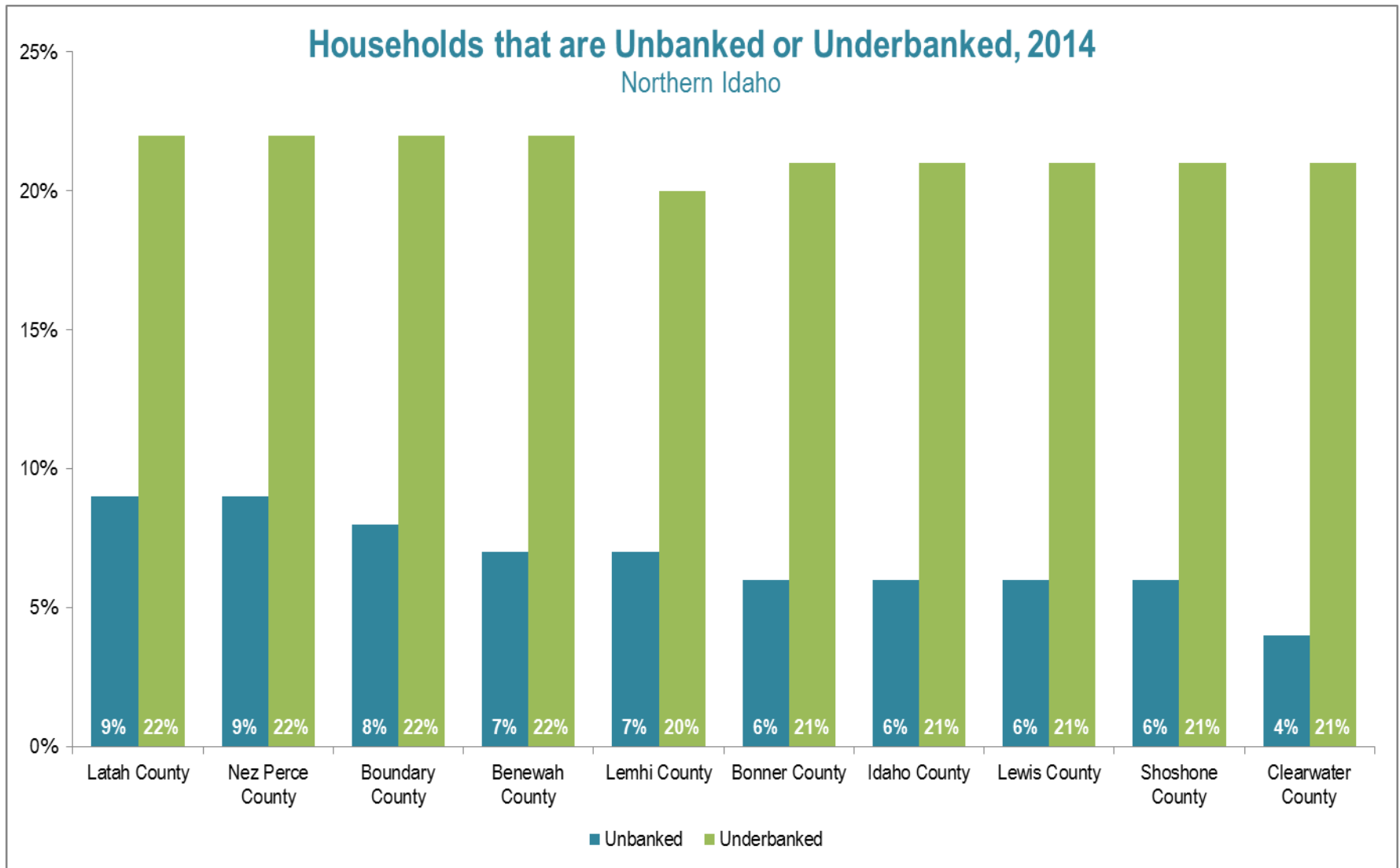

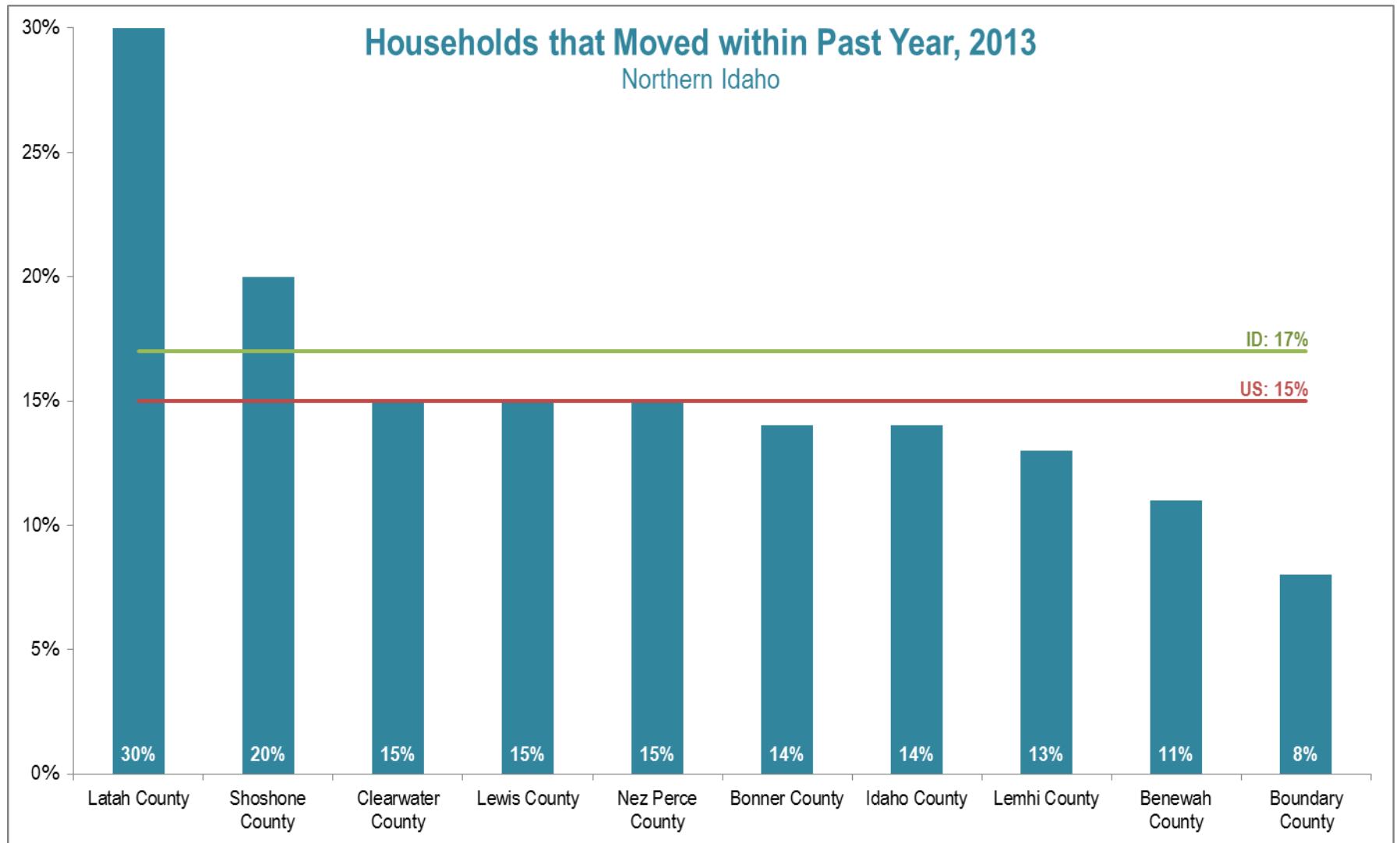

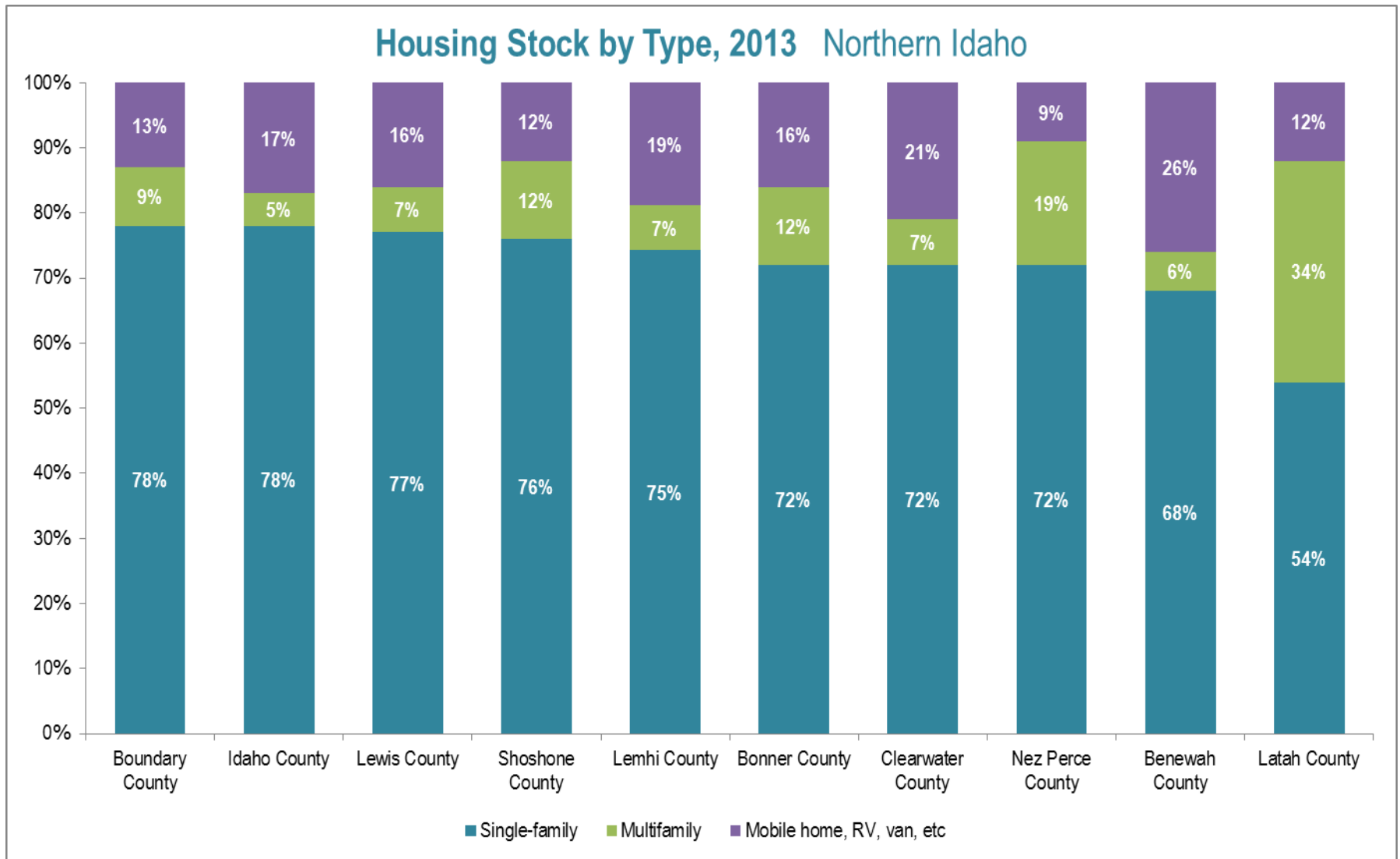

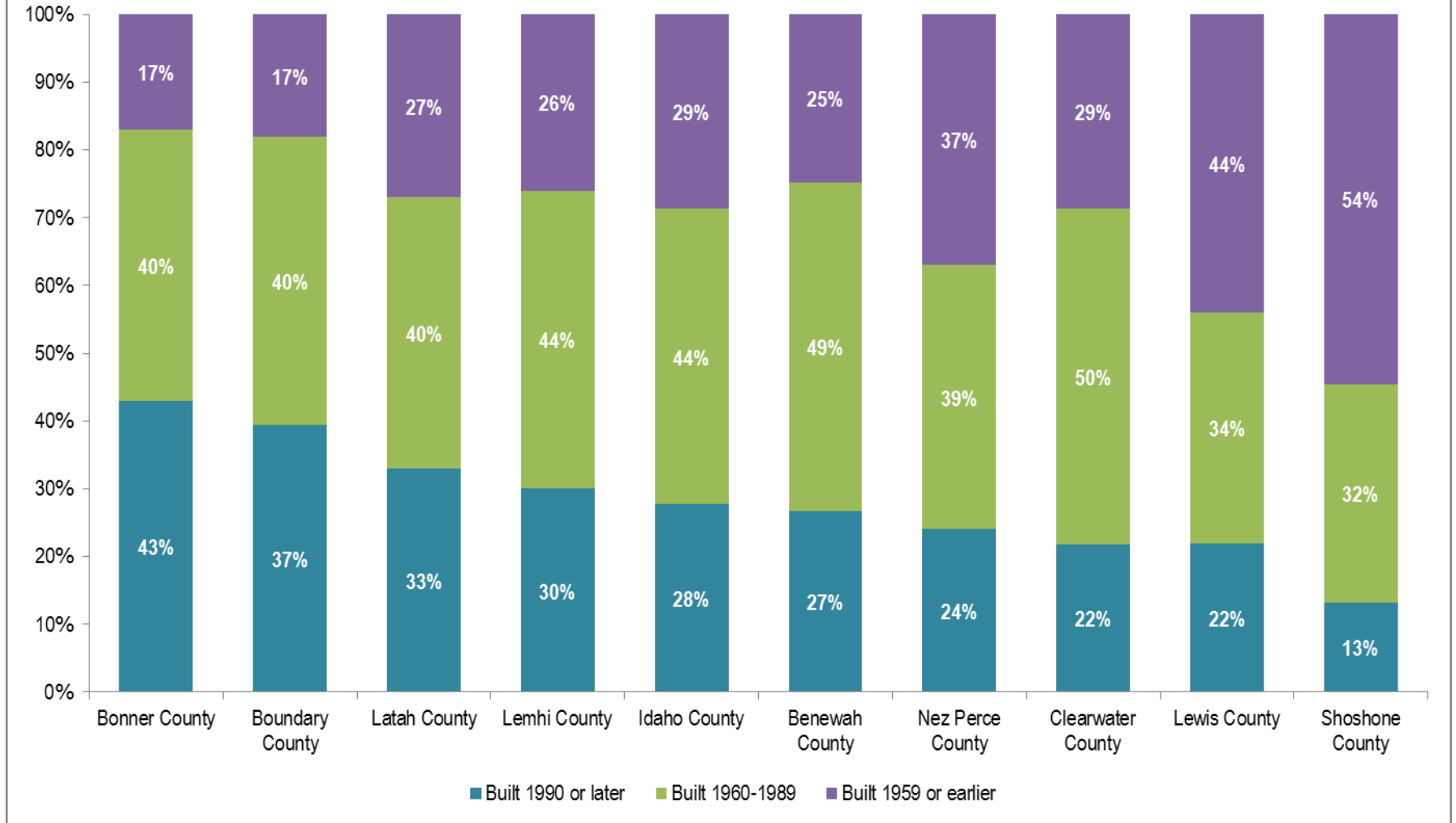

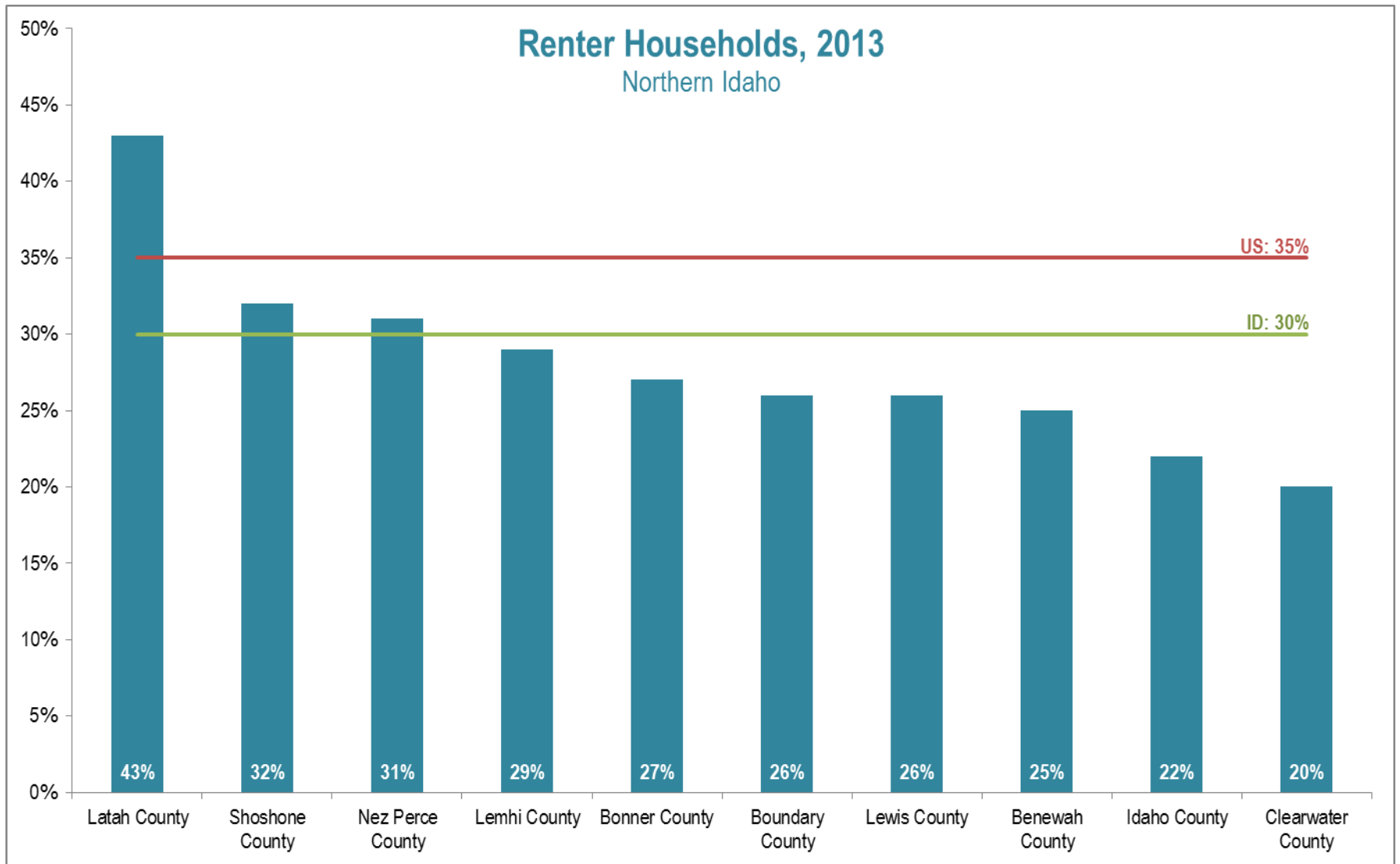

Housing Stock by Year Constructed, 2013 Northern Idaho



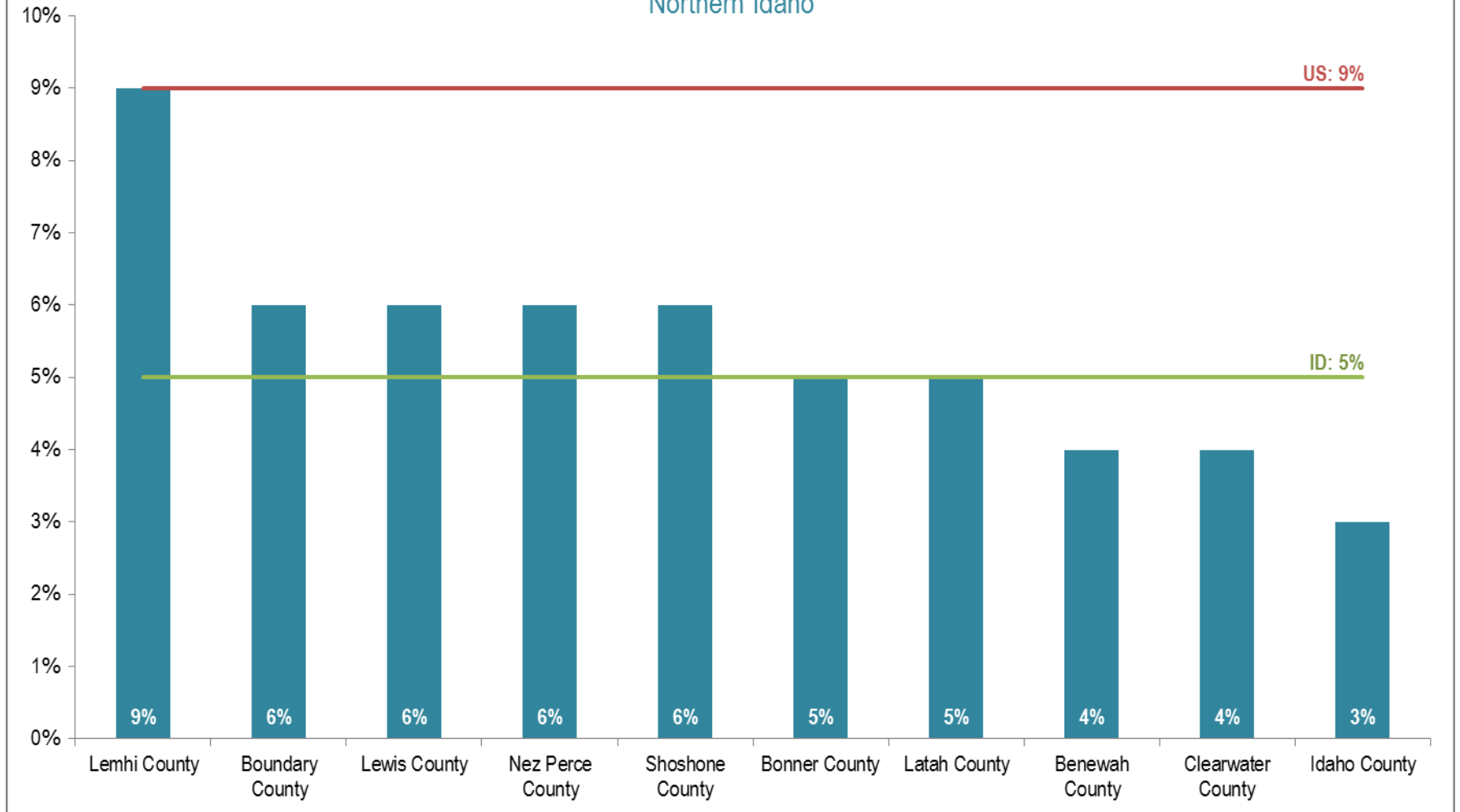

Households with No Personal Vehicles Available, 2013

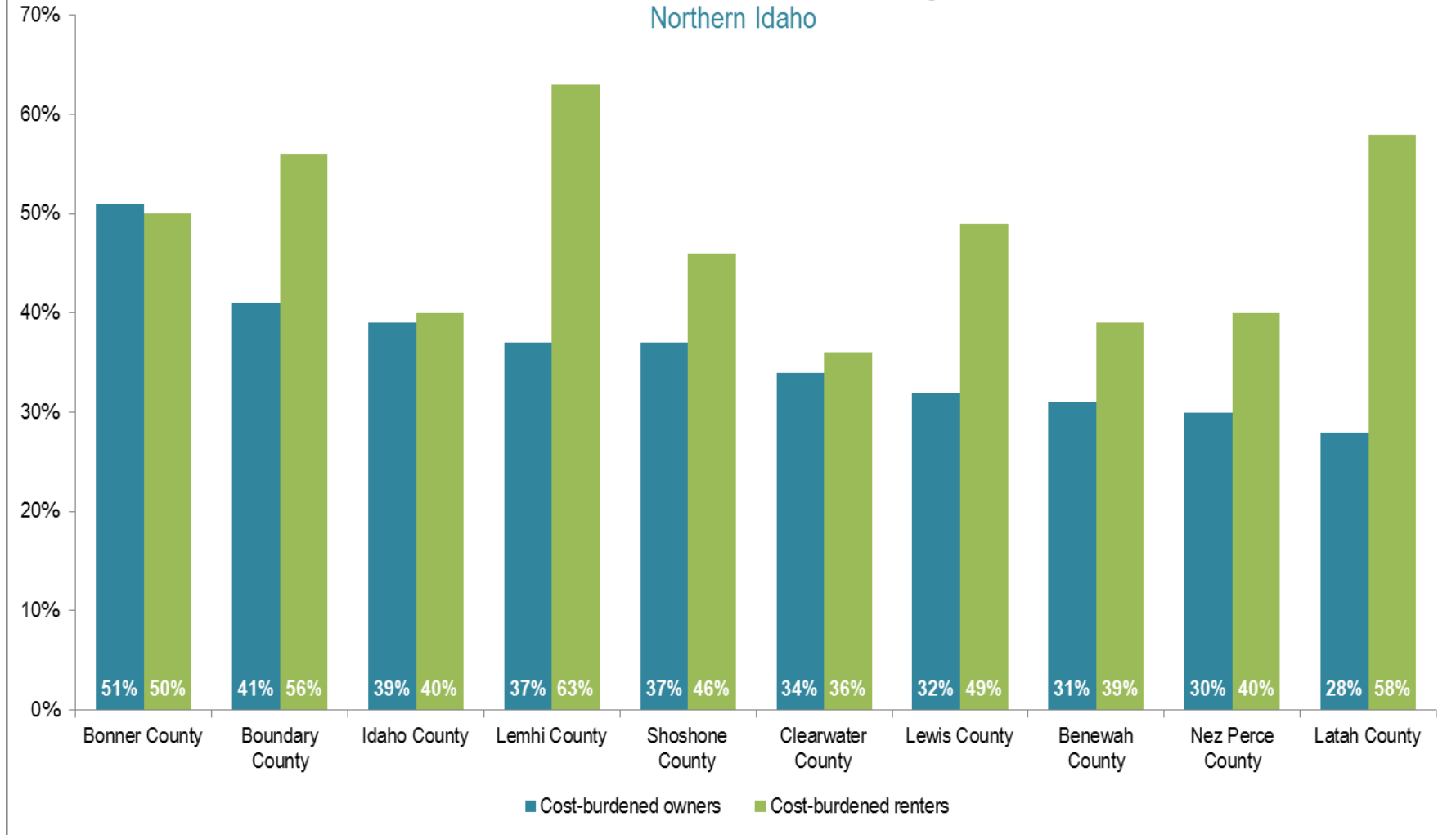
