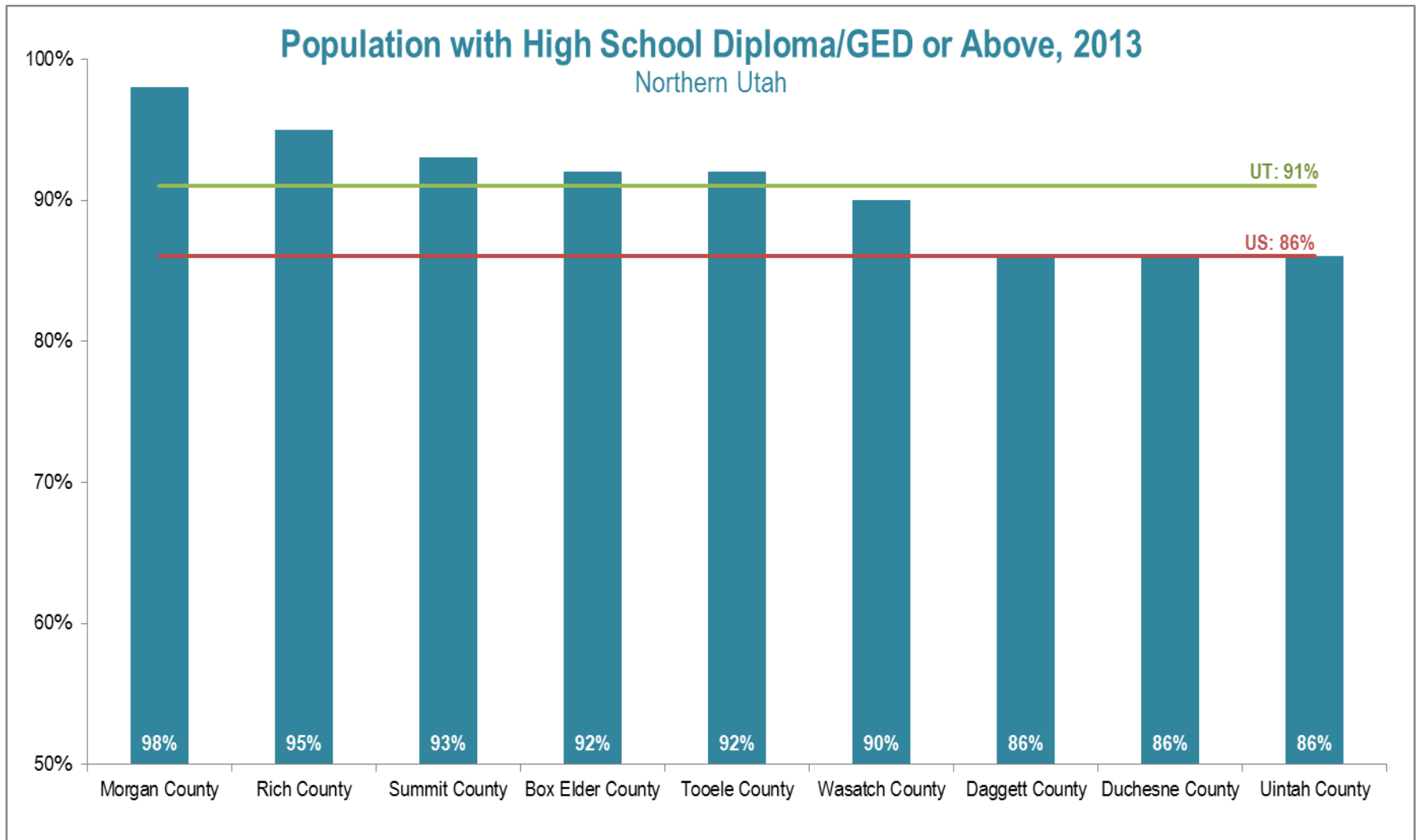

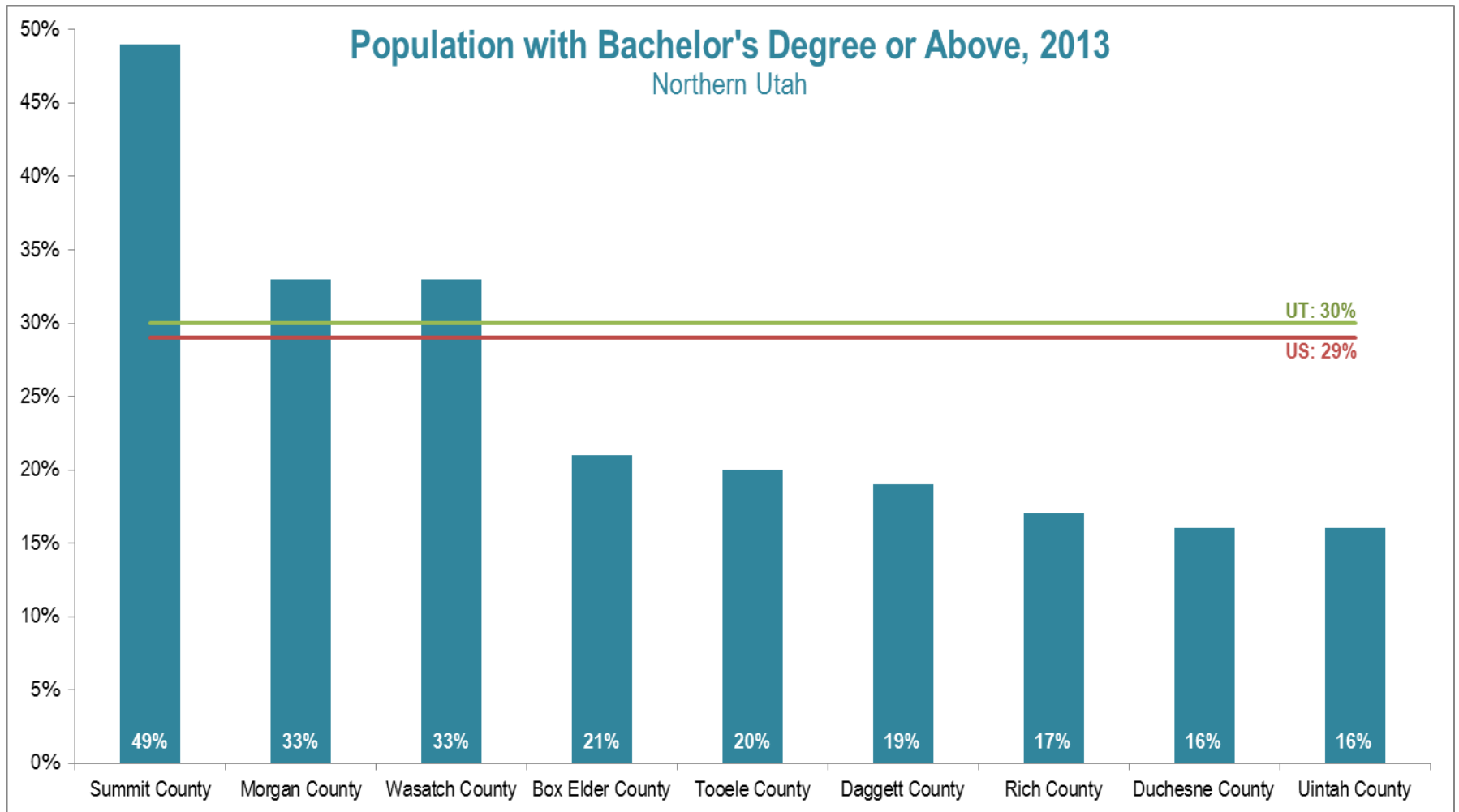

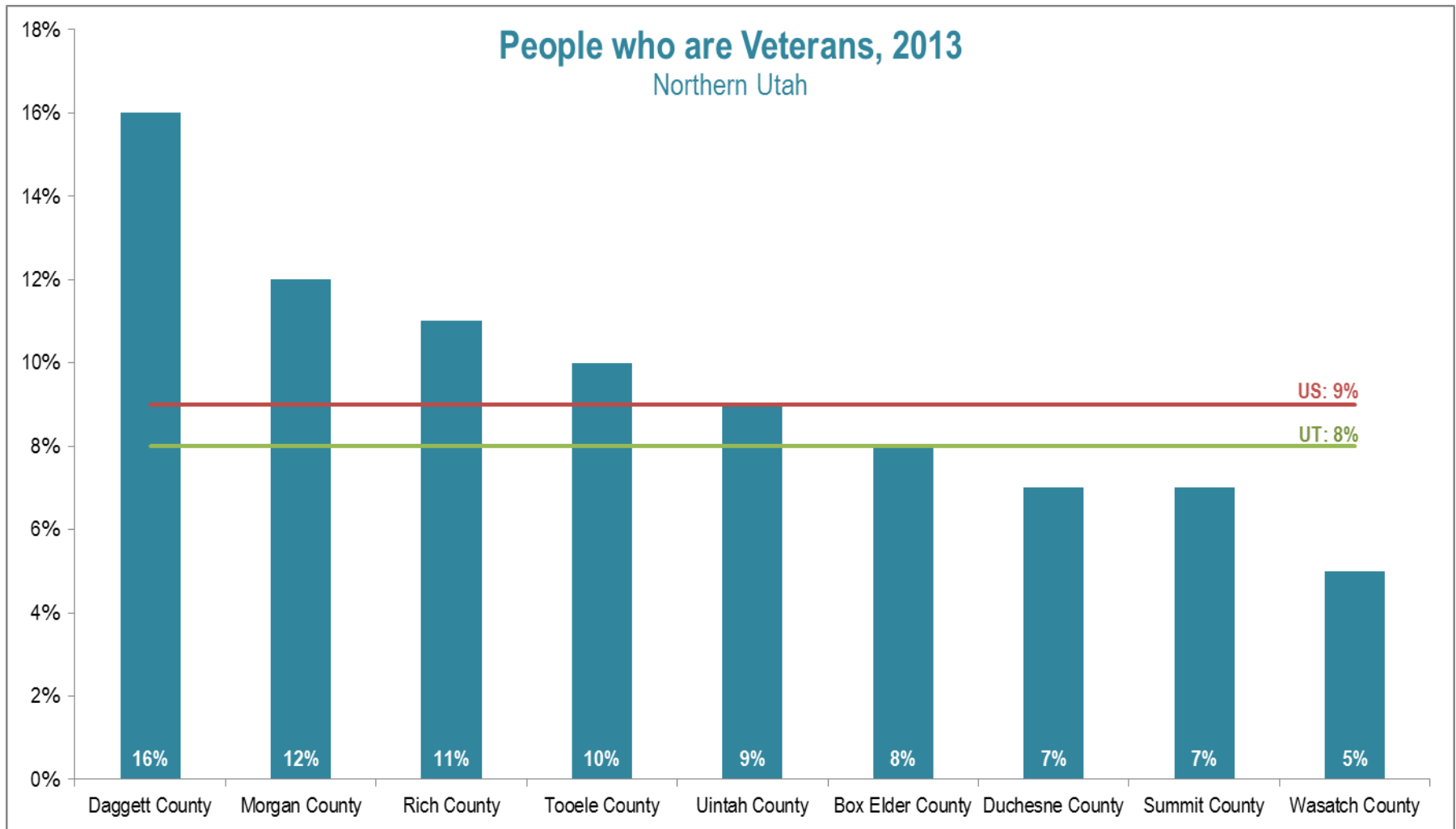

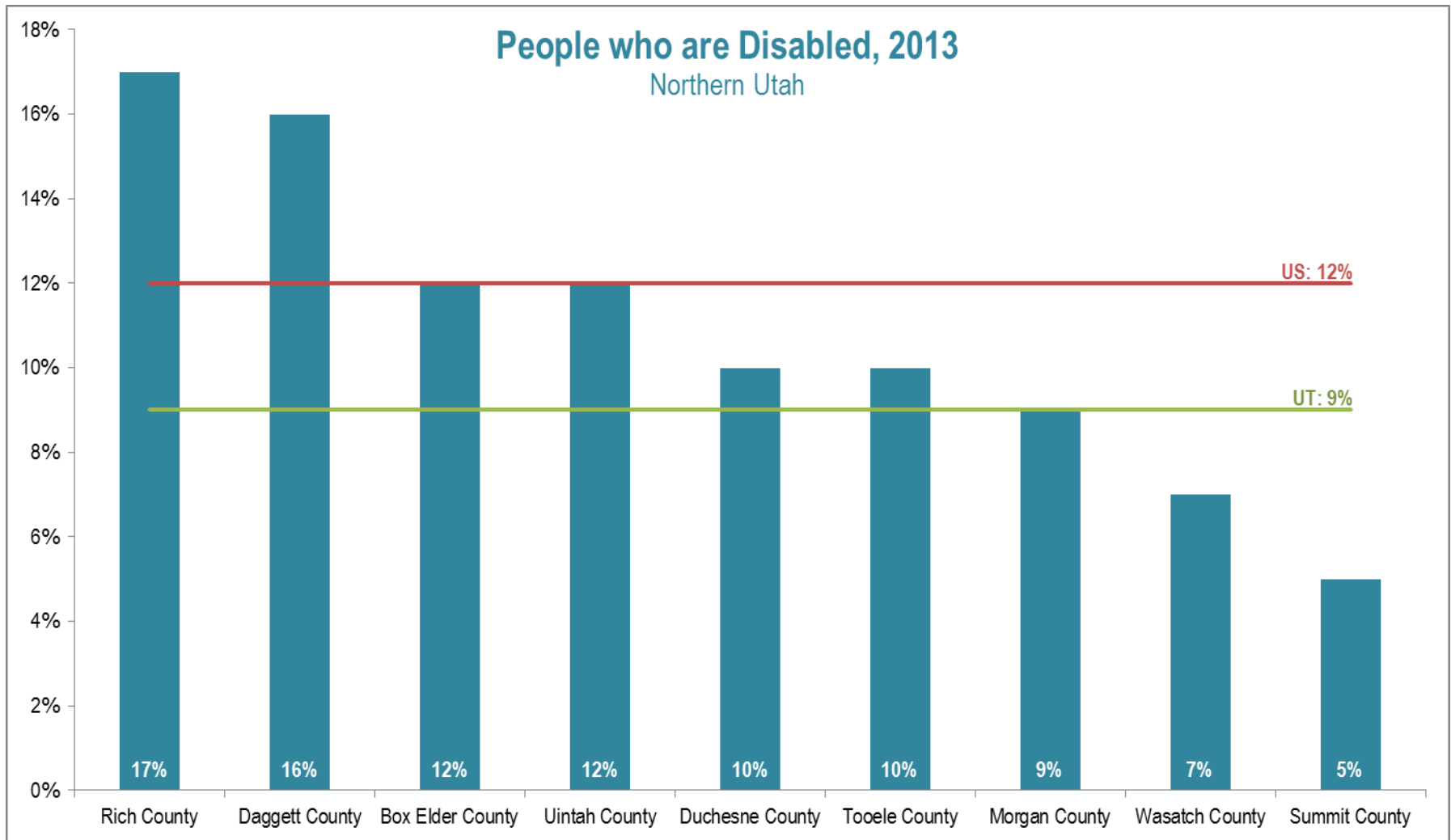

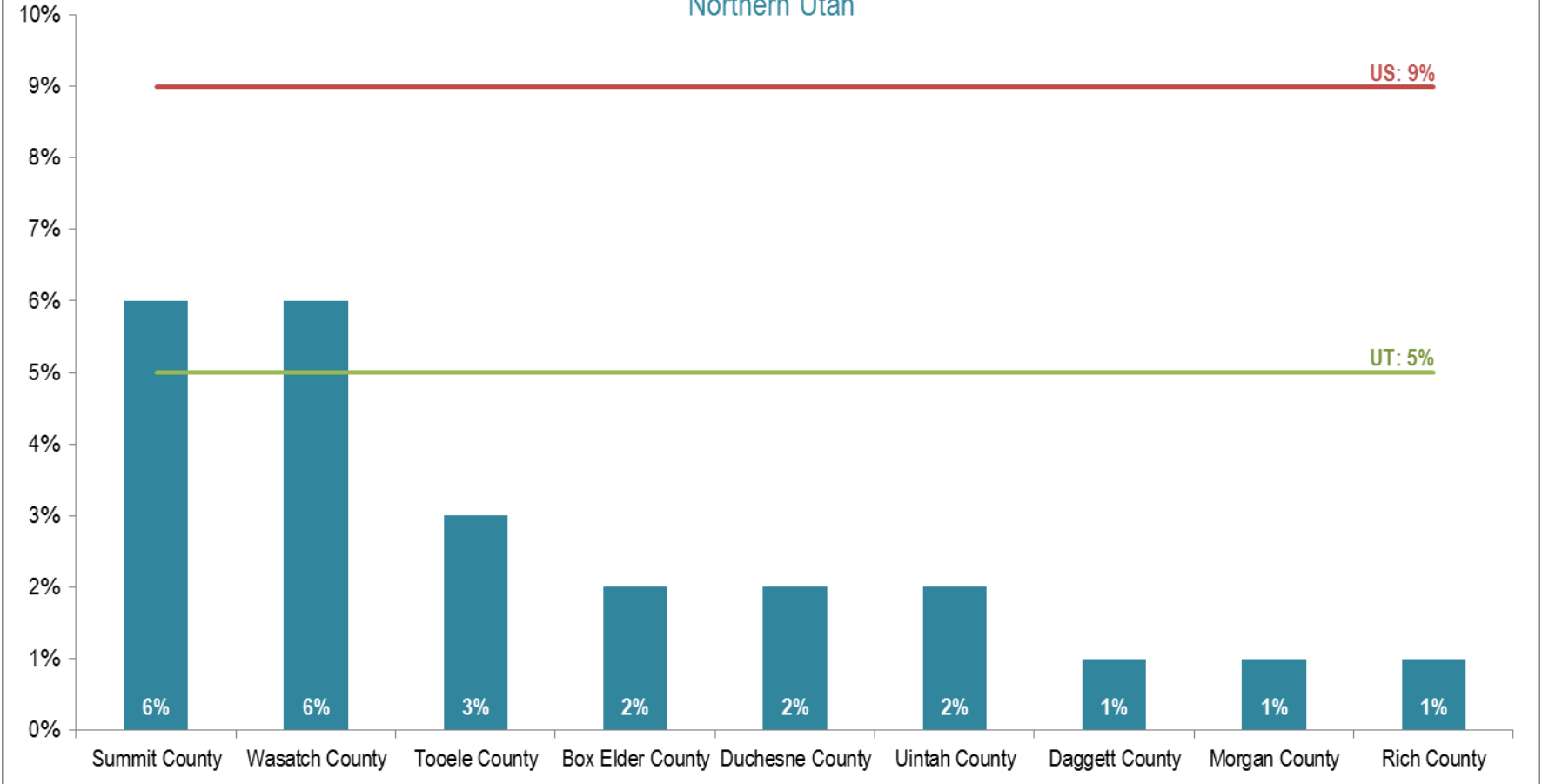

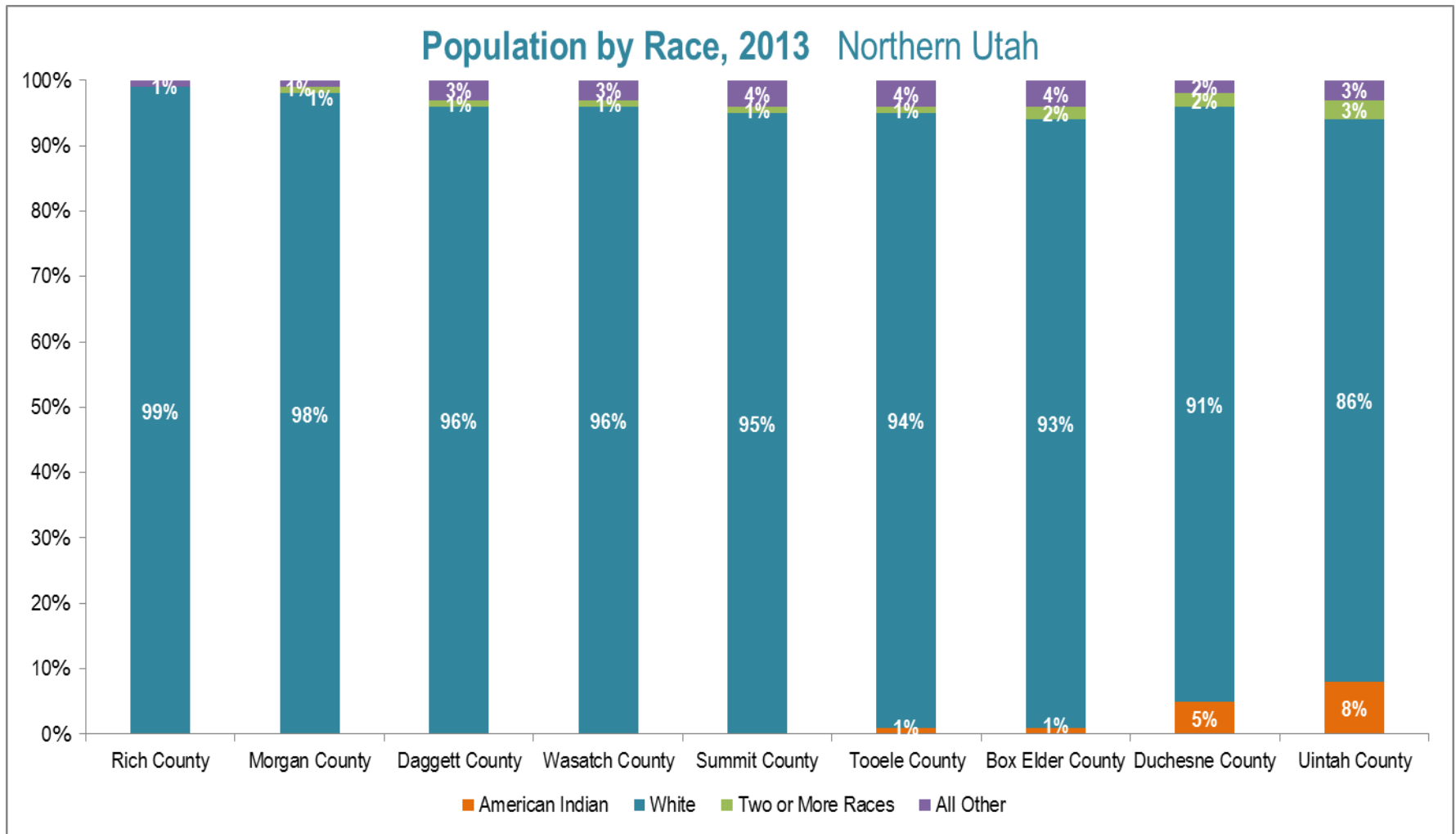

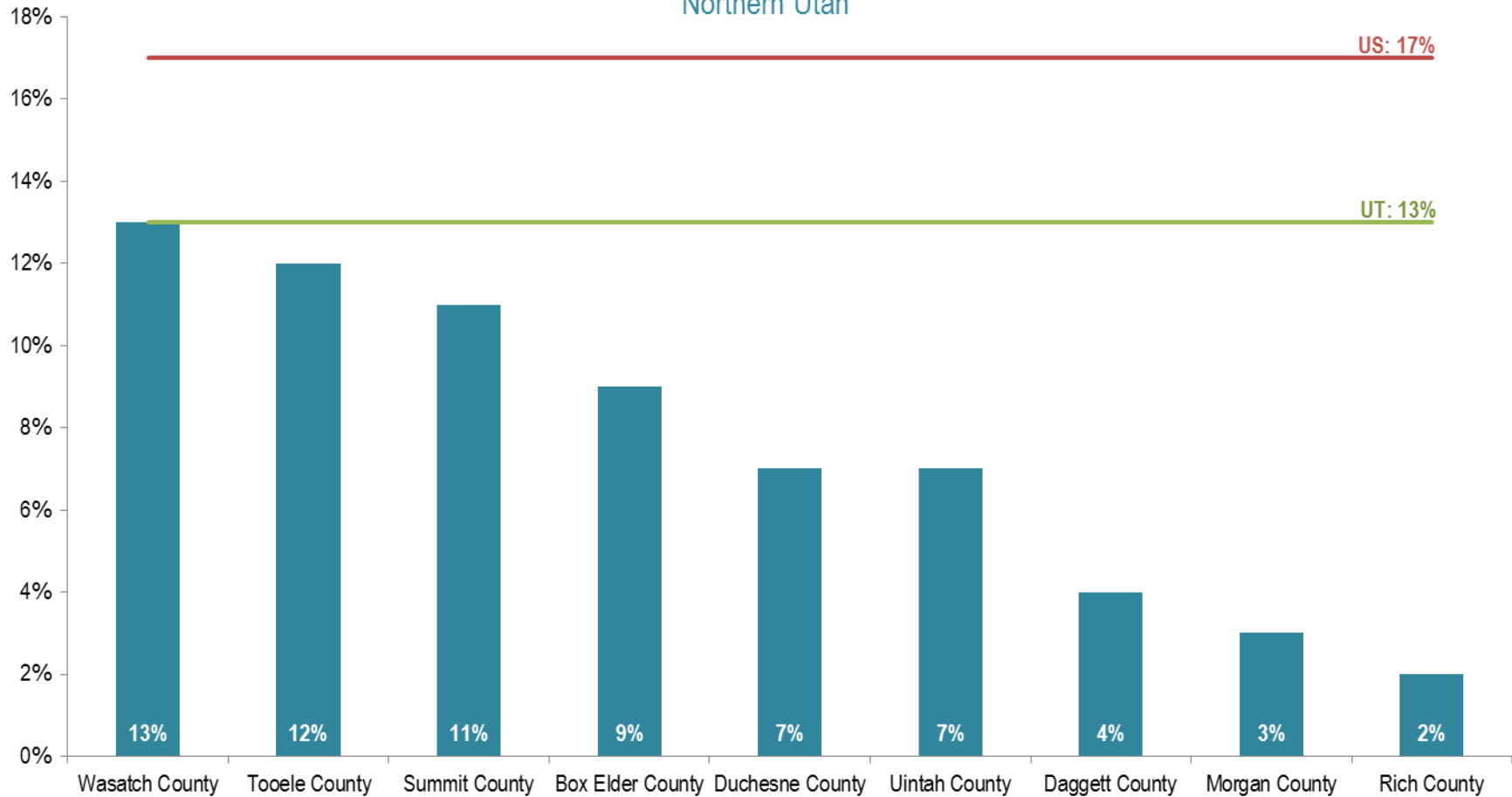

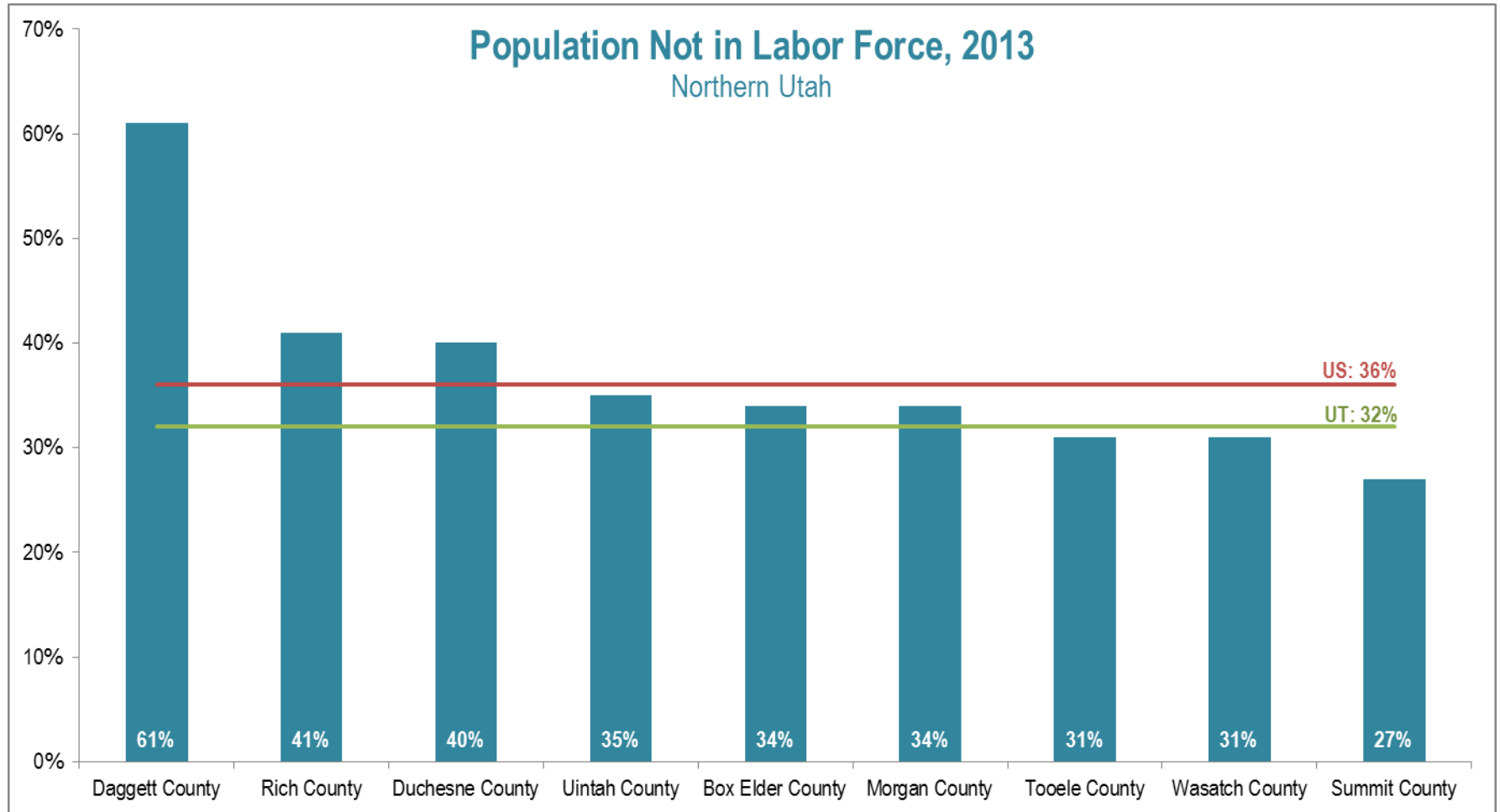

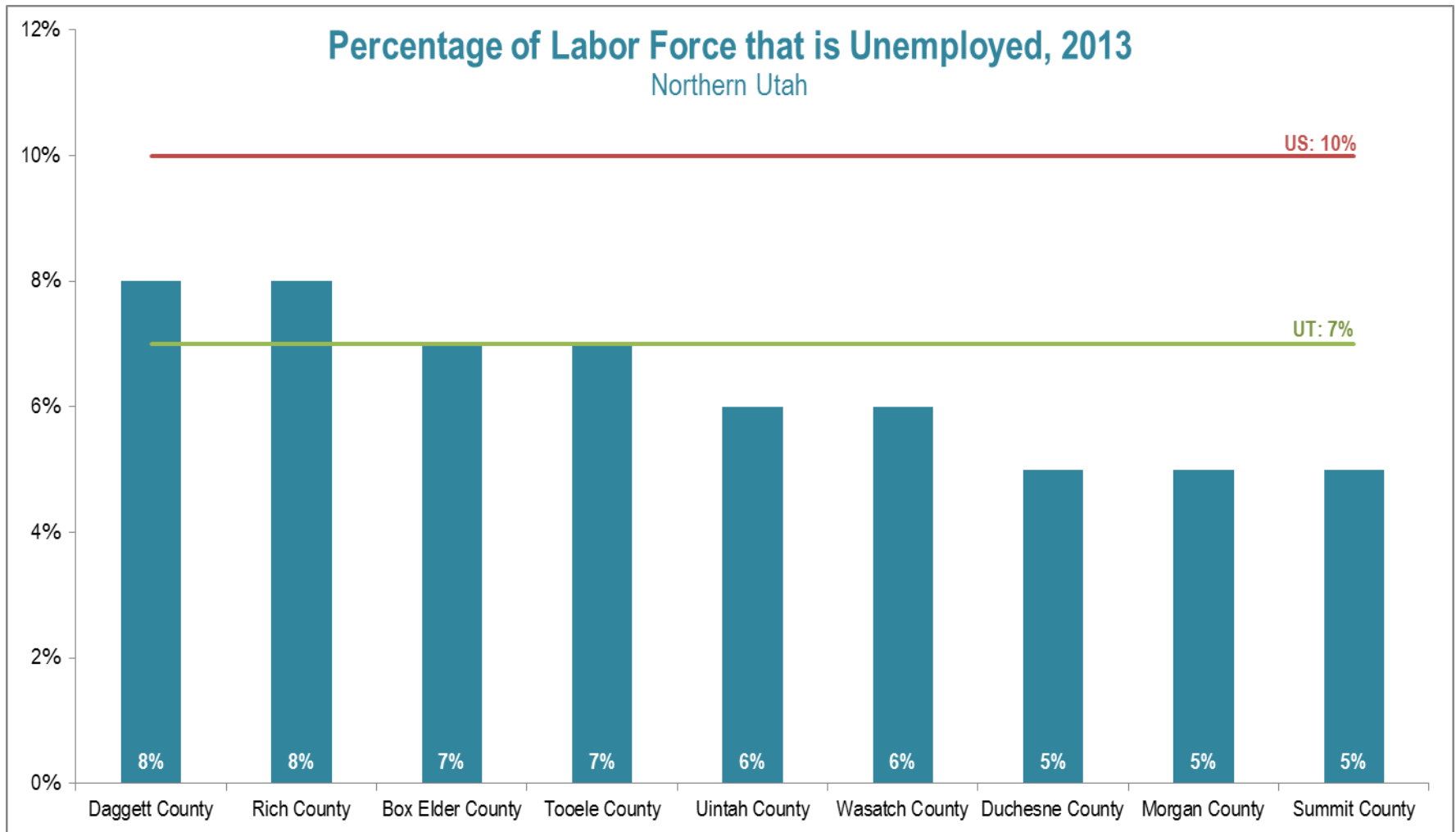

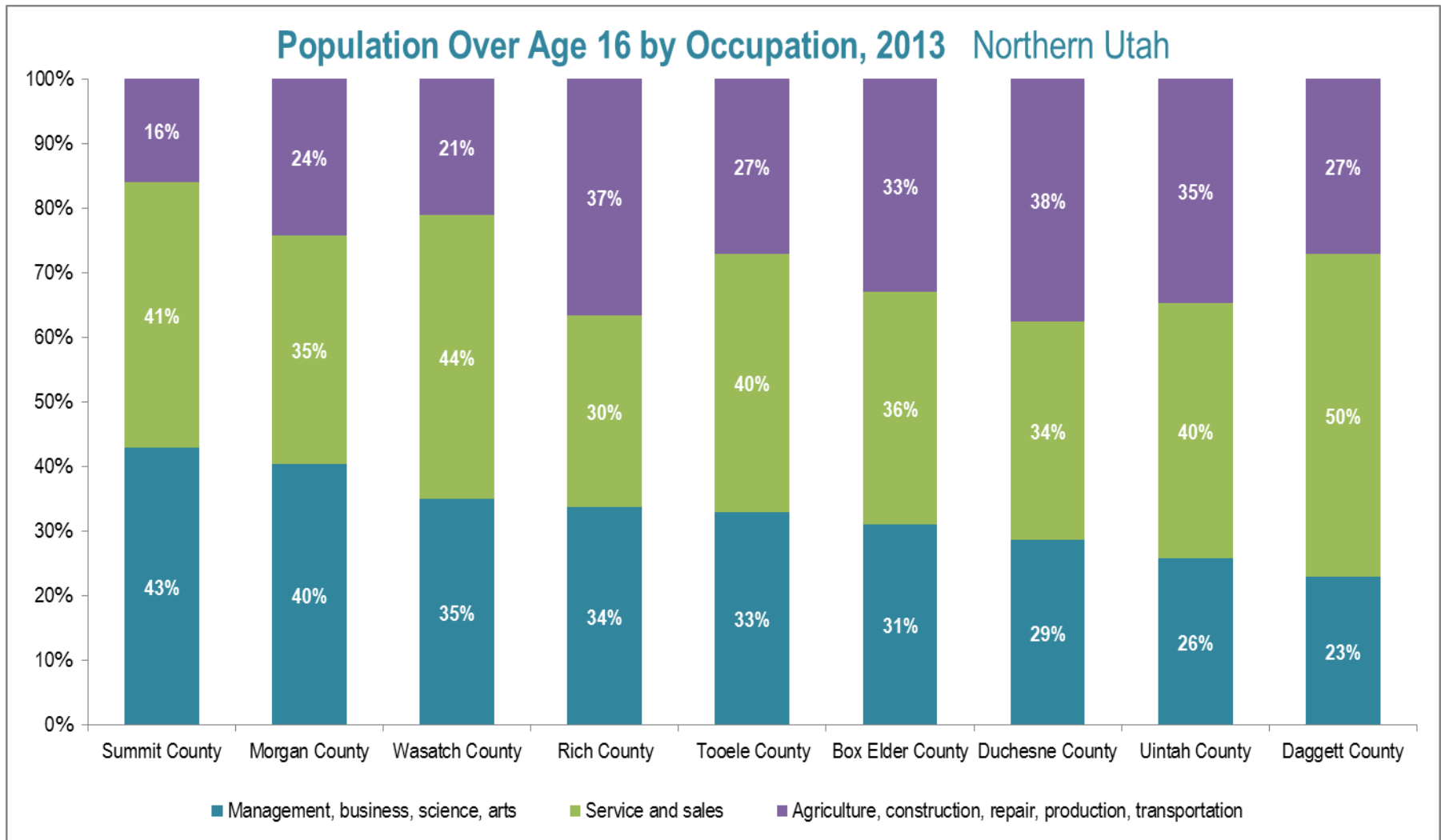

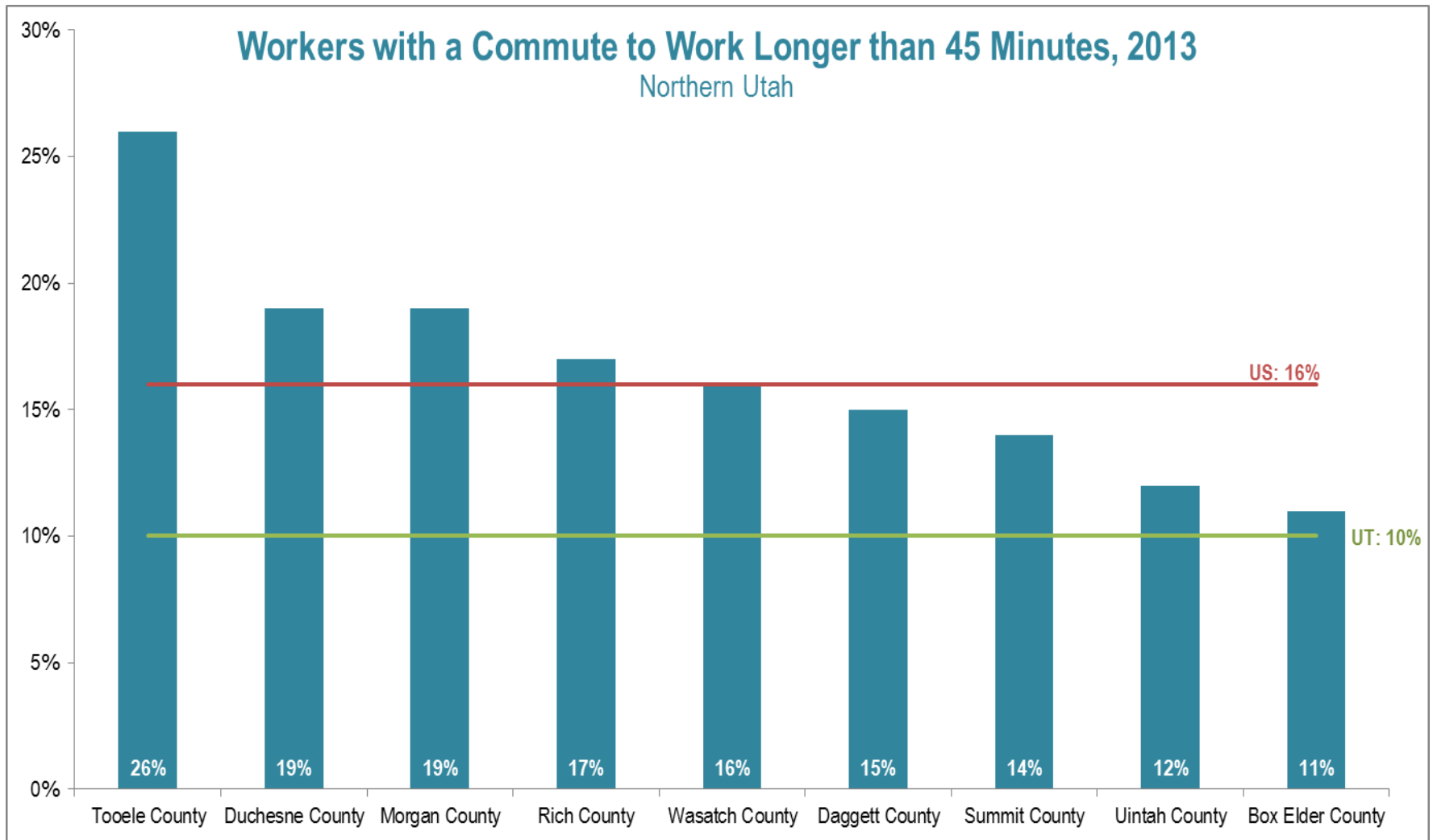

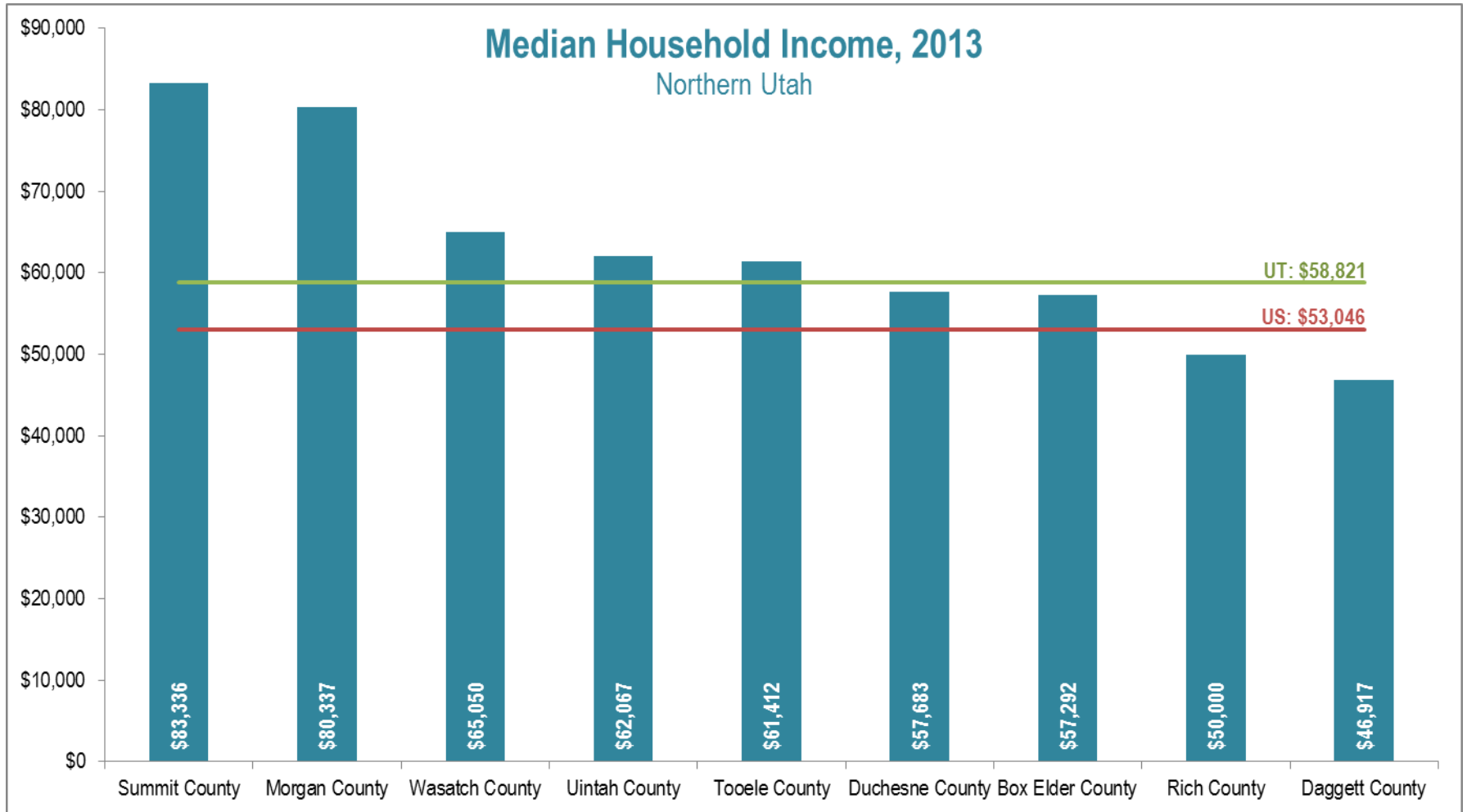

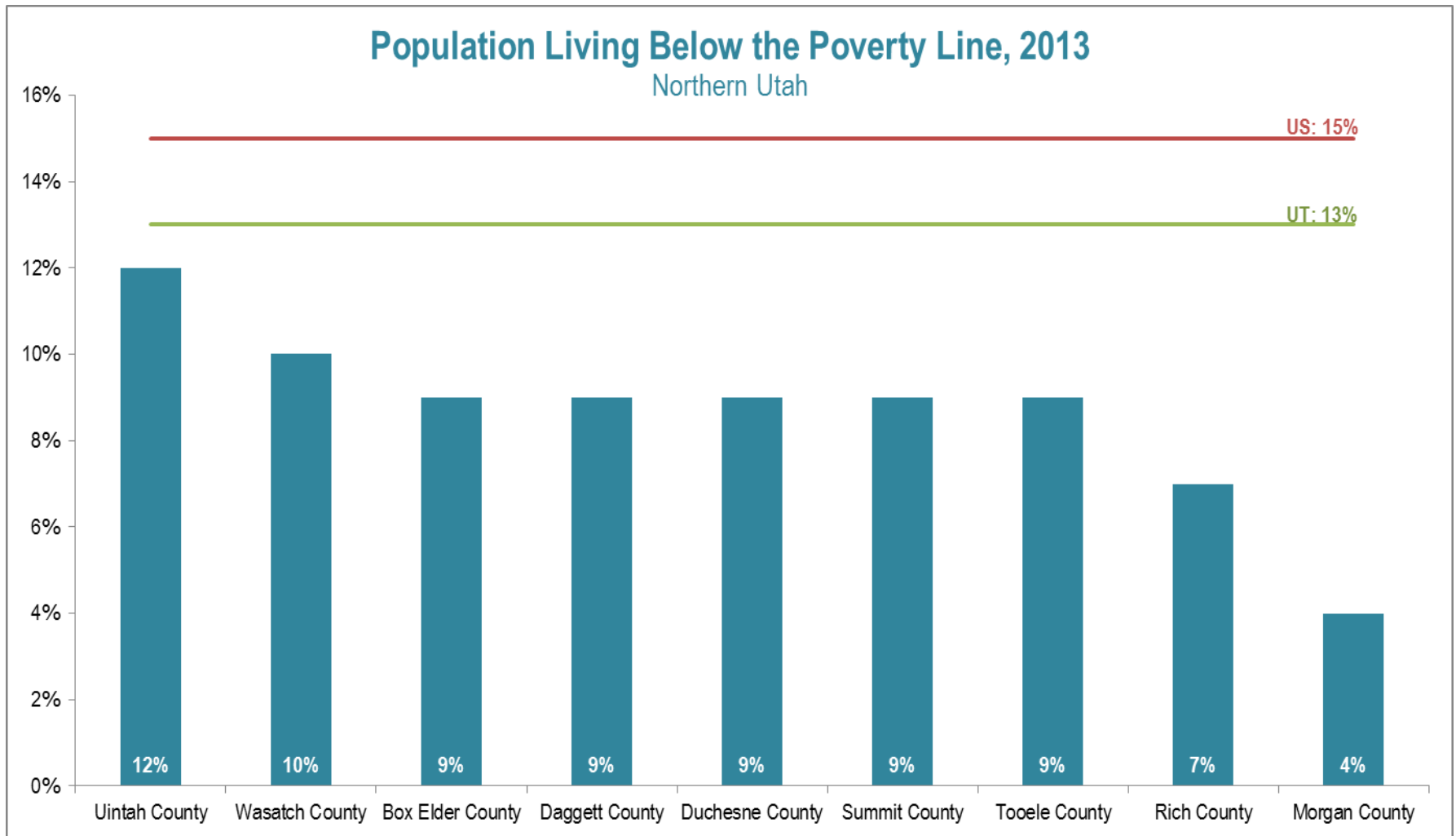

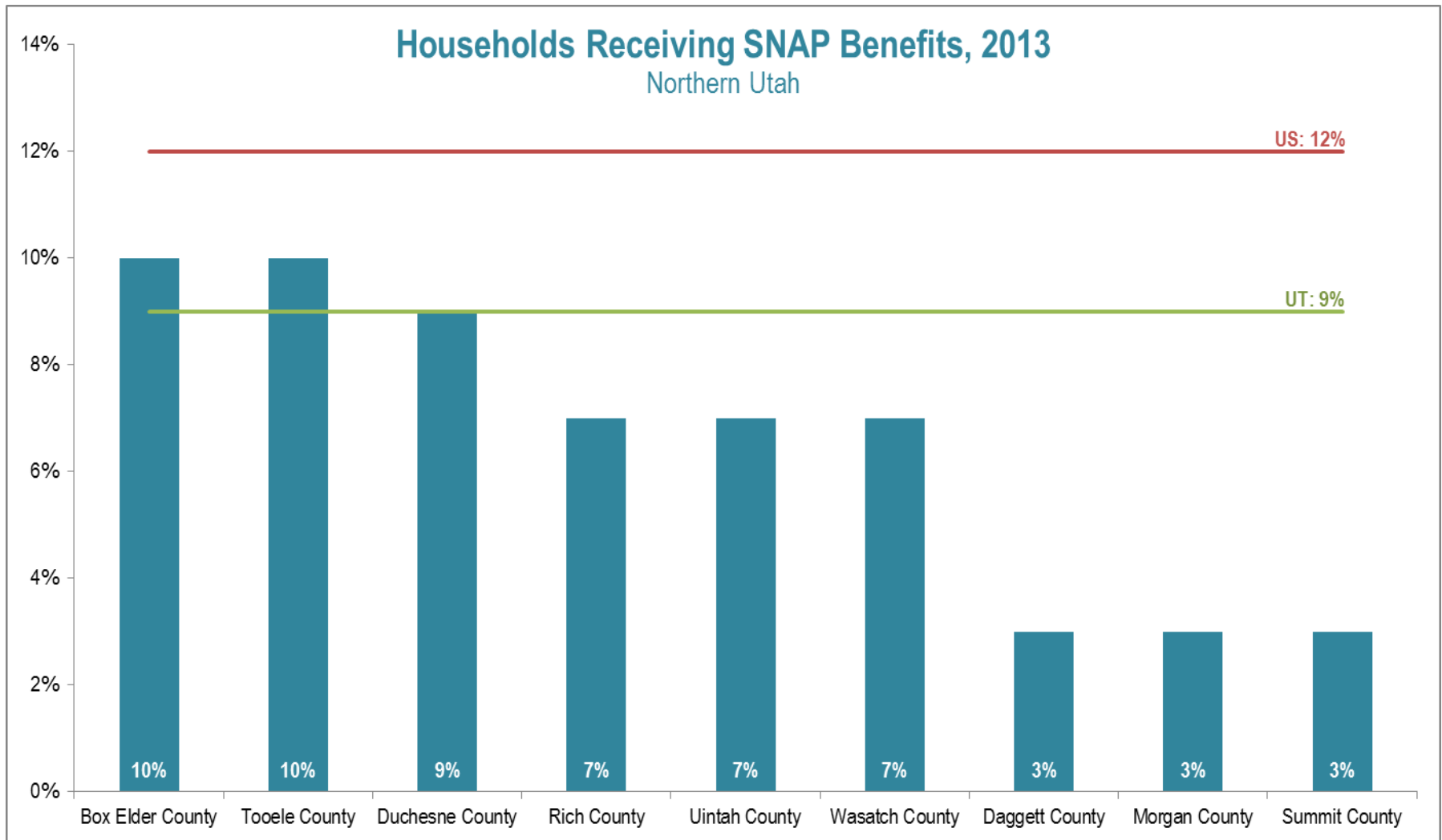

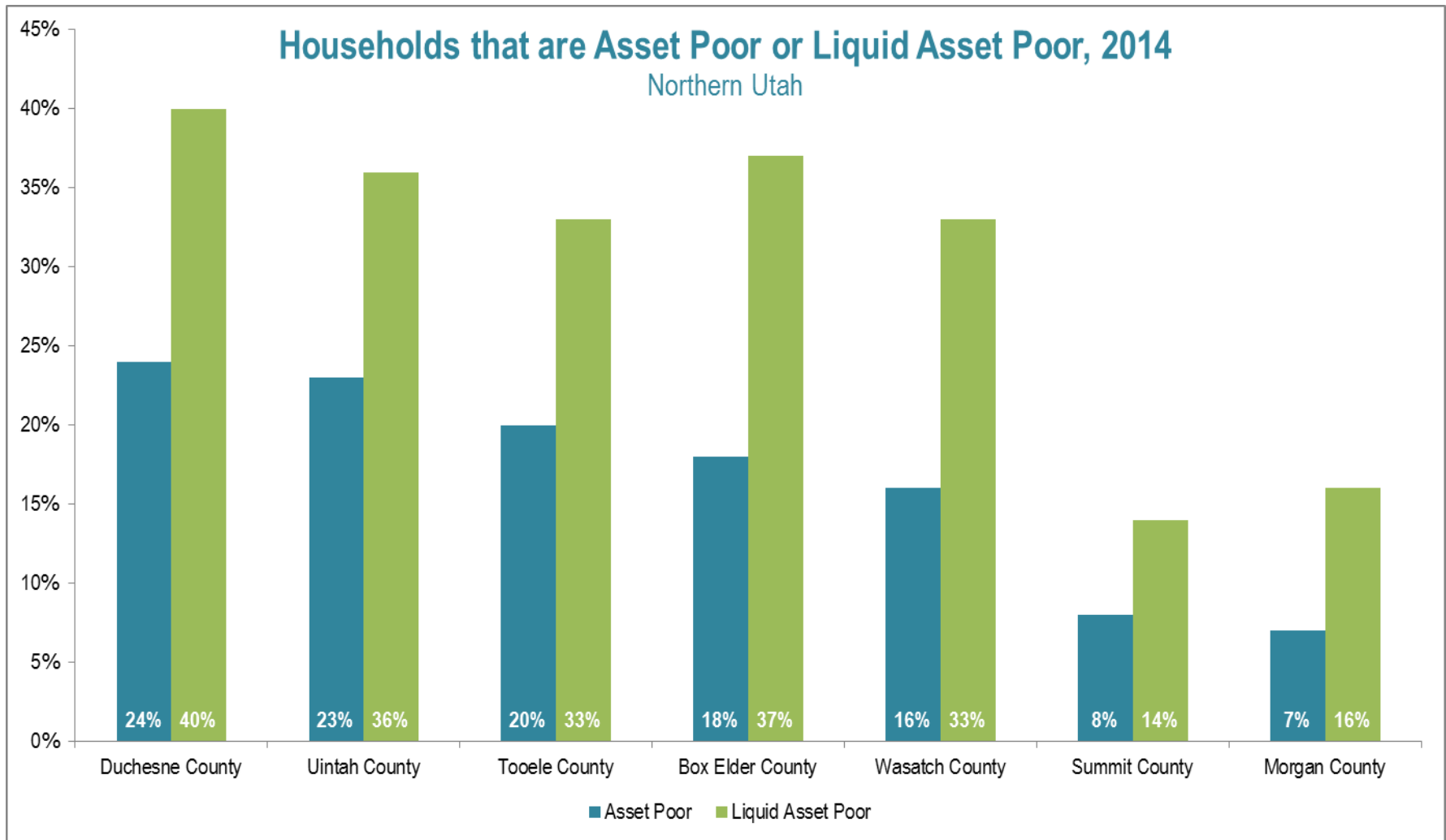

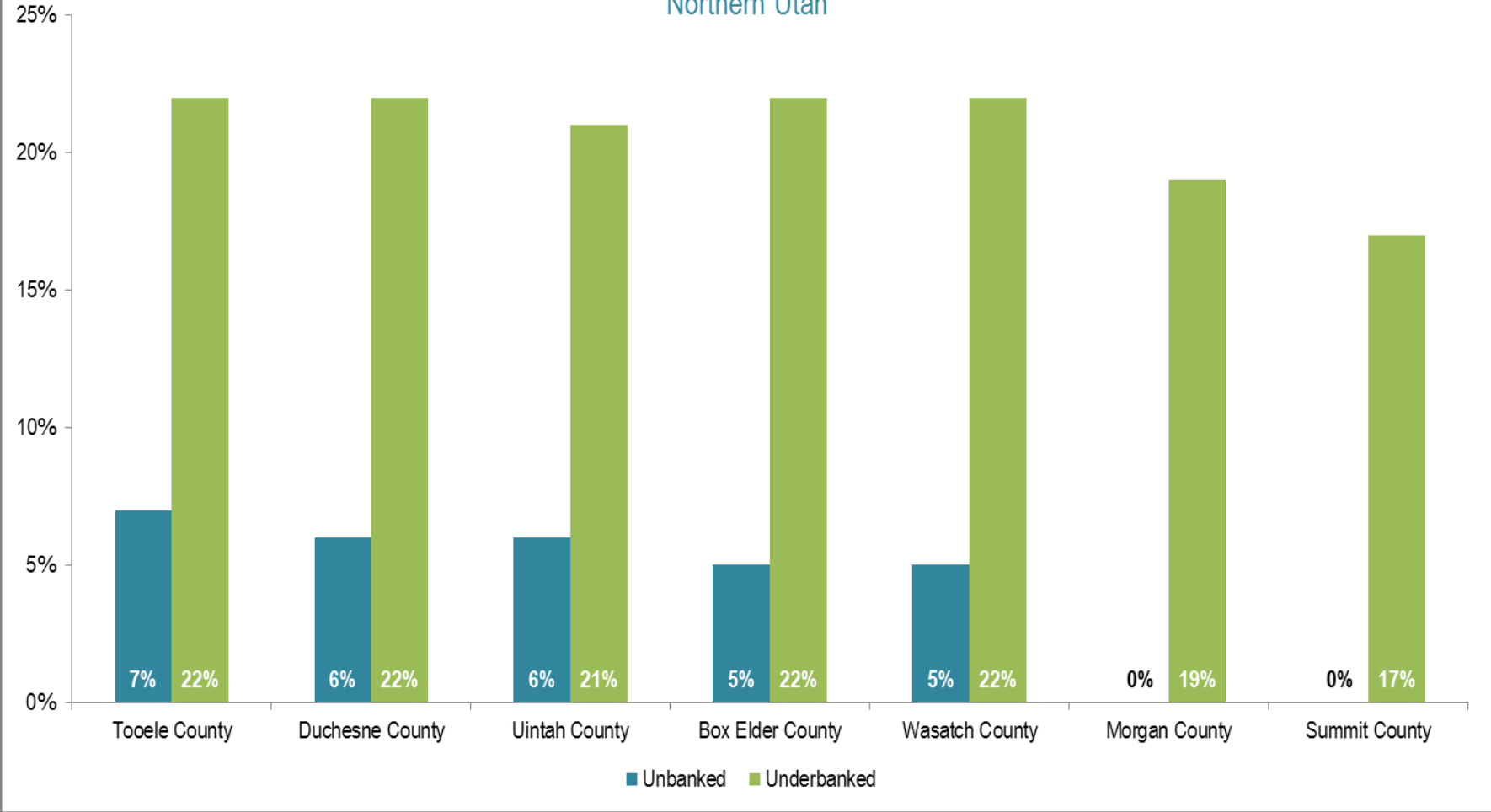

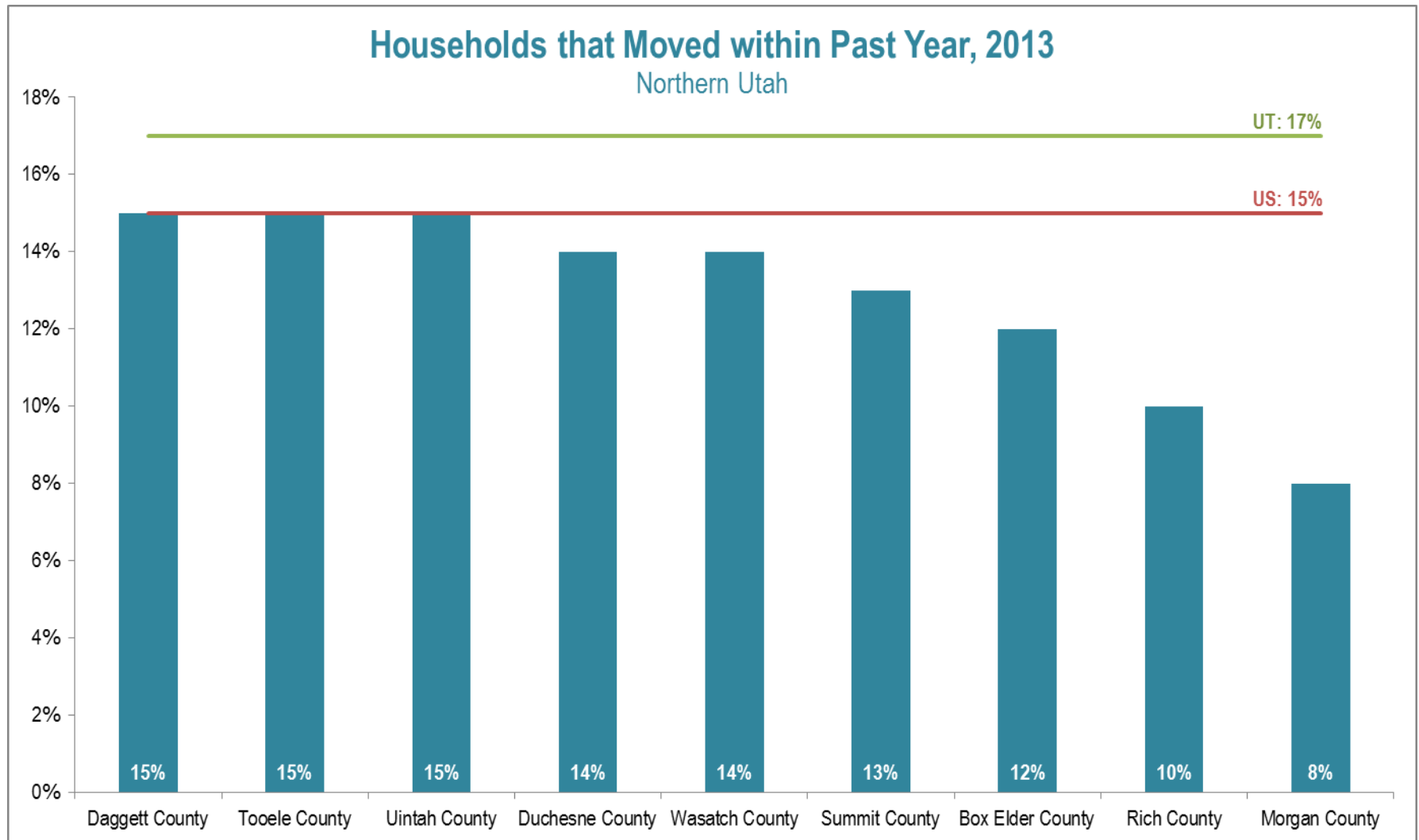
Households that are Unbanked or Underbanked, 2014

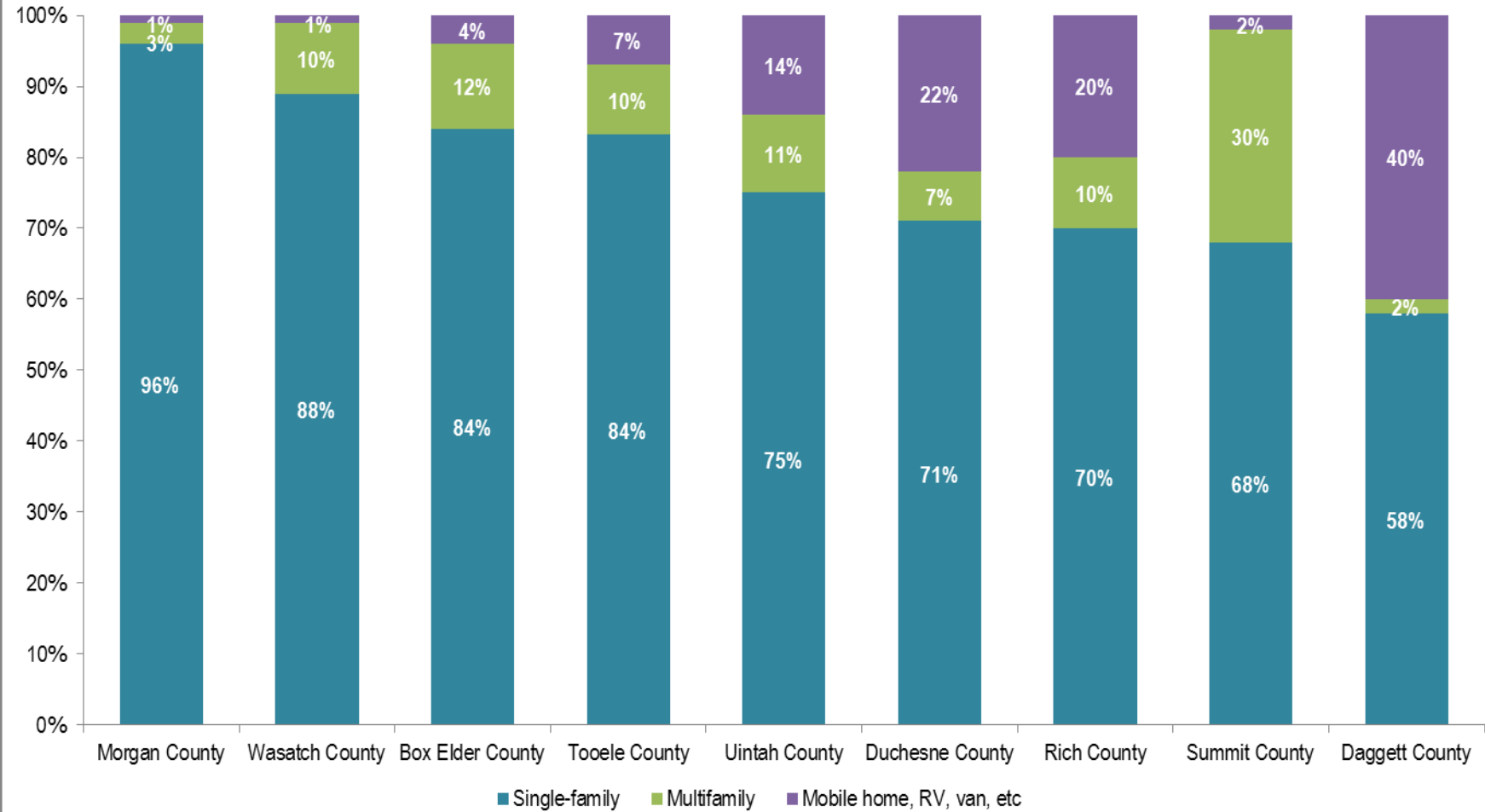

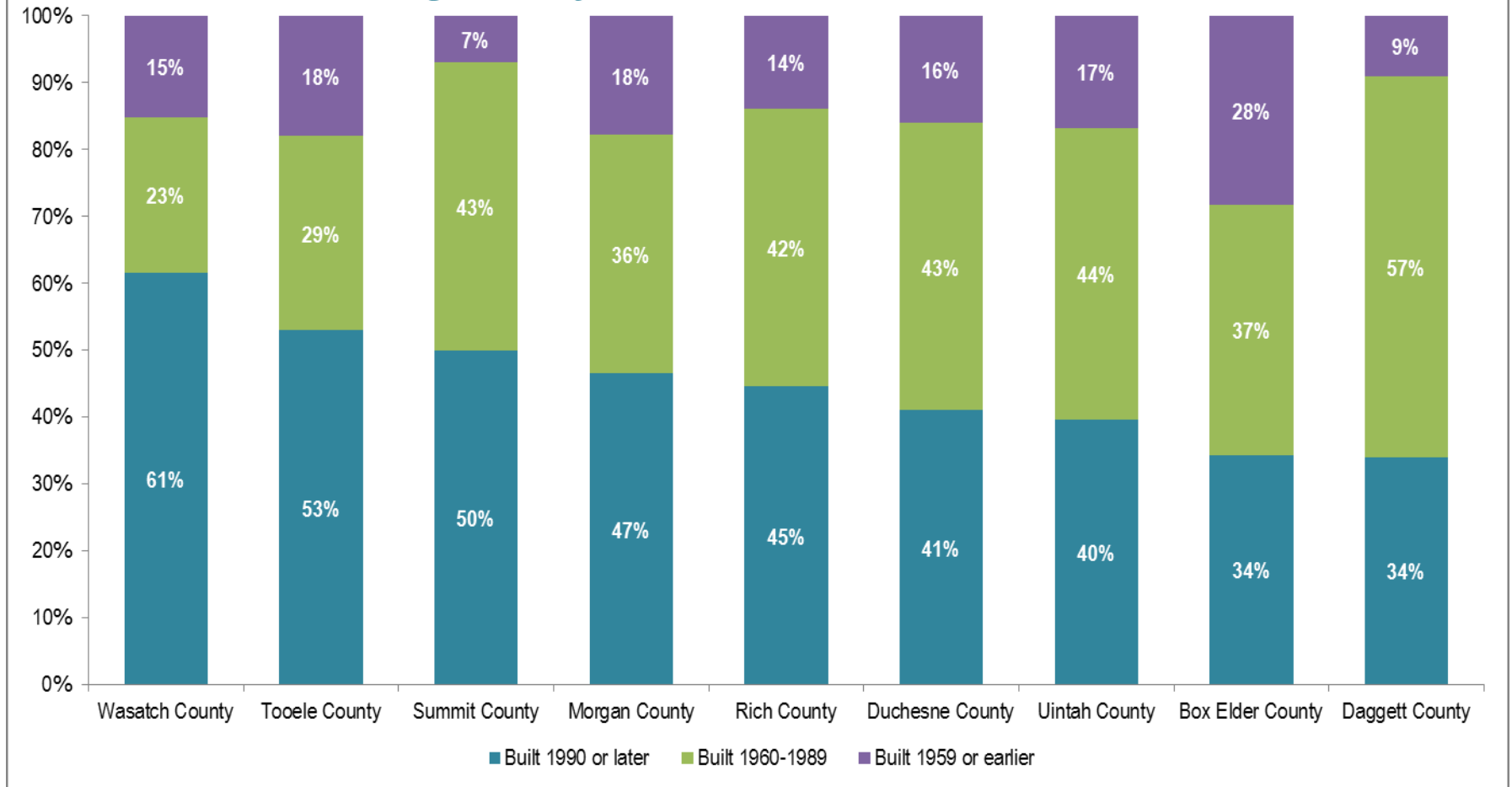

Housing Stock by Type, 2013 Northern Utah

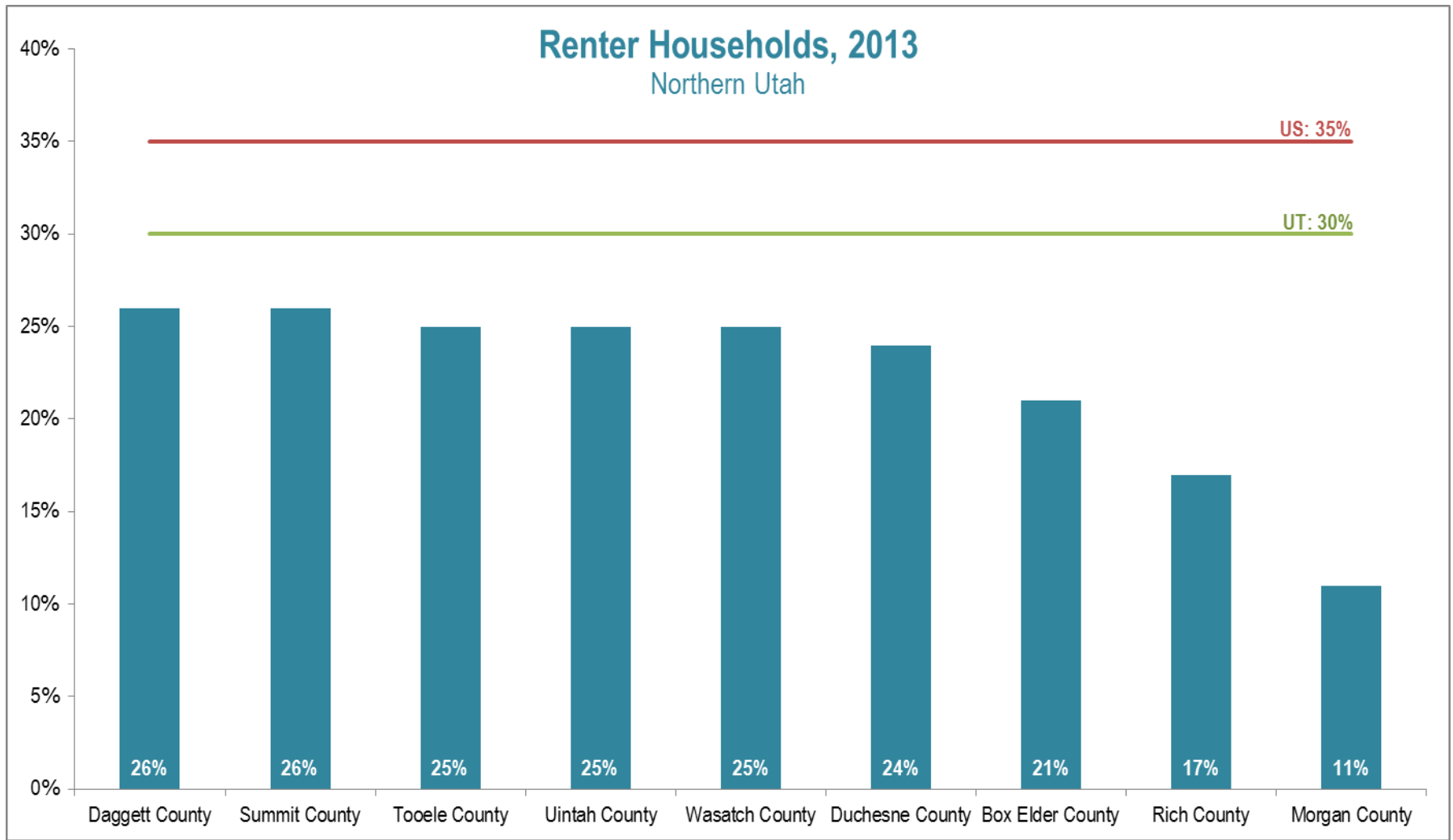

Housing Stock by Year Constructed, 2013 Northern Utah



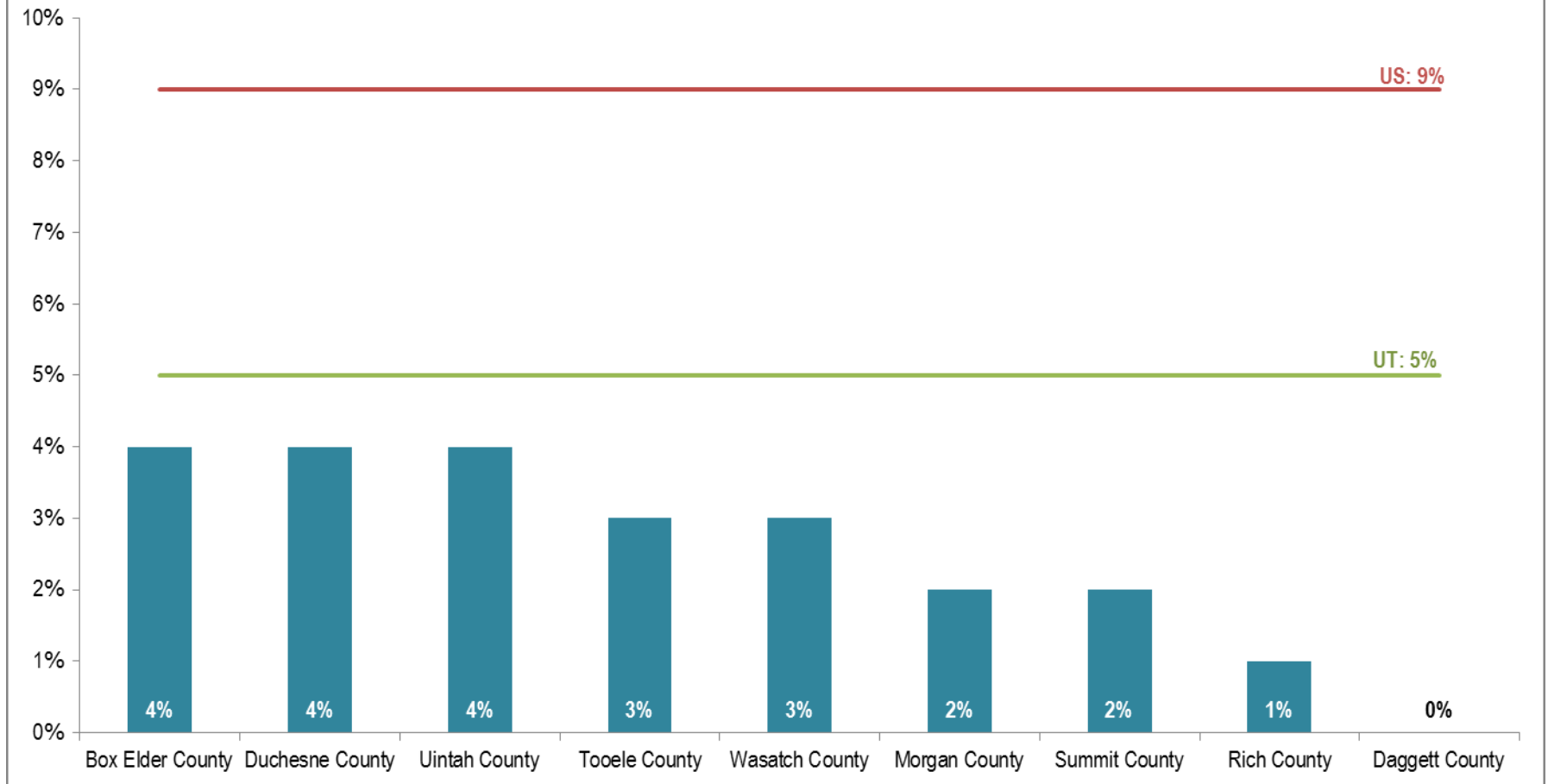

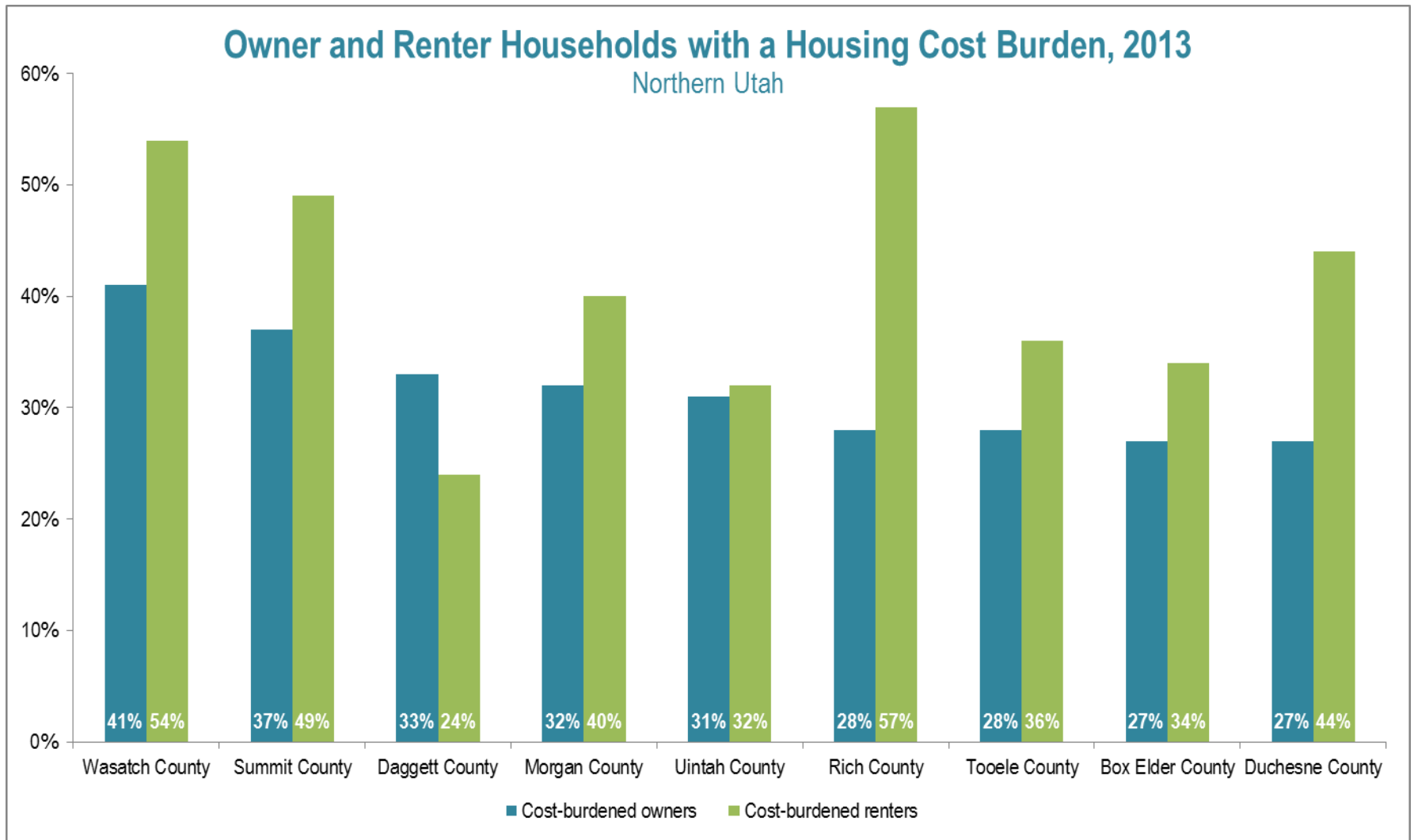
