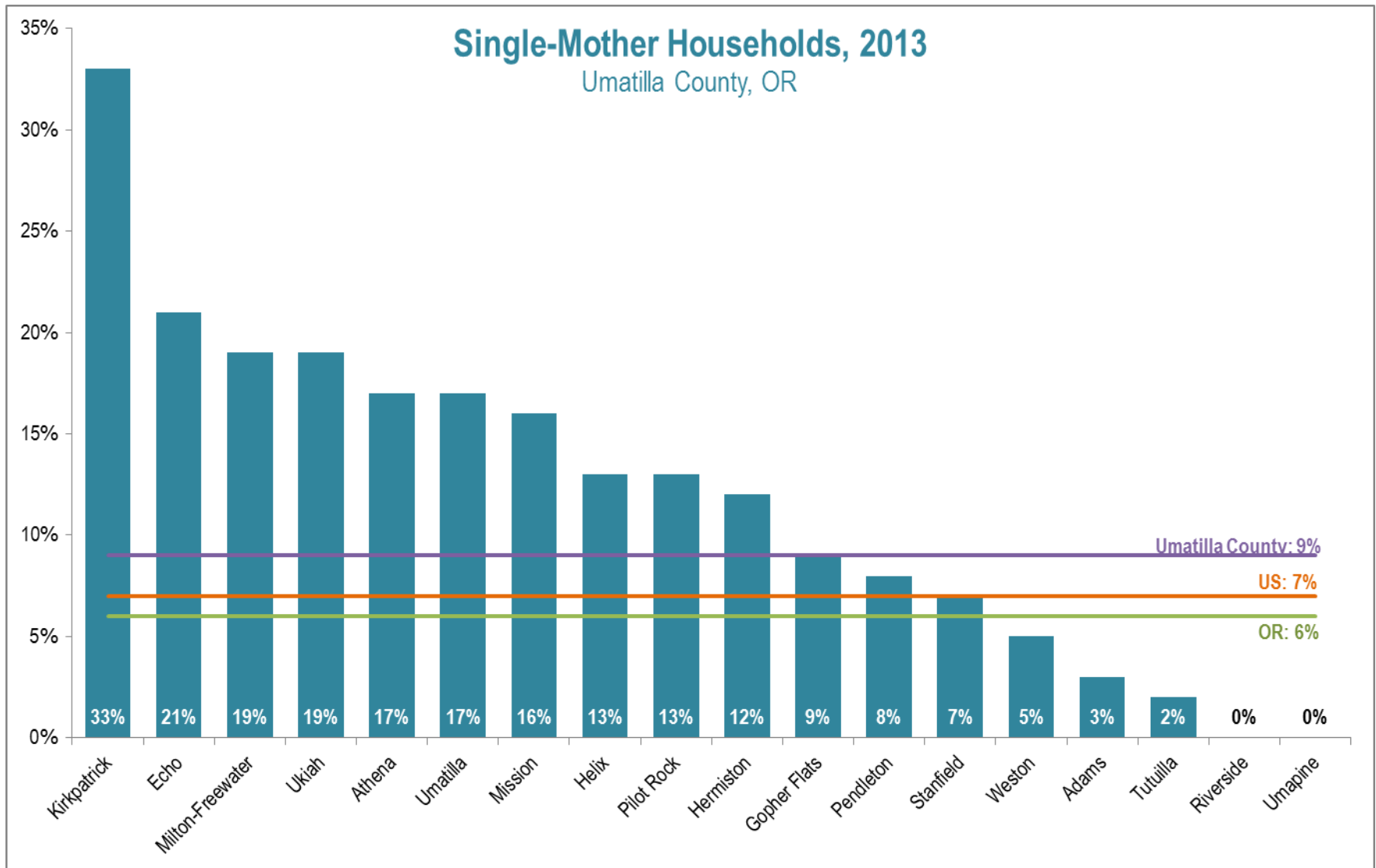

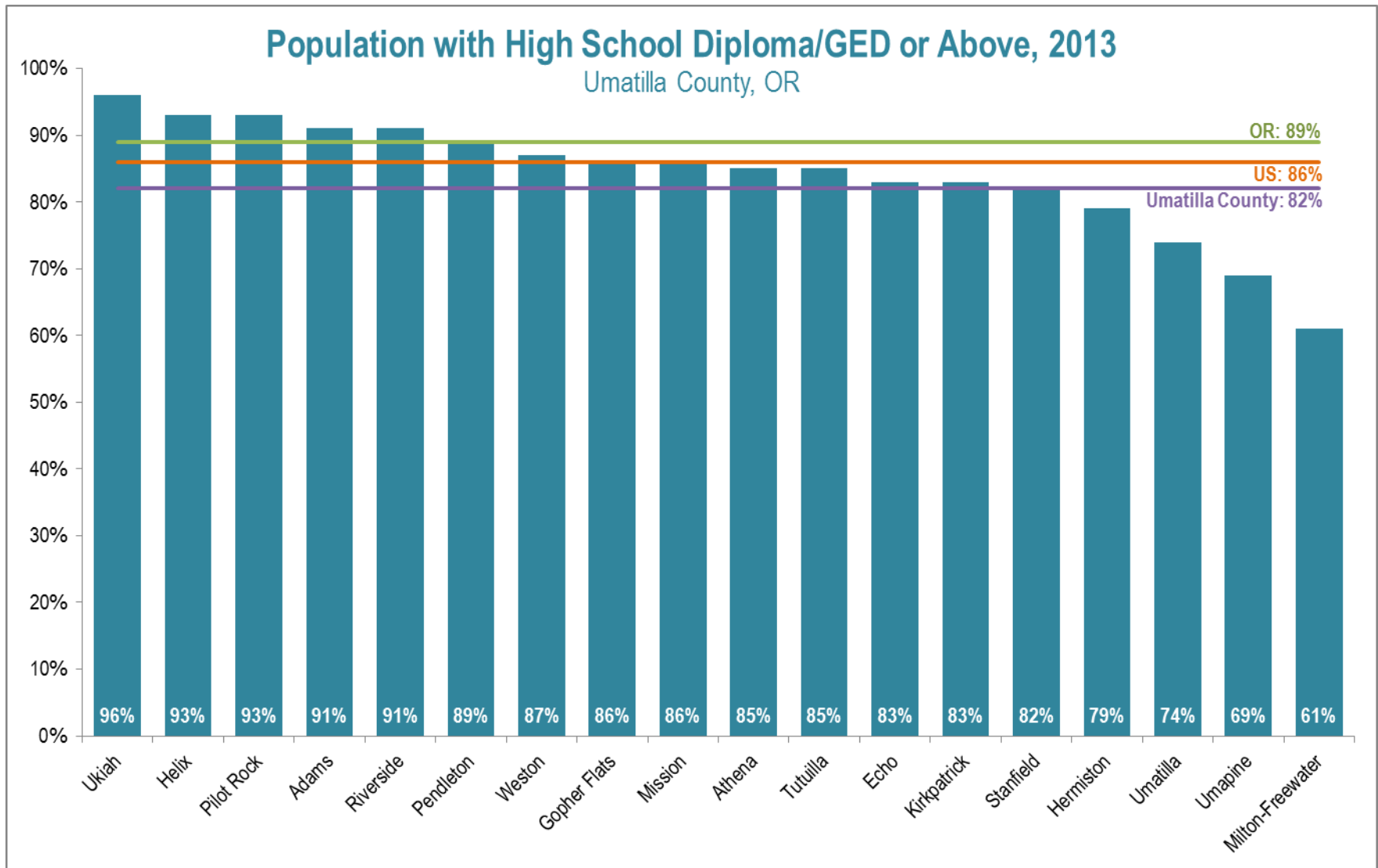

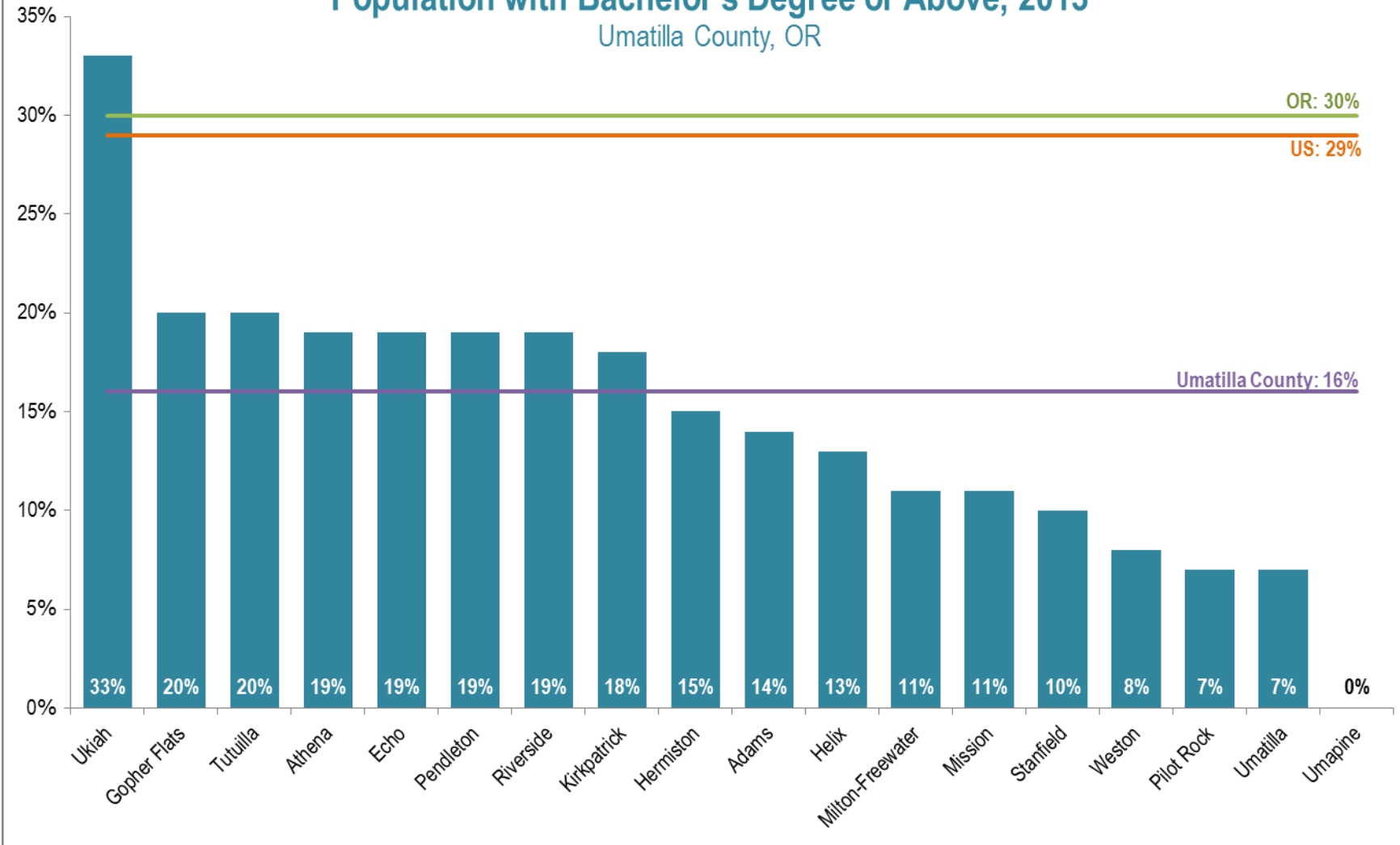

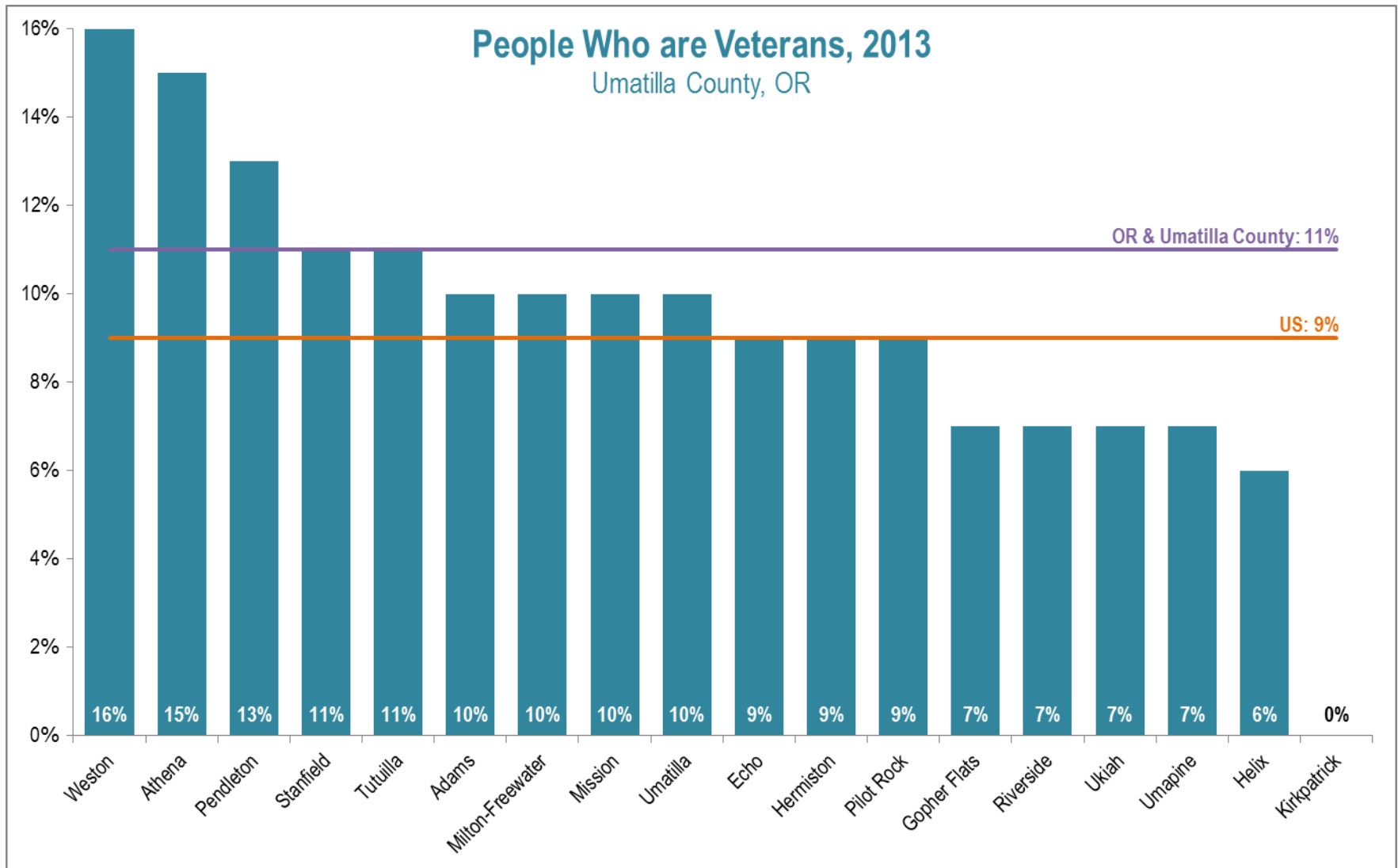

Population with Bachelor's Degree or Above, 2013

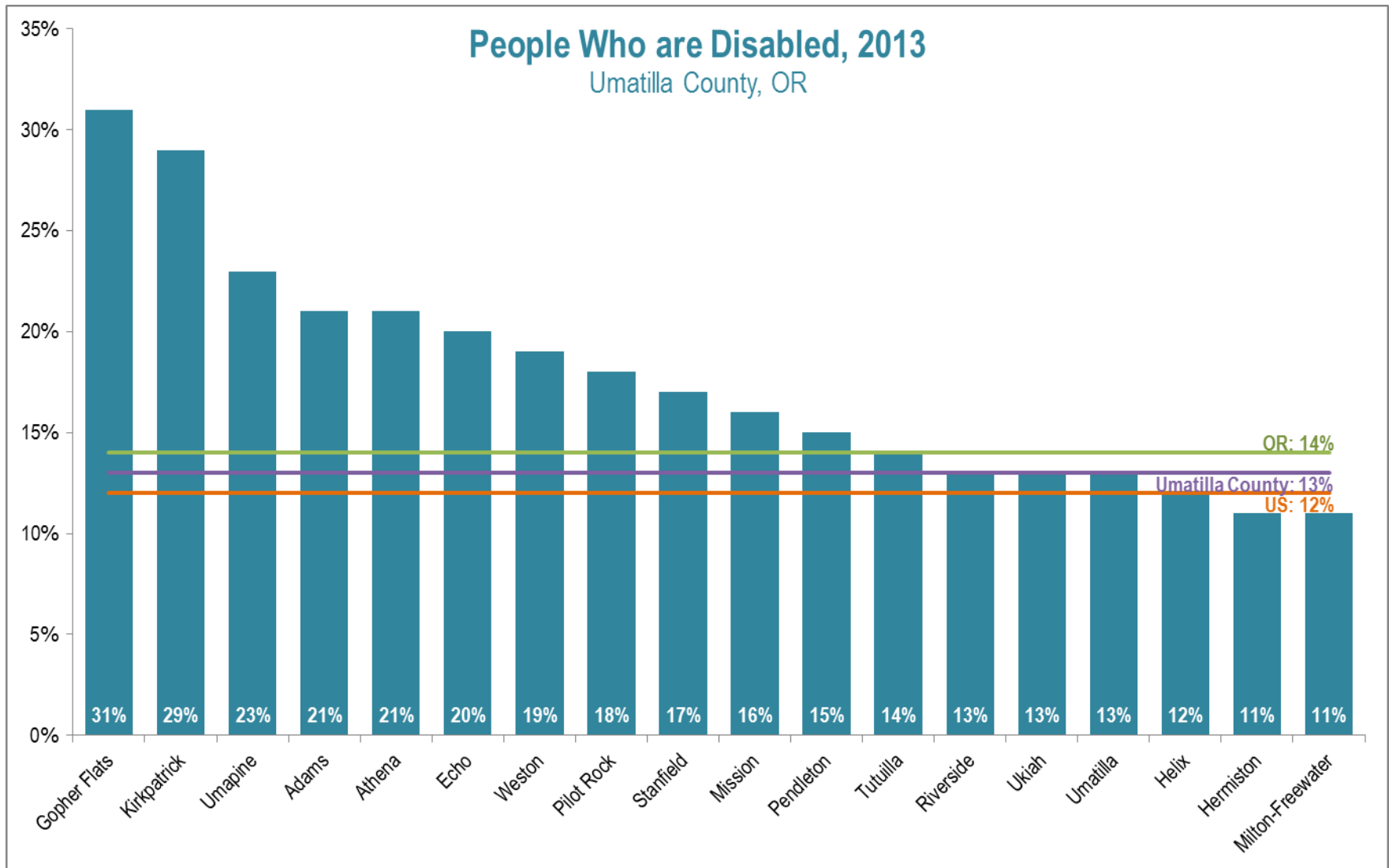

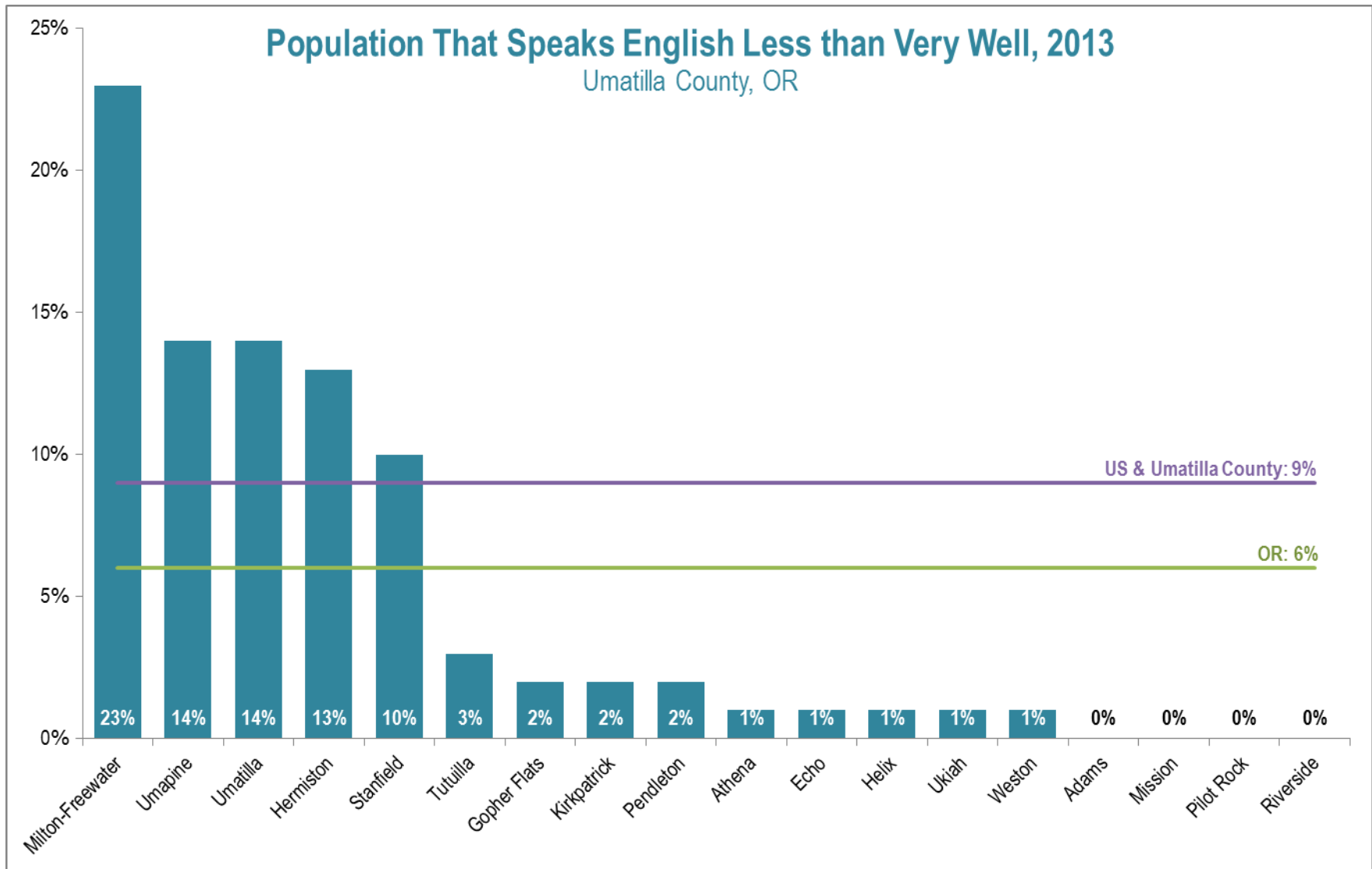

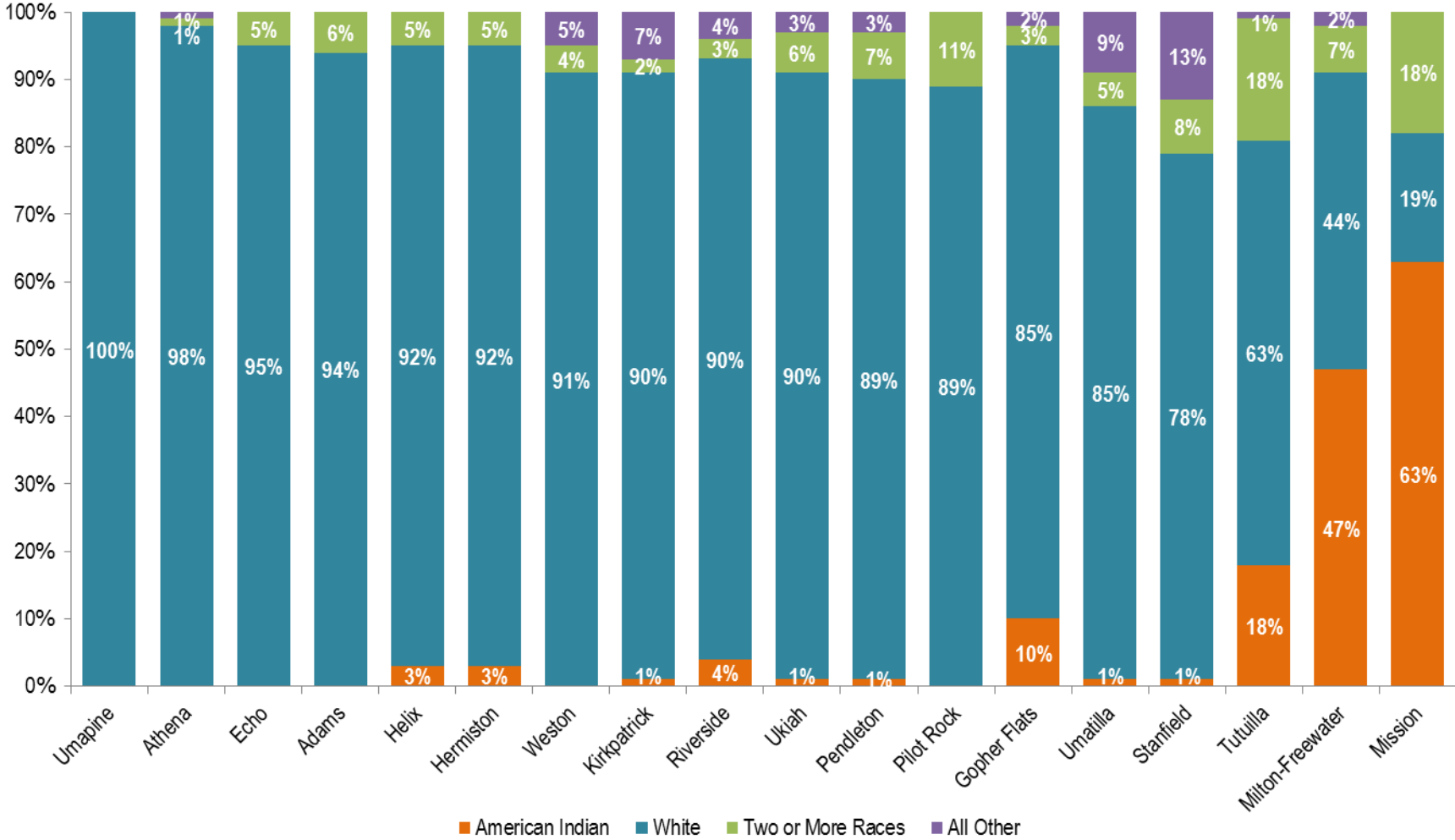

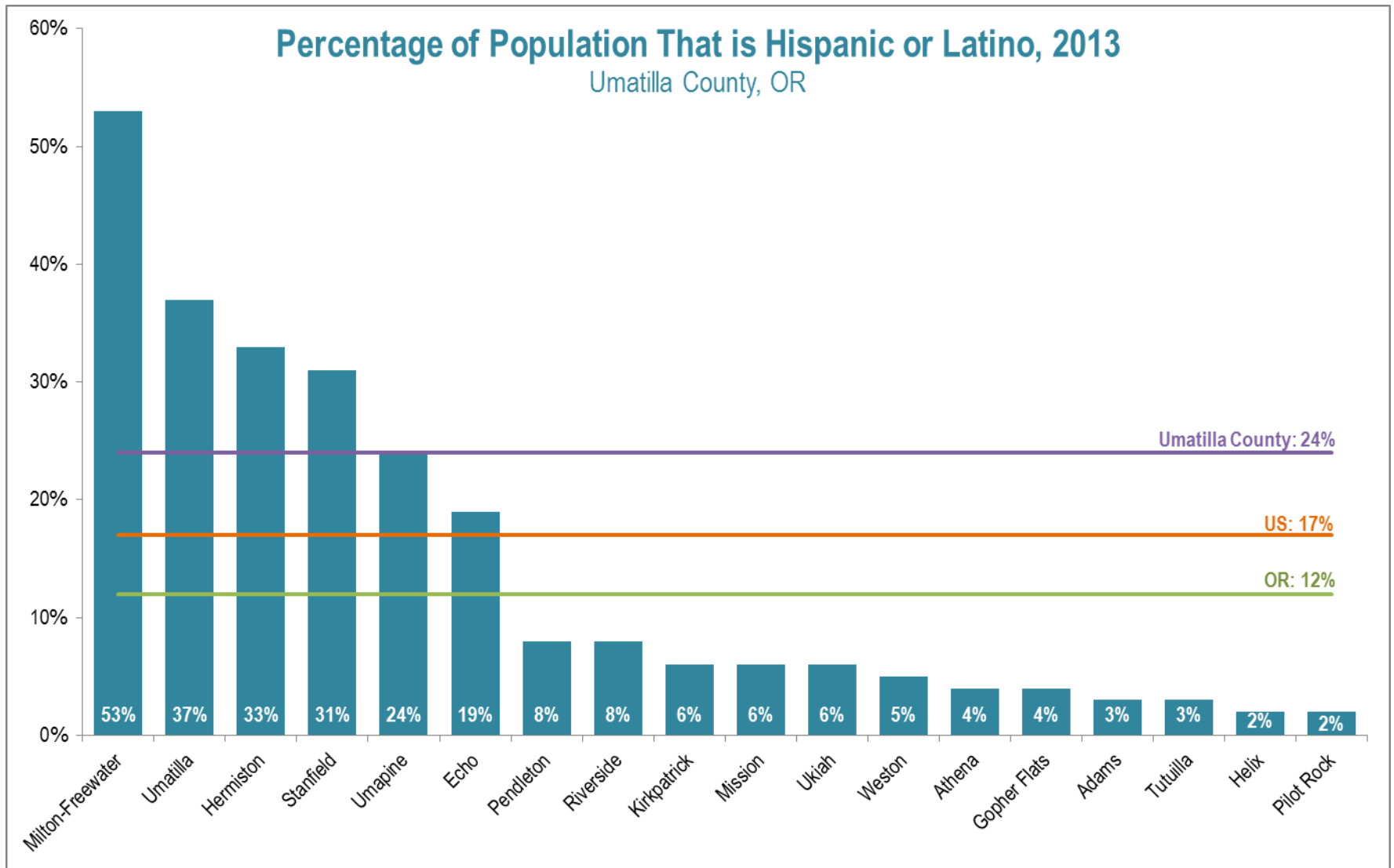

Population by Race, 2013 Umatilla County, OR

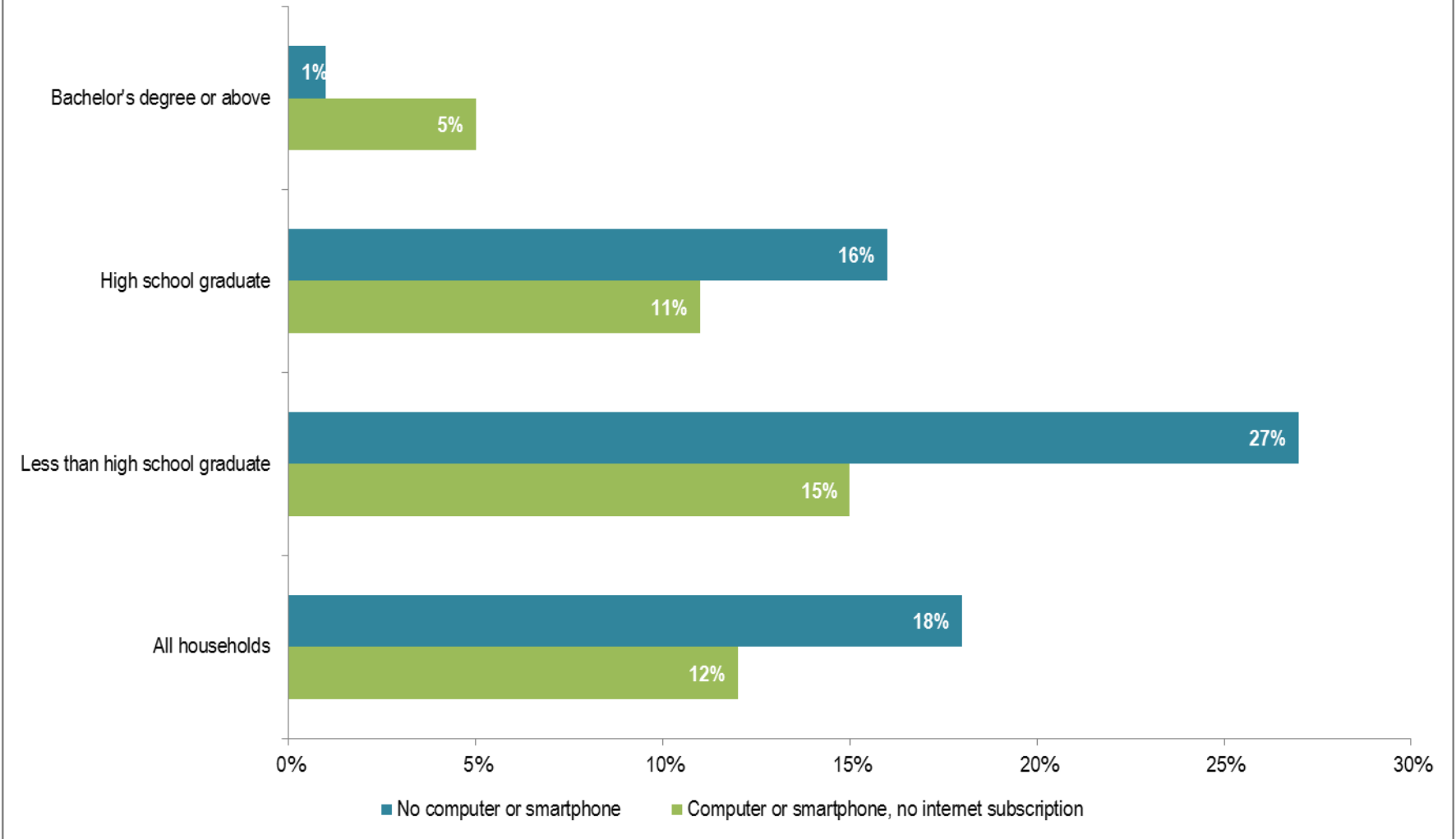

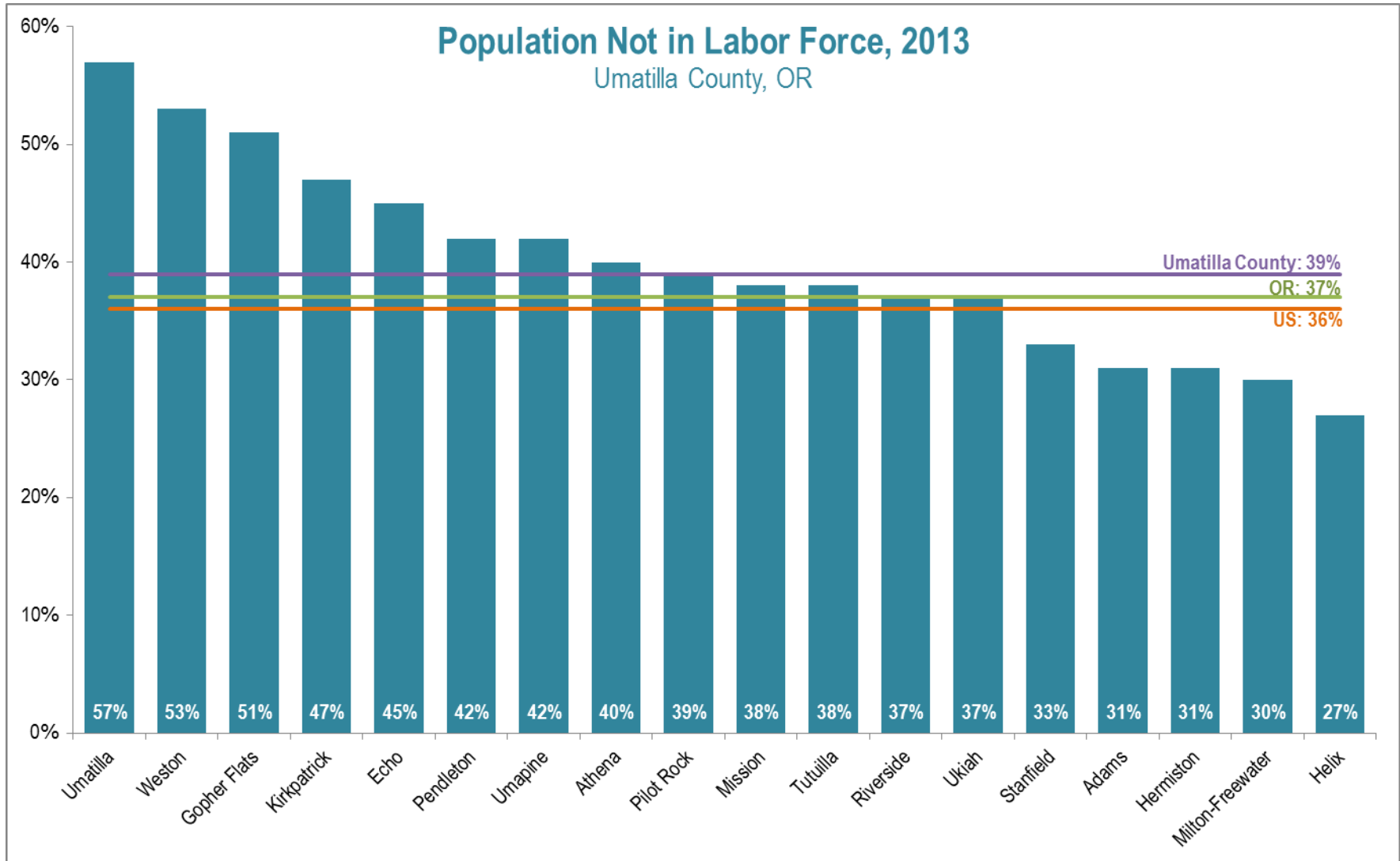

Access to Computers, Smartphones, and Internet, 2013 Umatilla County, OR

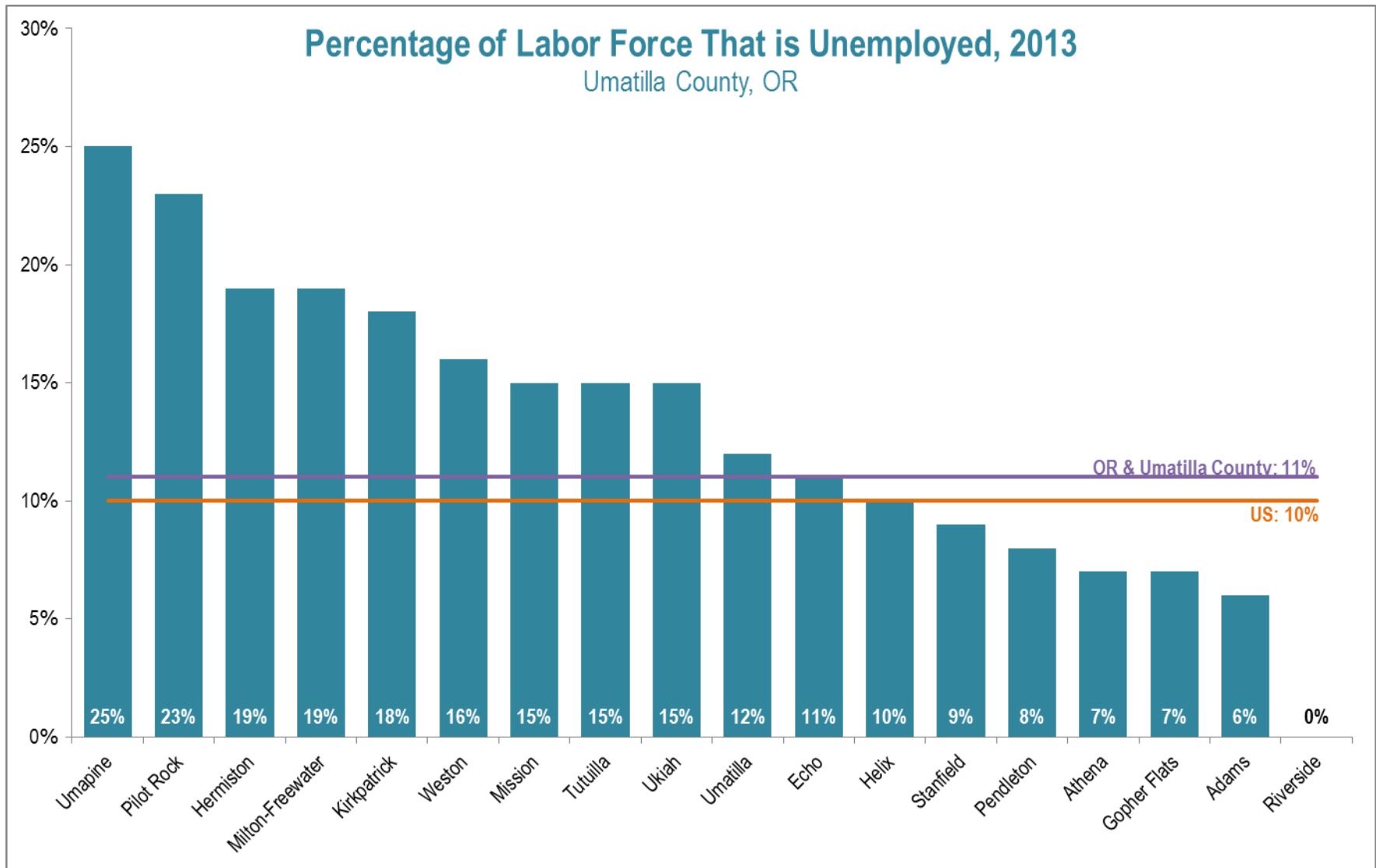

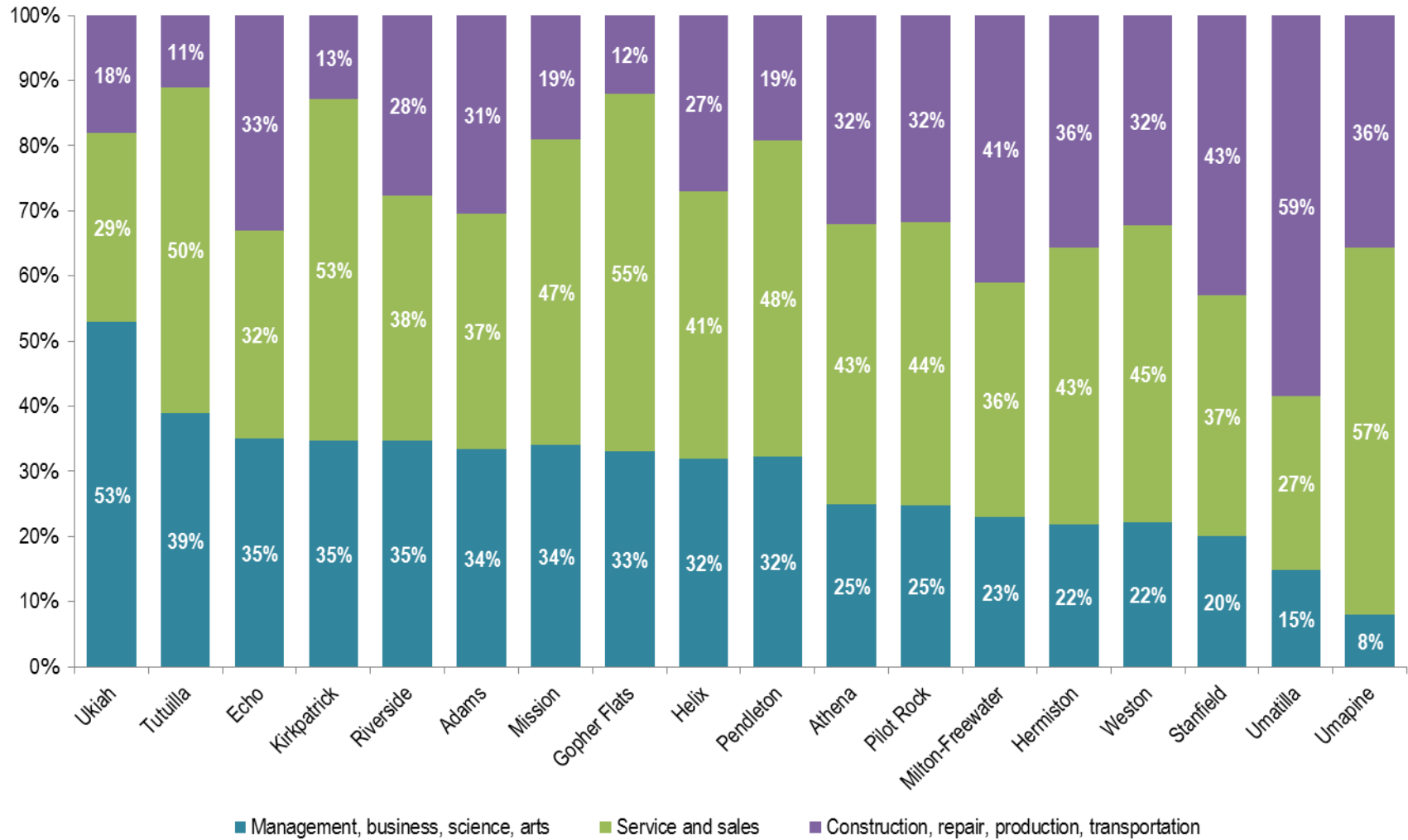

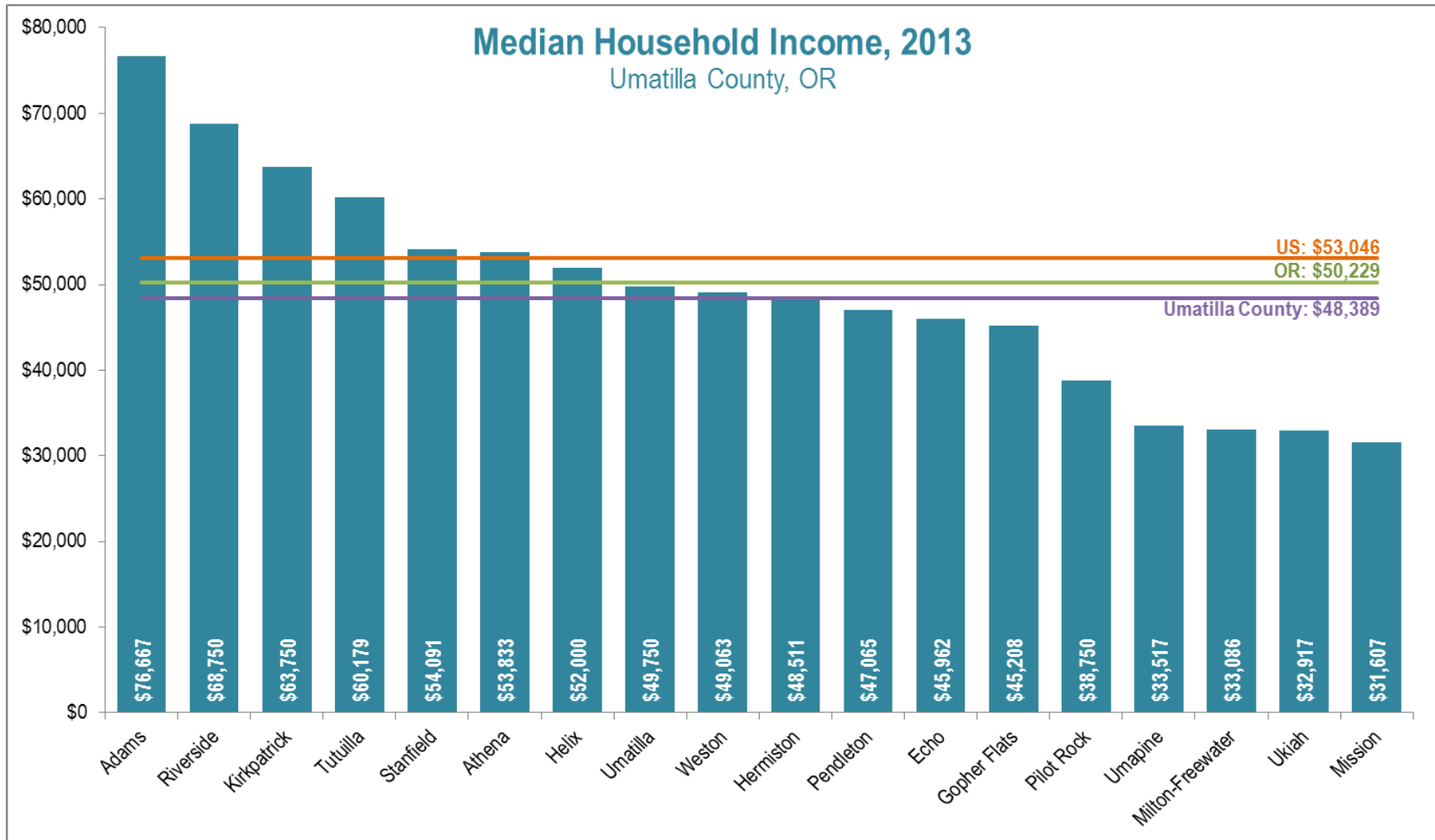

Population Over Age 16 by Occupation, 2013 Umatilla County, OR

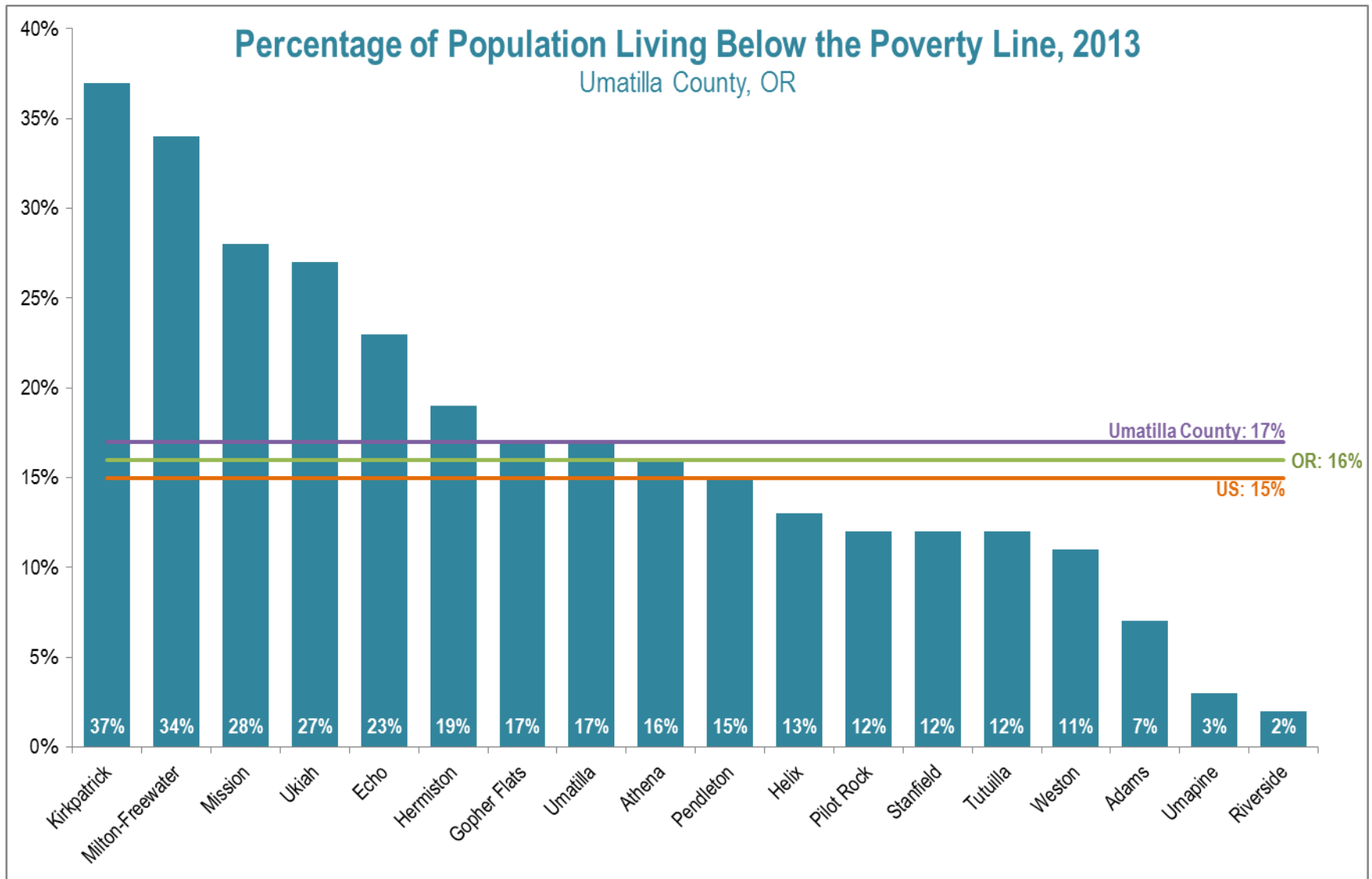

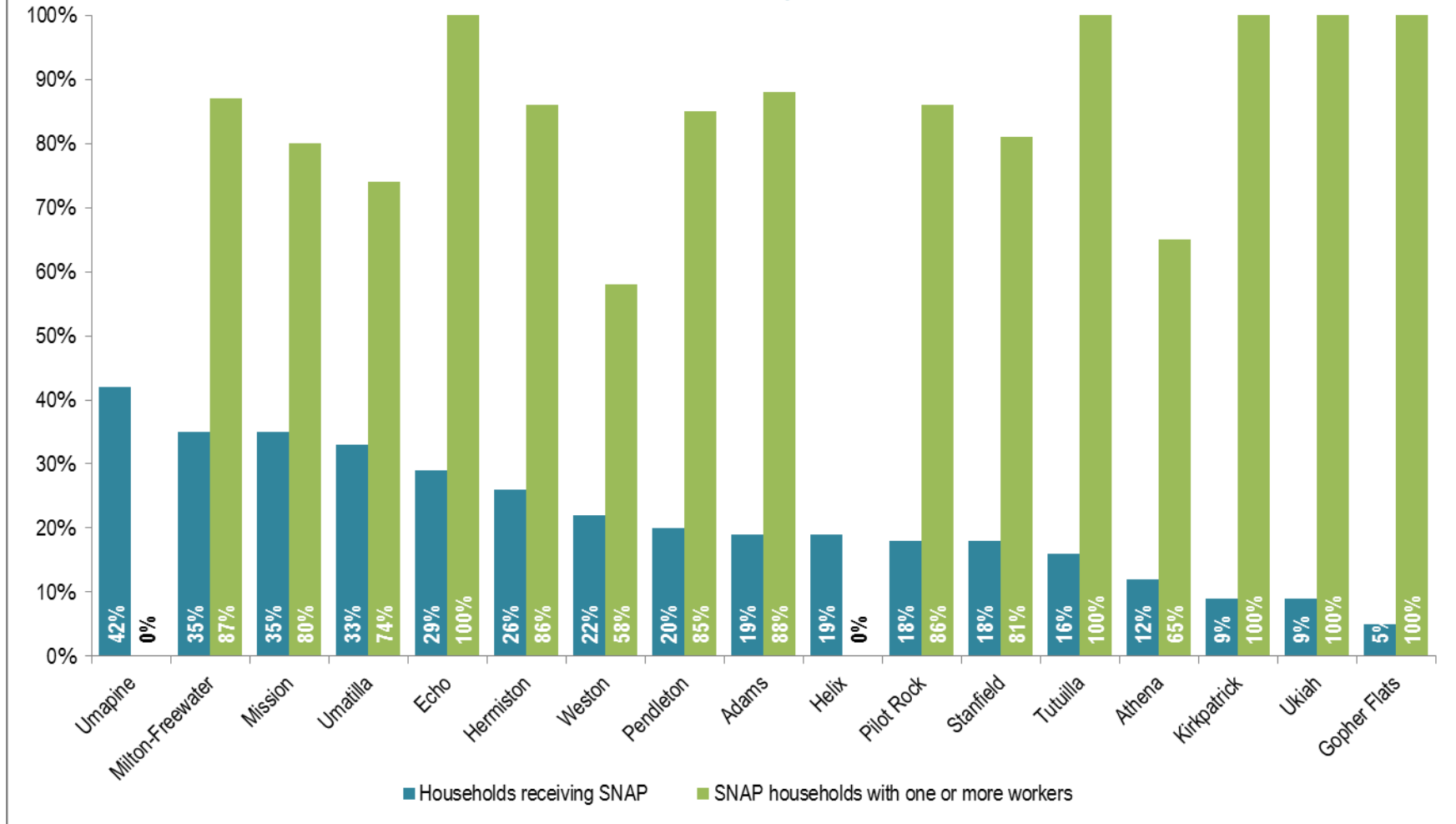

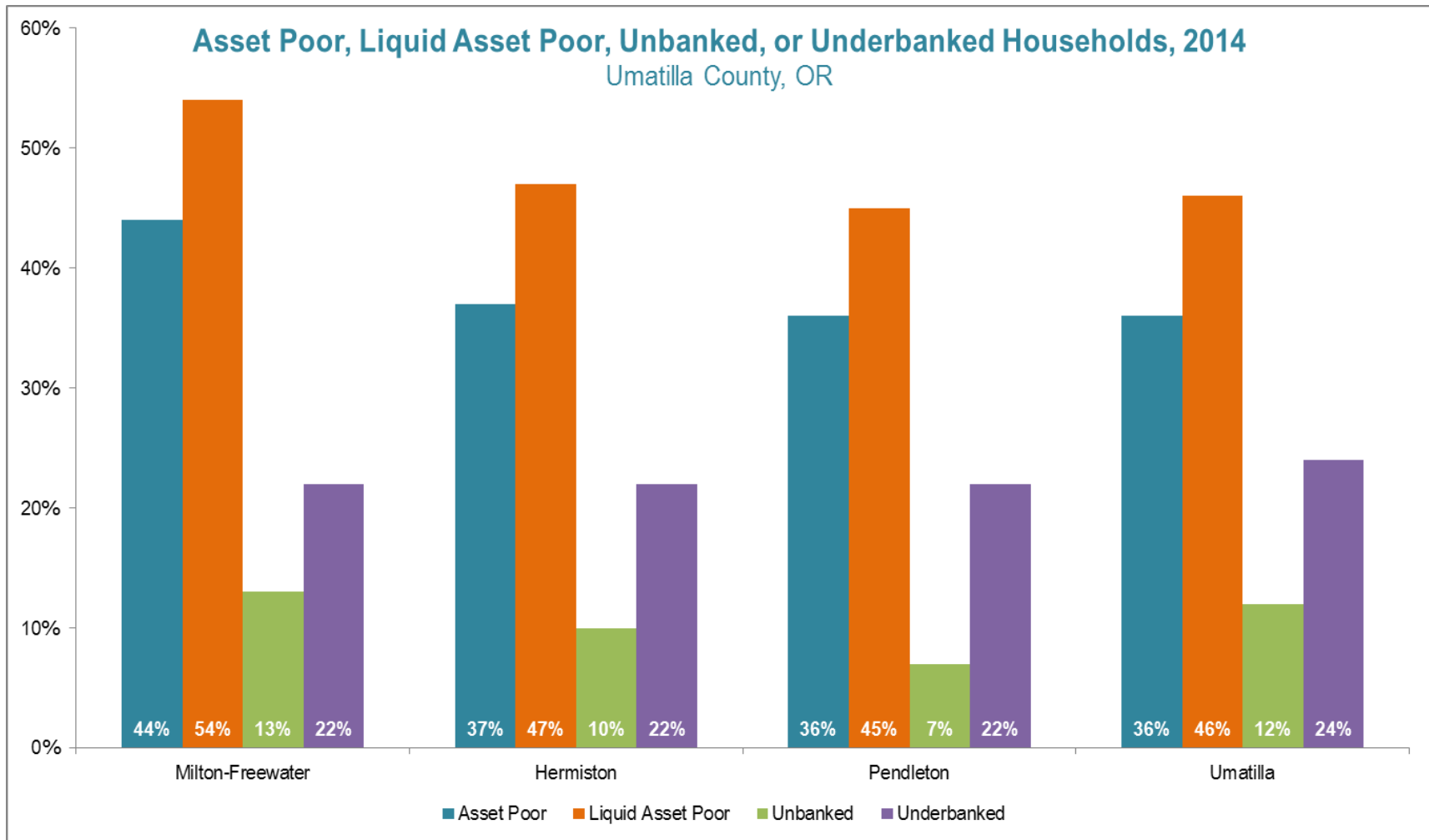

Umatilla County, OR

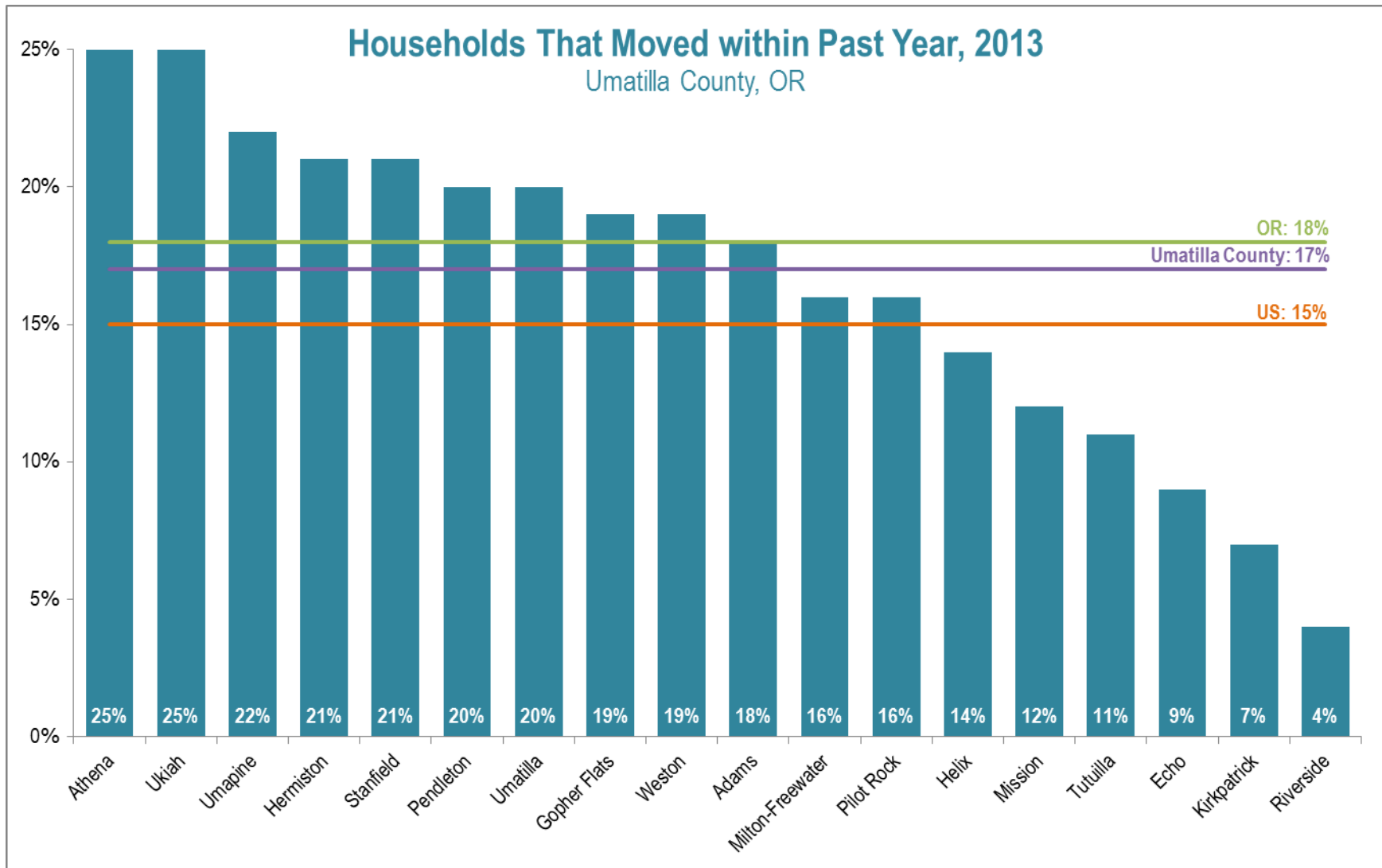

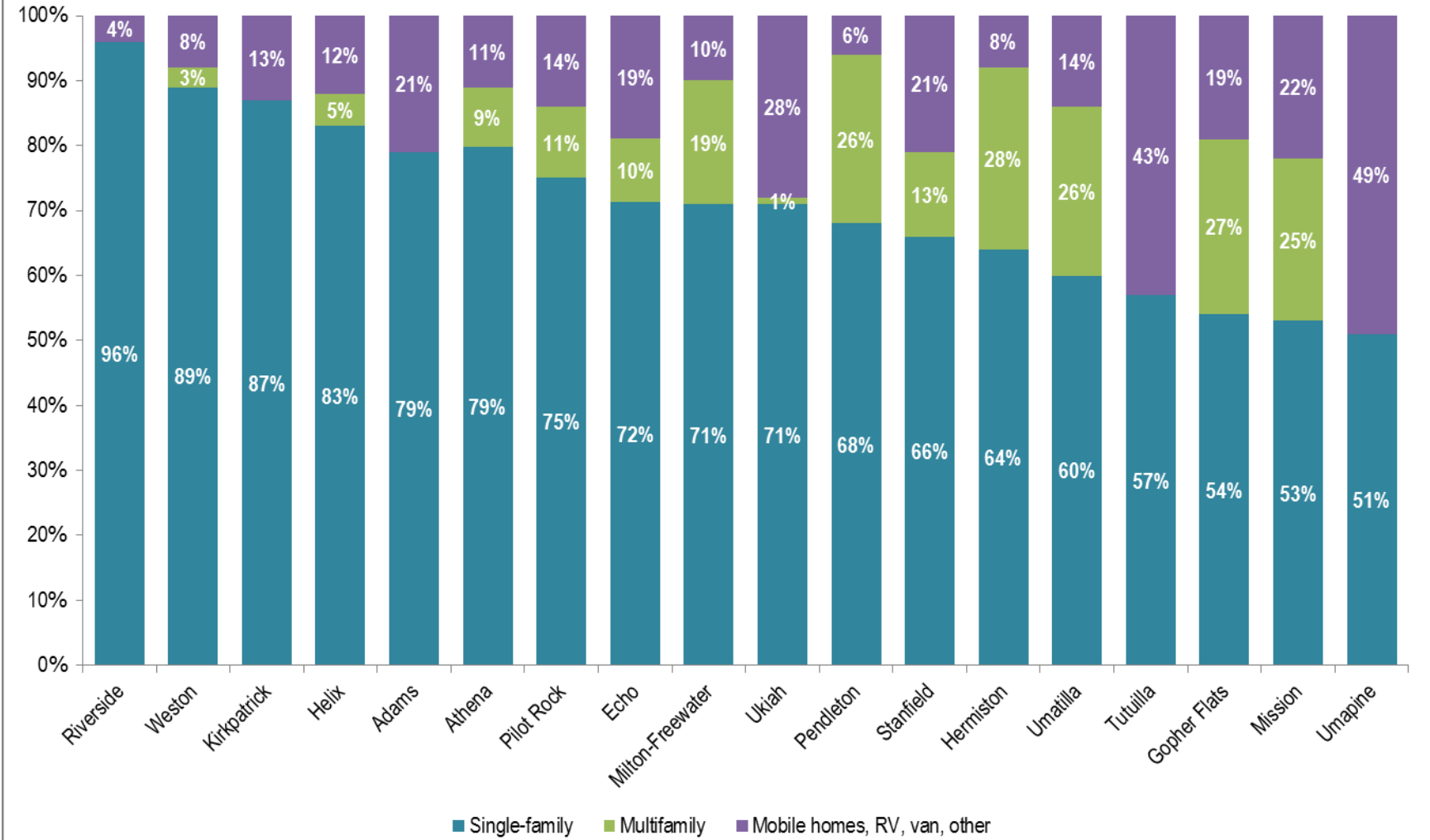

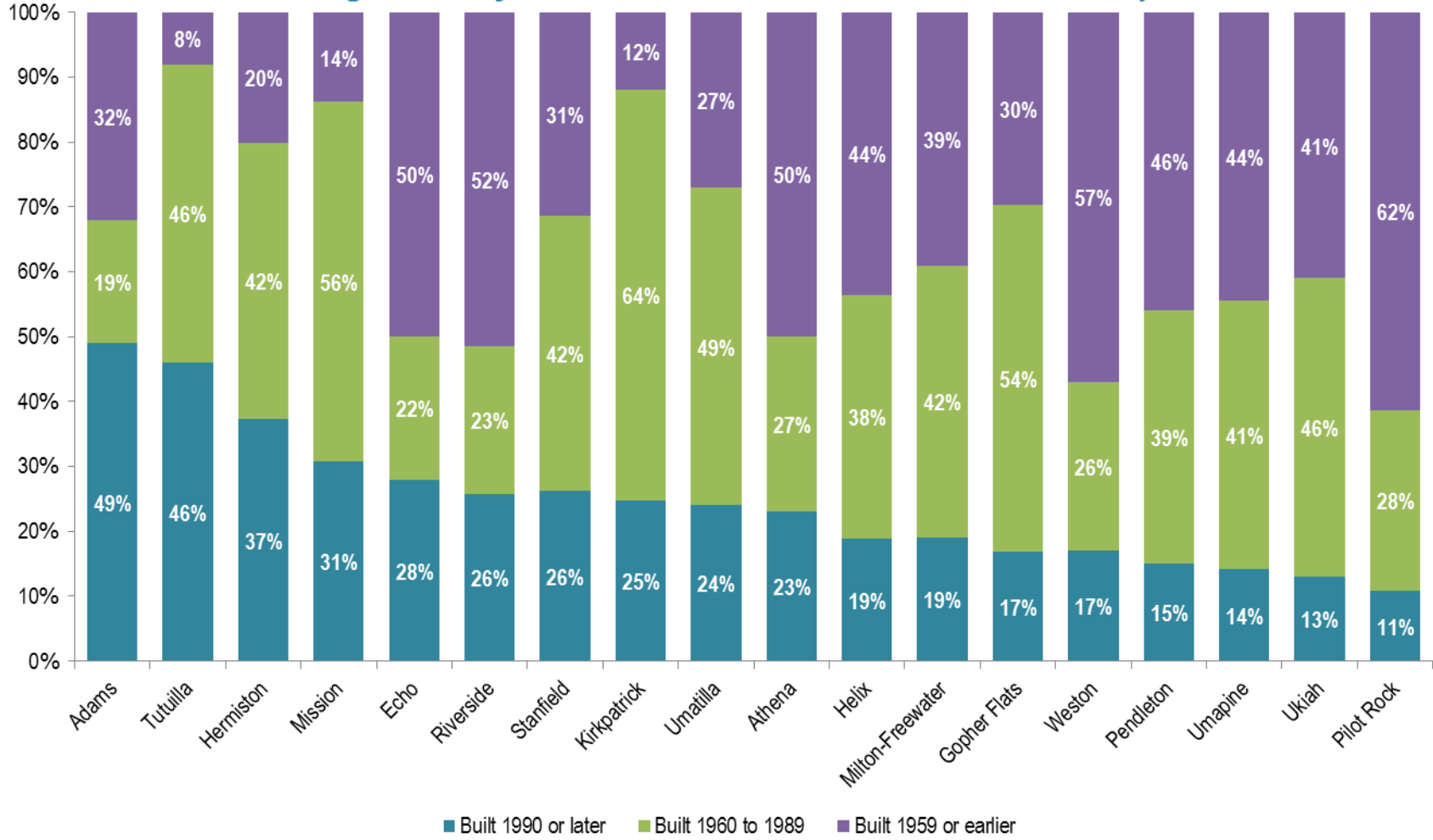

Housing Stock by Type, 2013 Umatilla County, OR

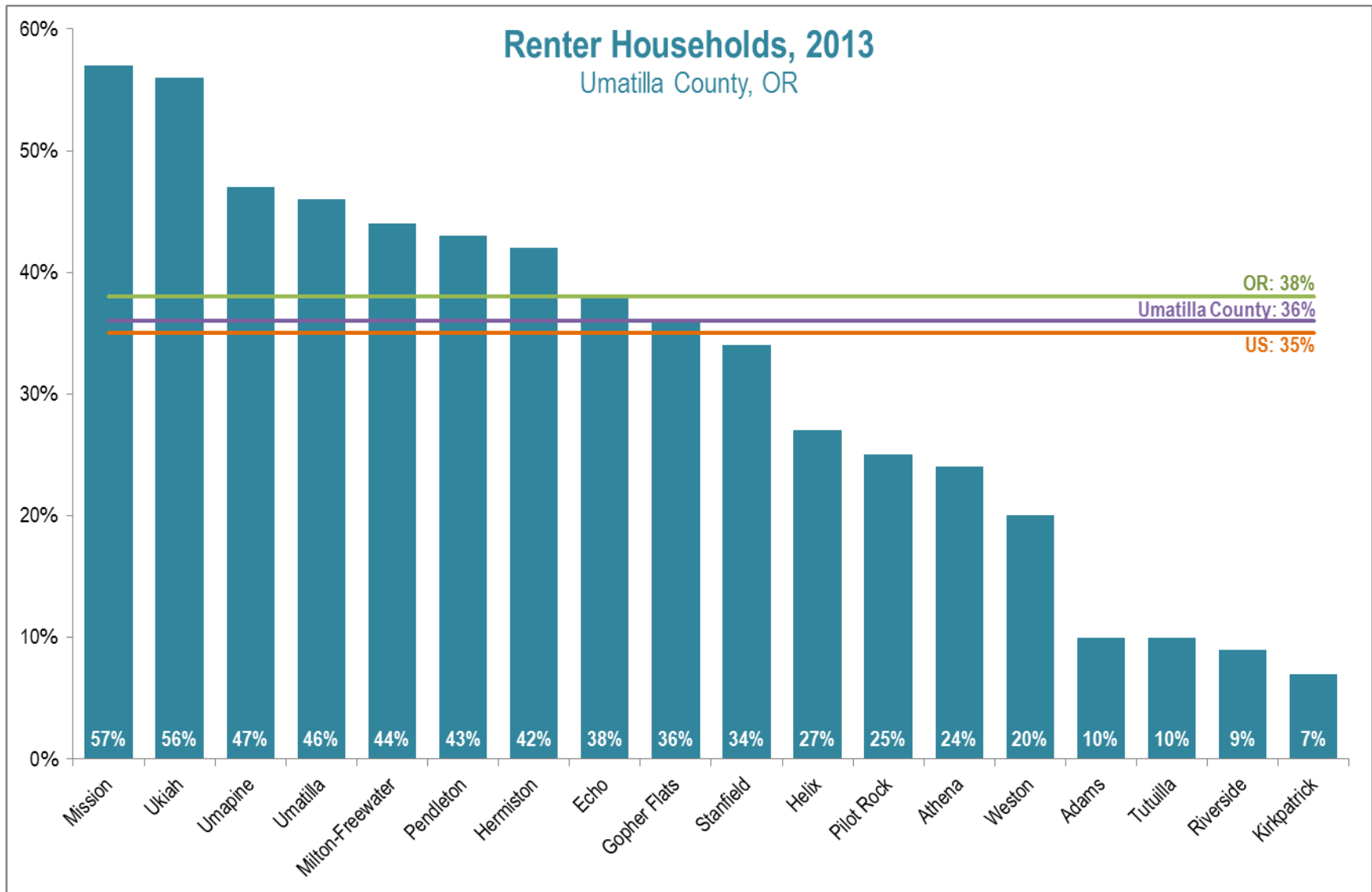

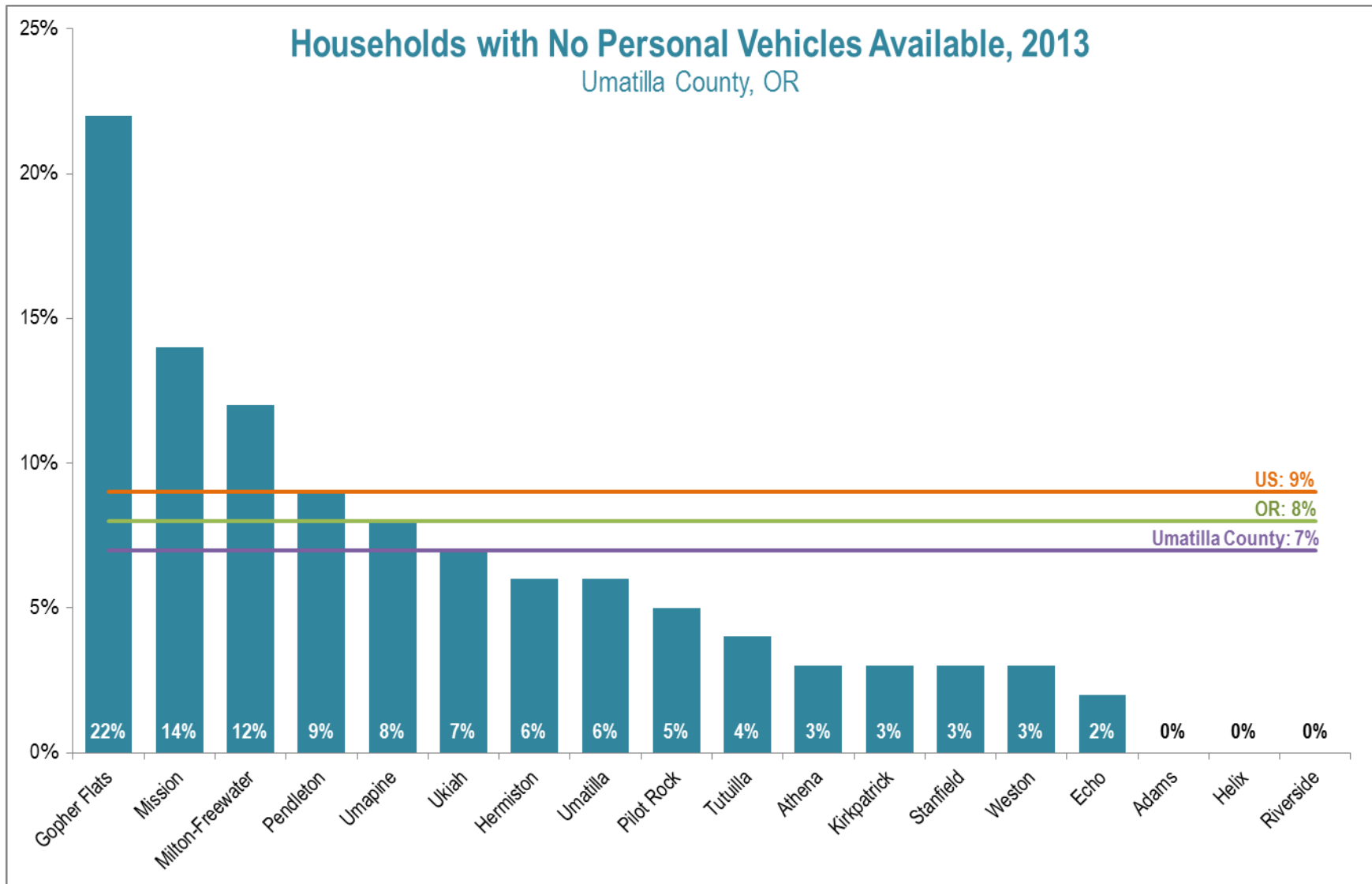
Housing Stock by Year Constructed, 2013 Umatilla County, OR



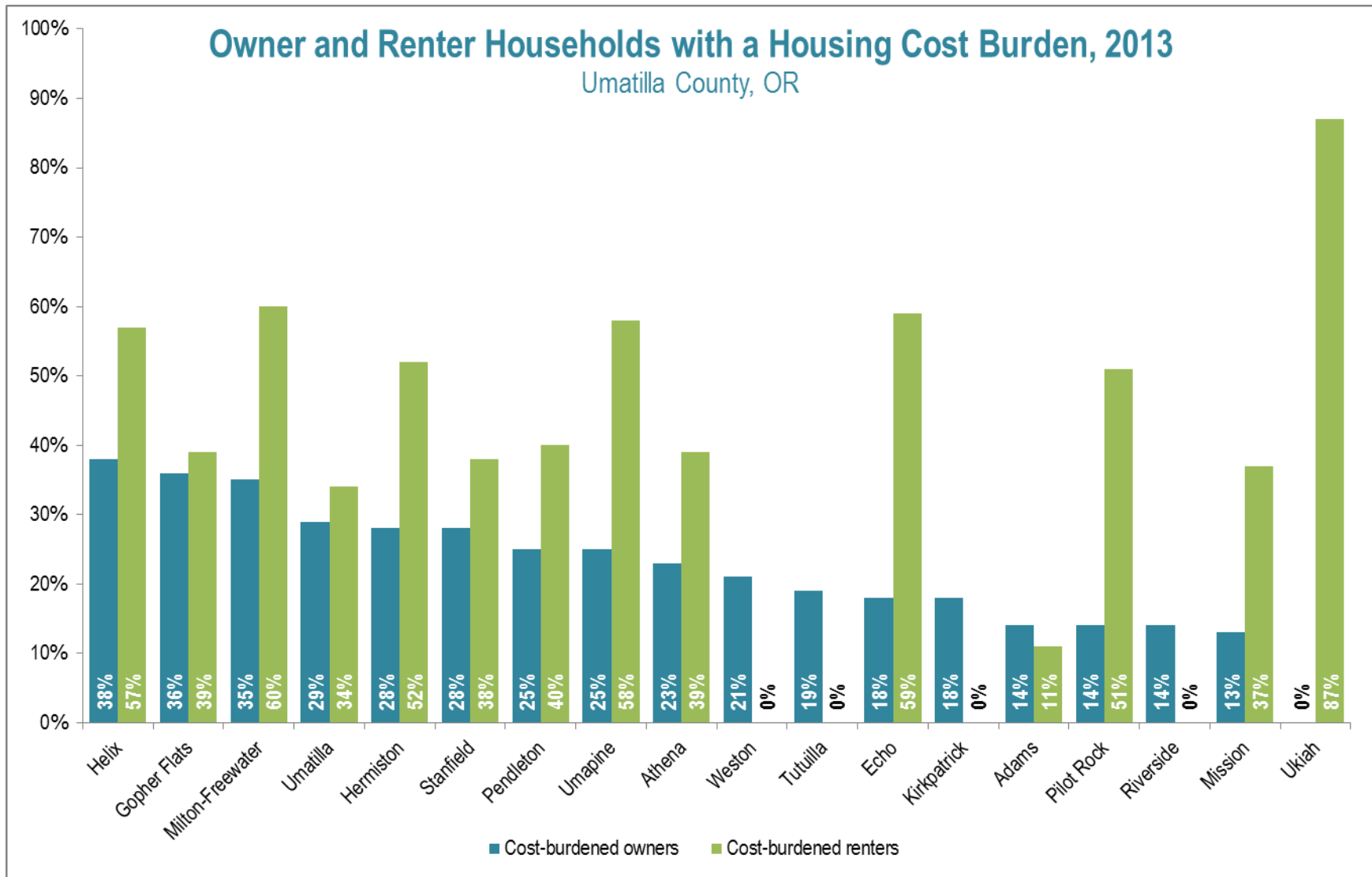
