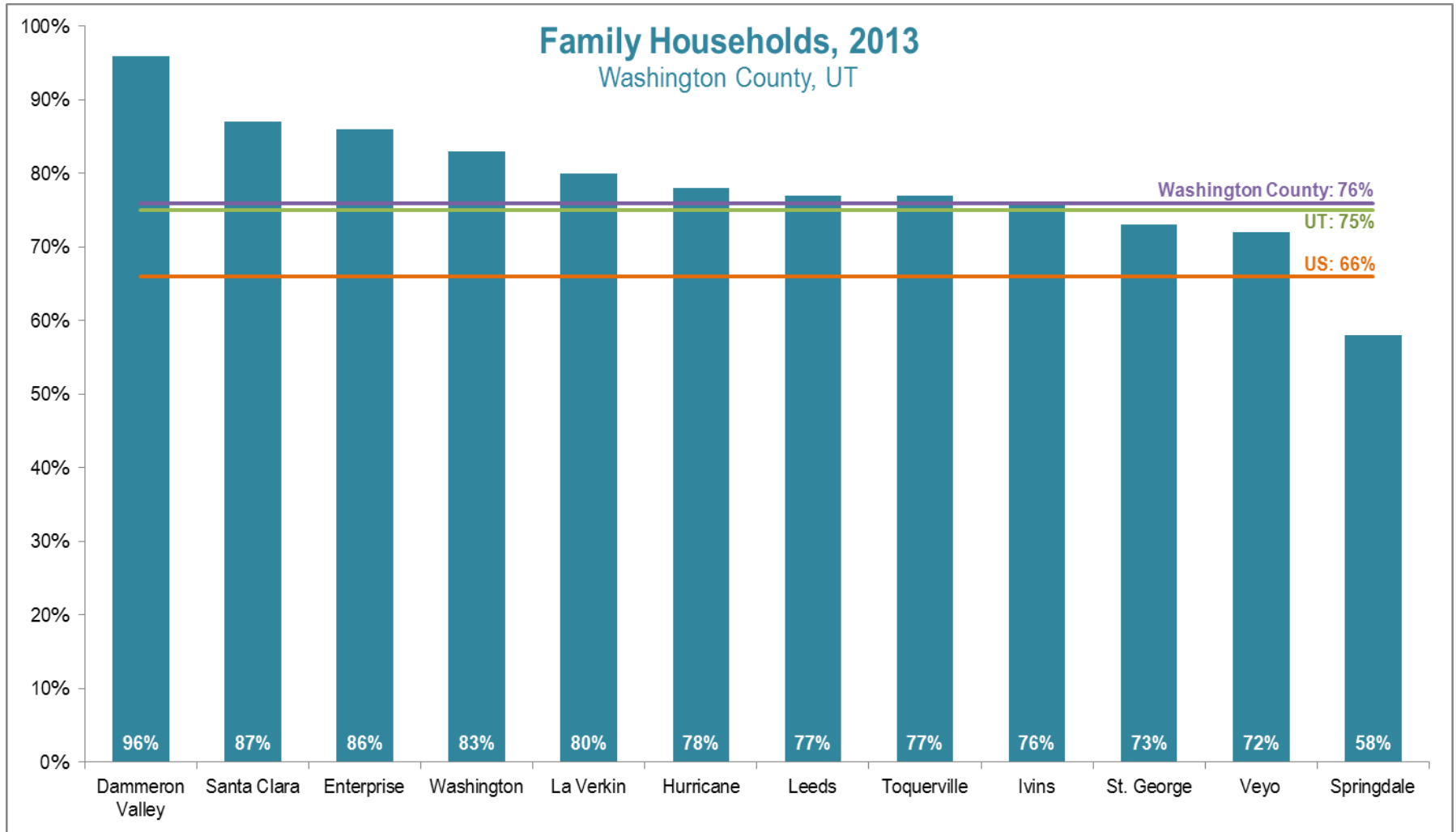

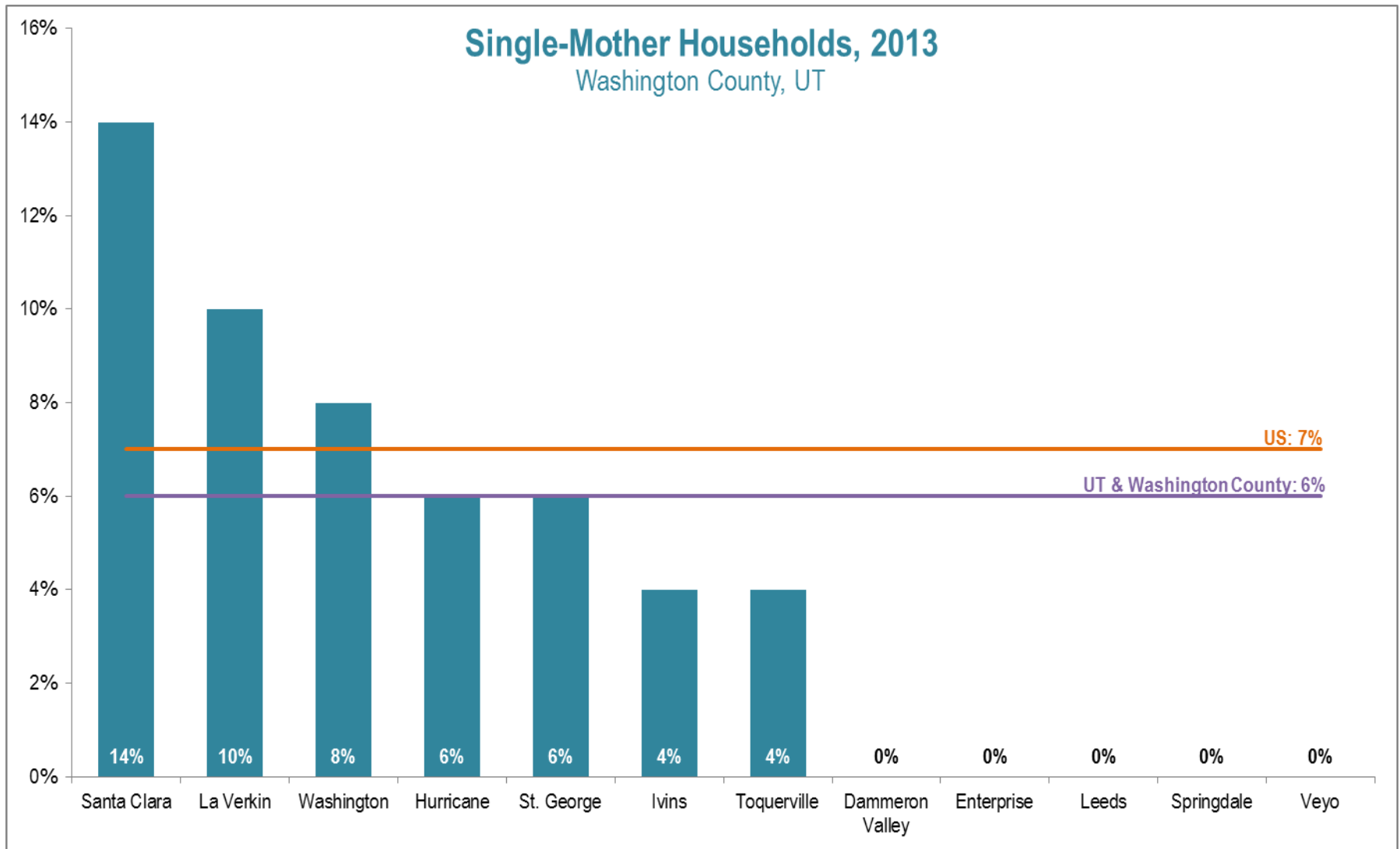

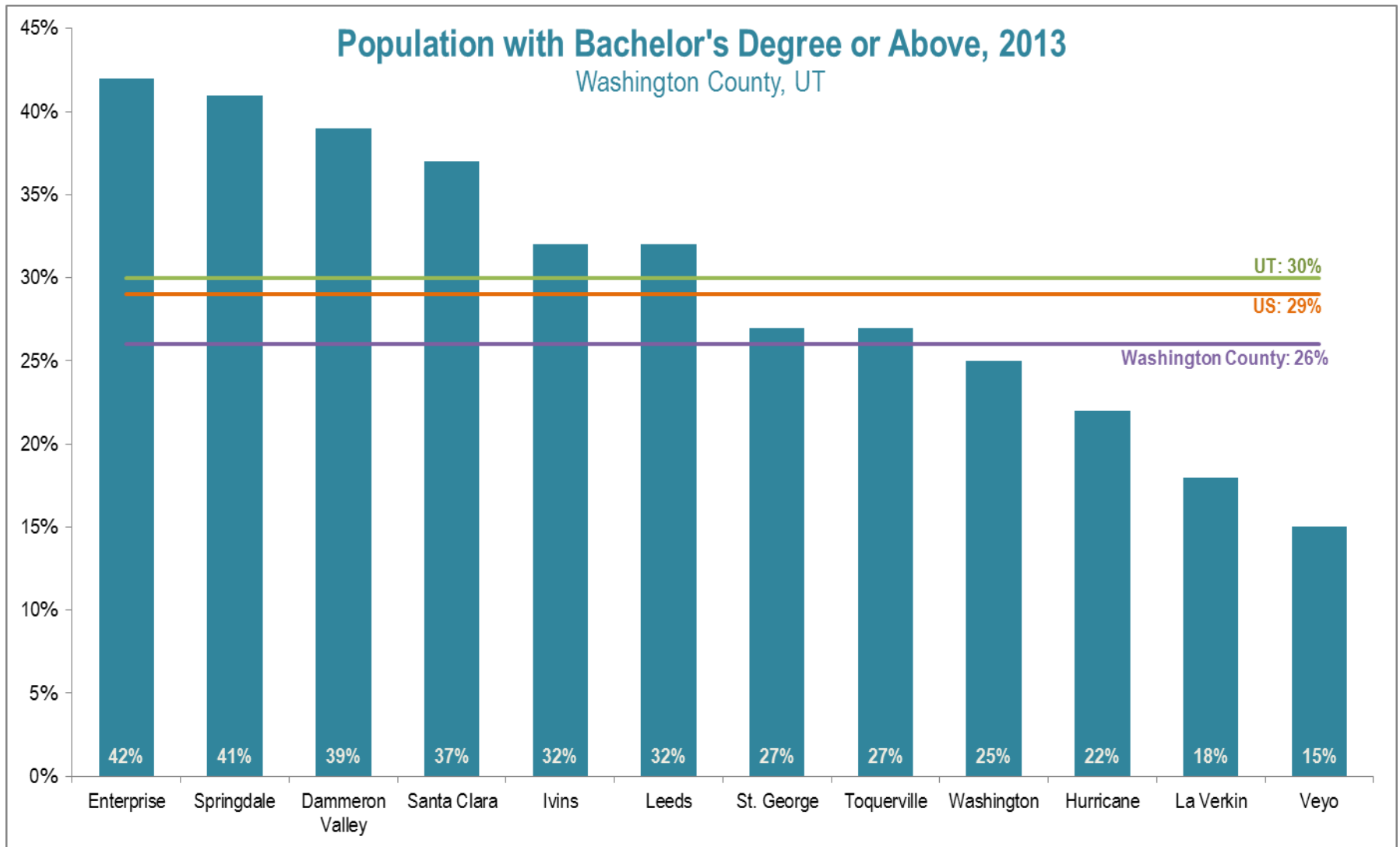

Population with High School Diploma/GED or Above, 2013

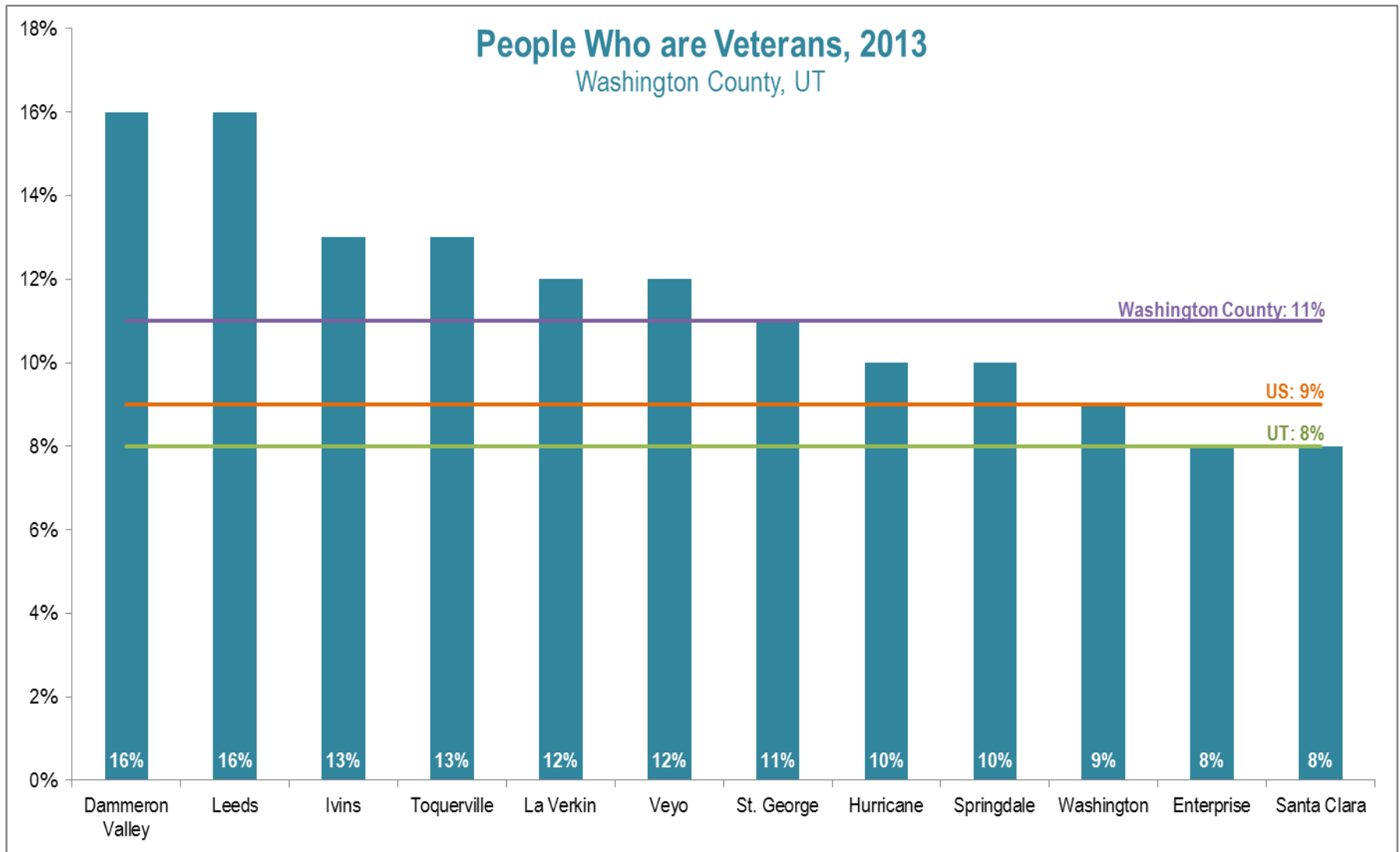

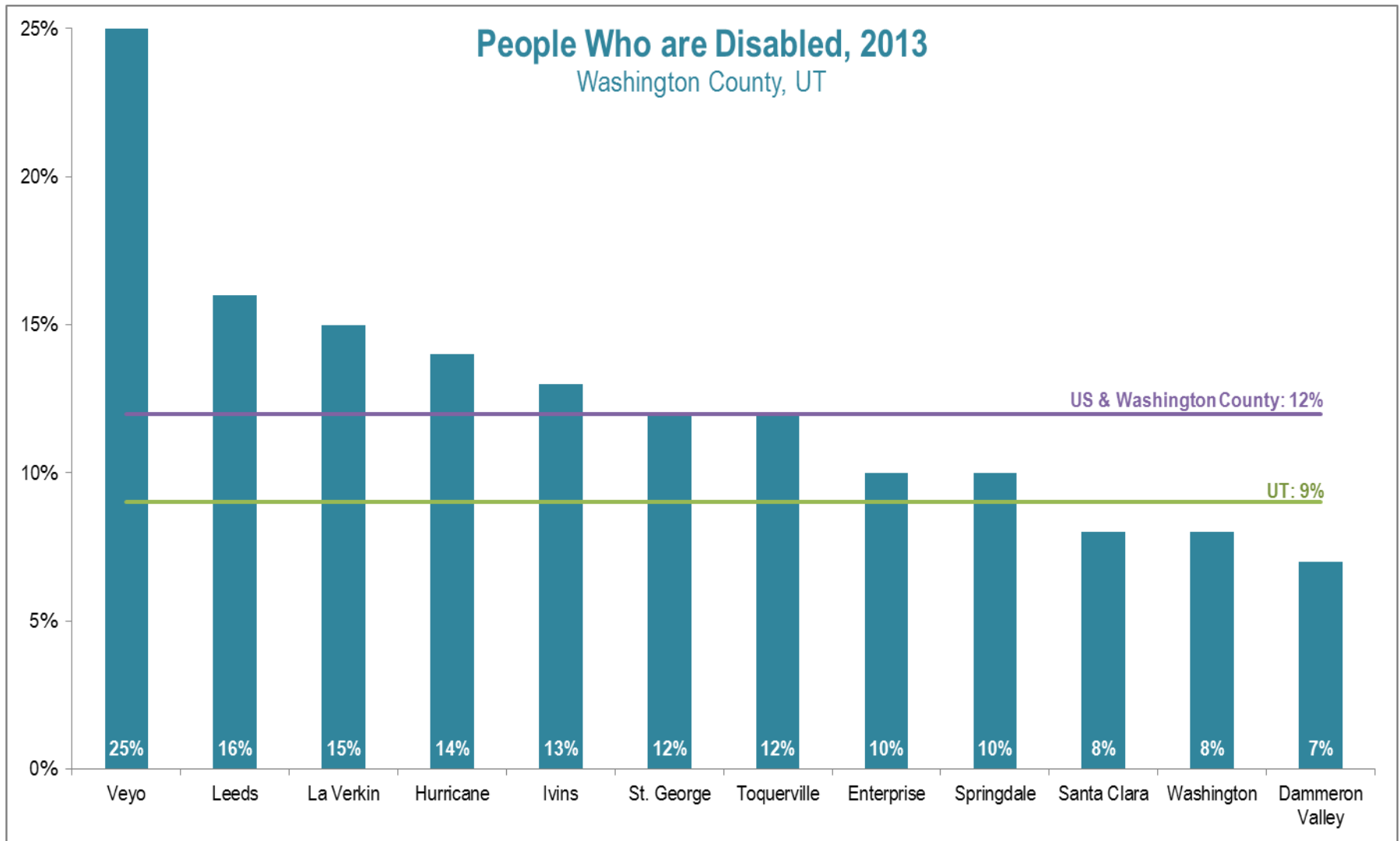

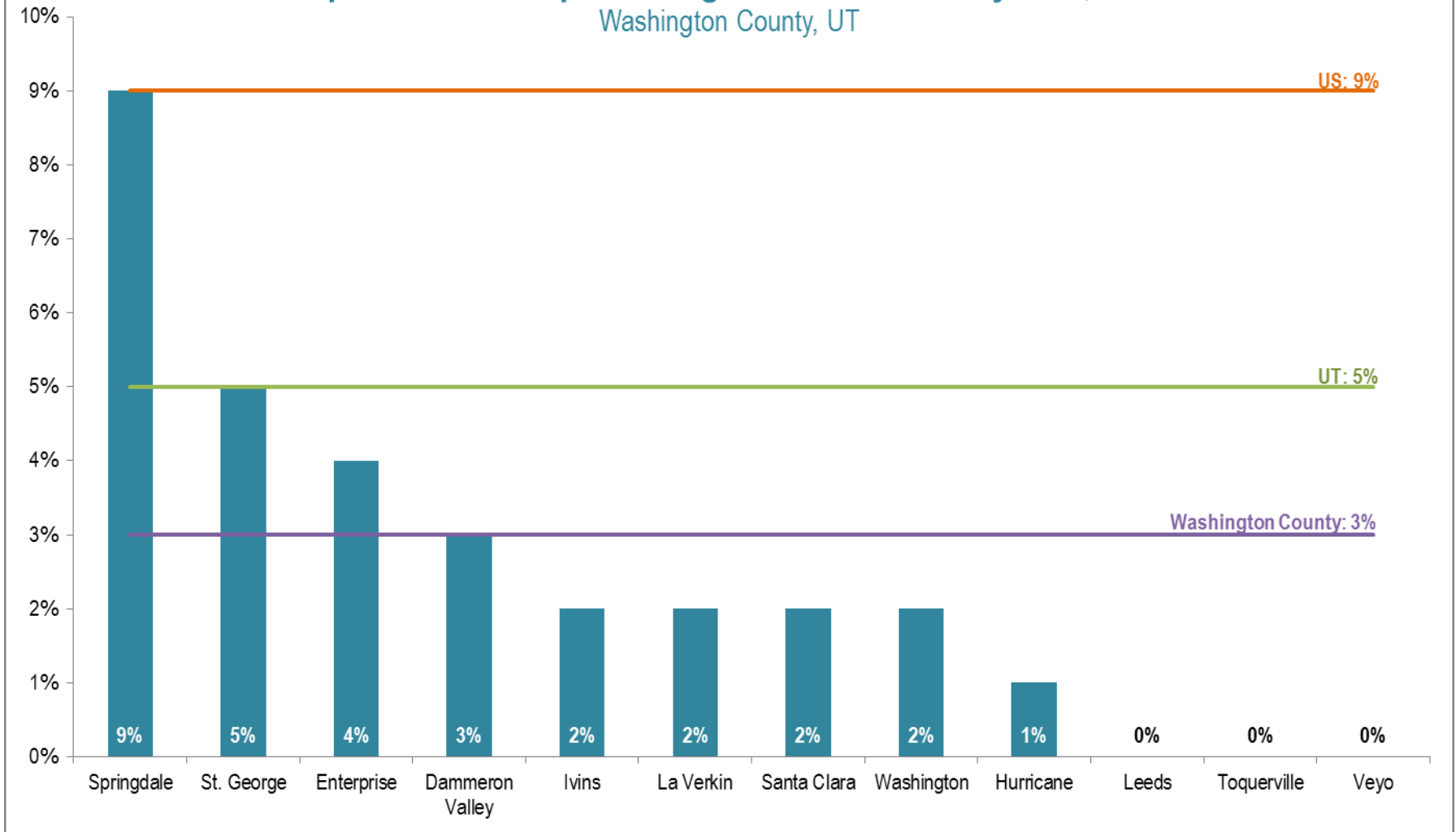

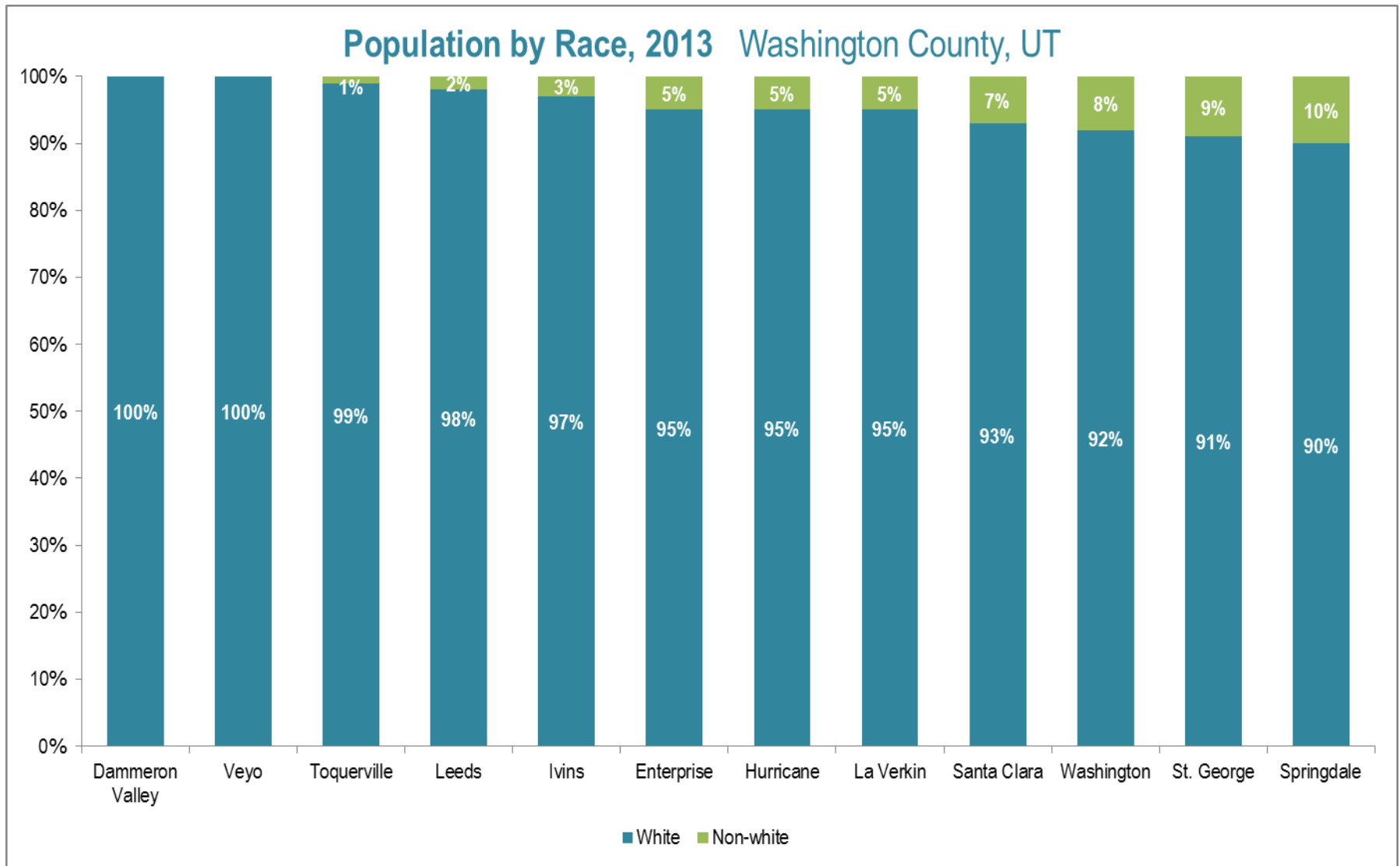

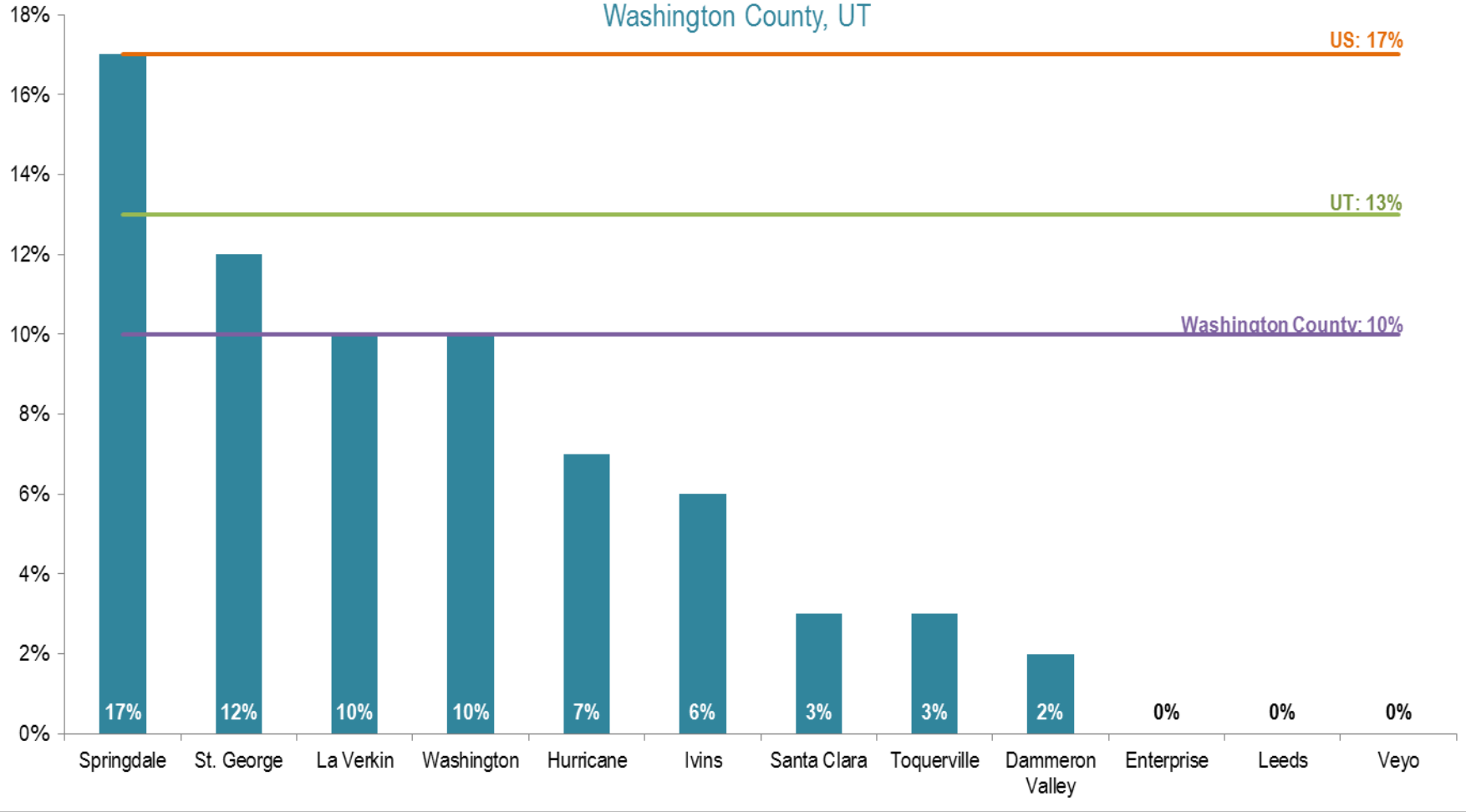
Percentage of Population That is Hispanic or Latino, 2013

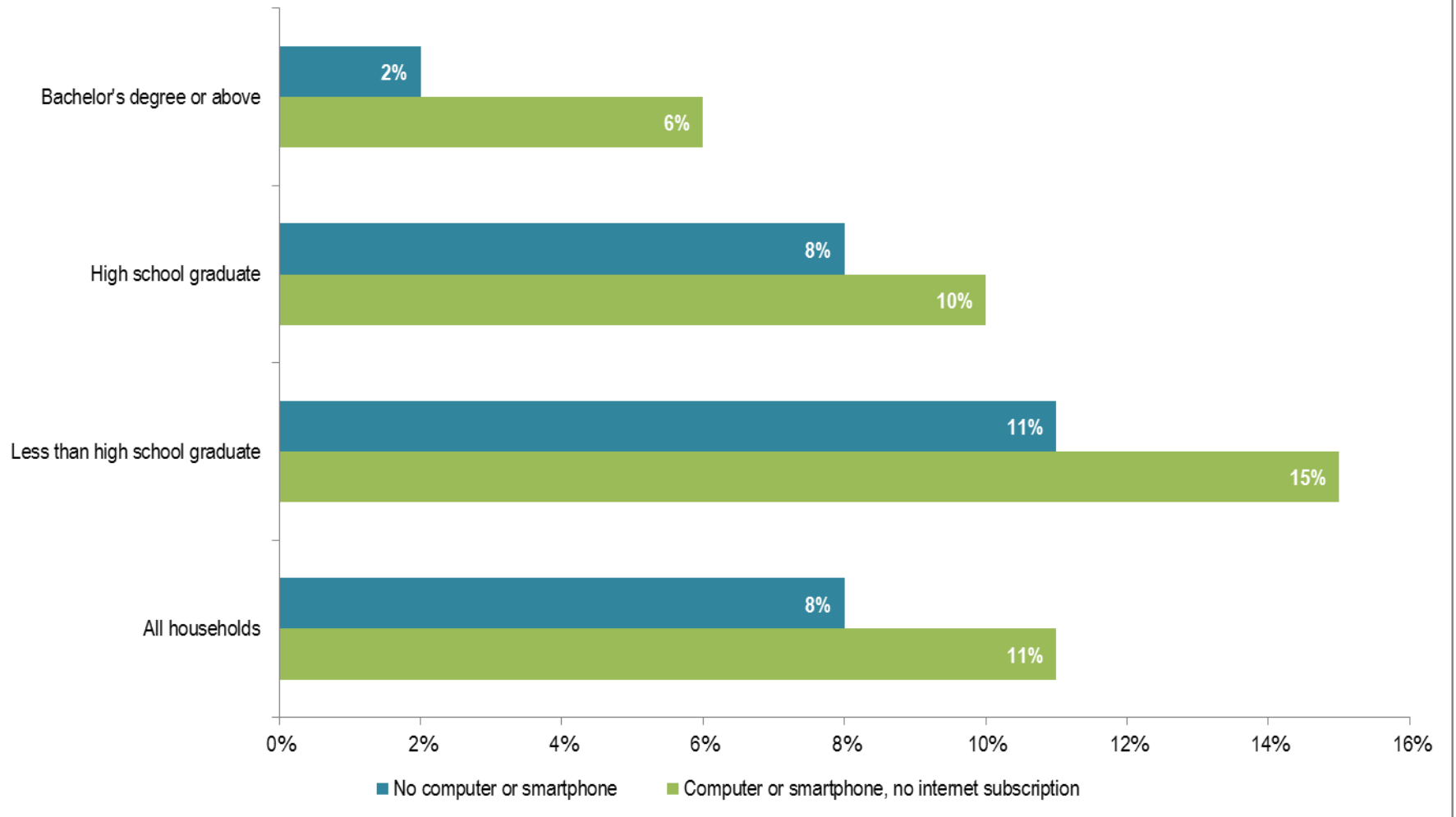

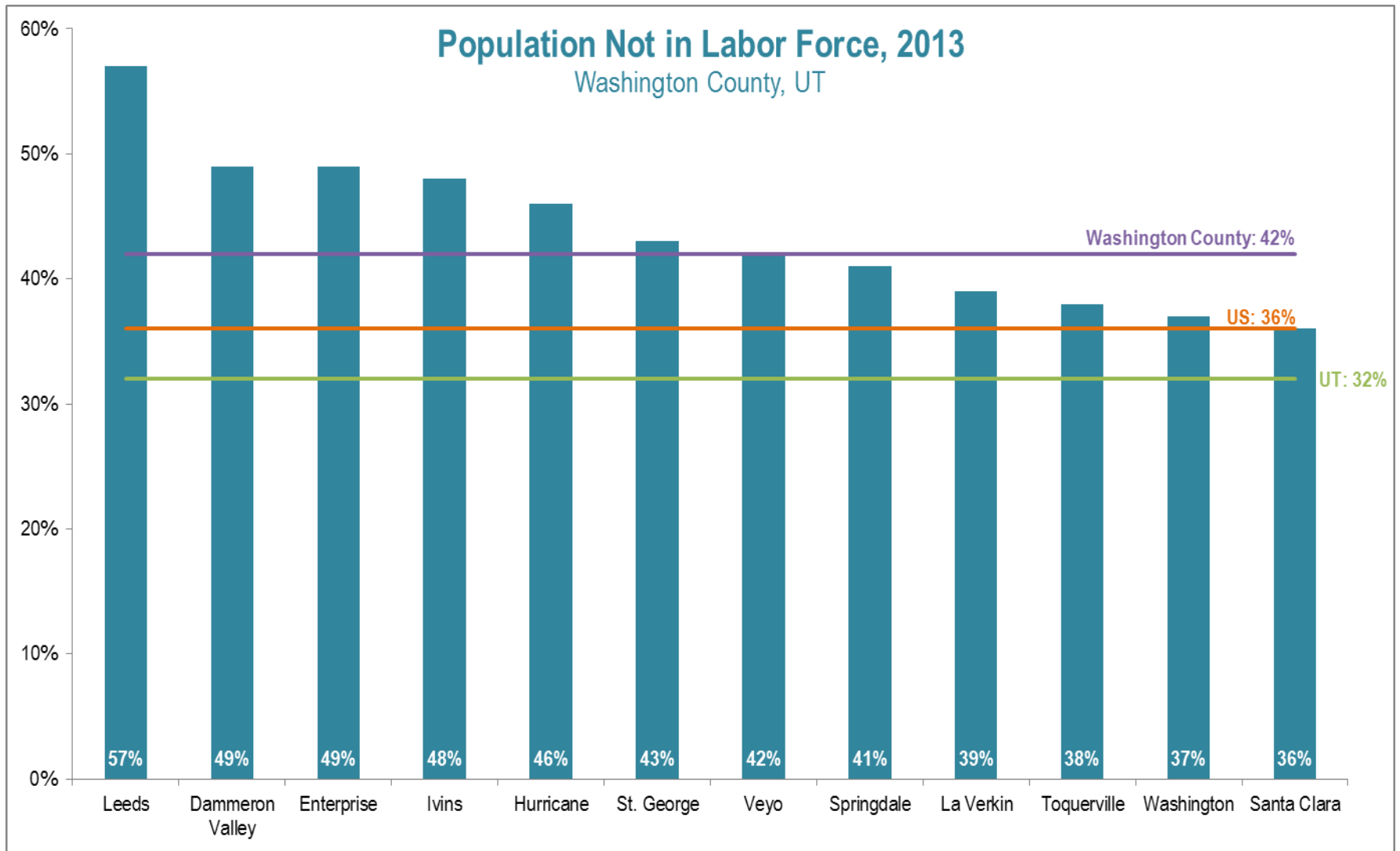

Access to Computers, Smartphones, and Internet, 2013 Washington County, UT

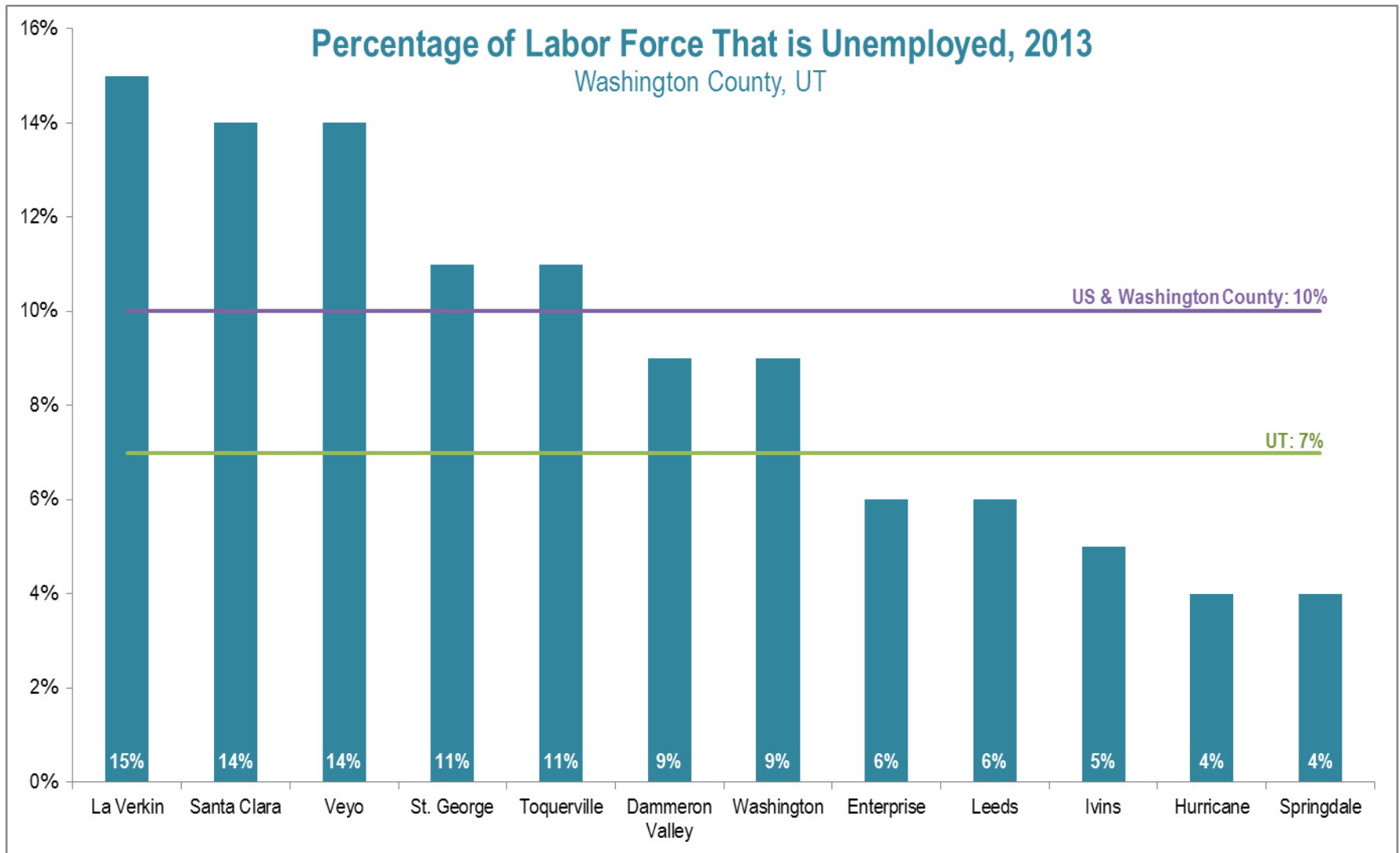

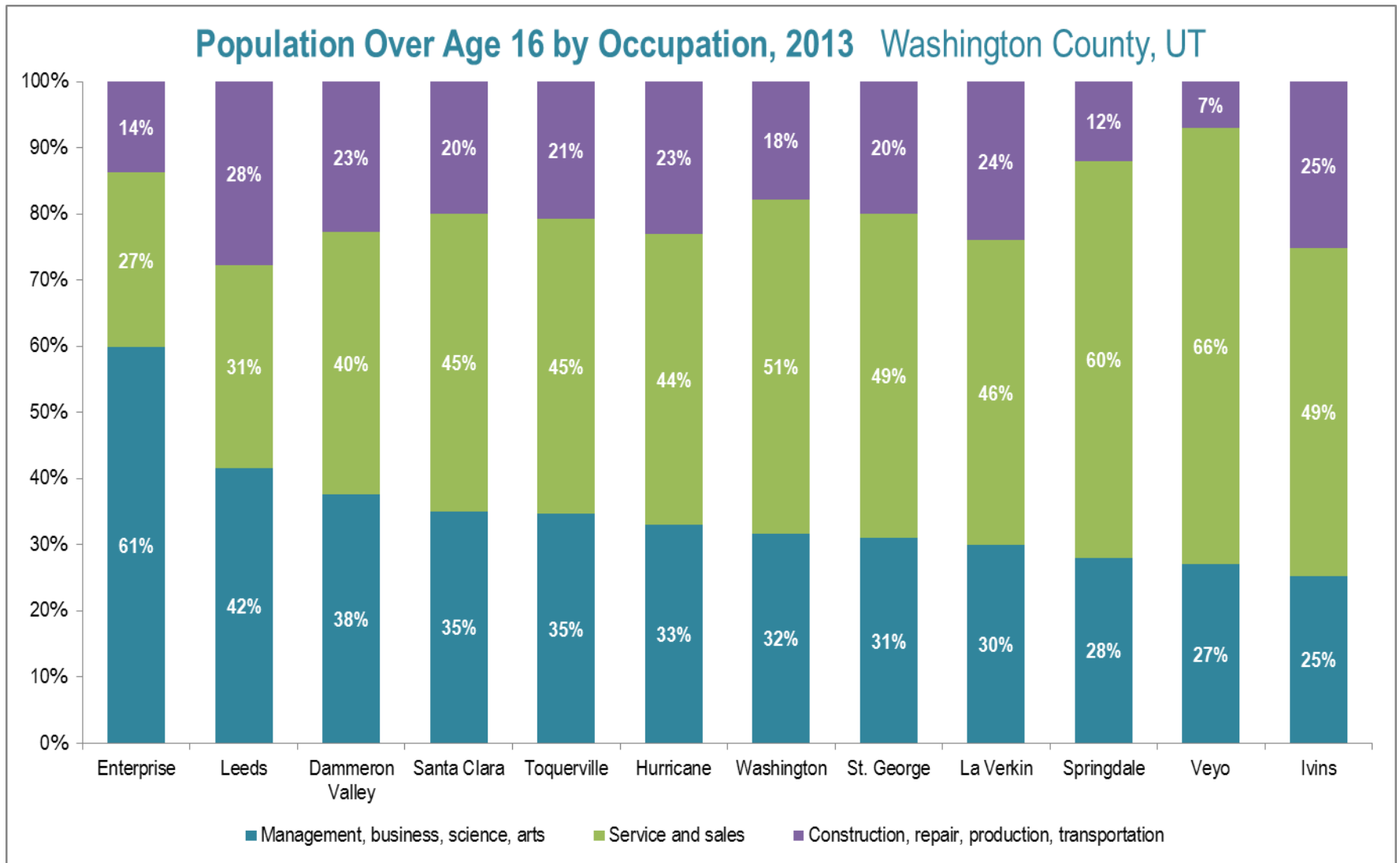

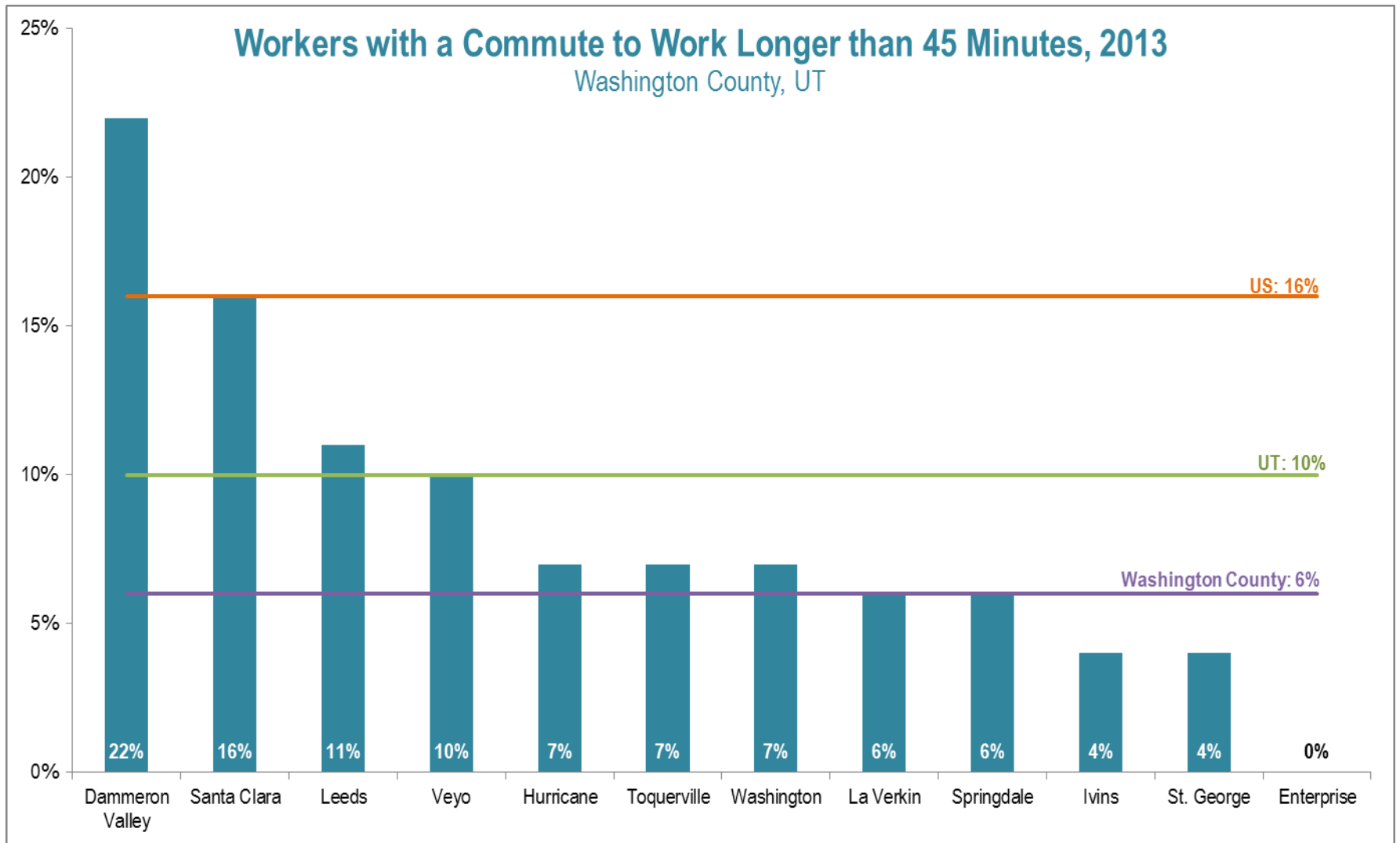

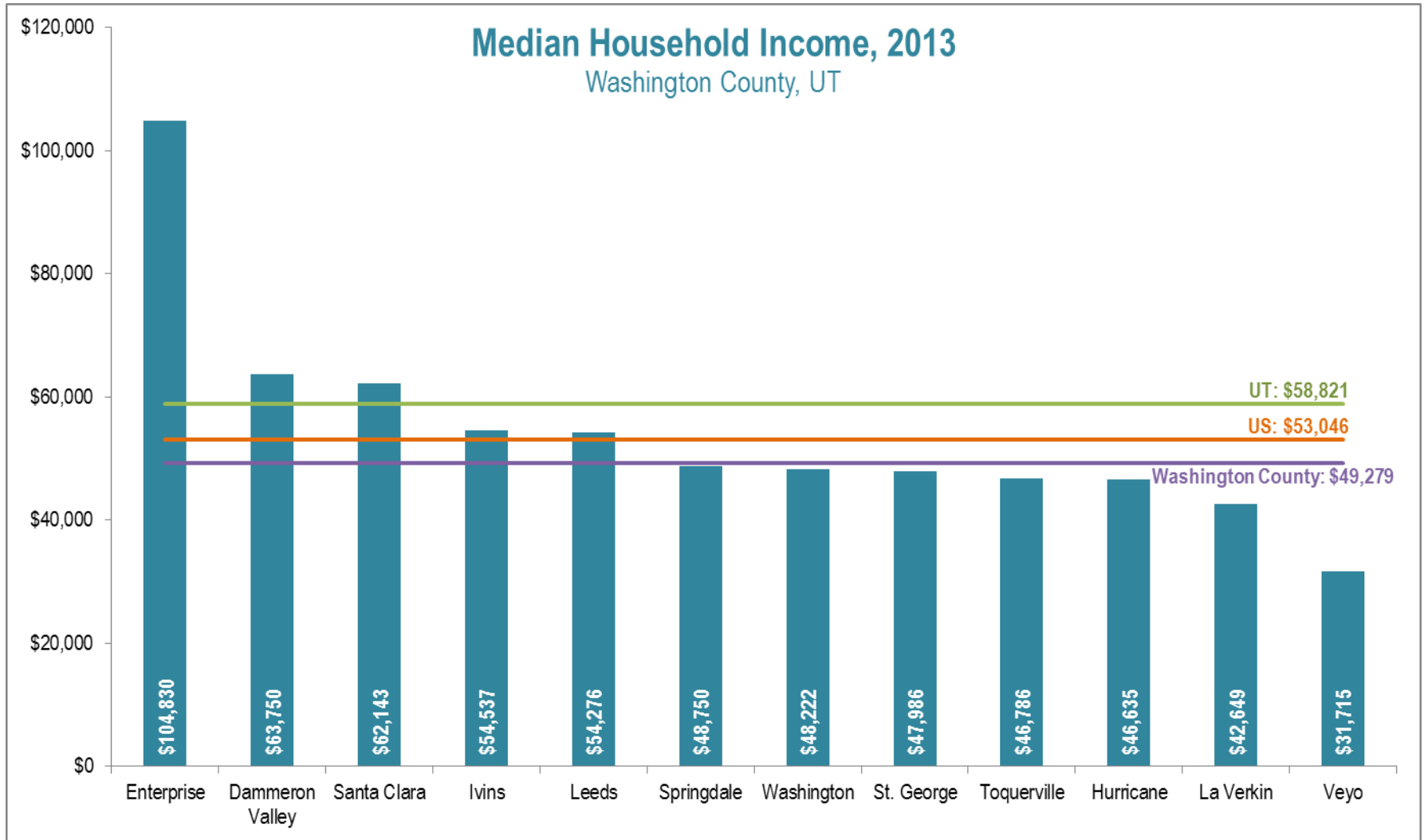

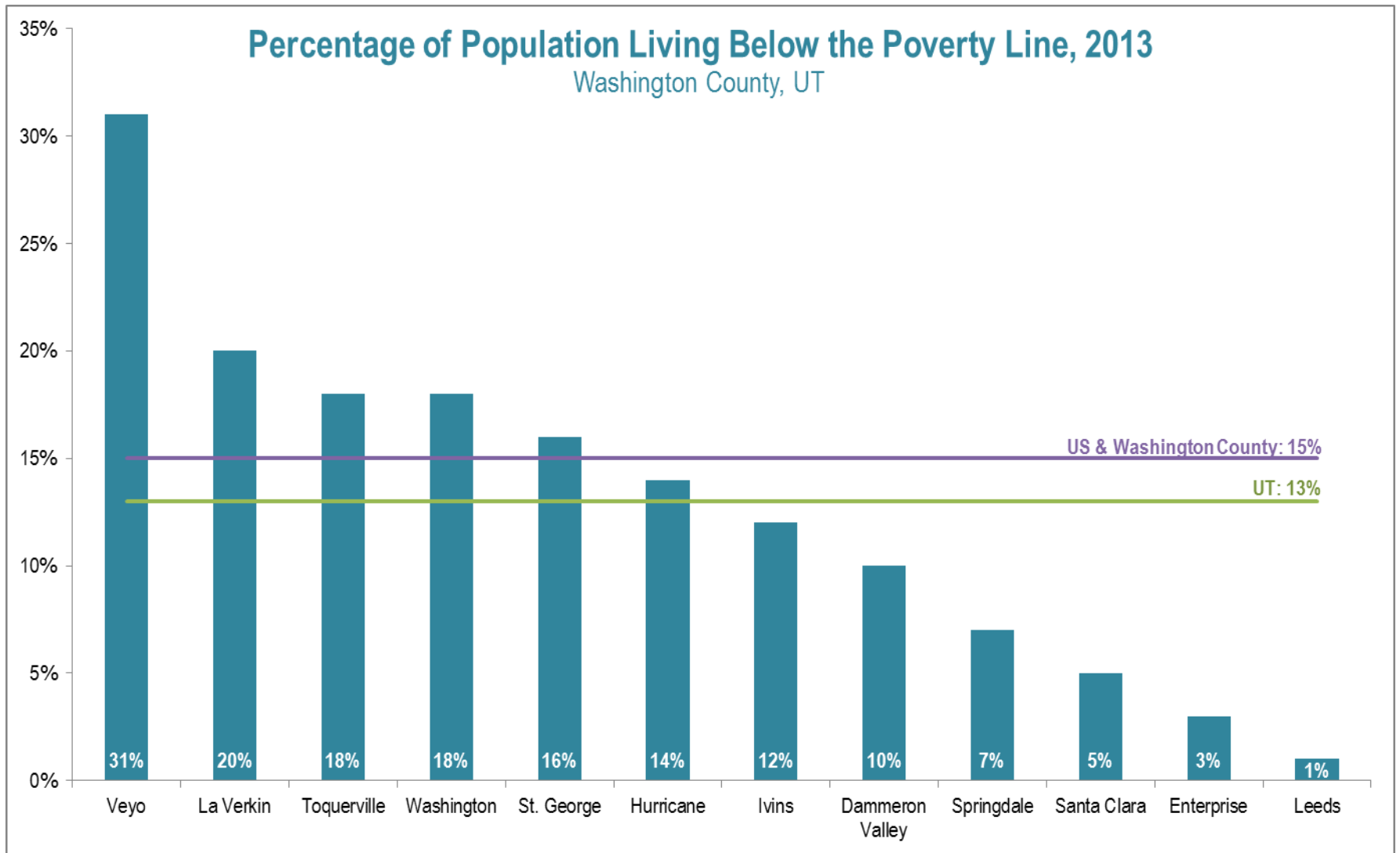

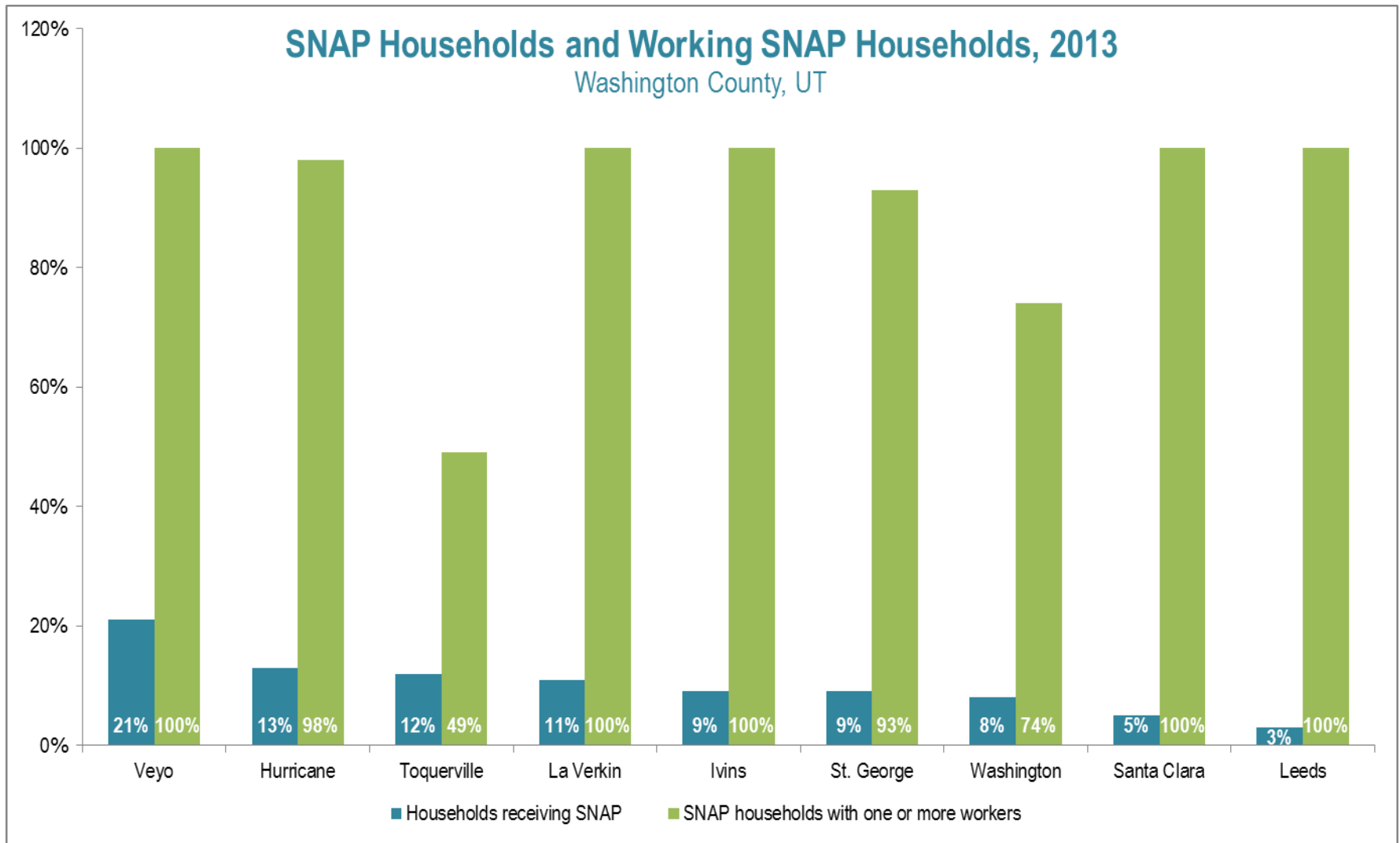

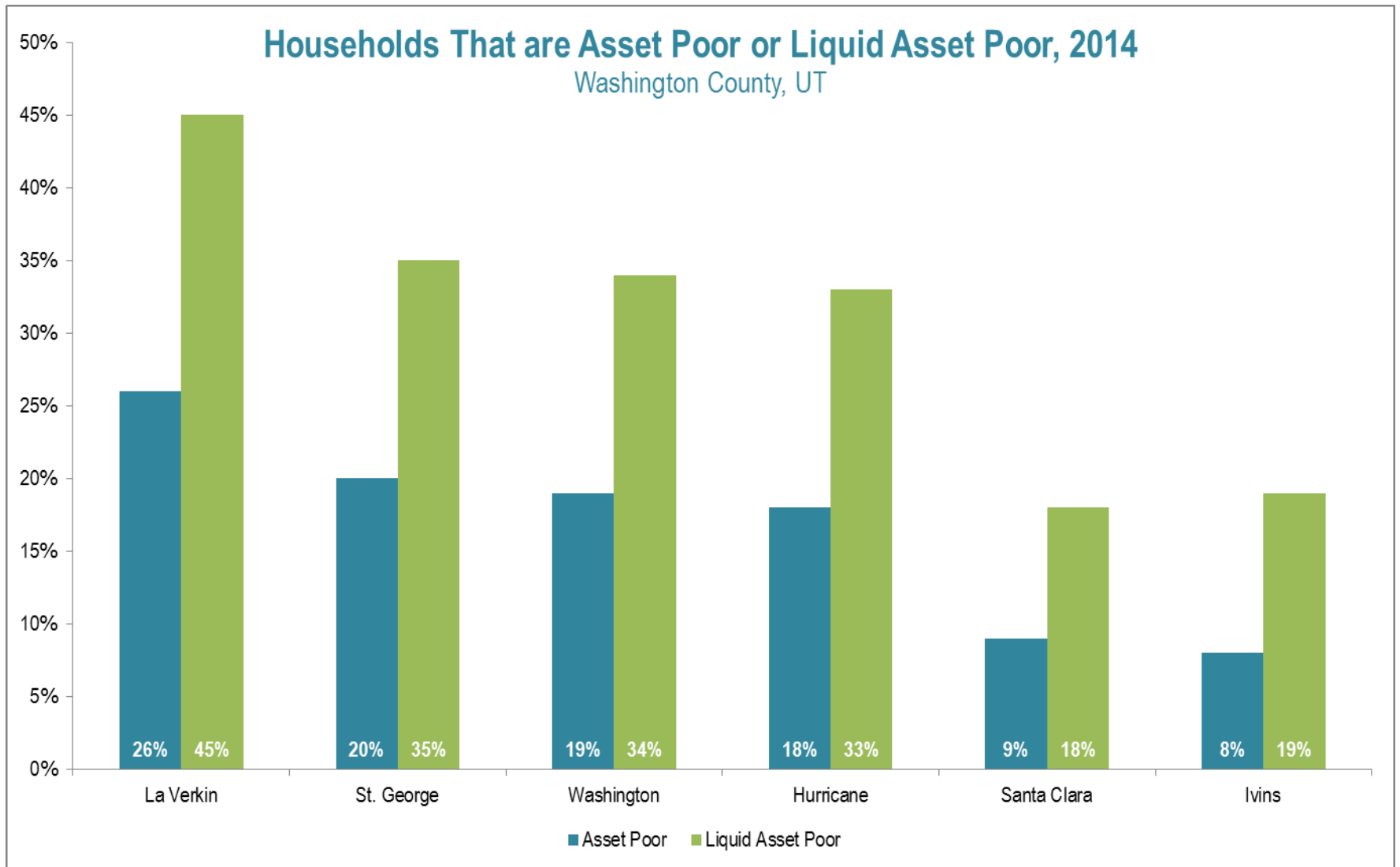

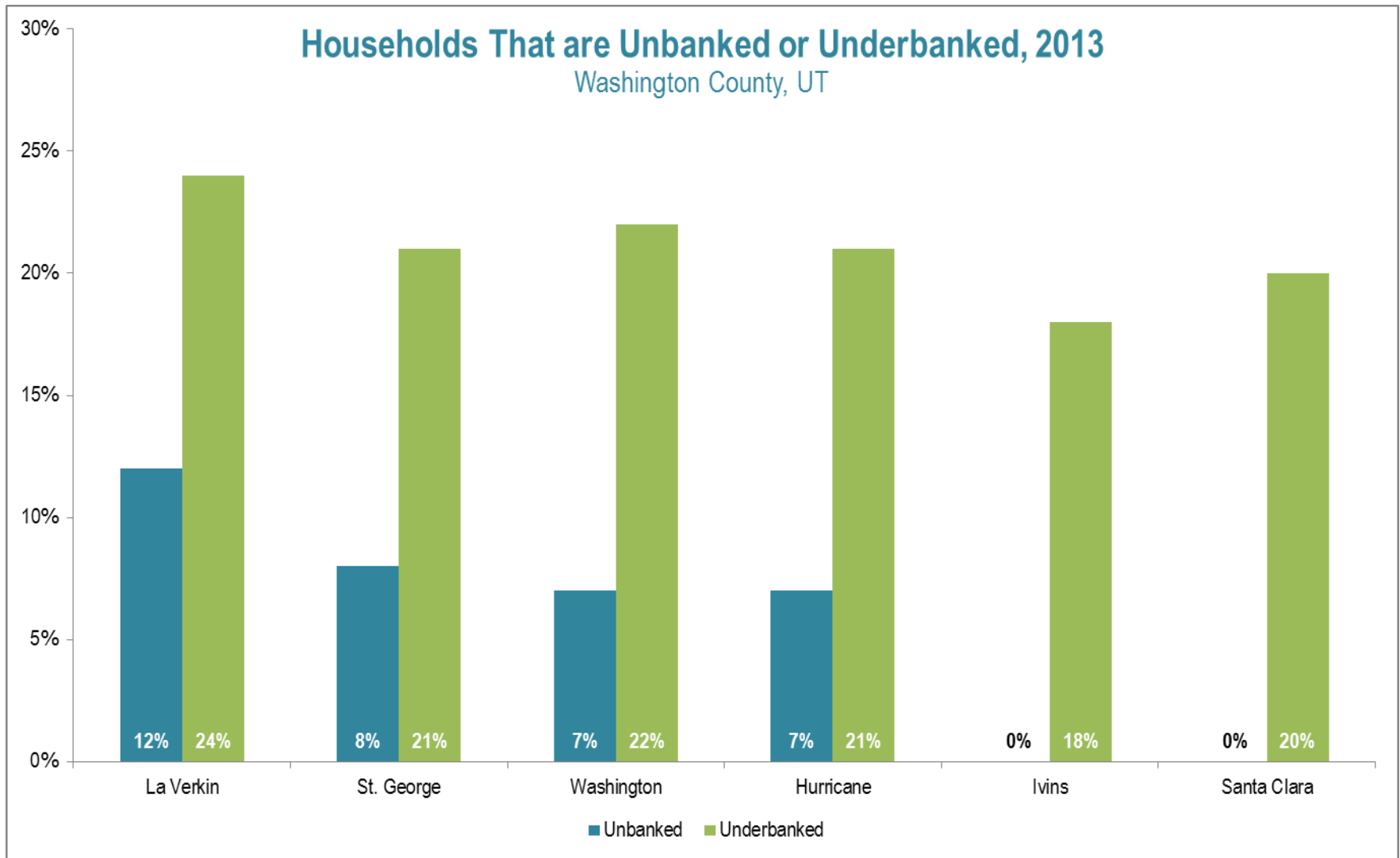

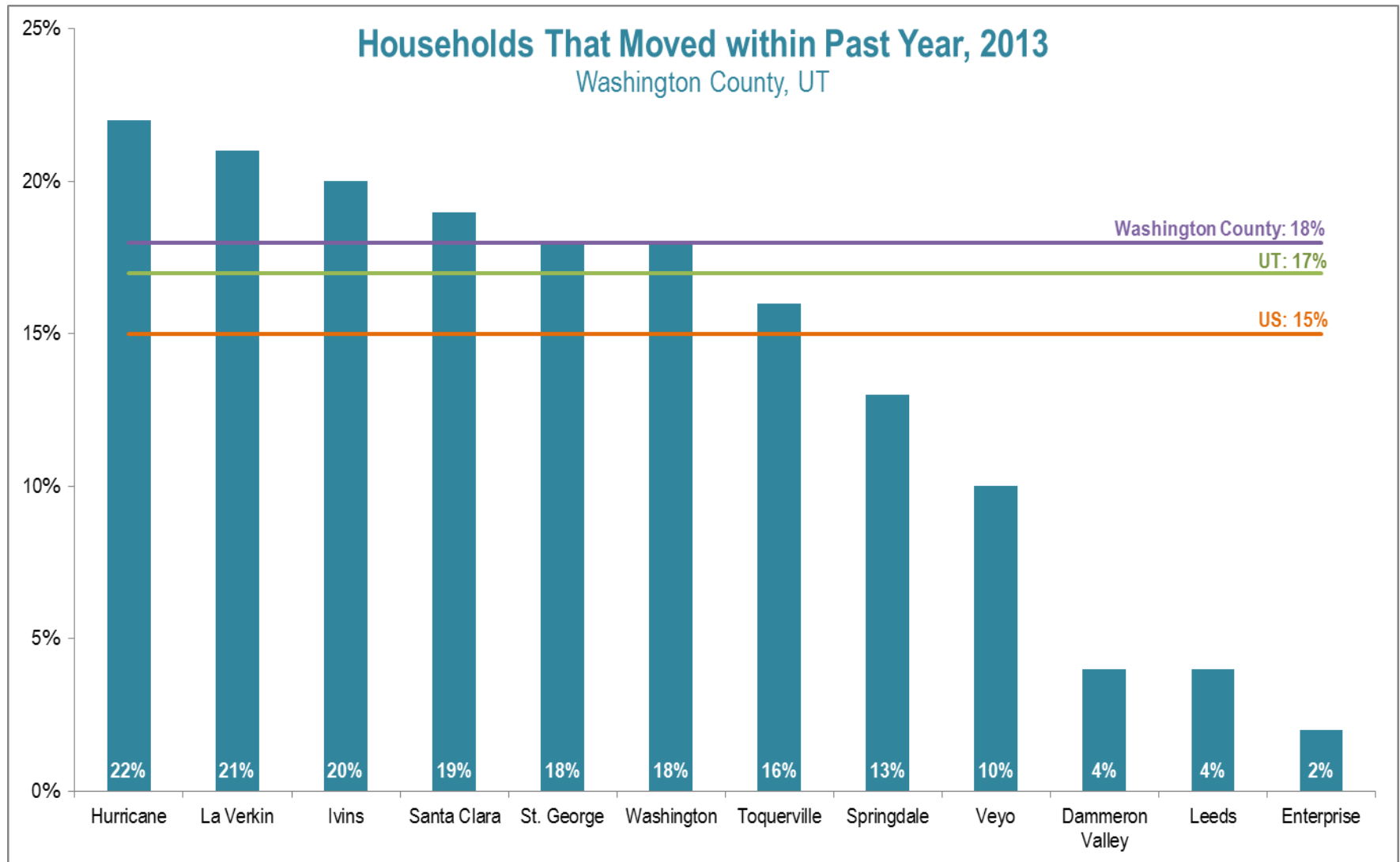

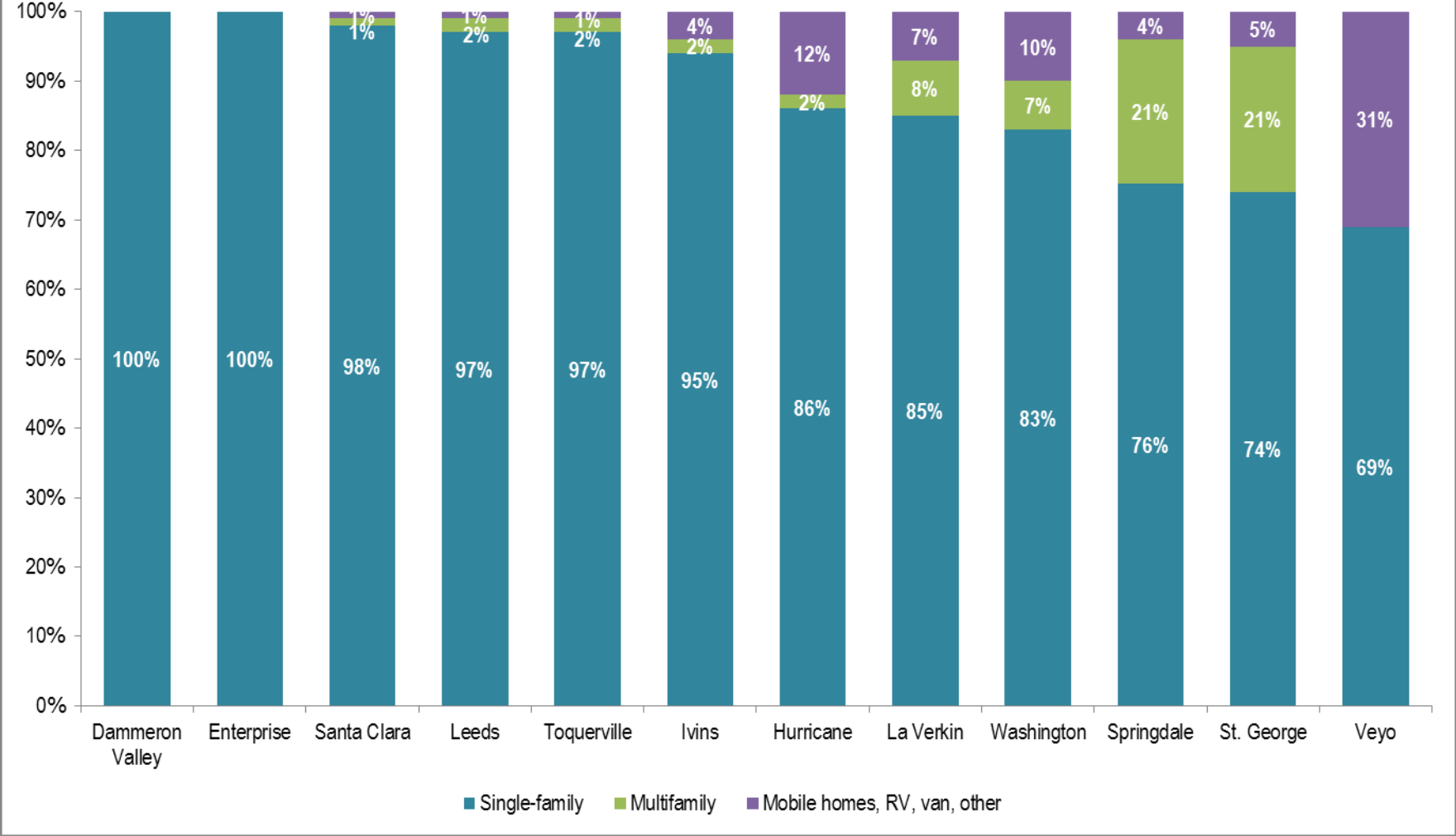

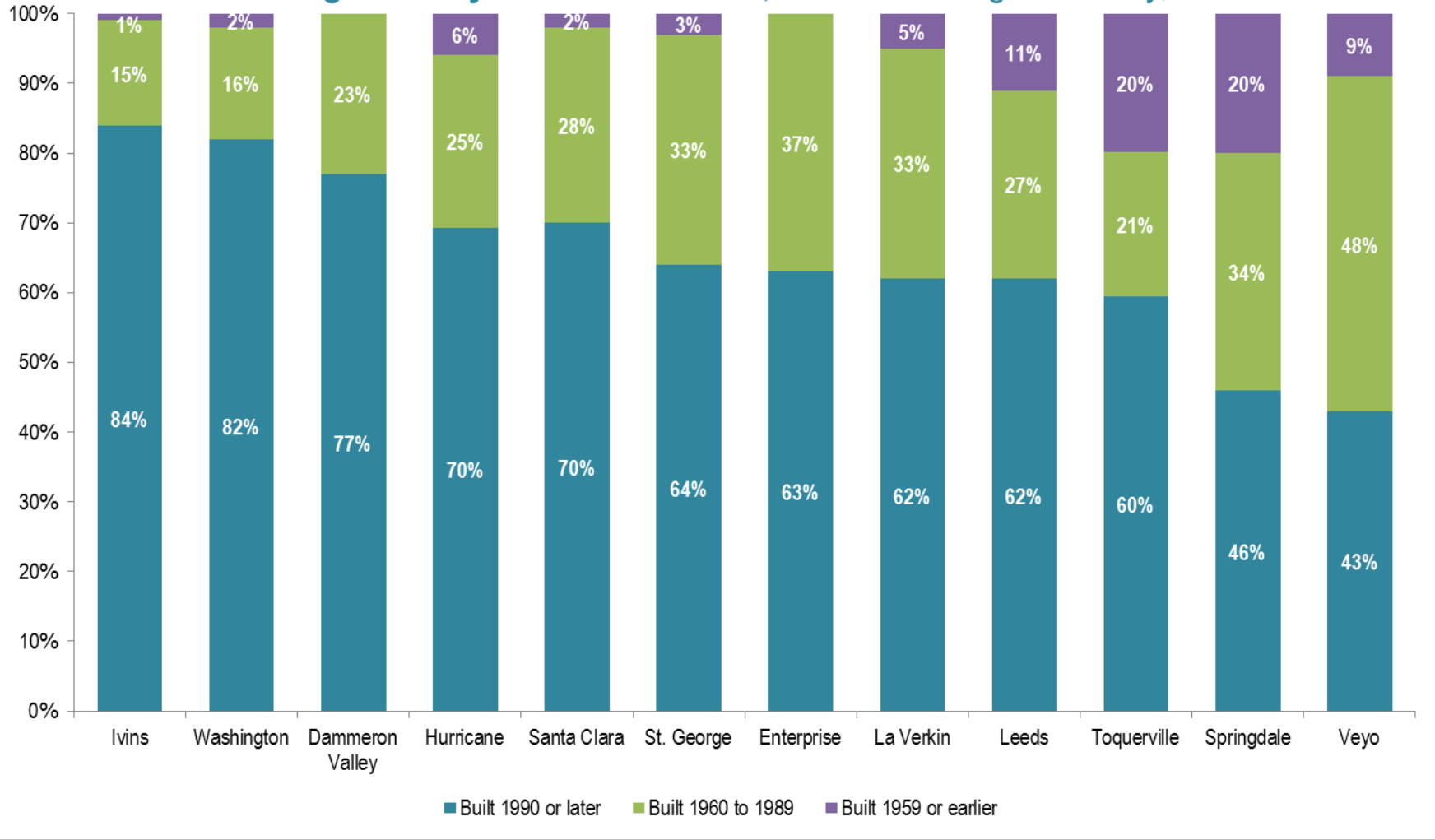

Housing Stock by Type, 2013 Washington County, UT

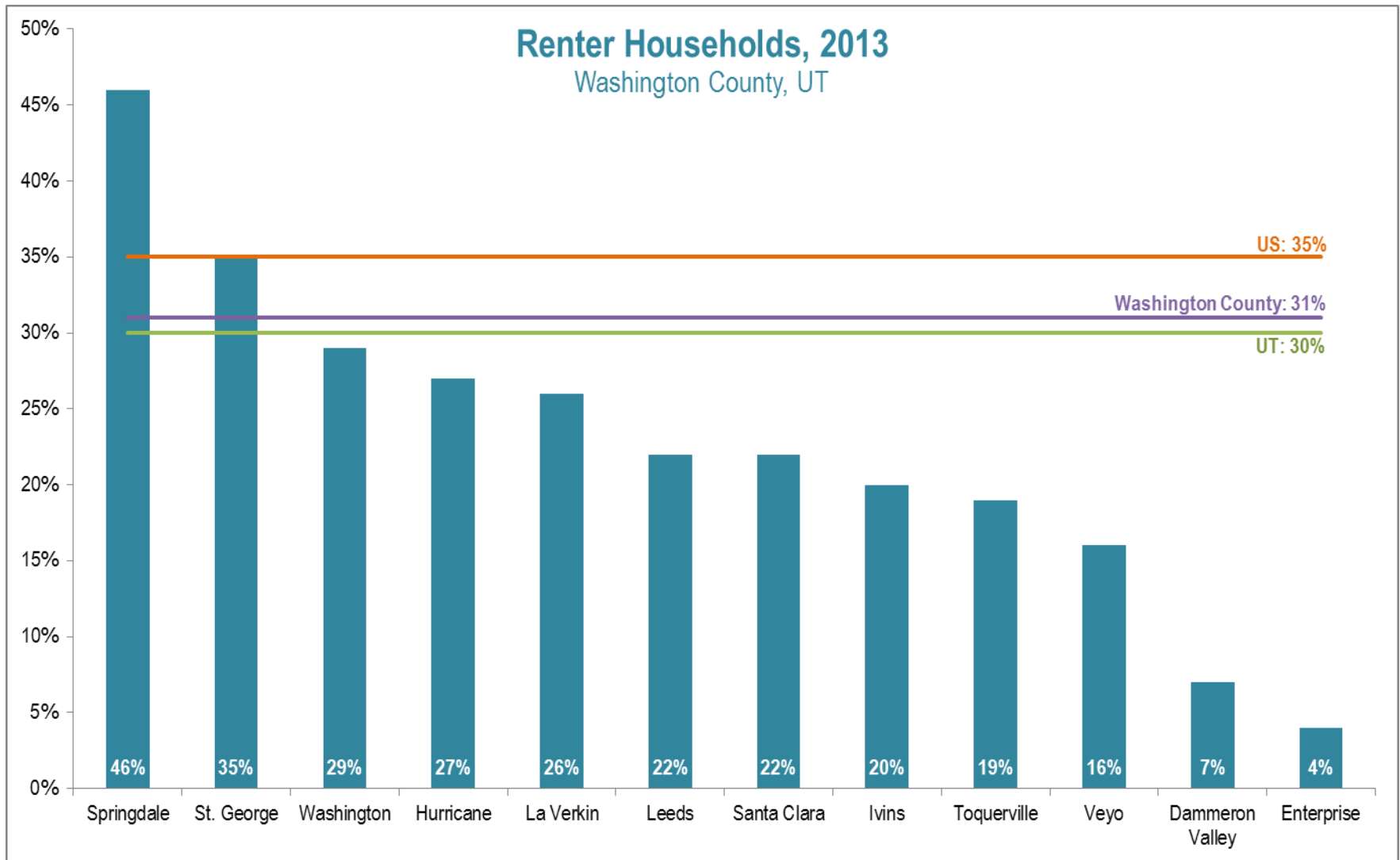

Housing Stock by Year Constructed, 2013 Washington County, UT



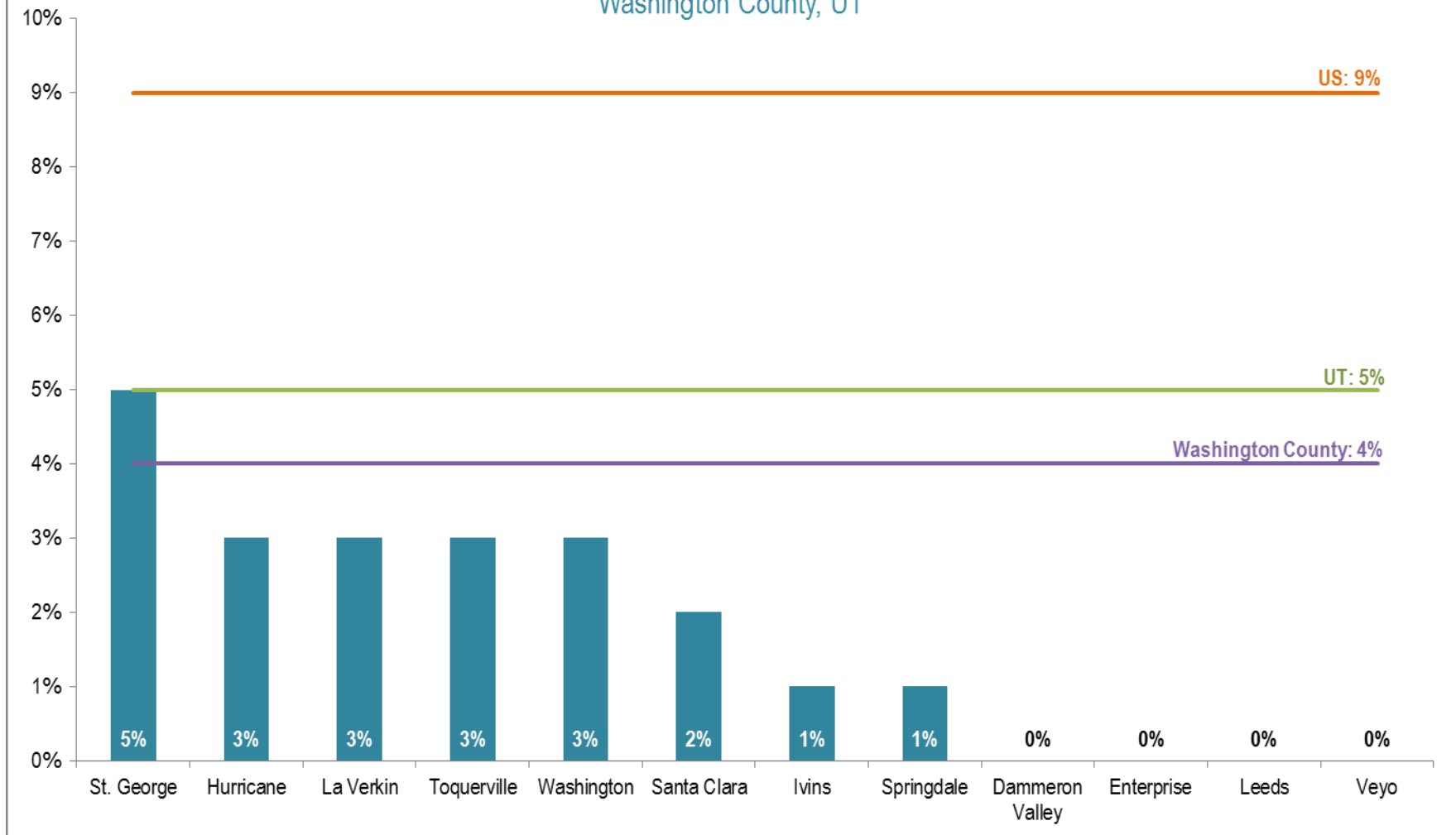

Households with No Personal Vehicles Available, 2013

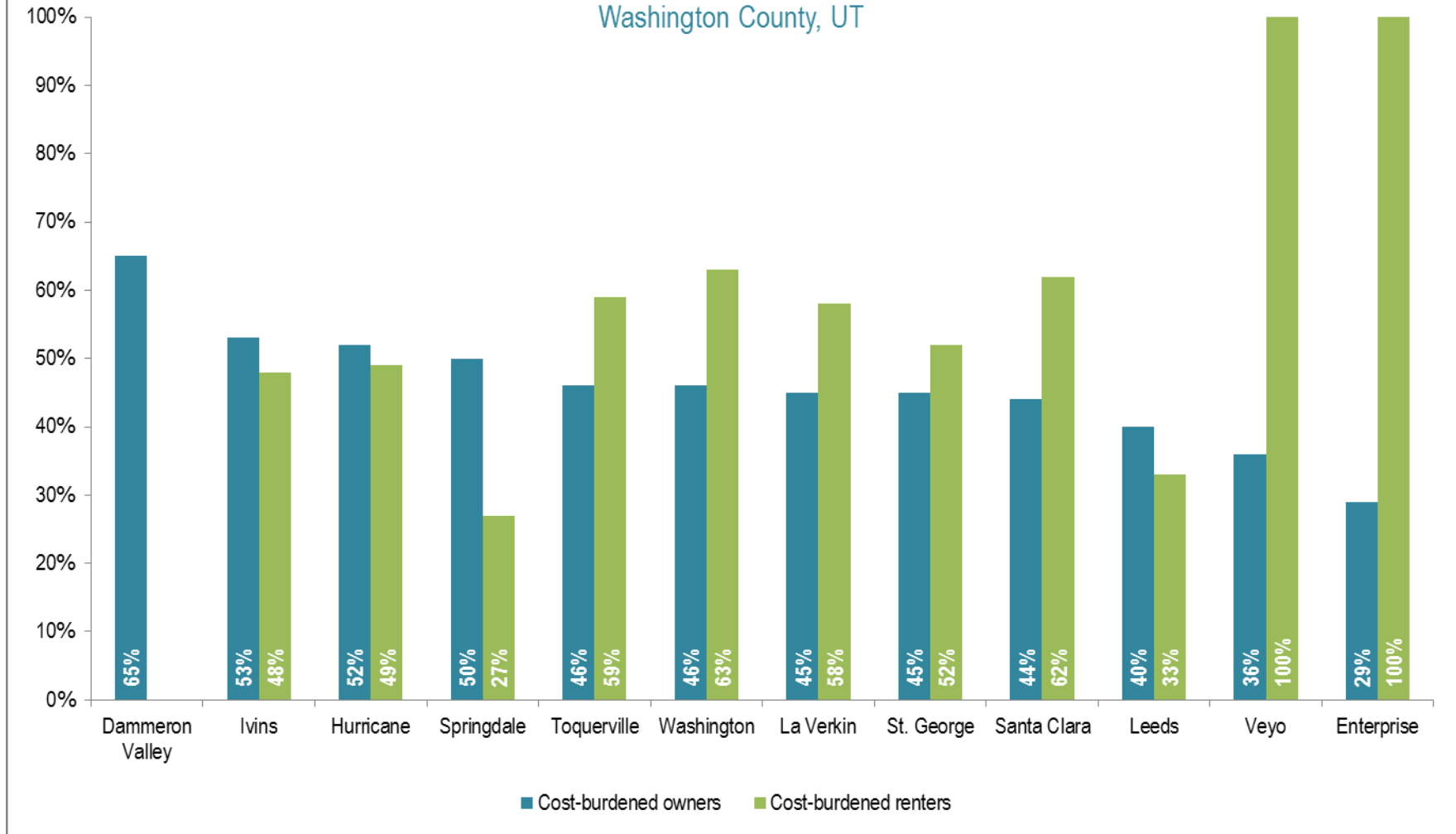
